Duterte admin provides 'sound take off point' for next leadership

MANILA – The Philippine Chamber of Commerce and Industry (PCCI) said the Duterte administration has provided a strong economic foundation for the next leadership.

In a statement Tuesday, PCCI president George Barcelon said the next administration will be faced with the same financial challenges that needed to be addressed.

These economic challenges were brought by the prolonged coronavirus disease 2019 (Covid-19) pandemic and the impacts of the conflict between Ukraine and Russia, he said.

"There will be blips in and downward rating trend, but we know better macroeconomic our fundamentals are intact and the economic reforms President Rodrigo Duterte's administration, kudos to Finance Sec. (Carlos) Sonny Dominguez who provided a sound take off point for (the) new administration," the PCCI Among economic reforms passed during the Duterte administration include the Corporate Recovery and Incentives for Enterprises (CREATE) law, Ease of Doing Business and Efficient Government Service Delivery (EODB) law, as well as the amendments to the Retail Trade Liberalization Act, Foreign Investments Act, and the Public Service Act. "Let's give the incoming administration time to draw up and share their plans in making our country more progressive," Barcelon said.

Uncontrolled use of technology brings behavioral addictions: NGO

ISTANBUL – Uncontrolled use of technology and the internet brings various behavioral addictions that can harm people both physically and psychologically, according to the Turkish anti-addiction body.

Unconscious and uncontrolled use of technology and the internet is a type of addiction that manifests itself with addictive sub-behaviors such as behavioral addictions, internet gaming disorder, and excessive use of social media and smartphones, according to data compiled by Anadolu Agency from Turkiye's Green Crescent organization.

The problems caused by technology addiction include physical complaints such as eye burning, pain and stiffness in the neck muscles, poor body posture, numbness in hands, and physical weakness.

Also, social complaints, including low academic achievement, personal and family problems, time management issues, sleep disorders, decrease physical activities, as well as social isolation, are counted as other problems related to technology and internet addiction.

To help people deal with these issues, Green Crescent Counseling Center provides free support to those aged 12 and over.

According to research by the UK-based GlobalWebIndex last year, the average daily time spent on the internet worldwide was six hours and 58 minutes.

However, users in Turkey spent an average of eight hours on the internet -- above the world average.

Japan ranked last in internet use time, with four hours and 26 minutes, according to the research.

Meanwhile, Green Crescent recommends a maximum of 120 minutes of screen time daily for people aged 12 and over.

Infants and toddlers should be kept away from the screen, preschoolers aged 3-6 should spend no more than 30 minutes, children aged 6-9 a maximum of 50 minutes, and those aged 9-12 should spend no more than 70 minutes daily, according to the Turkish NGO.

Recommendations

To get rid of tech addictions, Green Crescent recommends limiting hours of daily internet use through weekly schedules or participating in support groups or family therapy.

Officials of the DOST and MSIT met virtually last April 28 to discuss the collaboration. Buendia said both parties agreed to prioritize projects on smart vertical or indoor farming, and the rapid intensification of cyclones.

The call for proposals covering these topics will begin in June, and the approved projects are expected to commence in September. Initially, the two parties are targeting at

Buendia, meanwhile, said that relevant institutions shall continue to coordinate in exploring and realizing potential collaborations between the DOST MSIT even with the new Philippine administration.

As to the delay in the start of collaborations, Buendia said this was due to the new leadership in MSIT. "Both sides need to agree on the topics to be tabled in consideration with the new head of Korea," she said. added Buendia that there were challenges in communication, making them seek the assistance of the Philippine Embassy in Seoul and interpreters.

CA upholds life terms on 2 Pampanga women in int'l sex ring

MANILA – The Court of Appeals (CA) upheld the life imprisonment sentence and more than PHP2 million in fines imposed by a Pampanga court on two women for violation of antitrafficking in persons law.

In a decision on May 4 and made public online recently, the CA said Julie Nicdao and another woman named in court records only as YYY are guilty beyond reasonable doubt of qualified trafficking.

YYY's real name was concealed to protect the identity of her sibling, one of their minor-aged victims referred to as AAA.

The operation to catch the two was hatched following international intelligence cooperation in 2018 with the Australian Federal Police, Queensland Police Service, and National Bureau of Investigation Anti-Human Trafficking DIvision (NBI-Ahtrad).

They identified Nicdao from Angeles City, Pampanga as producing and selling pornographic web camera shows to clients who pay her through international money transfers.

Australian authorities gathered the details following their arrest of a certain Alan Thomas Latimer on Dec. 6, 2017 and whose mobile phone camera files yielded a sex video of a minor sent by Nicdao.

An entrapment was hatched by NBI undercover agents who posed as foreigners and lured Nicdao into introducing them to the victims.

On Aug. 26, 2018, the NBI agents, social workers, and intelligence agents from the Department of Justice Inter-Agency Council Against Trafficking in Persons arrested Nicdao and YYY.

"The crime of trafficking in persons is considered consummated even if no sexual intercourse had taken place. The mere transaction consummates the crime," the CA ruled. "It is sufficient that the accused has lured, enticed or engaged its victims or transported them for the established purpose of exploitation, which includes prostitution, sexual exploitation, forced labor, slavery and the removal or sale of organs." (PNA)

PNR Lucena-San Pablo to open before Duterte steps down in June

MANILA – The revival and development of the Lucena-San Pablo stretch of the Philippine National Railways (PNR) continues as it is set to reopen before the end of the Duterte administration in June, the Department of Transportation (DOTr) said on Tuesday.

Construction of the Lucena-San Pablo line is ongoing with the rest of the PNR Bicol which links Metro Manila and the Southern Luzon provinces.

"As the Duterte administration nears its conclusion, Secretary (Arthur) Tugade made a covenant with the Filipino people not to waste even a single day at work. There is no time to relax even until

the last day of office," the DOTr said in a Facebook post.

Once reopened, the Lucena-San Pablo line will reduce travel time between San Pablo, Laguna and Lucena, Quezon to one hour and 30 minutes and is seen to help boost the economic corridors of both provinces and neighboring areas.

The line is part of the 560-kilometer PNR Bicol scheduled to be operational by 2027.

PNR Bicol will have 35 stations and will run from Manila through Laguna, Quezon, Camarines Sur, Albay, an extension line in Sorsogon, and a branch line in Batangas. (PNA)

DTI warns business owners, establishments that price tag is a must

MAKATI CITY -- Tightening its watch over booming e-commerce transactions in the country, the Department of Trade and Industry (DTI) warns business owners and establishments to disclose prices in compliance with the Fair Trade Laws.

The DTI Consumer Protection Group (DTI-CPG) urges online and physical store owners to comply with:

Article 81 of the Republic Act No. 7394 or the Consumer Act of the Philippines which requires appropriate tags, labels, or markings that indicate the prices of consumer products sold in retail. With these, products must not

than stated; and with Section 5 of Republic Act No. 7581 or the Price Act that stipulates that selling a basic necessity or prime commodity without a price tag is prima facie evidence of profiteering.

strengthen the implementation of the Price Act and Consumer Act, the DTI, Department Agriculture (DAR). Department of Health (DOH), Department of Environment and Natural (DENR), Resources Intellectual Property Office (IPO), and National Privacy Commission (NPC) have recently issued the Joint Administrative Order (JAO) No. 22-01, consolidating all existingrules and guidelines on online businesses.

The provisions of JAO No. 22-01 reiterate laws that apply to the establishments' responsibility to comply with the requirements of price tags on products and services of physical and online stores.

"We are firm in enforcing these laws, especially on the requirement of price tags, to ensure consumers' right to choose quality products at reasonable prices," says DTI – Consumer Protection Group (CPG) Undersecretary Atty. Ruth B. Castelo.

Several months ago, the DTI launched an online campaign against the "PM Sent (Private Message) culture." The "PM Sent culture" is the shady practice of online sellers who send private messages to consumers inquiring on the price of a product. The campaign emphasizes that online vendors who conceal prices as a marketing

strategy can be fined and/ or imprisoned, according to Article 95 of RA No. 7394. The fine ranges from Two Hundred Pesos (Php 200.00) to Five Thousand Pesos (Php 5,000.00) while imprisonment can last from one (1) month to six (6) months. 4 data centers eye to sign up with PEZA

MANILA – The Philippine Economic Zone Authority (PEZA) said at least four hyperscalers are looking into investing in the country through the investment promotion agency.

In an interview Tuesday, PEZA deputy director general Tereso Panga said the capacity of these data center operators ranges from 30 to 100 megawatts. Panga said the companies are still waiting for the developments of the May 9 polls before proceeding to their investment decision. "These are big players

"These are big players aggressively looking for

a site already," he said, adding that these firms are eyeing the provinces of Bulacan, Cavite, and

Laguna. Hyperscalers are providers of scalable data storage

services.

The PEZA official said data center providers want to register their projects with PEZA so that they are not exposed to the regular high power rates outside ecozones.

"Data center —it's power intensive. So they want to be co-located in PEZA zone kasi (because) only PEZA provide franchise, can embedded power operate it in ecozone. If they are not inside the ecozone, they will be exposed to regular power rates, and this is (a) bigticket (project). They would want to be in an ecozone,' Panga added.

He said PEZAhas urged the Fiscal Incentives Review Board (FIRB) to include ecozone development among economic activities that would be provided with tax perks from the government. (PNA)

DOH to endorse CDC, Vax Institute creation to next admin

MANILA - The Department of Health (DOH) will endorse to the next administration the implementation strategies of the Universal Health Care Act and the establishment of the Vaccine Institute of the Philippines and the Centers for Disease Control (CDC). In an online media forum Undersecretary Tuesday, Maria Rosario Vergeire said the DOH would push for proper approaches to be observed "transitioning from the pandemic to the new normal". As the DOH has planned and

As the DOH has planned and informed the public "to live with the virus", Vergeire said the agency would urge the President-elect to continue the Covid-19 vaccination program and the implementation of minimum public health standards.

The DOH likewise sees the crucial role of a CDC in the country's goal to move out of the pandemic and ensure health care for all.

"Andiyan po ang Centers for Disease Control bill na pinapasa sa Senado sa . Kongreso kung saan diyan po mare-restructure ang ating health care system. ang ating DOH na magkaroon tayo ng isang institusyon kung saan dito na tayo magre-rely pagdating sa mga pandemya, pagdating sa infectious disease, pagdating dito sa ating bansa at pagdating sa ating pagre-research and surveillance (There's Centers for Disease Control bill in the Senate, in Congress, where our health care system, DOH, will be restructured, and there will be one institution to rely on in times of pandemic, infectious disease, and research and data surveillance)," Vergeire said.

Senate Bill No. 2505 or the Philippine Centers for Disease

Control and Prevention Act will establish the Centers for Health Statistics, Surveillance and Epidemiology, Health Evidence, and Reference Laboratories under the DOH. A counterpart bill in the House of Representatives was approved in July 2021.

Vergeire noted that the Covid-19 pandemic highlighted the country's need for a vaccine institute that would promote the protection against infectious diseases and pandemics.

'Libreng Sakay' ridership reaches almost 11 million

MANILA – The Metro Rail Transit Line 3 (MRT-3) has given almost 11 million free rides to the public so far since the beginning of its "Libreng Sakay (free ride)" program in March.

In a Facebook post on Tuesday, the MRT-3 said a total of 10,990,908 passengers have so far received free rides at the MRT-3 from March 28 until Monday.

The free ride program is set to end on May 30 after it was extended for another month at the end of April.

The program is meant to showcase the improved service and facilities of the MRT-3 after its rehabilitation was completed in December last year.

To date, it runs four fourcar trains and 18 threecar trains -- each train car is capable of carrying 394 passengers, allowing fourcar trains to carry 1,576 passengers and three-car trains with 1,186.

To help ensure the safety of passengers a day after the elections, it also held antigen testing for all of its employees on Tuesday.

GSIS loan condonation program extended until June 30

MANILA Inactive membersoftheGovernment Service Insurance System (GSIS) will have more time to settle their loans as the condonation program has been extended to June 30. GSIS president and general manager Rolando Macasaet announced on Tuesday that they will waive all penalties from outstanding principal loans.

"We encourage our inactive GSIS members to apply for this program, which also gives them the option to pay their loan balances on a three-year installment basis at 10 percent interest per annum only," Macasaet said in a statement.

Dubbed Program for Restructuring Repayment of and Debts (PRRD), Macasaet said the one-time condonation and restructuring program covers various service loans like salary loans, cash

advances, consolidated loans, emergency loans, assistance educational loans, and policy loans. PRRD availees may settle their loans directly at GSIS offices or through partner payment facility Bayad Center.

"If the borrower is a retiree who will receive the pension at age 60 or after five years, the payment may be deducted from his or her pension. If the loan will be settled by the legal spouse, he or she may have it deducted from the survivorship pension or pay through the almost 3,000 Bayad partner outlets Macasaet nationwide," added.

He said the GSIS intends to recover and collect outstanding loan accounts through PRRD to ensure members will continue to receive their benefits. (PNA)

EU looks forward to working with next administration

MANILA - The European Union (EU) looks forward to forging closer cooperation with the Philippines under the next administration, its delegation in Manila said Tuesday.

The bloc was among the groups to send foreign observers to monitor the conduct of the Philippine national elections on May 9.

The delegation said it observed generally "peaceful, free, and fair democratic elections" based on the polling precincts its diplomats visited in different parts of Metro Manila and nearby provinces.

"The EU (Delegation to the Philippines) looks forward to working with the incoming administration for the next six years and foster closer EU-Philippines relations," it said on its official Facebook page.

Presidential Ferdinand "Bongbong" Marcos Jr. is leading in the partial and unofficial tally by 30.9 million over his nearest rival Vice President Leni Robredo with 14.75 million votes, based on 97.72 percent of election returns processed.

To recall, the Partnership and Cooperation Agreement (PCA) between the EU and the Philippines entered into force in 2018, creating a joint committee that allows the two partners to boost relations based on mutual interest and respect.

The joint committee established three specialized subcommittees focused on Development Cooperation; on Trade, Investment and Economic Cooperation; and on Good Governance, Rule of Law and Human Rights. (PNA)

FIRB approves tax perks for Hanjin shipyard rehab

MANILA The Fiscal Incentives Review Board (FIRB), upon the endorsement of the Subic Bay Metropolitan Authority (SBMA), has approved the grant of tax incentives to Project AGILA for the redevelopment and operations of the Hanjin shipyard in the Subic Bay freeport zone.

Finance Secretary and FIRB chairman Carlos Dominguez III supported the approval of the tax perks for Project AGILA with a total project cost of PHP17 billion as the rehabilitation of the Haniin shipvard presents economic potential given its strategic location near the West Philippine Sea (WPS). The project was granted special

d corporate (SCIT), valu income value-added tax (VAT) exemption from importation, VAT zero-rating on local purchases, and duty exemption on importation.

"We expect the project to create jobs in the adjacent communities, increase economic activity as well as support the national government's economic recovery efforts," Dominguez said. "The resumption of operations in the shipyard will also prompt development and productivity in the area, which can attract more investment opportunities into the country. The project will cater to both the Philippine Navy (PN) and potential export locators.

It will be beneficial, specifically to the Navy, as it will involve the safety and efficiency of Philippine government ships' performance and, consequently, strengthen national security.

This project is funded by United States (US)-based private equity firm Cerberus Capital Management. *(PR)*

And if somebody does not reply 'alright', or keep silenct then that leads to an investigation. So, that's one way for us to find out if there's any violation, grave offenses particularly maltreatment," paliwanag ni Tomines.
