## CAVITE 1st DISTRICT TO STRENGTHEN HEALTHCARE

**TRECEMARTIRES, Cavite (PIA)** – The health officers of the local government units (LGUs) in the First District of the province convened for the first time with Cavite First District Representative Jolo Revilla to discuss plans for the district's health care system.

Present during the meeting were Dr. Rubiano of the Southern Tagalog Regional Hospital, Dra. Joy Caballes from Kalayaan Hospital and other health care officials. The meeting focused on measures and recommendations to enhance the medical services in public health facilities, starting from barangay health centers up to public hospitals.

Congressman Jolo Revilla said, "Sisiguraduhin natin ang maayos na referral system, palalakasin ang kakulangan sa mga pasilidad at bibigkisin natin ang buong pwersa ng ating health care sa Unang

Distrito." (We will ensure a proper referral system, augment the lack of facilities and we will bind the entire force of our health care in the First District.)

He pointed out that for a long time, the health system of the district was neglected, and medical services had been insufficient to meet the needs of the citizens.

The congressman requested the health officers to give priority to developing programs and projects related to health. Congressman Revilla also revealed various infrastructure projects for health facilities in the first district such as the dialysis centers in Rosario and Kawit towns, Mega Rural Health Unit in Rosario, the public city hospital in Cavite city, the completion of the Noveleta infirmary, and the enhancement of our own District Hospital. **TRECE MARTIRES CITY, Cavite (PIA)** – The Department of Health's (DOH) Bakunahang Bayan: PinasLakas Special Vaccination Days launched in the city of Trece Martires Public Market was recently held from September 27 to October 1.

DOH Officer-In-Charge Dr. Maria Rosario Vergeire together with Calabarzon Center for Health Development-Regional Director Ariel I. Valencia and Assistant Regional Director Leda Hernandez led the activity in coordination with the city government represented by Mayor Gemma Buendia-Lubigan, Vice Mayor Bobby Montehermoso and other government officials.

A number of residents from different parts of the city were vaccinated with their respective first and second booster doses including Mayor Gemma Lubigan who received her second CoVid-19 booster dose administered by Dr. Vergeire.

The Bakunahang Bayan: PinasLakas Special Vaccination Days was conducted nationwide in coordination with local government units (LGUs) by conducting a setting-based launch that include: schools, malls, markets, plazas, workplaces and places of worship where people can easily access COVID-19 primary and booster shots. ## Corregidor rehabilitation to revitalize Cavite City tourism

**CAVITE CITY, (PIA)** – The Cavite City government recently coordinated with the officials of the Corregidor Foundation, Inc. for the rehabilitation of the historic Corregidor Island.

A Memorandum of Agreement (MOA) was signed during the meeting by the city government headed by Mayor Denver Chua, City Administrator Abraham Urubio together with Ms. Cynthia Carrion, Chairperson of the Corregidor Foundation, Inc., and Ms. Rowena Bautista, Officer-in-Charge (OIC) Department Manager.

"Isa sa ating mga plano ang pagpapaayos sa isla at maayos na mapreserve ang mga historical relics nito upang mapalawig ang turismo ng ating lungsod," shared Mayor Denver Chua.

(One of our plans is to restore the island and properly preserve its historical relics to boost tourism of our city.)

Mayor Chua said, "We are excited for you to see the beauty of Corregidor Island and I believe that slowly our city will be recognized and our economy will be restored to being 1st class."

Ha also says that for a long time, the city government had not utilized the historic site and did not participate in its development.

"With the cooperation of Councilor Nash Aguas, Chair, Committee on Tourism, our goal is to make tourism shine in our city," the mayor said.

Corregidor Island is 37 kilometers or 19.9784 nautical miles off the shores of Cavite city proper in PN, Samonte Park, and places second to the most visited tourist destinations in the province despite its geographical location having to travel by ferry boat. It is estimated that it can provide a huge tourism income when properly restored and promoted. (RBF/PIA-Cavite)

At the forefront of such are the caravans, forums and learning sessions primarily designed to enlighten both the DHSUD body and the public of the financial elements and possibilities of the Pambansang Pabahay para sa Pilipino Program. Recreational activities will likewise be organized including Zumba sessions, office Olympics and tree-planting initiatives.

Meanwhile, Undersecretary Henry Yap in his speech expressed gratitude toward partner organizations that have been assisting the DHSUD in fulfilling its mandate, particularly the United Nations Human Settlement Program or UN-Habitat, whose "assistance in numerous Philippine projects such as the development of climate resilience urban plans and design studies, provincial climate risk diagnostics, and in rebuilding Marawi, reinforces their shared commitments toward establishing safe, resilient and sustainable communities."

He then recognized UN-Habitat not only for participating in the kick-off event, but also for "jointly celebrating with us World Habitat Day and continuously creating awareness on the growing inequalities and challenges facing our settlements that are further exacerbated by the '3 Cs Crisis,' namely, covid-19, climate change and conflicts."

Ending the program, Bernard Barth, the human settlements officer of UN-Habitat's regional office for Asia and the Pacific, expressed the organization's support of the DHSUD's goal to realize the Filipino family's dream of owning a safe and sustainable home toward improving their quality of life.

Relatedly, the NSM coincides with Urban October, a month-long celebration that aims to raise awareness and engage the international community in discussing the challenges and opportunities created by the fast pace of change in cities. (DHSUD)

## Woman acquitted on drug raps over technical lapse

**MANILA** – The Supreme Court (SC) has acquitted a peanut butter vendor on drug charges citing irregularities in the case against her.

In a notice published online on Sept. 29, the high court cleared Ken Cola Ali after it noted a lapse in the case when the officer who allegedly had contact with the informant which prompted the entrapment operation against the accused was not presented as a witness.

Ali has been convicted by a Kidapawan court for selling PHP500 worth of shabu to police in plain clothes on April 10, 2017, during a buy-bust

operation following information received by local police from a confidential asset of the alleged activities of a certain "Tomboy".

The accused claimed that she had been called by a friend to meet at a road to pay for items the latter purchased a week before.

Ali claimed that when she was arrested, the police allegedly planted incriminating evidence in her bag which contained her jars of peanut butter. Her conviction was subsequently upheld by the Court of Appeals (CA).

In taking her case to the SC, Ali questioned why Senior Police

Officer 1 (SPO1) Rogelio T. Ybañez, Jr. of the Kidapawan City police, who supposedly received the information from an informant, was not presented as a witness by the prosecution.

The defense claimed that since the officer who received the information from the informant was not presented, "the prosecution failed to present evidence as to the veracity of the allegation that she was involved in the sale of illegal drugs" and said "it is incumbent upon law enforcers to show legal or reasonable justification before embarking on a buy-bust operation".

The court said while buy-bust operations are legal, the testimony of PO2 Rhino Ramos, the police officer who

effected the actual arrest, is not sufficient.

"The manner by which the initial contact was made, whether or not through an informant, the offer to purchase the drug, the payment of the buy-bust money, and the delivery of the illegal drug, whether to the informant alone or the police officer, must be the subject of strict scrutiny by courts to insure that law-abiding citizens are not unlawfully induced to commit an offense," the SC said.

"The details that led to such exchange must be clearly and adequately accounted for. Failing in which will certainly cast a doubt on the veracity of the whole buy-bust operation." the tribunal added. (PNA)
