SM'S 80TH MALL OPENS IN TANZA ON OCTOBER 14

As part of a province with a rich historical tradition, Tanza in Cavite is the place where Emilio Aguinaldo was sworn in as President of the revolutionary government of the Philippines. It is also the birthplace of Felipe G. Calderon, who composed the Malolos Constitution.

It's another date with history on Friday, October 14, 2022 when SM City Tanza opens its doors to the public as SM Prime's 80th mall. It is also the 7th supermall in this historic and bustling province after SM City Bacoor, SM City Dasmariñas, SM City Molino, SM City Rosario, SM City Trece Martires, and SM Center Imus. SM also has a Marketmall in Dasmariñas.

Strategically located in a 86,718 square meter site along Antero Soriano Highway, SM City Tanza will serve shoppers in the northwestern areas of Cavite as well as in nearby Batangas. More than that, it will be a catalyst for employment and business opportunities in the area.

The two story almost 60,000 square meter mall's design is inspired by the chief means of livelihood in Tanza, which is farming and fishing, as well by its nearby beach resorts in the coastlines. Symbolizing warmth from the colors of the boats and serenity of the seas, its interior is configured in an L-shaped layout, provided with natural clerestory light that stretches across the mall area, including the Cyberzone.

The ceiling is accented with curvilinear cove light lines depicting the ripples of the sea. The mall also has a 1,500 square meter Events Center which for activities and exhibits. It also features a lush landscaped indoor area that will provide the mall with a place to relax, shop, and dine.

SM Store and SM Supermarket are SM City Tanza's major anchors along with SM Appliance Center, ACE Hardware, Watsons, Surplus, Uniqlo, Pet Express, Miniso, Levi's, and Crocs. It will also have fashion boutiques, jewelry stores, bookstores, as well as service and wellness centers.

Eating out options include a Food Court; specialty restaurants like Mesa, Boteju, The Great Buddha Café, Marugame Udon and Tempura, and Crustasia Asian Bistro; and international and local food chains like Kenny Rogers, Panda Express, Bon Chon, Coffee Bean and Tea Leaf, Mary Grace Café, Breadtalk, J. Co Donuts and Coffee, and Starbucks.

SM City Tanza will also have five state of the art cinemas and a Cyberzone for techie enthusiasts.

For its customer's convenience, and enhanced mall experience, SM City Tanza will have almost 800 slots in its carpark. The new mall will also have public transport terminals for inter-province, and inter region travel that will further boost tourism and commerce in the area.

SM City Tanza's project team includes DSGN, Design Consultant; Asya, Architect on Record; RM Cabanela, Construction Management; and Dahn Bager, General Contractor.

BACOOR CITY, Cavite (PIA)— The Philippine Information Agency and Bureau of Communications Services work hand-in-hand with the Bacoor City Government to enhance government personnel's social media and news writing skills from October 11-14.

Silang highlights transparency, impartiality & good governance in first 100 days

SILANG, Cavite (PIA)— The Municipality of Silang showcases its thrusts for transparency, neutrality, and good governance for its stakeholders in line with its 100 days of administration. The local government implements transparency through its "No to Corruption" stance with the LGU's procurements undergoing open public bidding which results to lower purchase costs and eventual savings.

Silang Mayor Atty. Kevin Amutan Anarna says, "These savings went to the purchase of school supplies that were distributed to students of public elementary schools in the municipality." Employees wear colors white and gray to show impartiality from previous election party affiliations and always render service with a smile. Implementation of the anti-corruption policy also led to the collection of taxes and fees by the Business Permits and Licensing Office (BPLO) at a 42% increase for the same period last year as well as with the collection of market rental fees which reached above 500%.

Good governance practice made transactions at the Public Assistance Center reliable and efficient with the shortened processing time of 95% same-day completion of government service transactions.

The local government chief plans to have a public hearing to give higher funding for scholarship programs to the top 50 scholars of about P40K a year, and a full scholarship to students of law, medicine, and even civil engineers in the municipality, to groom future lawyers, doctors, and engineers who will help serve the municipality. Mayor Anarna addressed Silangueños saying, "Pagpasensyahan niyo po kung hindi agaran ang pagbabago pero paunti-unti ay pinipilit natin na mabago natin ang ating bayan. Expect niyo na po very transparent ang ating pamahalaang bayan at accountable sa mga mamamayan ng bayan."

SC turns down dismissed judge's plea for clemency

MANILA – The Supreme Court (SC) has turned down a Mindoro judge's plea to reverse his dismissal from the service by the court for gross ignorance of the law in connection with his handling of cases in his sala.

The high tribunal, in a resolution published online on October 11, denied the motion for "judicial clemency" of former San Jose, Mindoro regional trial court (RTC) Branch 45 Judge Jose Jacinto Jr. who was dismissed from service by the court for gross ignorance of the law in connection with his handling of 17 criminal cases involving illegal drugs.

In the case, Jacinto either granted motions for rehabilitation or transferred custody of the accused to the provincial parole and probation office in violation of the requirements under the law.

Jacinto's actions in the drug cases, the SC said, were "unwarranted and clearly violative of requirements" under Republic Act 9165 or the Comprehensive Drugs Act of 2022.

The SC noted that some of the accused were re-committed to rehabilitation without the required endorsement of the Dangerous Drugs

Board and an examination by a Department of Health accredited physician.

The court also noted the parole and probation office is not legally designated as a detention facility for those accused of illegal drug offenses pending trial.

The SC had also found Jacinto liable for gross misconduct in a civil case where he ordered the transfer of the custody of prisoner Ruben Tiu from the San Ramon Penal Colony in Zamboanga to the Sablayan Prison and Penal Farm in San Jose, Mindoro without the approval of Supreme Court.

In seeking the restoration of his retirement benefits, the judge for 39 years said his transgressions started at the height of his personal sufferings in 2008 when he experienced vertigo and hypertension attacks after his wife died of pancreatic cancer.

In turning down his motion, the court said a judge penalized for professional misstep must support his plea for reconsideration with "compelling proof of remorse, rehabilitation, and potential."

"Judicial clemency is not a privilege or a right that can be availed of at any time. Courts can only accord it upon showing that it is merited," it said. (PNA)

CSC urges govt workers to get booster shots

QUEZON CITY (PIA) -- The Civil Service Commission (CSC) after hosting on 5 October the Department of Health's (DOH) "Sa Boosters: PINASLAKAS" event at the CSC Central Office in Quezon City pushes to further improve the COVID-19 booster coverage rates in the country.

DBM, DOH release guidelines on cancer assistance fund

CALOOCAN CITY, (PIA)

-- In the Philippines, 189 of every 100,000 Filipinos are affected by cancer, with four Filipinos dying of cancer every hour or 96 cancer patients every day according to a study undertaken by the University of the Philippines' Institute of Human Genetics, National Institutes of Health.

The cancer treatment price can range from Php 120,000 to as much as Php 1 million pesos or more. Note that some cancers may only involve surgeries while others may require lengthy treatment options.

For most, if not for all cancer patients, the news on the Department of Budget and Management (DBM) and the Department of Health (DOH) releasing the Joint Memorandum Circular (JMC) No. 2022 - 0002 prescribing the Implementing Guidelines for the Use of Cancer Assistance Fund (CAF) amounting to P529.2 million is heaven sent.

The provision of P529.2 million is anchored on Special Provisions (SP) No. 13 of the DOH budget under the 2022 General Appropriations Act (GAA), which requires, among others, the issuance of the JMC as a pre-requisite for the utilization of the fund. This is pursuant to Republic Act No. 11215 or the National Integrated Cancer Control Act, which seeks to provide an integrated and holistic support to cancer treatment and management.

"Malaking tulong po para sa ating mga kababayan itong nakalaang pondo for cancer assistance na maaari na pong magamit sa mga DOH hospital access sites at iba pang health facilities sa bansa. We hope that it will ease the burden of many cancer patients, as we know that cancer is one of the leading causes of morbidity and mortality amongst Filipinos," DBM Secretary Amenah F. Pangandaman said.

CAF aims to complement and supplement existing financial support mechanisms exclusive for cancer patients, persons living with cancer, and cancer survivors.

Pursuant to the JMC, which was released on 28 September 2022, the CAF shall likewise fund

outpatient and inpatient cancer control services, including but not limited to diagnostics, therapeutic procedures, and other cancer medicines needed for the treatment and management of cancer and its care-related components.

The said fund shall be available for utilization until December 31, 2023 in line with the adoption of the cash-based budgeting system and subject to applicable general and special provisions under the FY 2022 GAA and other existing budgetary guidelines issued by the DBM.

The JMC shall take effect fifteen (15) days after its publication in the Official Gazette or a newspaper of general circulation. (DBM/ PIA-NCR)

CA orders reinstatement of 2 illegally dismissed NBI execs

MANILA – The Court of Appeals (CA) has ruled in favor of two senior officials of the National Bureau of Investigation (NBI) dismissed from their post by former justice secretary Leila de Lima eight years ago.

In its 24-page decision written by Associate Justice Mary Charlene V. Hernandez-Azura, the appellate court decided in favor of reinstatement and back pay in the NBI of lawyer Reynaldo O. Esmeralda as deputy director without loss of seniority rights; and the immediate payment of full back wages, incentives and benefits of lawyer Ruel Masala, who has since reached retirement age.

"The removal of petitioners was illegal and in violation

of their right to due process. Hence, petitioners are entitled (to) the payment of back wages and other benefits due them from the time they were replaced up to their reinstatement to their former position without loss of seniority rights," the CA said.

The two were promoted from the NBI ranks as directors in 2006 and 2007 by former President Gloria Macapagal-Arroyo. On March 13, 2014, then justice secretary De Lima issued Department Order 192 ordering the two to wind up and turn over their affairs to newly appointed NBI Deputy directors Ricardo S. Pangan Jr. and Antonio M. Pagatpat.

Esmeralda and Masala claimed they were dismissed by De Lima as the latter was convinced that they were the ones who prematurely informed Janet Lim Napoles of the issuance of a warrant of arrest in connection with a case for illegal detention filed by whistleblower Benhur Luy.

In 2018, then justice secretary Menardo Guevarra ruled that the two must possess career executive service (CES) eligibility to be qualified for the position of NBI deputy director, and since they were not CES eligible, they do not possess the requirements for the position and were only temporary appointees without security of tenure, regardless of the designation of their appointments.

On December 2018, the Office of the President, through then executive secretary Salvador C. Medialdea rendered a decision denying their appeal.

The CA in its ruling, however, said the two need not be accredited and qualified CESO before being considered permanent appointees since the positions held by the officials belong to the closed careers system whose inherent job responsibilities are scientific and highly specialized and technical in nature under Career Executive Service Board (CESB) rulings declaring it beyond the coverage of the CES. Include communication strategies in policy making to avoid misinterpretations – PIA chief

QUEZON CITY, (PIA)

-- Philippine Information Agency Director-General Ramon Lee Cualoping III said on Monday, Oct. 10, that in the process of policy making, the creation of communication strategies and planning must be included.

"It has always been my advocacy to include communications planning right at the onset of policy making," Cualoping said, in message delivered during the Commission on Higher Education (CHED) agency-wide flag raising ceremony via Zoom application.

The event is in observance of the 7th anniversary of its attached agency, UniFAST or the Unified Student Financial Assistance System for Tertiary Education, with the theme, "Let's Stay in Touch: Sustaining Relationships Through Communication."

UniFAST is the primary implementer of the Free Higher Education and Tertiary Education Subsidy program under Republic Act No. 10687, that was signed by former President Rodrigo Duterte on October 2015.

According to Cualoping, the common practice of having the communication strategies incorporated in the last part of the policy-

making process, may result to misinterpretations, and probably, the spread of fake news.

"Because for the longest time, we have created policies, we have created action plans and so on and so forth, and then communications only come in after," he said.

"Tapos pagnagkagulo, pag mayroong misinterpretation, miscommunication and pagkumalat na ang fake news, nagiging reactive na tayo, instead of being proactive (Then when it gets messy, when misinterpretation and miscommunication occurs, and when fake news is rampant, we become reactive instead of being proactive)," he added.

In the end, the Director-General hopes for the time when all national government agencies include communications planning and development communication in the process of policy making.

"I hope together with CHED and other national government agencies, we include communication planning, strategy, and to embrace development communication as part our policy making process," he said. (PIA-NCR)

DSWD, NCIP vow to make Christmas merrier for IPs

MANILA—The Department of Social Welfare and Development (DSWD) and the National Commission for Indigenous People (NCIP) chiefs vowed on Wednesday to work together in providing intervention for the indigenous people (IPs) who traditionally roam around urban areas to ask for "pamasko" or Christmas gifts during the holiday season.

During a Senate budget deliberation, DSWD Secretary Erwin Tulfo said there are existing government programs that can help the poor IPs in bringing them back to their provinces and providing them with their own livelihood there.

Tulfo cited the Balik Probinsya, Bagong Pagasa (BP2) and the DSWD's Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (KALAHICIDSS).

"Ang unang gagawin natin this December ay (The first thing we will do this December is) we will start registering them sa mga (in) local civil registrars para sila ay magkaroon ng (so they can have their own) birth certificates," he told the senators, noting that certain personal documents like a birth certificate would be needed for a person to be part of various government programs.

Tulfo cited another program for Badjaos which also includes a comprehensive program for street children where PHP34.9 million was allotted by the agency this year.

"But this is just for rescue. What they really want is a concrete solution at pangmatagalang na bibigyan sila ng livelihood pagdating sa kanilang tirahan (and lasting wherein they will be given livelihood when they arrive at their homes). This administration will make sure that they will be given livelihood para hindi na sila pabalik-balik (so, they will not go back and forth anymore)," he said.

Meanwhile, NCIP Chairperson Allen Capuyan suggested replicating

Davao City's approach in welcoming the IPs during December.

"Ang ginawa ng City Government of Davao tuwing December, iniipon sila sa isang lugar. Lahat ng gustong tumulong, mga sponsors ay pupunta doon. While ang ating brothers and sisters ay nasa isang gym, ay gagawa sila ng cultural presentations. Yan ang isang nakita ko na pwede nating gawin (What the City Government of Davao is doing by December, they gather them in a place. All who want to help, the sponsors will go there. While our brothers and sisters are in a gym, they will do cultural presentations. That is what I think we can do)," Capuyan said.

Senator Robin Padilla was asking the two agencies to break the endless cycle of Badjaos and other IP tribe members who are forced to travel to Metro Manila during Christmas.

Padilla, who chairs the Senate Committee on Cultural Communities and Muslim Affairs, said he is ready to coordinate with the agencies to help the IPs.

"Tuwang dadating ang Kapaskuhan, nakikita po natin ang ating mga katutubo sa iba't ibang kalsada kasama ang kanilang mga anak lalo ang mga kapatiid kong Badjaos. Kukunin sila, tapos ibabalik sa lugar nila, babalik din sila dito (When Christmas approaches, we see IPs such as our Badjao brethren on the streets, with their children. Our authorities would rescue them from the streets and send them to their home provinces, but they will keep coming back)," he said.

"Meron pong magaprograma ang DSWD tulad ng livelihood program. Ito ang sa akin lang mapaglarong isip. Pwede po kaya na turuan na lang sila kung paano mamasko nang hindi delikado, parang gawin ba nating livelihood yan (Our DSWD has livelihood programs. This is a suggestion - can we teach them to earn a living without having to risk their lives?)" he added. (PNA)

DENR pursues sustainable 'green, blue' economy

MANILA—The Department of Environment and Natural Resources (DENR) spent the first 100 days under the new administration of President Ferdinand "Bongbong" Marcos Jr. pursuing sustainable management and development of the environment while creating "green" jobs and ensuring investments and revenue for the government.

In an accomplishment report dated Sept. 29, the DENR said it has been pursuing a "blue" and "green" economy, referring respectively on the fisheries and marine sectors, and agriculture and forestry sectors, into which strategies to address climate mitigation and adaptation are incorporated.

The DENR said it has prepared four resiliency roadmaps and Investment Portfolios for Risk Resilience (IPRRs) for the climate-vulnerable provinces of Eastern Samar, Northern Samar, and Siquijor, as well as climate-vulnerable city of Metro Iloilo.

By December 2022, 12 more resilience roadmaps are expected to be completed for nine climate vulnerable provinces and three major urban areas. For the "green" economy, the DENR said from July to August 31, it developed 646 hectares of forestland and produced 702,470 seedlings benefitting 3,605 CBFM-People's Organization (PO) members nationwide, and provided Enterprise Livelihood equipment to POs in Regions 5, 6, 9, 10, and Cordillera.

A total of 944 Forest Extension Officers and 154 Technical Staff have also been hired under the Enhanced National Greening Program, while a total of 1,937 jobs were generated and 1,548 persons were employed in nursery establishment, seedling production, plantation establishment, maintenance and protection, the DENR said. The agency also strengthened the government's Anti-Illegal Logging and Forest

Protection Program by renewing a total of 3,215 forest patroller contracts to implement the Lawin Forest Protection and Biodiversity System.

Also, 163 lawyers/legal researchers/legal assistant contracts were renewed to speed up the resolution of forestry-related cases, it added.

For the "blue economy," the DENR said from July 1 to Sept. 15, 2022, it monitored 50 priority water bodies with 44 of them passing the water quality standards for Dissolved Oxygen (DO) and 42 water bodies passing the water quality standards for Biochemical Oxygen Demand (BOD).

Still part of its Clean Water Program, pursuant to Republic Act 9275 or The Philippine Clean Water Act of 2004, the agency also monitored 268 esteros/water bodies, of which 156 exhibited significant improvements in BOD, while 160 other water bodies showed water quality improvements in DO.

A total of 2,365 estero/river rangers were also hired to monitor, protect, clean up, and rehabilitate the bodies of water draining to the Manila Bay, the DENR said in its report.

As to Boracay Island in Malaybalay, Aklan, the DENR hired a total of 40 Boracay Environmental Lawin patrollers and 22 support staff for the Boracay Action Plan.

Some 19 Lawin patrollers/beach watch patrollers in Panglao and 19 personnel in Siargao were also hired to protect beaches designated as Green Economy Model sites, the installation of signage for no build zone, and other activities.

The DENR has also issued one Community-based Forest Management Agreement (CBFMA) to the Kawasan-Inuralan Farmers Association, Inc. covering a total area of 49.36 hectares in Region 10; and two Provisionary CBFMAs to the Singlot National Greening Program Consumers Cooperative covering 136.57 hectares and the San Isidro Upland

OPS eyes measures to combat proliferation of fake news

MANILA — Office of the Press Secretary (OPS) officer-in-charge (OIC) Cheloy Garafil on Wednesday said her office will be implementing several programs aimed at fighting fake news.

This, after private polling firm Pulse Asia found that nine of 10 Filipinos consider fake news as a problem in the Philippines.

In a Palace press briefing, Garafil agreed that the proliferation of fake news is a "serious" issue that needs to be addressed.

"Ito po ay isang seryosong bagay na tututukan ng OPS. Kaya ngayon, meron kaming mga programa na ili-lay down in the coming days (This is a serious matter that the OPS will focus on. That's why we will lay down various programs in the coming days)," she said.

Garafil noted that "in the coming days," the OPS would take several measures to combat the spread of misinformation and disinformation.

"We'll let you know kasi

Responsible mining

In the mining sector, the DENR said the Mines and Geosciences Bureau has issued 797 mining permits/contracts from July to Sept. 15, 2022.

Currently, 79 mining projects are being planned to start near-term and/or medium-term mining operations that will bring in total investments of PHP430 billion, revenues of PHP93.14 billion, and jobs to 16,275 individuals, the agency said.

"All priority mining projects are expected to earmark a total of PHP6.904 billion in Environmental Protection and Enhancement Programs expenditures," the DENR added.

The DENR also monitored the handling of infectious wastes in 42 treatment, storage, and disposal facilities.

Of these, four facilities were found non-compliant, hence, issued with Notice of Violations. (PNA)

gusto rin talaga natin na ma-address itong mga problema ng fake news (because we also want to address the problems on fake news)," she said.

Around 86 percent of 1,200 adult Filipinos believed that fake news is a problem, according to Pulse Asia's Sept. 17 to 21 survey.

The sentiment was more pronounced in Metro Manila (87 percent) and the rest of Luzon (92 percent) than the Visayas (77 percent) and Mindanao (81 percent), Pulse Asia noted.

The opinion was also more prevalent among Classes ABC (87 percent) and D (93 percent) than Class E (74 percent).

"Sizable majorities," Pulse Asia said, identified either social media (68 percent) or television (67 percent) as their source of fake news.

Radio (32 percent) and friends or acquaintances (28 percent) were the second group of fake news sources, the survey showed.

Around 21 percent of adult Filipinos said they are receiving fake political news from family or relatives.

Pulse Asia found that 58 percent are convinced that "social media influencers, bloggers, and/or vloggers are responsible for spreading fake political news in the country."

President Ferdinand "Bongbong" Marcos Jr. earlier expressed optimism that communication experts would join his administration in its fight against misinformation and fake news by using their voices to "leverage positive communication in stirring the nation towards full recovery and lasting unity." Garafil, a journalist-turned-lawyer, vowed Monday that the OPS will uphold "transparency, accuracy, and accountability" in delivering and disseminating information on the Marcos administration's policies, programs, and activities.

She added that her office seeks a wider public engagement to keep more Filipinos aware of the government's plans for the country. (PNA)

Mario Flores Canilao thought his world was about to end when Typhoon Glenda (International: Rammasun) struck his village in the province of Pampanga in July 2014 and ravaged a fishing pond where he derived his main source of livelihood.

"Yun ang pinakamalupit. Akala ko nga natapos na ang mundo sa akin noon (I thought life was too harsh. I thought that was the end of my world)," Mr. Canilao, a fisherman by trade, recalled.

Despite the blow he was dealt, he mustered the will and determination to move forward. Soon, the Department of Environment and Natural Resources enlisted his help to plant Bakawan or mangrove trees.

As the president of the Samahang Makakalikasan ng Pampanga, Inc. (SAMAPA), Mr. Canilao has been working tirelessly with the government and the private sector in the last decade to help build a coastal forest for the natural protection of their community in the municipality of Macabebe, to avoid pitfalls in the wake of another storm like Typhoon Glenda.

This year, he is delighted to know that SM Foundation, the social good arm of SM and Fast Retailing Foundation, a general incorporated foundation in Japan, are providing extensive support by planting Bakawan trees in his coastal community under their joint 'Grow Trees Community' project.

This reforestation initiative is set to introduce at least 100,000 mangrove trees of the Bakawan babae and lalaki species in Barangay Consuelo in the municipality of Macabebe, the second site after the project formally

launched in Batangas last September 27.

"Malaking tulong itong mangroves para sa akin, para sa pamilya ko at sa aking mga kababayo na magkaroon din po ng hanapbhuhay. Sa darating na mga henerasyon, makakatulong ang mga bakawan sa dipensa sa malalakas na alon at hangin (Mangroves are a huge help not just to my family but to my fellow villagers, also in supporting livelihood. The bakawan will help the next generation gain protection against strong winds and waves)," Mr. Canilao said.

Aside from providing a natural coastal defense against storm surges, the Bakawan has been widely personified in Filipino fiction and many children's books for its role in nurturing biodiversity in the environment.

"As visitors, we often see the beauty of the mangrove thickets, but for communities, this is nature's shield that protects them from natural calamities and serves as breeding grounds for fishes and shellfishes," Cristie S. Angeles, SM Foundation Assistant Vice President for Livelihood and Outreach Programs said.

"A well-preserved mangrove forest can provide an ecosystem of interconnected benefits promoting biodiversity in marine life and a reserve of valuable resources. Beyond this, the collective efforts of the community are vital to the preservation of the environment. As SM enables the growth of so many communities, we are also enabling these communities to lead the preservation of the environment in their areas," Ms. Angeles added.



Hindi na nag-aksaya ng panahon sina Bautista at kasama ang mga operatiba ng QCPD District Special Operations Unit (DSOU) ay agad ikinasa ang operasyon laban sa mga suspek nitong ika-08 ng Oktubre ganap na alas 3:15 ng madaling araw sa

Abatan Sing-Along Bar na matatagpuan sa No. 17-B Vincent Street, Barangay Holy Spirit, Quezon City. Inihayag ni Torre na isang pulis ang nagpanggap na customer at nagkunwari na naghahanap ng babae.

Nagkasundo ang pulis at ang suspek na sa halagang isang libong piso ay bibigyan siya ng bugaw na isang batambatang babae. Pagkatanggap ng bugaw ng halagang Php500.00 na "marked money" bilang partial payment mula sa pulis agad na itong sinunggaban ng mga operatiba ng DSOU.

Sa isang press conference, sinabi ni Department of Interior and Local Government (DILG) Secretary Benhur Abalos na ang nasabat sa anti-illegal drug operation ay posibleng pinakamalaking halaga sa kasaysayan ng bansa.

"Of course, ito ay dahil sa kampanya ng ating Pangulong Ferdinand Marcos Jr. Ang kanyang instruction sa PNP [Philippine National Police] at DILG ang importante ay makuhang talaga ang malalaking ganito," ani Abalos.

Sinabi naman ni PNP Drug Enforcement Group Director Police Brigadier General Narciso Domingo na ikinasa ang unang operation bandang alas-4:45 ng hapon sa Jose Abad Santos Street sa Barangay 252, Tondo, Manila, kung saan naaresto ang 50-anyos na suspek na si Ney Saligumba Atadero.

Sa interogasyon, inilahad ni Atadero na nakatago ang mga iligal na droga sa loob ng isang opisina sa lending firm na Wealth and Personal Development Lending Inc. sa Sta. Cruz, Manila.

Isa pang operasyon ang ikinasa nitong Lunes ng umaga kung saan tiklo ang isa pang indibidwal na pinangalanang ng suspek. Inihayag ni Domingo na naaresto si Police Master Sergeant Rodolfo Mayo sa Quezon Bridge sa Quiapo, Manila bandang alas-2:30 ng madaling araw nitong Oktubre 9.

Si Mayo ay isang intelligence officer para sa PNP Drug Enforcement Group, base sa police records.

Sa kasalukuyan ay wala pa siyang pahayag ukol sa pangayari.

"Matapos ang operasyon, nakakuha tayo ng ebidensya sa pagkakasangkot ng isang pulis. Nakuha sa nasabing pulis ang humigpit-kumulang na dalawang kilong shabu na nagkakahalaga ng P13.6 million matapos ang ating hot pursuit operation," sabi ni Domingo.

"Nakuha din natin 'yung mga ID niya, mga resibo ng kanyang transaction

at ibang personal notes na kung saan nakasulat ang kanyang mga kautransaksiyon," patuloy ni Domingo.

"Actually, maliban sa tunay niyang pangalan ay may iba pa siyang ID na iba ang pangalan," ani Domingo.

Narekober din ng mga awtoridad ang baril sa loob ng kanyang sasakyen.

Kaugnay nito, naaresto rin ng police operatives ang isang Juden Francisco at pito pa sa Pasig City.

Si Francisco ay isang "high-value" drug suspect at sinasabing ikaapat na most wanted sa Northern Mindanao, ayon kay Domingo.

"Kasama ni Juden Francisco ang kanyang pitong mga tauhan na initially nagsabi na wala si Juden then eventually nalaman natin na nandoon si Juden kaya damay sa obstruction of justice ang bodyguard niya... mayroon din silang iba't ibang mga kaso," paglalahad ni Domingo.

Samantala, sinabi ni PNP chief Police General Rodolfo Azurin Jr. na hindi nila kukunsintihin ang maling gawain ng mga pulis sa ilalim ng kanyang pamumuno.

"There will be no let-up. We don't care who gets caught and who gets hurt for as long as we will get the evidence in any crime. We will pursue them until the end. We expect yung pagkakahuli ng ating pulis, na kasamahan pa sa PDEG, ay napakalaking breakthrough para sa inyong kapulisan, na ito ay isang halimbawa na [This capture of a police officer, a member of the PDEG, is a huge breakthrough for the police and an example that] we don't tolerate and will not tolerate any wrongdoing of any policeman under my watch, and of course under the watch of our DILG Secretary," giit niya.

Sinabi ni Azurin na ang lending business ni Mayo ay isang "legal front" para sa drug trade.

"Sa totoo, we found out na dun pala yung tambakan ng mga droga na binebenta nila sa iba't ibang users at kliyente nila. I would believe and assume na hindi lang ito sa level ni Mayo," sabi ni Azurin Jr.

Si Mayo ay hawak ng mga awtoridad at inihanda ang reklamo na ikakasa sa kanya at iba pang mga suspek, batay kay Azurin. **(Leonard Basilio)**
