NMIS 4A inaasahan ang pagtaas ng demand sa karne nitong kapaskuhan

LUNGSOD NG CALAMBA, Laguna (PIA) – Inaasahan ng National Meat Inspection Service Region 4A (NMIS 4A) ang pagtaas ng demand sa karne at iba pang meat products dahil sa nalalapit na holiday season.

Sa kanyang panayam sa Sulong Calabarzon, siniguro ni NMIS 4-A Regional Technical Director, Dr. Orlando Ongotto na striktong ipinapatupad ng pamahalaan ang mga panuntunan nito upang masigurong ligtas ang mga karne na inaangkat sa rehiyon.

"Ang meat ay highly regulated. Hindi ka basta makakapag-import kung walang lisensya. Maging sa ibang bansa ay regulated rin ito upang maiwasan ang smuggling o pagpasok ng mga karne na hindi dumaan sa inspeksyon," ani Ongotto.

Mayroong 52 meat importer sa rehiyong Calabarzon ang kasalukuyang lisensyado bilang meat importer-processor, meat importer-traders, at mga institutional meat importer tulad ng mga hotel.

Puspusan rin ang NMIS sa pagsasagawa ng mga

inspeksyon sa mga meat processing facility dahil sa inaasahang pagtaas ng demand sa karne para sa holiday season.

Bukod dito, dumarami rin ang mga pasilidad na kumukuha ng 'Double A' at 'Triple A' certification upang makasabay sa pagtaas ng demand ng meat products. "As early as September at October, nag-iipon na ang meat producers ng raw materials para sa paggawa ng ham, bacon at iba pang produkto para sa holiday season. Dahil dito, lumalaki na rin ang volume ng pagkatay," ani Ongotto. Paliwanag ni Ongotto, tumataas ang demand sa mga meat processor sa pagpasok ng '-ber' months bilang paghahanda sa pangangailangan ng merkado hanggang Enero sa susunod na taon.

"Pagdating ng December, hindi na tayo nag-iinspeksyon ng mga meat establishment. Kaya kung ang expiry ng permit ay December o January, kailangan ay natapos na ang inspection sa November. Inaasahan natin ang pagbugso ng mga inspeksyon." "Triple A' certification ng

NILINAW ni NCRPO Regional Director PBGEN JONNEL C ESTOMO na legal ang pagkaka-aresto sa isa sa mga organizers ng Kilusang Mayo Uno kamakailan.

Ayon kay Estomo, si Benjamin Cordero y Reyes na kilala din sa pangalang "Banjo" ay dinakip ng mga pulis sa bisa ng warrant of arrest na inilabas ng korte dahil sa kaso nito na frustrated homicide na may kaukulang piyansa na P72,000.00.

Sinabi ni Estomo na ipinatupad lamang ng mga pulis ang kautusan galing sa korte at wala umanong intensyon ang kapulisan partikular na ang mga nakatalaga sa NCRPO na mang-harass o mag-maltrato ng sinuman dahil lang sa personal nitong opinyon, paniniwala o ideolohiya.

Binigyang diin ni Estomo na bilang mga alagad ng batas tungkulin ng mga pulis na ipatupad ito ng pantay-pantay para sa lahat walang mayaman o mahirap.

"We know that the public

PH eyes retail dollar bond sale in December

MANILA – The Philippine government plans to offer another US dollar-denominated retail treasury bond (RTB) in December 2022.

“Kasi very attractive yan for the OFWs (overseas Filipino workers), especially kung may mga papa-aralin kang bata five years from now (This issuance is very attractive for OFWs, especially if they will send kids to school five years from now),” Finance Secretary Benjamin Diokno told journalists at the sidelines of a forum hosted by The Asset in Taguig City on Monday.

RTB is a debt instrument intended for small investors and is part of the government’s regular borrowing options.

Minimum investment for the peso-denominated RTB is PHP5,000.

The first time the government offered a US dollar-denominated RTB

was in September 2021 as part of the diversification of its funding resources.

It raised a total of USD1.6 billion (PHP80.91 billion) from the sale of five- and 10-year paper, higher than the initial target of USD400 million.

Minimum placement for the retail dollar bond (RDB) is USD300, lower than the USD200,000 minimum investment for the government’s US dollar denominated bonds.

Diokno said they intend to hold a roadshow in Milan, Italy for the planned debt issuance.

The planned offering is part of the government’s move to raise funding for its various programs.

Diokno said they intend to have a 75-25 borrowing program in favor of domestic borrowings in most of the Marcos administration.

“That is to reduce the foreign exchange risk,” he added. (PNA)

Tax court affirms refund ruling for rice importer

MANILA – The Court of Tax Appeals (CTA) has affirmed its decision ordering the Bureau of Customs (BOC) to refund an agricultural firm for the proceeds of a public auction of rice that was seized by the government due to supposed irregularities in importation.

The CTA ruled there is “no cogent reason to disturb the findings and conclusions which this court made (in February 2022)” and denied for lack of merit the motion for partial reconsideration filed by the BOC.

In its previous decision, the tax court reversed and set aside the BOC findings and ordered it to refund the Sta. Rosa Farm Products Corporation the proceeds of the public auction amounting to PHP103,596,589, less the corresponding customs duties imposable in the subject rice shipments and other applicable expenses and obligations.

In 2018, the BOC’s Action Team Against Smugglers filed criminal complaints against the owners, officers, and customs broker of the company for alleged importation of 200 containers of rice from Thailand without permit.

They were charged with violating Section 1401 (Unlawful Importation or Exportation) of the Customs Modernization and Tariff Act and Republic Act (RA) No. 10845, or the Anti-Agricultural Smuggling Act.

Originally charged were Jomerito Soliman, company

president and general manager; Dolores Opancia, chief financial officer; directors Mary Grace Cayanan and Marileen Avañez; and customs broker Diosdado Santiago.

Of the 200 containers that arrived at Manila International Container Port, 150 were ordered forfeited in favor of the government while the remaining 50 were declared abandoned.

The BOC sold the rice in a public auction, generating total revenues of PHP177.991 million.

The Department of Justice subsequently dismissed the charges, with Undersecretary Deo Marco citing that a subsequent law, RA 11203 or the Rice Import and Export Liberalization Law, had taken away the need for import permits.

“(T)he decriminalization of importation without an import permit pursuant to RA 11203 can be applied retroactively in favor of herein respondents-appellees (Sta Rosa officials),” Marco said in his ruling, adding that “where the importer himself is no longer liable, then it follows that he who acted only as customs broker for the importer is likewise not liable.”

Aside from the importer, the ruling said a licensed broker like Santiago is not required to go beyond the document presented to him for filing an import entry on the basis of such documents. (PNA)

Sa utos ni NCRPO regional director, PBGEN JONNEL C ESTOMO, pinangunahan ni PCOL Wilson L Doromal, hepe ng Regional Headquarters Support Unit (RHSU) ang pagsasagawa ng “OPLAN SITA” sa loob ng Camp Bagong Diwa upang ipatupad ang Camp Rules and Regulation at maging ang umiiral na Batas Trapiko sa Kalakhang Maynila kung saan maraming pulis ang nasita at natiketan ng Traffic Violation Ticket dahil sa mga violations na ito: no decal; expired decal; no driver’s license; no helmet; unregistered vehicle at paglabag sa Article V ng Taguig City Ordinance (failure to carry/show OR/CR registration).

Ang kabilang sa nasabing operations ay sina PCPT Felix Paor, Regional Highway Patrol Unit - National Capital Region (RHPU-NCR); PMAJ Ember Ilumba ng Counter Intelligence and Security Section - Regional Intelligence Division (CSS-RID); PSSg Marvin Balasa ng Regional Mobile Force Battalion (RMFB); PEMS Rafael Balubar ng Taguig City Police Station at si Mr. Nilo Formento ng Traffic Management Office – Taguig City.

Like his father before him, John Dizon, Jr. and his family have been long-time stewards of protected trees in their community in Tuba, Benguet. When the time came for him to take up the mantle, he did so willingly to honor his father's legacy. "My father passed away in

2012. It was then that we found out that the area he is managing in collaboration with the government was part of a community-based forest management program," said Mr. Dizon. A year later, Mr. Dizon, who now heads Benguet-based environmental conservation group,

Grow Trees Community was previously launched in Nasugbu, Batangas and Macabebe, Pampanga. Across the three locations, the project aims to plant over 200,000 seedlings and propagules.

Nagawa, Manganese, Liw-Liw, Sadle Agroforestry Assoc. Inc. (NAMALISA), started working closely with the SM Foundation for an inaugural tree-planting campaign back in 2013 to pick up where his father had left off in his advocacy. With the impact of climate change more felt in recent years, Mr. Dizon shared the importance of planting more trees in communities to thin out air pollutants in keeping the air fresh and people healthier. The trees which his father planted also helped prevent soil erosion and landslides caused by earthquakes.

He nurtures a dream that some of his children will take after him to help protect the environment. Getting closer to that dream, one of his sons is eyeing a career in forestry, a nod to his father's chosen field.

To further this advocacy, Mr. Dizon supports the reforestation initiative of SM Foundation, Inc., the social good arm of SM and the Fast Retailing Foundation (FR Foundation), a general incorporated foundation in Japan through the Grow Trees Community campaign.

The project aims to plant and grow forest trees such as the Benguet pine, Alnus or Calliandra and Coffee trees to also help create livelihood opportunities for the community by working closely with People's Organizations such as NAMALISA in Tuba, Benguet.

The proponents teamed up with SM Supermalls and government partners such as the Department of Environment and Natural Resources, Department of Social Welfare and Development, Department of Agriculture, Technical Education and Skills Development Authority, Department of Trade and Industry, Department of Science and Technology, Philippine National Police, Philippine Information Agency and the local government of Tuba.

SC upholds Monetary Board not liable in bank graft suit

MANILA – The Supreme Court (SC) has upheld the decision of the Office of the Ombudsman clearing officials of the Monetary Board (MB) in graft charges filed by officials of the defunct Banco Filipino Savings and Mortgage Bank.

The ruling of the SC First Division affirmed the Court of Appeals (CA) decision, which denied the suit questioning the ruling of the Ombudsman.

The MB faced graft charges arising from its denial of Banco Filipino's application for PHP25 billion in emergency loans and its order for the bank's closure in 2011.

The SC noted that the Ombudsman's ruling had become final after the petitioners elevated the case to the CA, instead of the high court.

"Clearly, petitioners have lost their right to assail the Ombudsman's findings of absence of probable cause. The CA, therefore, did not commit any reversible error in denying their petition for availing of the wrong remedy," the SC stated in its decision published online October 20.

In MB's negotiations with bank officials for the loan, there was a pre-condition of a withdrawal of all pending cases against the regulatory body and its officials in connection with the Central Bank of the Philippines (now Bangko Sentral ng Pilipinas or BSP) order to cease operations in 1985.

The bank refused to agree to the conditions and in 2011, was placed under receivership of the Philippine Deposit Insurance Corp. and liquidation after determining it cannot continue its business without probable losses to its depositors and creditors.

In 2012, the Department of Justice (DOJ) found no manifest and evident bad faith nor violation of pertinent banking laws and said the respondents did not cause undue prejudice nor committed acts which constitute abuse of authority when it did not release the financial assistance sought by the bank.

The Ombudsman approved the DOJ recommendation in 2014 and said that the MB resolution was issued only after an investigation and assessment of the actual state and condition of Banco Filipino.

The SC affirmed the second amended decision issued by the CA in November 2019, giving BSP the go-signal to bid out, sell, and dispose of the assets of Banco Filipino.

The first closure in 1985 spawned multiple suits between the bank and MB, including a case decided by the SC in 1991 that ruled the bank's closure was illegal.

In 1993, the MB, under the newly formed BSP, allowed the bank to resume business until it ran into financial troubles anew. **(PNA)**

DA recommit to protect consumers, enhance food safety measures

QUEZON CITY -- The Department of Agriculture (DA) once again expressed its unwavering dedication to strengthening its food safety measures and protecting consumers from foodborne illnesses and food contamination during the opening ceremony of the Food Safety Awareness Week on October 24, 2022. This year's celebration centers on the theme, "Sapat at Ligtas na Pagkain Ating Adhikain, sa Hapag ng Bawat Pamilyang Pilipino ay Siguruhin." Recognizing "a need for continuous education on food safety to achieve the goal of eradicating food poisoning and other foodborne illness," the Food Safety Awareness Week is celebrated every last week of October as per Presidential Proclamation No. 160, series of 1999. "Celebrations such as this are clear manifestations of our commitment to our mandate; this reminds us that food safety plays a very important role in the food trade. International as well as local movement of food commodities require us to be vigilant on food quality and wholesomeness so as not to compromise food safety amidst the challenges of the limited access and availability of food supply caused by increasing prices and climate change," expressed Assistant Secretary James Layug. To take charge of consolidating and disseminating related information, the Food Safety Focal Group (FSFG) was created in 2018 by virtue of the DA Special Order No.

155 in accordance with the Implementing Rules and Regulations of the Food Safety Act of 2013. The group composed of 11 DA Food Safety Regulatory Agencies (FSRAs) is tasked to coordinate and monitor all DA programs and activities on food safety, provide consultative and feedback mechanism to facilitate delivery of appropriate action and/or response on related issues and concerns, participate in pertinent program and planning activities, harmonizing efforts on food safety within FSRAs, and recommending food-safety-related plans and policies for action by the Office of the Secretary. The current FSFG is composed of the Agricultural Training Institute (ATI), Bureau of Agriculture and Fisheries Standards (BAFS), Food Development Center (FDC), National Dairy Authority (NDA), Sugar Regulatory Administration (SRA), Fertilizer and Pesticide Authority (FPA), National Meat Inspection Service (NMIS), Bureau of Animal Industry (BAI), Bureau of Plant Industry (BPI), Bureau of Fisheries and Aquatic Resources (BFAR), and Philippine Coconut Authority (PCA). "Our Office for Regulations commits to harmonize and unify our efforts on overseeing compliance to regulations and enforcement of the same at the department level, in collaboration with other government agencies

as well as concerned non-government food business operators. Advocacy to the Food Safety Act of 2013 coupled with quad-media information awareness such as social media campaigns and webinars, and physical information drive through caravans conducted at the regional and local government levels are deemed vital. Hence, our Office shall continue to serve as primary movers of these efforts," Asec. Layug vowed. DA Senior Undersecretary Domingo Panganiban, through Assistant Secretary for Operations Arnel de Mesa, proudly announced that under the leadership of President Ferdinand "Bongbong" Marcos Jr. (PBBM), the Department has been undertaking various food safety initiatives such as: ●Restructuring the country's food safety policies and regulations; ●Developing world-class safety standards with help of institutions such as the Food and Agriculture Organization of the United Nations (FAO) and the World Health Organization (WHO); and ●Encouraging closer coordination between local government units, national government agencies, and the scientific community to boost food safety research, education, and surveillance efforts in the Philippines. He also bared that the PBBM-

led DA forges ahead "under a policy of concentrating public investments" that includes: ●Constant modifications to field protocols as the country improves its risk-based inspection of food products throughout the value chain; ●Improvement of national policies for food and nutrition security and the enforcement of more rational food safety regulations, including early detection of threats; and ●Various measures to ensure stronger political will at the local level by encouraging local executives to prioritize food safety and advocacy beyond "business as usual" approach. "I am confident that the new standards and policies that will result from our actions will address potential food safety problems throughout the production and distribution system. They will also improve the sanitation and safety practices of all those seeking to sell food products in the Philippine market," Asec. de Mesa said on behalf of Senior Usec. Panganiban. The Food Safety Awareness Week celebration, which showcases a week-long food bazaar and an exhibit of information materials, was also attended by Assistant Secretary-designate for Policy, Research, and Development Noel Padre and heads of the various DA FSRAs. Meanwhile, the city of Dasmariñas ranked Top 7 Component City, and the municipality of Carmona ranked Top 8 Component Municipality.

Rankings of Cities and Municipalities are based on the sum of their scores on 5 Pillars: Economic Dynamism, Government Efficiency, Infrastructure, Resiliency, and Innovation. Provincial rankings are based on population and an income-weighted average of the Overall scores of cities and municipalities under a province.

SC orders Sandiganbayan to junk fertilizer cases vs. Lorenzo, Yap

MANILA – The Supreme Court (SC) has ordered the Sandiganbayan to dismiss the five graft cases filed against former agriculture secretary Luis Ramon P. Lorenzo and former National Food Authority (NFA) administrator Arthur C. Yap over the alleged irregularities in the purchase of PHP46.45 million worth of fertilizers in 2003.

In its decision dated September 14 but only released on October 21, the SC sided with the petition of Lorenzo and Yap to dismiss the cases against them for the supposed "inordinate delay in the investigation of their cases on the part of the Office of the Ombudsman."

The SC said the Sandiganbayan abused its discretion when it denied the accused's motion to quash the charges "despite the prosecutors' failure to provide sufficient justification for the delay in the termination of the preliminary investigation."

"Consequently, the cases against petitioners before the Sandiganbayan should be dismissed for violation of petitioners' right to speedy disposition of cases," the SC said.

The cases against Lorenzo and Yap stemmed from the alleged irregularities in the procurement of fertilizer under the Ginintuang Masaganang Ani Rice Program from the Philippine Phosphate Fertilizer Corp. (Philphos) for several regions in Luzon.

The Ombudsman alleged that in 2003, then agriculture chief Lorenzo and Yap,

received the plaque for the special citation award in recognition of the LGU's initiatives to improve and streamline business processes, quality management, and innovative systems for the good of the business community in the town of Carmona.

The municipal government of Carmona was acknowledged as a Hall of Famer since the LGU had received the said award from 2009 to 2011. **(RBF/PIA-Cavite with reports from Dennis Abrina)**

the NFA administrator at the time, conspired with Philphos representative Tomas Guibani for the negotiated procurement of fertilizers, in violation of the Government Procurement Act.

The Ombudsman said Lorenzo and Yap "wielded their power as DA secretary and NFA administrator, respectively, to control the bidding procedures and technical requirements/eligibility of prospective bidders to tailor-fit the requirements of favored bidder, Philphos."

However, Lorenzo and Yap claimed there had been an inordinate delay in the termination of the preliminary investigation against them.

They said that from October 2003, when the investigation began, until April 20, 2018, when they were charged before the Sandiganbayan, it took the Ombudsman more than 14 years to build a case. **(PNA)**

PGC awards cash incentives to Nonagenarians
