In line with the celebration of Deaf Awareness Week with the theme, DEAFusion: Bridging the Gap, the Provincial Government of Cavite through the Persons with Disability Affairs Office, spearheaded the conduct of an Exploratory Meeting with the Cavite Officers Federation of the Deaf on November 16, 2022, at the Conference Room of the new Municipal Building in Kawit, Cavite.

On behalf of Mayor Angelo Emilio Aguinaldo, Municipal Administrator, Engr. Rey Victor Santos welcomed the attendees and expressed support to programs for persons with special needs.

To set the tone relevant to the event, a self-introduction using sign language was done.

With the assistance of sign language interpreters, Ms. Beatriz Go and Ms.

Josephine Barbin, the participants were able to communicate and convey information to one another. A screening of the short film "Trio" was included in the program as well.

The heartwarming movie tackled topics including motherhood, bullying, truth, and acceptance revolving the lives of a deaf teenage son, an alcohol-dependent mother, and her 7-year-old daughter.

The highlight of the meeting was a focus group discussion where the participants were divided into two teams. The deaf participants were encouraged to share their past and present struggles while representatives from partner agencies helped identify recommendations and suggestions in terms of access to education, employment, livelihood, health services, and information and communication technology.



SC affirms 15-year jail term vs. woman for human trafficking

MANILA – The Supreme Court (SC) upheld the 15-year sentence and PHP500,000 fine imposed on a woman found guilty of human trafficking involving a seven-month-old baby who was left under her care by an American couple. On July 30, 2020, the Court of Appeals earlier ruled against and affirmed the lower court decision that found Lenida Maestrado and Jenylin Alvarez guilty of attempted trafficking.

Maestrado, Alvarez and the couple were charged in 2016 for attempting to simulate the birth and keeping under their custody the infant.

Alavarez, whose case is still on appeal, was made to appear as the midwife. They conspired to register the child in 2014 as the offspring of American couple Gerald Vincent and Stephanie Jean Locker.

At the time, the two were living in Japan while Gerald served in the US Marines Corps.

The child was discovered in Maestrado's custody after the American couple temporarily left the child when they failed to pass immigration check, as officials noted that the baby looked like a Filipino.

Laguna's Paete town, 1st recipient of PBBM's Pambansang Pabahay

MANILA – Laguna's Paete town received the "first dose" of the Department of Human Settlements and Urban Development (DHSUD) housing project under President Ferdinand R. Marcos Jr.'s "Pambansang Pabahay para sa Pilipino: Zero Informal Settlers Families (ISF)".

Paete Mayor Ronald Cosico on Tuesday welcomed the new development, saying it would greatly boost his successful campaign to protect and provide safe and decent homes for his constituents who are in danger zones.

The National Housing Authority (NHA) and DHSUD felt the importance and urgency to grant the application of the neophyte mayor, who presented a resolution from the Paete town council seeking the housing project.

NHA acting General Manager Roderick Ibañez approved PHP25 million for 350 houses, which will comprise the first phase of the project.

The project is part of the 1,300 houses the DHSUD has recently approved in principle for Paete families, most of whom are living along the risky lowlands near Laguna Lake and in a danger zone along the town's mountain cliffs.

Cosico said his constituents whose houses would be

affected by the impending road widening will also benefit from the President's housing project.

"Kapansin-pansin po na lahat halos ng bahagi ng national road na naglalagos sa mga karatig bayan ng Paete ay pawang na-road widened na at tanging yung sa amin na lamang ang hindi pa (It is noticeable that almost every part of the national road passing through Paete's neighboring municipalities are already widened except our own town's)," said Cosico, who is serving his first term in office.

The DSHUD has embarked on Marcos' promise to build one million houses for ISFs every year of his six-year term.

Ibañez and other key individuals involved in the project will conduct an ocular inspection of the project site in Barangay Quinal on Friday.

Cosico expressed hope that the DHSUD implementing rules and regulations (IRR) would be released soon so that the entire project for his 1,300 family constituents would be completed without delay.

Since the DHSUD IRR has yet to be released, the Paete housing project is expected to push through, using the old Housing and Land Use Regulatory Board's IRR. (PNA)

MANILA — Speaker Martin Romualdez on Monday said the approval of the measure providing media workers with enhanced protection, security and benefits highlights the efforts of the House of Representatives to promote the welfare of media personnel and ensure that the press remains free. Romualdez made the statement after the lower chamber approved on third and final reading House Bill 454, or the proposed Media Workers' Welfare Act, with 252 affirmative votes, no negative vote, and zero abstention.

"We regard the Fourth Estate as an essential partner in nation building and in protecting our democracy," Romualdez said.

ACT-CIS Party-list Rep. Jeffrey Soriano, author of the measure, said the bill is geared toward the creation of a safe, protected, and conducive atmosphere for productive, free, and fruitful media work.

"This bill seeks to ensure that our media workers be granted humane conditions of work, living wage and comprehensive benefits package at par with the current benefits enjoyed by the labor force both in government and the private sector," Soriano said.

HB 454 shall apply to all media workers and media entities in the private sector. The bill provides that the minimum compensation for media workers shall not
