## CAVITE WAREHOUSE YIELDS P150-M WORTH OF FAKE GOODS

**MANILA -- An inspection of a warehouse in Cavite on Thursday yielded fake apparel, appliances, and general merchandise estimated to be worth PHP150 million, the Bureau of Customs (BOC) said.**

According to the BOC, a team from the Customs Intelligence and Investigation Service-Manila International Container Port (CIIS-MICP), armed with a Letter of Authority (LOA) signed by Commissioner Yogi Filemon Ruiz, proceeded to Hong Yun Real Estate Group Inc. on M. Salud Road, Alapan II-A, Imus, to inspect the contents of the warehouse.

The Customs agents found ready-to-wear garments from brands such as Dickies, Mossimo, Bench, Levi's, Puma, Fila, Mickey Mouse, Hello Kitty and others, as well as appliances and general merchandise. "The implementation of this operation comes with reinforcement from different departments. It was also made possible by the coordination with the police and local barangay officials. This is what it means to work with one goal in mind, which is to put a stop to this menace," Ruiz said in a statement.

"From top to bottom, we are united in our aim to see our markets free from these contrabands as well as smuggled fake products," he added.

The Philippine National Police (PNP) and local barangay officials who were notified of the implementation of the LOA assisted the team to the location of the warehouse. Customs Deputy Commissioner Juvymax Uy assured that the LOA was discussed with the warehouse's representative and to the security guard on duty who acknowledged it, before the team proceeded with the inspection.

"Following the proper process is critical in every operation by the BOC. Remember that behind these are big-time organizations used to circumventing the laws,

whether here or somewhere else. We have always been careful with making sure cases like these won't be dismissed because of the lack of due process," Uy said.

Customs examiners are set to conduct an inventory of the counterfeit items, to be witnessed by CIIS-MICP agents, as well as the representatives of the warehouse.

On other hand, CIIS Director Jeffrey Tacio acknowledged the diligence and dedication of Customs teams that had been behind every successful operation this past year.

"You know, everyone's mind is already on the upcoming holidays but our team here is still out there doing the job that they swore to do. That's how dedicated they are to protecting our markets, the sellers themselves, and the consumers," he said. (PNA)

## DOST, PARTNER HEIs CONDUCT PATENT WRITESHOP FOR MIS OCC RESEARCHERS

**CAGAYAN DE ORO CITY** – To further enhance the researchers' capabilities in writing patent applications a patent claims writeshop was conducted at La Salle University - Ozamiz recently. There were 40 researchers from various Higher Education Institutions (HEIs) in Misamis Occidental who actively participated in the event.

The patent granting procedure and patent claim drafting were among the highlights during the writeshop before the participants worked on drafting their own patent claims for their technologies which are to be submitted immediately to the Intellectual Property Office of the Philippines (IPOPHL). At the end of the 2-day writeshop, 12 utility model applications have been submitted.

Experts from the Bureau of Patents of the IPOPHL served as the resource speakers during the writeshop. Ms. Rosa M. Fernandez shared the technologies related to the chemical field while Engr. Chamlette D. Garcia, one of the speakers, also discussed matters from the Mechanical and Information

and Communications Technology (ICT) field.

The participating researchers were from the following institutions: La Salle University (LSU), University of Science and Technology of Science and Technology of Southern Philippines (USTP)-Oroquieta, USTP-Panaon, and Northwestern Mindanao State College of Science and Technology (NMSCST).

Numerous research outputs are being generated in the HEIs in the province and it is of vital importance to protect the Intellectual Property (IP) of the researchers. The Northern Mindanao Consortium for Industry, Energy, and Emerging Technology Research and Development (NorMinCIEERD) aims to help researchers in the region in managing their IPs through the Fostering Innovation for New Discoveries through IP (iFIND) Webinar Series episode 3: Patent Specifications and Claims Drafting Writeshop. This series covers the basics of IP management, conducting a prior art search using the necessary tools, drafting patent applications and claims, and even IP valuation. It is envisioned that this series will be conducted annually in order to help more of our researchers in the region in protecting their intellectual properties.

This initiative was initiated by NorMinCIEERD, the Department of Science and Technology (DOST) region 10, the Philippine Council for Industry, Energy, and Emerging Technology Research and Development (PCIEERD), Intellectual Property Office of the Philippines (IPOPHL), and La Salle University (LSU)-Ozamiz. ## Increased PhilHealth contributions in 2023 to benefit members

**MANILA** – The monthly contribution of Philippine Health Insurance Corporation (PhilHealth) members will increase by next year. In a televised public briefing Monday, PhilHealth Corporate Communications senior manager Rey Baleña said the monthly contribution would be adjusted to 4.5 percent from this year's 4 percent based on the Universal Health Care (UHC) law. He noted that the UHC law included the adjustment in its provisions to ensure Filipinos' access to medical services and the financial protection of the corporation as PhilHealth implements the national health insurance program. The employee pays for the monthly contributions on a 50-50 arrangement -- half of the contribution is shouldered by the employer. "Doon po sa kumikita ng PHP10,000 kada buwan, so times 4.5 percent starting January. Ang atin pong kontribusyon ay PHP450 kada buwan. ## PBBM asks supporters to rally behind gov't initiatives amid challenges

President Ferdinand R. Marcos Jr. on Saturday asked for the continued backing of his ardent supporters after a successful campaign, and with the country now facing multiple challenges. "Ngayon, ang pinaglalaban natin ay hindi kandidato, hindi partido, hindi para sa eleksyon pero 'yung ating mga kailangang gawin para sa mga problemang hinaharap ninyo, natin lahat, ng buong Pilipinas," President Marcos said in his message during a meeting with his supporters in Malacañang. The UHC law also includes the provision of comprehensive outpatient benefits which would depend on the adjusted monthly contributions. **(PNA)**



## Filipinos urged to visit visa-free, no-quarantine Taiwan

**MANILA – Filipino travelers are encouraged to explore Taiwan now that borders have been reopened to tourists.**

Taipei had further eased entry restrictions since October, allowing travelers to visit Taiwan by undergoing a "self-initiated prevention" instead of a quarantine.

Travelers aged two years old and above will be given four rapid test kits which they can use to monitor themselves upon arrival.

"The first day you are in Taiwan, you are free. You can go to any place you like," said Peiyung Hsu, Taipei Economic and Cultural Office in the Philippines representative, during a recent travel fair in Taguig City.

"Taiwan offers foreign tourists unique travel experiences, apart from enhanced facilities and service quality, including food tourism, leisure farms, bicycle tourism and many more," he said. "We

wholeheartedly welcome more Filipino friends to visit, eat, and do shopping in Taiwan. I believe you will find it one of the safest, most interesting and hospitable destinations in the world."

Prior to the pandemic, around 510,000 Filipino tourists visited Taiwan under its visa-free privilege, which was piloted in 2017. This year, Taipei reinstated the program that will run until July 31, 2023. Visa is not required if a visitor is staying for a maximum of 14 days and is non-extendible.

Keen to fast-track its tourism sector's recovery, the Taiwan Tourism Bureau had been boosting promotions for its travel products to attract international tourists, especially its railway and food tourism.

"With Taiwan's travel requirements relaxed, I hope to see more Filipino tourists enjoy the beauty of Taiwan," Hsu said. (PNA)

## CA junks pretender's petition to be recognized as lawyer

**MANILA –** The Court of Appeals (CA) has dismissed outright a suit filed by a man seeking to be recognized as a lawyer and member of the Integrated Bar of the Philippines (IBP).

The appellate court junked the petition filed by Lamberto Payongayong, who is also facing a usurpation of authority case before a Manila court.

He sought "acknowledgment" as a lawyer in numerous instances that he acted as one, including falsely representing himself as a legal counsel in letters sent to the Bangko Sentral ng Pilipinas (BSP) in 2020.

"The petition is not only defective in form, but in substance as well. In sum, the petition has no leg to stand on," the tribunal said in its Dec. 6 ruling that was recently posted online.

In 2020, operatives of the National Bureau of Investigation (NBI)

arrested Payongayong in an entrapment operation in Quezon City.

It was reported to the NBI that he sent several letters to BSP, addressed to then-Governor Benjamin Diokno and lawyer Henry De Vera of the Currency Integrity Staff and Currency Issue and Integrity Office.

Payongayong claimed that he was a trustee of a private individual who has trust account covering \$300 dodecallion that allegedly matured in 2007 and which he sought to withdraw with the help of the BSP.

He also claimed that he's an assignee of a parcel of land covered by original certificate of title allegedly "being used by the BSP to back up the printing of legal tender notes"

The Office of the Bar Confidant and IBP confirmed he is not a member of the Philippine Bar. (PNA)

## Chemical, food maker sees another record profit in 2023

**MANILA –** Food ingredients and plastics manufacturer D&L Industries is optimistic about surpassing this year's record earnings in 2023 as the economy further reopens.

In a media interview Monday after the marking of the firm's 10th listing anniversary, D&L president and chief executive officer Alvin Lao said the opening of its Batangas plant by the middle of next year is expected to boost local and export sales.

"Our new plant is based in a PEZA (Philippine Economic Zone Authority) zone. So as a Filipino company, in a PEZA zone, we are mandated or required to export minimum 50 percent of our revenue. Right now, we only export 33 percent of revenue. But this new plant, when it comes online, the minimum exports (should be) 50 percent so that is going to be one of our growth drivers to increase exports," he said.

Lao said they are looking to penetrate new export markets in Asia, North America and Europe.

"2023 will be an even better year than 2022... Hopefully, the tourism (also) opens up again, recovers and then next year, the global

economy will get back to growth," he added.

Lao said the company is expected to surpass this year its record performance before the pandemic in 2018 despite it was adversely affected by the surge of coronavirus disease 2019 (Covid-19) cases due to the Omicron variant in the first quarter.

As people gain more confidence in going out of their homes with the recent lifting of the mask mandate, he said the resulting increase in consumer spending should be good for their various businesses.

The company registered a 17-percent year-on-year growth in net income as of end-September 2022 to PHP2.5 billion.

During D&L 10th listing anniversary bell-ringing ceremony at the bourse, Philippine Stock Exchange president Ramon Monzon said, "I am confident that this net income growth trajectory will not only be maintained but will be surpassed in the coming years as the company's new PHP10.2 billion facility in Batangas becomes operational next year, 2023." ## PH, UAE ink space cooperation

**MANILA – The Philippines and the United Arab Emirates (UAE) have signed early this month an agreement for space cooperation, the Philippine Space Agency (PhilSA) announced Tuesday.**

PhilSA said the country will collaborate with the UAE Space Agency (UAESA) on space research and development; space data mobilization for disaster management, emergencies, food security, and agriculture, among others.

A memorandum of understanding between the two agencies was signed last Dec. 5 on the sidelines of the Abu Dhabi Space Debate.

"It is a pioneering agreement involving our countries and ushers Philippines and UAE relations into a new and exciting frontier," said PhilSA Director General Joel Marciano in a statement.

He added that the UAE, being at the forefront of

groundbreaking space missions, inspired PhilSA in its efforts to bring space capabilities to the fore in addressing present and future sustainability challenges.

Capacity-building, people-to-people exchange, and space industry-building are some of the things in the pipeline under the MOU.

Other activities in line with the cooperation are scientific missions on space exploration and access to relevant data; joint conferences, workshop, and knowledge-sharing activities on space science and technology applications; advancement of space education through student exchange programs and graduate studies; utilization of ground stations and infrastructures; and, promotion of space industry and industrial cooperation.

Stronger ties between the two agencies and maximized opportunities are expected from this partnership. (PNA)

## BSP 28-day bill rate up anew amid hawkish sentiment

**MANILA – Expectations for the sustained rise of interest rates resulted in another increase in the Bangko Sentral ng Pilipinas' (BSP) 28-day bill yield on Friday.**

Data released by the central bank showed that the average rate of the debt securities rose to 6.2647 percent from 6.1740 percent during the auction on December 2.

The BSP kept the offer volume at PHP120 billion as demand remained strong after tenders reached PHP161.8 billion. The auction committee made a full award.

BSP Deputy Governor Francisco Dakila Jr., in a statement, said yields accepted in this week's securities auction "shifted higher but narrowed to a range of 6.1000 to 6.3750 percent."

"The results of the BSP bill auction reflected market

participants' expectations of continued hawkish sentiment from the BSP following the release of the November CPI (consumer price index) figures," he said.

The Philippine Statistics Authority (PSA) reported on December 6 a further acceleration in the domestic inflation rate in November 2022, the fastest since November 2008. Inflation in the previous month was at 7.7 percent.

This made economists project another hike in the central bank's key policy rates even after the latest 75 basis points hike last month, which brought the total increase since last May to 300 basis points.

"Looking ahead, the BSP's monetary operations will remain guided by its assessment of the latest liquidity conditions and market developments," Dakila said. (PNA)
