Four candidates vie for Cavite 7th Congressional District seat

TRECE MARTIRES, CAVITE (PIA) – Four Caviteño candidates filed their Certificate of Candidacy (CoC) with the Commission on Elections (COMELEC) last Monday and Tuesday, December 5 & 6, 2022 for the 7th Congressional District of Cavite per COMELEC Resolution 10848. This is to fill up the vacated seat of Justice Secretary Jesus Crispin Remulla in a "special election" slated on February 25, 2023.

COMELEC Spokesman Rex Laudiangco revealed that the candidates running for the said position are: Jose Angelito Domingo Aguinaldo (Independent); Melencio Loyola De Sagun, Jr. (Independent); Michael Angelo Bautista Santos (Independent); and Crispin Diego Diaz Remulla (National Unity Party).

"This is on account of the appointment and assumption to office of former Representative Jesus Crispin C. Remulla

as Secretary of Justice, subsequent to his election thereto in the recently concluded May 9, 2022, National and Local Elections," stated Laudiangco.

The COMELEC official said that all registered voters from the municipalities of Amadeo, Indang, and Tanza, and the City of Trece Martires will be participating in this electoral exercise. The voting, counting, and canvassing of the votes will be done with the use of the automated elections system, the Vote-Counting Machine (VCM), and the Consolidation and Canvassing System (CCS).

Meanwhile, the voters' registration in the 7th District of Cavite is suspended from November 25, 2022 until February 24, 2023 while the official campaign period will start on January 26, 2023 until February 23, 2023. **(RBF/PIA-Cavite with reports from COMELEC)**

PEZA investment pledges back to pre-pandemic level

MANILA – The Philippine Economic Zone Authority (PEZA) reported Tuesday that investment pledges for 2022 are back to pre-pandemic level.

In a statement, PEZA said it approved a total of PHP140.7 billion investment pledges this year, more than double from the PHP69.3 billion approvals in 2021.

This year's investment approval is also the highest in five years. In 2018, PEZA-registered projects reached PHP140.2 billion.

PEZA officer-in-charge Tereso Panga said these investment approvals came from 198 projects.

"Despite the 29.85 percent decline in the first semester of the year 2022 compared to the first semester of 2021, we never lost hope that we will recover. With the big-ticket investments that were prequalified by the Board for endorsement to the FIRB (Fiscal Incentive Review Board), we were able to record a positive increase in investments in

2022," Panga said. PEZA's target for this year is to grow by 6 to 7 percent at end-2022.

Earlier, PEZA reported that investment pledges from January to November this year was only at PHP57.05 billion.

During the PEZA board meeting last Dec. 15 led by Trade Secretary and PEZA Chairperson Alfredo Pascual, the investment promotion agency (IPA) approved 13 projects amounting to PHP83.65 billion.

Bulk of these newly approved investment pledges were from three economic zone development projects worth PHP83.02 billion, four manufacturing projects worth PHP502.98 million and six information technology (IT) service projects worth PHP125.17 million.

These projects are expected to rise in Taguig City and the provinces of Pangasinan, Cavite, Batangas, Laguna, Cebu and Negros Occidental.

DA-ATI 4A holds Year-End Review & Consultation in Silang

TRECE MARTIRES, CAVITE (PIA) – The Department of Agriculture – Agricultural Training Institute (DA-ATI) CALABARZON held its Year-End Review on Regional Rice Competitiveness Enhancement Fund-Rice Extension Services Program (RCEF-RESP) Activities cum "RCEF Farm School Owners Cluster Meeting and Consultation" at the Teofely Nature Farm, Silang on December 14 to 16, 2022.

The three-day program aimed to have a discussion between RCEF-RESP Implementing Agencies (IAs) and RCEF Farm School (FS) owners, and to share the status and achievements of RCEF-RESP implementers in the CALABARZON region.

OIC Training Center Superintendent II / Center Director Dr. Roland V. Maningas led the opening of the event as he acknowledged all the program participants.

Around twenty-five (25) farm

school representatives, and Provincial Agriculture Officers from the provinces of Cavite, Laguna, and Quezon attended and participated in said activity. Agencies such as the Technical Education and Skills Development Authority (TESDA), Philippine Rice Research Institute (PhilRice) Los Baños, DA Regional Field Office IV-A, Philippine Center for Postharvest Development and Mechanization (PhilMech), and ATI presented updates and accomplishments for the current year.

Chair Senate Committee on Agriculture and Food Senator Cynthia A. Villar showed support for the activity while PhilRice Los Baños Director Remelyn Sevilla-Relado and TESDA Provincial Director of Quezon province, Dr. Gerardo Marasigan sent their message of encouragement and inspiration thru Scholarship Focal- TESDA Provincial Office Ms. Myla Canzana.

Meanwhile, Owner/Operator, and Farm School Director of Sweet Nature Farm Ms. Suzette Sales expressed her appreciation for DA-ATI's support.

Marcos Jr.) administration and we hope to sustain very good performance as we prepare for the upturn in the economy and our transition to upper-middle income status," Panga added. Meanwhile, exports in PEZA zones reached USD54.24 billion while employment within ecozones rose to 1,850,842 as of October 2022.

"PEZA remains committed to performing its sworn mandate and attracting the much-needed strategic and big-ticket investments to the country and contribute to PBBM's goal for the country's transition to the upper middle-income economy within his term," Panga said. **(PNA)**

PBBM vows to continue building housing communities under 'Pambansang Pabahay Para sa Pilipino' program

MANILA -- President Ferdinand R. Marcos Jr. vowed Wednesday to continue breaking ground for the administration's ambitious housing project to provide ordinary Filipinos with decent housing complete with basic amenities and facilities. "I'm glad that we are continuing. This is not the first groundbreaking that I have attended. I hope... I know it will not be the last, and that we will continue to break ground in different parts around the country para naman 'yung ating pinapangarap na one million homes a year," President Marcos said during the groundbreaking of the Palayan City Township Housing Project in Nueva Ecija. "One million homes a year, pagka naabot natin 'yun, at least napakalaking bagay na 'yan na nabigyan natin ng solusyon ang problema ng bahay ng ating mga kababayan," the chief executive pointed out.

According to the President, the administration's concept is to provide families with shelter not only for poor residents but also for employed people who struggle to have decent housing. Housing agencies and developers must consider providing their housing projects with facilities and necessities like water, power, schools, markets as well as transport hubs, Marcos said. "Yun ang mga dapat -- hindi dapat makalimutan at kaya't ito ating ginagawa, ganoon ang ating sinusundan. And I hope that we will continue at this rate at kailangan na kailangan talaga natin gawin 'to but this is one of the many actually that we are going to break ground," Marcos said. The President expressed his gratitude to the Department of Human Settlements and Urban Development (DHSUD) and to the Palayan City local government for their

efforts in spearheading the housing project, stressing that collaboration is necessary for ventures like shelter projects. President Marcos also thanked all other local government units (LGUs) and emphasized their crucial role in ensuring the success of the government's major housing program. LGUs usually identify suitable lands, select qualified beneficiaries and ensure the livability of the houses and communities that will be built. The 11-hectare Palayan City Township Housing Project is part of President Marcos' Pambansang Pabahay Para sa Pilipino Program aimed at addressing the country's housing needs by building 1 million houses each year

in the next six years. Under the three-phase project, 5,100 housing units will be built, with support infrastructure such as an elementary school, livelihood center, administrative offices, a central park, basketball court, a mini market and hawker area, aquaponics area, sewage treatment plant and materials recovery facility. Construction will commence in April next year with the project's phase 1, with 2,500 housing units seen to be finished in 2024. Joining the President in Nueva Ecija were DHSUD Secretary Jose Acuzar, Sen. JV Ejercito, House Speaker Martin Romualdez and Palayan City Mayor Viandrei Nicole Cuevas. **(OPS-PND)**

PBBM signs P5.2 trillion 2023 national budget

President Ferdinand R. Marcos Jr. on Friday signed the P5.2 trillion 2023 General Appropriations Act (GAA), which will fund the administration's recovery plan next year as the country emerges from the effects of the coronavirus pandemic. Among the priority sectors under the administration's first national budget are education, public works, health, social welfare, agriculture as well as transportation. In his speech during the ceremonial signing of the GAA in Malacanang, President Marcos said its passage is essential because it will serve as a roadmap of what the government intends to do next year. "And to see the rapidity of the passage is significant because it means that this budget, the roadmap that we have proposed from the Executive, is fully supported by our legislature. And that is very, very important indeed," Marcos said. "Because it is what is essentially or sometimes regarded as a long, difficult, long-drawn-out process... shown to still be able to express that kind of support, that kind of solidarity with the Executive," the President said. The government, Marcos said, has listed its plans for next year and it is now

slowly moving toward realizing its goals such as carrying out all the needed structural changes. The signing into law of the General Appropriations Act is important because it will provide the government with a tool to transform the economy, the chief executive noted. "It is always very important that the GAA has been put together in consonance with all of the plans of the Executive. And that kind of coordination and that kind of synergy that we will gain from that is going to be an essential part of the way that we move forward," Marcos said. The President expressed his gratitude to the members of the legislature and all those who worked hard for the passage of the 2023 national budget. According to President Marcos, the legislature has been very cooperative in making amendments that were necessary in terms of investment as well as financial policy. "All of these elements that are important for us to position ourselves in the new --- I nearly said new society --- in the new economy after the pandemic," Marcos said. The President also thanked the Department of Budget and Management (DBM) for its efforts in passing the government spending program for next year.



**PSA Rizal holds 2022
PPA Dissemination forum**

ANTIPOLO CITY, Rizal (PIA)— The Philippine Statistics Authority — Rizal conducts the 2022 Provincial Product Accounts Dissemination Forum at the First Pacific Leadership Academy this December 16 to showcase the regional and provincial economic performance. PSA Regional Director Charito Armonia states that the forum will showcase estimates on the Rizal's economic performance. Stakeholders from the local government units and national government agencies participate in the forum to align data with respective plans, programs and projects.

Director Armonia also reports that CALABARZON's Gross Regional Domestic Product (GRDP) as of April 2021 indicates positive growth of 7.6% in 2021, the fastest rate among 17 regions in the country. CALABARZON is also the only region which is industry-driven and has the second share in terms of Domestic Product nationwide. Industry remains as the region's largest contribution with 51.1% in 2021 followed by 44.1% Services and Agriculture at 4.8%. Rizal Chief Statistical Specialist Yra Sibug presents the province's first provincial report from

2018-2021 with focuses particularly on 2021. She reports that Rizal has Gross Provincial Domestic Product (GPDP) of P 319.B in 2021 with a 11.7% share to CALABARZON's Regional Economy. The province's top three industries in terms of percent share are manufacturing at 23.1%, wholesale and retail trade at 22.7% and, real estate ownership and dwellings at 11.8%, respectively.

Meanwhile, major industry shares in the province are sourced from Services at 66.7%, 30.6% from Industry and, Agriculture, Forestry & Fishing at 2.5%.

Rizal Planning and Development Officer Architect Herbert Jose then highlights the province's programs and policies noting that it is has been the country's Most Competitive Province for several consecutive years. "We believe that planning without data is like a boat without a rudder, we do not have any direction," says Architect Jose.

The planning officer adds that the statistical data in the forum is crucial in order to determine the province's policies and direction setting. PSA-Rizal and present stakeholders concluded the activity with an open forum to further discuss inquiries. **(GG/PIA-Rizal)**

**"Get vaccinated, boosted ahead
of the holidays" - DOH IV-A official**

PAGSANJAN, Laguna (PIA) — The Department of Health (DOH) Center for Health Development CALABARZON continues to vaccinate more individuals against COVID-19 ahead of the Christmas holidays, with the Bakuhang Bayan National Vaccination Days on December 5-7, 2022.

As part of the program, DOH-CHD CALABARZON, World Health Organization, UNICEF Relief International, Philippine Pediatric Society Southern Tagalog Chapter, Philippine Foundation for Vaccination, and the local government of Pagsanjan, Laguna, join the national campaign dubbed as "Bakunahang Bayan: Biyayang Proteksyon sa Paskong Pilipino, Batang Bakunado, ProtektoDOH", in an event held at the Areza Mall and Shopping Complex, Pagsanjan, Laguna on December 6, Tuesday.

The said campaign aims to integrate routine immunization for infants aged 0-23 months old and the ongoing COVID-19 PinasLakas campaign which aims to increase the coverage for the country's Fully Immunized Children (FIC) that has been critically low.

DOH Undersecretary Dr. Enrique Tayag, DOH-CHD IV-A OIC Director IV Dr. Leda Hernandez, and Pagsanjan Mayor Cesar Areza graced the event, among others. Usec. Tayag said that the first Christmas gift that a child could receive is the gift of safety and healthy body that a COVID-19 vaccine provides. He also urged the parents of infants to have their children inoculated with (PENTA, OPV, AND PCV) routine vaccines to prevent them from catching measles, rubella, and other diseases. He then led the ceremonial COVID-19 vaccination and routine immunization for children.

In an interview with the Philippine Information Agency - Laguna, DOH IV-A Assistant Regional Director Dr. Leda Hernandez said that Bakunahang Bayan serves as an 'integrated activity' which aims to bolster the COVID-19 vaccination coverage of the pediatric and general population and to also catch-up with routine vaccination against tuberculosis, polio, measles, and more.

She said that during the pandemic, the routine immunization rate slowed down, making all five provinces of the region in

red area classification. "Sa routine immunization, naapektuhan din po ito ng COVID pandemic medyo bumaba po tayo so nasa red areas po ang lahat ng probinsya ng CALABARZON so we hope na tumaas-taas kasi ang target ng national is 95% medyo mababa po kami. Noong nag-start po kami ng catch-up is 34% but now we are in the 40% na so this will go on hanggang last week ng December."

Dr. Hernandez said that the challenge lies on how they can reach the more than 500,000 unvaccinated individuals in the region, but she said that with the help of health workers and social mobilizers, they could lessen the number.

"Ang dami pa pong unvaccinated. Ibig sabihin yung primary series, hindi pa nila naumpisahan for the whole CALABARZON is more than 500k pa. But we're already 91% fully vaccinated for the whole CALABAR. So we hope na mataasan pa 'to," Hernandez said.

She added, "Hindi naman po tumitigil ang mga health workers doon. At meron po kaming social mobilizers for each of the provinces para i-explain doon sa mga hindi pa nagpapabakuna ang benefits ng COVID-19 vaccines"

Dr. Hernandez then cautioned the public that compliance with the minimum health standards and getting vaccinated or boosted against COVID-19 is imperative to avoid a post-Christmas surge of COVID-19 cases.

"Kaya po hindi kami tumitigil na kahit po [nagsabi] tayo na pwede nang walang masks sa mga restaurants, [nire-recommend] pa rin namin kung hangga't maaari ay wear your masks. 'Yung paghugas natin ng kamay, alcohol nandyan pa rin, and yung vaccination. Ito na yung armas natin para hindi magka-surge this coming Christmas and prayers."

As of December 2, 2022, Region IV-A has a total of 10,753,096 adults fully vaccinated against COVID-19 or a 91% coverage. First booster vaccine coverage for adults still lags at about 3,259,872 or 28%.

For pediatric vaccination, children aged 5 to 11 has reached a total of 676,556 fully vaccinated individuals or 44%. DOH-CHD IV-A targets around 758,226 unvaccinated children to be inoculated. **(CH/PIA-Laguna)**

PTFoMS caps year with consultative meetings with PROs

MANILA – To mark the yearend, the Presidential Task Force on Media Security (PTFoMS) Secretariat met with several officials of the Philippine National Police (PNP) in key regions of the country to promote the safety and security of local journalists, broadcasters and other media practitioners. Pursuant to its mandate to protect the life, liberty and security of media workers, officials of PTFoMS Secretariat visited the Police Regional Offices (PROs) of Region 7 (Central Visayas) at Camp Sergio Osmeña in Cebu City; Region 8 (Eastern Visayas) at Camp Sec. Kang Leon in Tacloban City, Leyte; and Region 4-B (Mimaropa) at Camp Efigenio Navarro in Calapan City, Oriental Mindoro during the first and second week this month.

Case conferences were also held with the chiefs of police and investigators on case of local police to discuss the updates on cases of violence committed against media workers in their respective areas of jurisdiction. Problems that might have been encountered during investigations were also resolved.

PTFoMs said the safety and welfare of all members of the press is a top concern of the Marcos administration. President Ferdinand R. Marcos Jr. has acknowledged the media's importance in nation building, saying on several occasions that his administration would respect and protect the rights of media workers.

Marcos' unwavering commitment to safeguard press freedom is best demonstrated by the manpower and resources poured into bringing to justice those responsible for the killing of broadcaster Percy Lapid. This also serves as a warning that the full force of Presidential power will be brought to bear upon those who seek to harm any member of the press.

Lawyer Perry Solis, officer-in-charge of the PTFoMS Secretariat, headed the delegation, together with PTFoMS officers – Rodante Santos II, Aristoteles Estrella, John Aquino and Jeffrey Sy Egco. The official visits are part of its yearlong proactive measures to promote the safety of journalists all over the country. During the visits, Solis emphasized the significance

of investigating these cases. "Any form of violence committed against media workers is a human rights issue that transgresses upon the freedoms of expression, of speech and of the press and the right of the people to truthful information. These, in turn, severely impact the very foundations of democracy," he said.

The PTFoMS Secretariat also instructed police officials who attended the conference to remind journalists in their respective areas to abide by the Journalist's Code of Ethics as a means to ensure their safety.

It also turned over several copies of the "Handbook on Personal Security Measures for Media Practitioners" for distribution to media workers and thanked the PNP for its continued support to the mandate of the PTFoMS to bring to justice all perpetrators of media killings.

The PTFoMS was established under Administrative Order No. 1 in 2016 as a task force directly under the Office of the President to combat the perceived impunity in killings of journalists that transpired during past administrations. With the creation of the PTFoMS, media workers nationwide now have a direct line to the highest executive office of the land to air their concerns.

The PTFoMS is an inter-agency task force composed of various law enforcement agencies with the participation of several private media organizations as observers.

Its main responsibility is to oversee the investigation of cases of violence committed against media workers. As such, it is co-chaired by Justice Secretary Jesus Crispin Remulla and Office of the Press Secretary Officer-In-Charge, lawyer Cheloy Garafil.

The PTFoMS reminds all journalists and media practitioners to report any threat or harassment so that the matter can be thoroughly and swiftly acted upon by authorities.

In collaboration with the PNP, the PTFoMS has the ability to provide "real time" protection to any journalist who has been unduly harassed or threatened, especially with the designation of all PNP's Public Information Officers as Media Security Vanguard. (PNA)
