## CALABARZON WORKERS GET SECOND TRANCHE OF WAGE HIKE

**CALAMBA CITY, Laguna (PIA)** — Minimum wage earners in Calabarzon will get an increase of P23 to P48 in their daily take-home pay following the implementation of the second tranche of a wage order.

The Regional Tripartite Wages and Productivity Board (RTWPB) IV-A announced on Tuesday, January 3 that Wage Order IVA-19 previously signed in May 2022 took effect last December 30.

Minimum wage earners in the region have already received an additional P3 to P49 daily increase during the first tranche of the wage order last year.

The new minimum wage rate in the non-agricultural sector is set to P470 in the extended metropolitan area which includes the cities of Bacoor, Imus, and Dasmarias in Cavite; Binan and San Pedro in Laguna; Antipolo City, Cainta, and Taytay in Rizal.

Component cities and first class municipalities will receive a P28 wage increase or P429 daily rate.

Wage rate in the second and

third class municipalities workers was set to P390 while the rate in the fourth to 6th class municipalities was set to P350.

Meanwhile, agricultural workers in the extended metropolitan area and component cities will now receive P429 daily; workers in first class municipalities will get P390 daily; those in second to sixth class municipalities will receive P350 daily.

Those in the retail and service establishments with not more than 10 workers will receive an across-the-board increase of P23 giving them a P350 daily wage rate.

The minimum wage rate is given to employees who work for not exceeding eight hours a day.

According to the RTWPB IV-A, the wage hike is the government's response to the lower purchasing power of the peso, two-tiered wage system, poverty threshold, impact of the COVID-19 pandemic, comparability of wages vis-a-vis benchmark regions, and the dispersal of industries across the region. **(CH/PIA-Laguna; with reports from RTWPB IV-A)**

## BPI told to update BSP on erroneous transactions

**MANILA** — The Ayala-led Bank of the Philippine Island (BPI) has been tasked to report to the Bangko Sentral ng Pilipinas (BSP) updates on the reversal of erroneous transactions experienced by several BPI account holders over the weekend.

In a statement on Wednesday, the central bank said it was coordinating with BPI regarding the double debit transactions that have affected an undisclosed number of BPI account holders.

"The Bank already identified the root cause of the operational error and committed to reverse the erroneous transaction and restore mobile and internet banking services the soonest possible," it said. Asked if BPI has submitted

any updates regarding the number of affected account holders and the volume and value involved in the erroneous transactions, BSP Deputy Governor Chuchi Fonacier told the Philippine News Agency that they have yet to get one.

"Not yet. Awaiting bank's update," she said.

BPI, on Wednesday, said transactions were posted twice from Dec. 30 to 31, 2022 for those done through automated teller machines (ATMs), deposits through the cash accepting machine (CAM), point of sales (POS) and e-commerce debit transactions.

"Please be informed that we expected correction of the duplicate transactions within the day," it said in a statement. **(PNA)**

## PEZA welcomes inclusion of ecozone development in PDP 2023-2028

**MANILA** — The Philippine Economic Zone Development Authority (PEZA) has welcomed the inclusion of economic zone development in the Philippine Development Plan (PDP) 2023-2028 as a catalyst for job creation and poverty alleviation.

"We in PEZA have lobbied through NEDA (National Economic and Development Authority) to include economic zones in the PDP as for a time in the previous administration that it was forgotten or excluded. Strengthening our ecozone development initiatives is a must as this will serve as a catalyst for growth in the country," said PEZA Officer-in-Charge Director General Tereso Panga in a statement Wednesday.

Panga said the inclusion of ecozone development in the PDP solidifies the strategic role of ecozones, especially in countryside development, as mentioned by President Ferdinand R. Marcos Jr. in his first State of the Nation Address in July last year.

PEZA approved the biggest ecozone development in 2022 during the first six months of the Marcos administration, which is a mixed-used project for manufacturing and tourism worth PHP81.65 billion.

Eleven out of 29 ecozone projects last year were also approved between July and December.

Total cost of ecozone development for the full year of 2022 amounted to PHP96.21 billion, with PHP90.65 billion of the projects approved in the first six months of the administration.

"As we welcome the new year, we in PEZA are preparing more initiatives and synergy with other government agencies to strengthen the country's economic zones in line with the PDP of PBBM administration in the next five years," he added.

Panga also urged investors to locate their businesses within ecozones to soften the impacts of economic uncertainties.

"Ecozones can be shields to soften the landing of the headwinds, the

external constraints, and all these global disruptions happening especially during this time. The other side to this is that ecozones can be economic drivers to accelerate economic recovery and growth," he said.

NEDA launched the administration's medium-term plan in December 2022, which is anchored on the government's long-term vision *AmbisyonNatin 2040*.

NEDA Secretary Arsenio Balisacan then said the latest PDP's goal is to reinvigorate job generation and accelerate poverty reduction by focusing on the "transformation agenda" that will steer the economy back to its high growth path towards a prosperous, inclusive, and resilient society. **(PNA)**

## 30 PH brands to join Germany trade fair

**MANILA** — Thirty local brands will be joining the Ambiente 2023 trade show in Frankfurt, Germany from February 3 to 7, Department of Trade and Industry's (DTI) export promotions arm Center for International Trade Expositions and Missions (CITEM) said.

In a statement Tuesday, CITEM said the Design Philippines brand will feature home, fashion, and lifestyle (HFL) products of the country's micro, small, and medium enterprises (MSMEs) and artisan communities in the Germany trade fair.

"We are excited for the competitive roster of exhibitors featured in the 2023 edition of Ambiente. A mix of returning and neophyte exporters are set to make a mark on the international stage where our local designs can be appreciated by attendees from different parts of the globe," CITEM executive director Edward Ferreira said.

CITEM said 10 out of the 30 Filipino brands that will join the exhibit are from Tarlac, the country's Partner Artisan Community.

It added that the Philippine pavilion in the trade fair will continue the narrative of "hands at work", which has

## 5 suspected communist rebels face raps over death of minor

**MANILA** — The Department of Justice on Wednesday approved the filing of criminal charges against five suspected Communist rebels who were responsible for the death of a minor killed in a crossfire in Batangas province last year.

Charges of murder and violation of Republic Act No. 11479, or the Anti-Terrorism Act of 2020, will be filed against Isagani Isita, Junaliece Arante-Isita, Mariano Bico, Gilbert Orr, and one alias "Ching," at the Batangas Regional Trial Court.

Government prosecutors, in a resolution issued on Dec. 27, have recommended the filing of the charges in connection with the July 18, 2022 encounter

between members of the New People's Army and elements of the 59th Infantry Battalion at Sitio Amatong, Barangay Ginhawa in Taysan town, Batangas.

The respondents, allegedly armed with shotguns, rifles, and improvised firearms, fired at government troops. A soldier was wounded and a nine-year-old girl who was caught in the crossfire died.

"While it may appear that the murder victim was not the direct target of herein respondents and was just caught in the line of fire when the respondents fired upon members of the Philippine Army, her death clearly was the result of the unlawful acts perpetrated by the respondents," the DoJ said. **(PNA)**

## 156 POGO workers deported so far, says DOJ

**MANILA**—Justice Secretary Jesus Crispin Remulla on Wednesday reported that the deportation of unlicensed POGO foreign workers from Angeles and Pasig City is nearly halfway complete.

Remulla said records from the Bureau of Immigration showed that 156 out of the 368 foreign nationals connected with operations of illegal POGOs in Pasig and Angeles City had been deported.

"This translates to a deportation implementation rate of approximately 42%," Remulla said but provided no additional details as to the nationalities of those who were reported.

The officials also said the bureau is in the process of securing all necessary documents and clearances for the deportation of the remaining 212 foreign nationals after failing to provide travel documents and confirmed airline tickets to their respective countries of origin. **(PNA)**

## More than 1.6 M students benefit from PBBM admin's fuel subsidy, 'libreng sakay' programs

A large number of Filipinos benefitted from the government's fuel subsidy and Libreng Sakay programs carried out to cushion the effect of oil price hikes on the transport sector and commuters.

According to the administration's year-end report, the Department of Budget and Management (DBM) had facilitated the timely release of funding to sustain the ongoing implementation of the fuel subsidy program for public utility vehicles (PUVs) and the Libreng Sakay Program of the Department of Transportation (DOTr). President Ferdinand R. Marcos Jr. also directed the DOTr to continue the implementation of the Libreng Sakay for Students Program in LRT-2, which benefitted an estimated 1.6 million students from August 22 to November 5 this year. In addition, under the Oplan Balik Eskwela program of the MRT-3 and the Philippine National Railways (PNR), a total of 143,290 students were given a 20 percent fare discount.

The government's Service Contracting Program (SCP) also provided compensation to operators and drivers whose livelihoods were affected by the COVID-19 pandemic and the increase in oil prices.

From April to July 2022, 19,194 PUV drivers were contracted to operate 16,832 PUV units on 921 routes across the country, the report said, adding that as of December 23, 2022, the EDSA Busway is being serviced by 751 Public Utility Bus units operated by 87 companies.

To reduce energy costs, the Marcos government implemented concrete steps since July this year, such as the Energy Efficiency and Conservation (EEC) program and also assisted distribution utilities to rationalize power supply sources.

The report said the Department of Energy (DOE) carried out the Government Energy Management Program (GEMP), which mandated all government agencies to save at least 10 percent on the consumption of electricity and fuel through the adoption

of energy conservation measures.

As of December 13, 19 percent of government entities are compliant with the GEMP, resulting in savings equivalent to P285 million.

The Energy Regulatory Commission (ERC) also suspended the collection of the Feed-in Tariff (FIT) from December 2022 to February 2023 to ease inflation pressure on electricity consumers.

The FIT is a uniform charge imposed on all on-grid electricity consumers for the development and promotion of renewable energy in the country.

The ERC and DOE have been conducting a Power Supply Agreement (PSA) Caravan since November 2022 aimed at assisting distribution utilities (DUs) and electric cooperatives (ECs) in rationalizing and optimizing their power supply sources.

Other government measures include the continued implementation of targeted

subsidies to mitigate the impact of increasing fuel and electricity prices.

As a result of DOE's negotiation with oil companies for a fuel discount program, participating gasoline station outlets offered a fuel discount of P1 to P4 per liter.

On October 28, 2022, the ERC, DOE, and the Department of Social Welfare and Development (DSWD) signed the Implementing Rules and Regulations (IRR) of RA No. 11552, extending the lifeline subsidy among qualified marginalized electricity users to another 30 years and expanded the beneficiaries to Pantawid Pamilyang Pilipino Program (4Ps) members.

The DOE likewise continued the implementation of Republic Act 11371 or the Murang Kuryente Act (MKA), allowing the use of the government's share from the Malampaya gas field as payment for the stranded contract cost and stranded debts of the National Power Corp. (NPC).

## Balik Probinsya beneficiaries receive P2.2 M aid from DA

**KORONADAL, South Cotabato (PIA)** -- Before 2022 ended, a farmer group in Antipas, Cotabato Province received more than P2 million worth of aid from the Department of Agriculture (DA) 12 for their dairy production project. DA 12 turned over cattle, milk containers, various chemicals, lactating feeds, urea, and veterinary drugs worth P2.2 million in support of the community-based dairy production project in Antipas on December 20 under the government's Balik Probinsya, Bagong Pag-asa (BP2) Program.

These aids were received by the Balik Probinsya Farmers Association of the said municipality.

Honeylene Carias, president of Balik Probinsya Farmers' Association in Antipas, said in an interview with Agri Tayo Soccskargen, that this is the largest aid their association has received so far.

"Lubos po ang aming pasalamat sa BP2 Program at sa Department of Agriculture dahil po sa inyong programa, malaki po ang naitulong sa amin, at nabago ang pamumuhay namin nang bumalik sa probinsya," Carias said. Apart from the dairy

production materials, Carias added, their organization has been beneficiary of several interventions from the agriculture department, including goat modules, swine, free range chicken, garden tools, vegetable seeds, assorted fruit trees, and many others.

According to a program briefer, BP2 program, "is geared towards addressing Metro Manila's congested urban areas by encouraging people, especially informal settlers to return to their home provinces."

Under the program, government agencies provide support to ensure "the continuous improvement of economies and quality of life in the provinces..."

Carias, in the same interview, expressed gratefulness on behalf of the BP2 beneficiaries.

"Malaking tulong po siya sa aming mga BP2 beneficiaries. Lahat po ng interventions malaki po ang naitulong sa amin kung ikukumpara namin ang buhay sa urban at dito sa probinsya. Dito po sa probinsiya kahit magtanim ka lang nandiyan na ang pagkain, ang halaman, sa bakuran mo," she said. (with report from DA-RFO XII)

## PBBM admin on high gear to digitalize gov't services, ensure bureaucratic efficiency

The administration of President Ferdinand R. Marcos Jr. has made a commitment to transform government services in 2023 to ensure responsiveness and accessibility to the public. Improving bureaucratic efficiency is contained in the administration's 8-Point Socioeconomic Agenda in the near-term, putting a premium on digitalizing, harmonizing, and standardizing government data. "In 2023, the government shall remain steadfast and continue to pursue streamlining initiatives to ensure the delivery of efficient government services to the people and fight corruption by eradicating all forms of red tape," the administration said in its year-end report. These include the strengthening of the TradeNet, a one-stop online shop aimed to reduce processing time and harmonize the permitting procedures involved in import and export in the country.

The Anti-Red Tape Authority (ARTA), in coordination with other government agencies, will pursue the National Policy on Regulatory Management System (NPRMS), which provides a common framework for good regulatory practices, and enforcement and compliance strategies.

The government plans to advance NPRMS components such as the Philippine Business Regulations Information System (PBRIS) to provide stakeholders and government agencies access to proposed and existing government regulations and avoid overlapping.

It will also push the Anti-Red Tape Electronic Management Information System (ARTEMIS) to provide a live database and mapping of all government services indicated in the Citizen's Charter.

In addition, Philippine Good Regulatory Principles (PGRP) will be implemented to promote proportionate, consistent, accountable, and targeted regulations through an effective dialogue between regulators and entities.

Also, the Department of Trade and Industry (DTI) will pursue the implementation of the

proposed Executive Order creating the Green Lane for Strategic Investments aimed at creating a more favorable business ecosystem.

In line with local government units' (LGU) devolution of functions, the national government will scale up its assistance to local governments through needs-based and targeted interventions, such as the Growth Equity Fund.

To optimize the government's Information and Communications Technology (ICT) resources, the government will continue to develop and implement interoperable systems that will further implement seamless sharing of data sources, such as the Philippine Identification System and electronic Business Permits and Licensing Service (eBPLS).

The administration will also address the fragmentation of the justice system through the implementation of the National Justice Information System and Middleware Exchange Platform.

On budget reforms, the Department of Budget and Management (DBM) will focus on rolling out digital systems that will promote prudent fiscal management and improve budget reliability.

This will be done through the enactment of the Progressive Budgeting for Better and Modernized Governance (PBBM) Bill, developing and implementing the Budget and Treasury Management System, and pursuing the National Government Rightsizing Program.

## Comelec resets first-ever election summit to March

**MANILA** – The holding of the first National Election Summit has been moved to March, the Commission on Elections (Comelec) announced on Tuesday.

Comelec chairperson George Erwin Garcia, in a press briefing, said the poll summit was pushed back from its original schedule set on the last week of January. "We will be meeting with our officials in the main and field offices to discuss preparations for the election summit this March," he said. Commissioner Nelson Celis, head of the poll summit's organizing committee, added

that the event will be held from March 8 to 10.

He noted that the decision to move the holding of the summit to be able to give way to the special elections in the seventh legislative district of Cavite on Feb. 25. "(In order) to give way for the special elections in Cavite on February 25, we will just move by about a month," Celis said.

He added that they have so far held 26 pre-summit activities since October 2022.

"So far, we have had discussions on the new technology that could be

possibly implemented for 2025 elections, full implementation of the digital signature, and the possibility of implementing blockchain technology, among others," Celis said.

The election summit aims to provide a platform for a national dialogue and interaction with, consultation and participation of election stakeholders in the review, formulation, or enhancement of policies, plans, and programs in election administration and electoral enforcement and adjudication.

The recommendations from the summit will be endorsed for consideration by the Comelec en banc. (PNA)

## LANDBANK AgriSenso: technical, credit assistance available to boost plantation crops

**MANILA** -- The Land Bank of the Philippines (LANDBANK) gathered farmers and stakeholders to discuss the National Government's support interventions to boost the local production of plantation crops, as part of the Bank's commitment to serve the diverse requirements of the agriculture sector.

During the sixth run of the LANDBANK AgriSenso Virtual Forums, Department of Agriculture (DA) Bureau of Plant Industry OIC-Director Gerald Glenn F. Panganiban, Ph.D. and LANDBANK Assistant Vice President Edgardo S. Luzano led the discussions on the available technical and credit assistance for farmers engaged in the production of plantation crops, such as banana, cacao, coffee, rubber and pineapple.

They were joined by Kennemer Foods International, Inc. President Simon Bakker and Goodyear Agrarian Reform Beneficiaries Multi-Purpose Cooperative (GARBEMCO) Operations Manager Mark Horace E. Gregorio, who shared how LANDBANK's affordable financing programs helped expand their operations and boost their income. For his part, DA OIC-Director Panganiban shared updates on the local industries of plantation crops as well as challenges experienced by the subsector, which include limited infrastructure and post-harvest facilities, high cost of production, and limited access to quality planting materials, among others.

To address these challenges, he presented various support interventions for farmers under the DA's High-Value Crops Development Program (HVCDP), including the distribution of planting materials, machineries and equipment, construction of facilities, and capacity building activities for farmers.

LANDBANK lending programs  
Meanwhile, LANDBANK

Assistant Vice President Luzano presented LANDBANK's available credit programs to further strengthen support for the various industries of plantation crops.

Under the Sulong Saka Program, LANDBANK can finance the production of high-value crops and other related projects, such as the establishment of nursery, budwood/mother plant/parent clone gardens, as well as the establishment of new plantations, and the replanting, rejuvenation and rehabilitation of old trees.

Individual small farm holders, small and medium enterprises (SMEs), cooperatives, farmers associations and organizations, large agribusiness enterprises and corporations, local government units (LGUs), non-government organizations (NGOs), and countryside financial institutions (CFIs) may avail loans under the Program.

As of end-October, LANDBANK has approved P17.8 billion in loans to 1,245 borrowers under the LANDBANK Sulong Saka Lending Program.

To support the agricultural value chains of cacao, coffee, coconut, and processed fruits and nuts, LANDBANK is also offering the Rural Agro-enterprise Partnership for Inclusive Development and Growth or RAPID Growth Credit Facility, in partnership with the Department of Trade and Industry (DTI) and funded by the International Fund for Agricultural Development (IFAD).

This Credit Facility aims to provide strategic business development interventions and matching grants to support qualified Program beneficiaries endorsed by the DTI, including cooperatives, farmers' associations and organizations, NGOs, and Micro, Small and Medium Enterprises (MSMEs) in selected provinces in Regions 8, 9, 10, 11, 12, 13 and the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

## DSWD holds caravan of gov't programs for children, families, Indigenous Peoples in street situations

**QUEZON CITY** -- President Ferdinand R. Marcos Jr. graced the grand launch of the Caravan of Special Protection Programs for children, families, and Indigenous Peoples in street situations, on Thursday, December 22, at the Open Amphitheater, Luneta Park.
