## PHO commences construction of TB culture testing laboratory

Cavite Provincial Health Office, in partnership with the Department of Health National TB Control Program and the Philippine Business for Social Progress, initiated the construction commencement ceremony of the TB Culture and Drug Susceptibility Testing Laboratory on January 10, 2023 at the Ancillary Building of General Emilio Aguinaldo Memorial Hospital, Trece Martires City. The project is expected to fast track testing to further improve detection and treatment of TB cases in the province.

During the ceremonial activity, 8th District Board Member Reyniel A. Ambion, Chair of the Committee on Health, gave a welcoming remark on behalf of Governor Jonvic Remulla and Vice Governor Athena Bryana Tolentino. He conveyed their gratitude for the time and effort exerted in making the activity come to fruition. He underlined that the project will benefit healthcare providers and those who are infected with TB, as they do not need to travel to other hospitals outside Cavite for laboratory testing.

Dr. Nonie John L. Dalisay, Provincial Health Officer II, explained that the idea of having a TB culture laboratory was first initiated in 2014, and the plan was formulated by the late Dr. George Repique Jr., former

Provincial Health Officer, and continued during the tenure of Dr. Gilbert Ilog. Meanwhile, Dr. Nelson C. Soriano, Provincial Health Officer I, stated that since they have the capacity and logistics for diagnosing tuberculosis, the occurrence of problems can be averted. He added that the team working on the project thinks outside the box. Hence, the achievement is invaluable and should be preserved. Dr. Eva Marie Torio, head of the DOH Infectious Diseases Unit, was delighted that after almost nine years, the construction of a TB culture and drug susceptibility testing laboratory will finally happen. Furthermore, Dr. Torio imparted that the establishment of TB culture is essential in the diagnosis, monitoring, and treatment of drug-resistant TB, as well as in the improvement of TB management turnaround time.

Subsequently, the Strategic and Area Manager of the ACCESS TB Project, Mr. Syrus Silvestre discussed the overview of the TB Culture Laboratory – how important it is for the province to have its own TB Culture – that through the laboratory, constituents, and patients living in Cavite could be catered to without the need to drive outside the province and wait 3–7 days for the result. "This is only the beginning of a challenge and a solution to the tuberculosis problem", he said.

The highlight of the activity was the official groundbreaking ceremony for the first public TB Culture Testing Laboratory in Cavite province led by BM Reyniel Ambion, Dr. Nonie John Dalisay, Dr. Nelson Soriano, Dr. Eva Marie Torio, Mr. Syrus Silvestre, and Mr. Raffy Macdonald.

Dr. Armand J. Dotollo, Provincial TB Program Medical Coordinator, delivered the closing remarks and reiterated that in spite of the presence of TB as one of the major health problems in Cavite, the province is working hard to eradicate the infection.

## DOST Sec. Solidum: 'Community Media are key partners for SciComm'

Department of Science and Technology (DOST) Secretary Renato U. Solidum, Jr. highlighted the important role of community media practitioners in disseminating science news and information during his talk at the 2023 Community Multimedia Summit on Wednesday, January 11 at the Aklan State University - Banga Campus.

The nationwide summit gathered broadcasters, publishers, editors, columnists, online broadcasters, writers, and professional communicators in general from various media organizations nationwide to discuss issues such as food security, climate change, tourism, social media education and other concerns affecting the national interest.

The three-day event is organized by the Provincial Multi-Media Press Corps PH, Inc. (PMPCPI), Publishers Association of the Philippines Inc. (PAPI), Philippine Online Broadcasters Association (POBA), and the Aklan Press Club, Inc. (APCI). It is considered to be the biggest convergence of the press and social media groups post-COVID-19 pandemic.

Also present during the event were Rev. Jose Corazon Tala-oc, Bishop of Kalibo; Undersecretary Edwin Cordevilla and Assistant Secretary Bobby Ricohermoso of Presidential Communications Office (PCO), Mr. Juan Dayang, Chairman of the Provincial Multi-Media Press Corps PH, Inc. (PMPCPI), Mr. Roy Bato, Chapter Chairman of the Kapisanan ng mga Brodkaster ng Pilipinas (KBP) Calabarzon, Ms. Lydia Bueno, President of the National Press Club of the Philippines, Mr. Nelson Santos, President, Publishers Association of the Philippines (PAPI), and Mr. Rowen R. Gelonga, Regional Director of DOST-VI.

During his talk, Secretary Solidum highlighted the DOST's efforts and initiatives that are anchored by four thematic areas: Wealth creation, through economic development and job creation; wealth protection, through climate

and disaster resilience; human well-being, through health, education, access to water and energy; and sustainability, by ensuring protection and conservation of natural resources.

"We at the Department of Science and Technology (DOST) have witnessed how communicators helped us become relevant in the public eye especially during the height of COVID-19 pandemic where most of the news are about vaccines, clinical trials, virgin coconut oil (VCO), and testing kits, to name a few. We owe the media the public's increased awareness about DOST, which then helped us leverage our projects with our lawmakers and stakeholders", said Secretary Solidum.

"Making sense of science & technology-related news can be a daunting task, and delivering it to public in layman manner requires keen sense of inquisitiveness and curiosity that only truly dedicated communicators can do."

Secretary Solidum added that engagement with members of the media has always been part of DOST's strategy to inform the public about the agency's efforts in terms of service delivery and improvement of public awareness about the Philippines' science & technology ecosystem in general.

In his presentation to the members of the media, Secretary Solidum discussed DOST's flagship programs and offerings in the field research and development (R&D); industry, energy and emerging technologies; food security and agricultural process; technology intervention among micro-small and medium enterprises (MSMEs), communities, academic organizations, government agencies, research institutions, and local industries; ICT tools and technologies for monitoring of weather and geophysical events; and scholarship opportunities for science, technology, engineering, and mathematics (STEM) students at the secondary, undergraduate, and graduate levels.

**SUMAILALIM** na din sa mandatory drug testing ang mga station commanders mula sa Manila Police District (MPD) at Quezon City Police District (QCPD) na ginanap sa Regional Headquarters ng National Capital Region Police Office (NCRPO) kamakailan.

Sa utos ni NCRPO Director PMGEN JONNEL C ESTOMO, agad tumalima ang 16 na hepe ng mga himpilan ng pulisya sa Lungsod Quezon at 14 naman buhat sa Lungsod ng Maynila at nagtungo sa Camp Bagong Diwa, Bicutan, Taguig City.

Ayon kay Estomo, lahat ng hepe ng pulisya sa kanyang nasasakupan sa Kalakhang Maynila ay kinakailangang sumailalim sa drug testing at inuna lamang aniya na isalang ang buhat sa MPD at QCPD at isusunod naman ang mga nasa Northern Police District (NPD), Eastern Police District (EPD) at Southern Police District (SPD).

Ipinaliwanag ni Estomo na isasalang sa mandatory drug testing ang lahat ng mga station commanders na nakatalaga sa NCRPO upang mapatunayan na ang kanilang tauhan ay malinis at hindi gumagamit ng ipinagbabawal na gamot.

Kaugnay nito, muling nagbabala si Estomo sa lahat ng mga station commanders ng NCRPO na kapag may nagpositibo sa kanila sa isinagawang

naghihintay sa mga doktor. Nakiisa sa programa sina Intergrated Provincial Health Officer Dr. Christine Villaseñor, QMC Chief of Hospital Dr. Jeff Villanueva. Nagpasalamat si Gov. Tan sa pakikiisa ng bawat departamento ng ospital sa pagbalangkas ng mga plano sa pagtatayo ng nasabing gusali.

"Lubos din po akong nagpapasalamat sa Sangguniang Panlalawigan ng Quezon sa pangunguna ni Vice Gov. Third Alcala sa pag-apruba ng pondo upang magamit sa paggawa ng gusali", sabi pa ni Gov. Tan. **(Ruel Orinday-PIA Quezon)**

mandatory drug testing ay siguradong mayroong kakaharapang kaso at posibleng matanggal sa serbisyo.

"Kung meron sa inyo ang magpositive, I will relieve you immediately and file appropriate charges against you. Kung negative naman, napakaganda para sa atin yan" ani Estomo.

Idinagdag pa ni Estomo "the conduct of this drug test to the station commanders of QCPD and MPD is to show their subordinates that their officers are not involved in illegal drug use. # Certification of Eligibility may now be secured in any CSC Regional Office

**QUEZON CITY** -- Requests for Certification of Eligibility or COE is now made more convenient, the Civil Service Commission (CSC) announced. Civil service eligibles may now request and secure their COE and its authenticated copies in any of CSC's 16 Regional Offices regardless of their place of examination.

"Mas magiging madali na para sa ating mga kababayan ang pagkuha ng kanilang eligibility records dahil kahit saang CSC Regional Office ay maaari na silang magpunta at mag-request ng COE. Kasama na ryan ang pagkuha ng authenticated copies ng COE," said CSC Chairperson Karlo Nograles.

This new development comes with the completion of a system called the Internal Civil Service Eligibility Verification System (iCSEVS) approved under CSC Resolution No. CSC Resolution No. 2200677 last 16 December 2022. iCSEVS allows CSC authorized verifiers to easily and quickly verify civil service eligibilities from an integrated database composed of passers of Career Service Pen and Paper Test and Computerized Examinations, and those granted special eligibilities under special laws and CSC issuances.

The CSC, however, clarified that only its Regional Offices are entertaining requests for COE; its Field

Offices do not issue COE at the moment. Further, the CSC Central Office shall only process requests for civil service eligibility required by the Courts or other investigating bodies, through a Subpoena Duces Tecum, and an Order and/ or a Written Request by the CSC Executive Offices and Office for Legal Affairs at its Central Office whenever the information is needed to resolve or check information involved in a pending case, complaint or issue, or to help a client who requires immediate assistance.

As the CSC continuously improves its systems and processes, also underway is the External Civil Service Eligibility Verification System (eCSEVS) that will allow the public to view from the CSC website the type of eligibility obtained by an individual. This web application is expected to be available within the year.

"Tuloy-tuloy ang ginagawang digitalization at streamlining efforts ng CSC upang maihatid nang mas mabilis at maayos ang aming mga frontline services. ## Aviation Security at NAIA T2 gets commendation for honesty, vigilance

### QUEZON CITY, (PIA)

--Albert L. Bautista, a guard assigned at the Ninoy Aquino International Airport Terminal 2 was recently commended by General Manager Cesar Chiong who personally thanked him in a simple awarding ceremony.

"Kaming lahat po dito sa MIAA, we appreciate very much your worthy contribution to promote NAIA as a safe and secured gateway to the Philippines. Maraming, maraming salamat po. Proud na proud kami sa iyo," GM Chiong expressed after handing over the certificate of commendation to AVSEC Bautista.

On January 4, 2023, cash amounting to P1.4M pesos and personal belongings were found by AVSEC Bautista at the NAIA Terminal 2 arrival area.

According to Bautista, he found a blue trolley bag in one of the gang chairs between Bay 8 and 9 at the domestic arrival area of Terminal 2. Thinking that the bag might contain valuables, he immediately sought the assistance of the Airport

Police officer on duty and the paging section to call her the attention of the owner. Despite numerous public announcements, no one came to claim the bag.

As part of security protocol, the area was cordoned-off and the Philippine National Police Explosive Ordinance Disposal and Canine Group (PNP-EOD/K9 Group) came to conduct inspection and later cleared the baggage of any explosive elements. During the inventory, the bag was found to contain P1.4M pesos, personal

effects and identification cards of Hon. Hanie Bud, Mayor of Maluso, Basilan who the Airport Police tried to contact through his available contact details.

In his Facebook account, the mayor stated "On my way, my wife called me saying that someone from the NAIA Terminal 2 informed her that I left my luggage in the waiting area. I was shocked. Maybe because I had so much in mind, I forgot my luggage which contains important things I needed. So, I immediately rushed back to the airport since no one is allowed to claim it but myself," said Mayor Bud.

The post gained positive reactions expressing appreciation to Mr. Albert Bautista for his good deed. Bautista has been an AVSEC for 12 years and had previously surrendered numerous items to the Lost and Found Section of the MIAA, the last one was in 2017. This is the first time however that he recovered a huge amount of cash. His advice to co-workers and other frontliners in NAIA, "huwag po natin pag interasan ang mga bagay na napupulot natin. Tiyak po na makakapagbigay po tayo ng kasiyahan sa taong may-ari kung maibabalik po natin ito sa kanila" Bautista stated. *(miaa/pia-ncr)*

## SC voids 2005 joint exploration deal with China, Vietnam

**MANILA** – The Supreme Court has struck down as unconstitutional an agreement signed in 2005 for mineral "pre-exploration" in the South China Sea.

In a statement on Tuesday, the SC said it voted 12-2-1 to void the Joint Marine Seismic Undertaking (JMSU) by and among China National Offshore Oil Corporation, Vietnam Oil and Gas Corporation and Philippine National Oil Company, covering 142,886 square kilometers.

The tribunal said the tripartite agreement, signed on March 14, 2005, is unconstitutional for allowing wholly-owned foreign corporations to participate in the exploration of the Philippines' natural resources without observing the safeguards provided in Section 2, Article XII of the 1987 Constitution.

All lands of the public domain, waters, minerals, coal, petroleum, and other mineral oils, all forces of potential energy, fisheries, forests or timber, wildlife, flora and fauna, and other natural resources are owned by the State and exploration, development, and utilization of natural resources shall be under the full control and supervision of the State, according to the law. The case was filed by former Bayan Muna party-List representatives Satur Ocampo and Teodoro Casiño.

Noting that "exploration" pertains to a search or discovery of something in both its ordinary or technical sense, the SC ruled that the JMSU involves the country's natural resources, particularly petroleum.

Under the JMSU, the parties will "engage in a joint research of petroleum resource potential of a certain area of the South China Sea as a pre-exploration activity," a clear indication that the deal was executed for the purpose of determining if petroleum exists in the agreement area.

"That the parties designated the joint research as a pre-exploration activity is of no moment," the SC ruled. "Such designation does not detract from the fact that the intent and aim of the agreement is to discover petroleum which is tantamount to exploration." The deal stated that the parties involved will "contribute to the transformation of the South China Sea into an area of peace, stability, cooperation, and development in accordance with the 1982 United Nations Convention on the Law of the Sea and the 2002 ASEAN-China Declaration on the Conduct of Parties in the South China Sea."

Sought for comment, Solicitor General Menardo Guevarra said his office has not received an official copy of the decision and would not react yet. *(PNA)*
