## MULTI-SECTOR AGENCIES PARTNER FOR OTOP HUB LAUNCH

**BACOR CITY, Cavite (PIA)** – The Department of Trade and Industry (DTI), the city government of Bacoor, and the Office of the 2nd District of Cavite Representative partner to initiate the launching of the One Town One Product (OTOP) hub located at the 2nd Floor Main Square Mall, Molino Boulevard last February 14. Together, DTI Secretary Alfredo Pascual, Mayor Strike Revilla, and Congresswoman Lani Mercado-Revilla led the ceremony together with Department of Interior and Local Government (DILG) Regional Director Lionel Dalope, DTI-Calabarzon OIC Regional Director Marissa Argente, Congressman Bryan Revilla, DTI-Cavite Provincial Director Revelyn Cortez, and Vice-Mayor Rowena Bautista-Mendiola. This is the second OTOP hub in the province that aims to provide a venue for market access to OTOP products that help Micro, Small, and Medium-scale Enterprises (MSMEs) in

the city to sell and promote their Bacooreño brand products and services. "I believe that giving opportunities to micro small enterprises will stabilize the local economy not only in the city of Bacoor, it will also provide a livelihood to those who make products, and give a higher level to the product that can be export," said ASEC Dominic Tolentino Jr. This project was first planned by the then mayor of the city and now Congresswoman Lani Revilla and was pushed to implementation by Mayor Strike Revilla in collaboration with the City Livelihood and Negosyo Center. Through the program, information is accessible to consumers to increase their awareness and protect them from online fraud and other unconscionable sales acts and practices. E-SIGAW is an internet site that features the following services and contents: e-ANGAT MSMEs, an online mentoring facility that provides MSMEs an easy access to local mentors, private organizations, and government agencies for their business development and information needs; e-BIDA ang LOKAL, a business-to-business commerce site to promote products of Cavite MSMEs, particularly those that have undergone product development through the One Town, One Product (OTOP) Next Generation Program; e-KONEK NEGOSYO, a directory of Cavite MSMEs, particularly beneficiaries of the Shared Service Facilities (SSF) Program, Kapatid Mentor Me (KMME) Program, and OTOP NextGen Program; e-TRAIN to LEARN, a calendar of activities and training to be conducted by DTI Cavite and access to e-learning materials; and e-CONSUMER CORNER, an information hub that features the programs and services offered by the DTI Cavite Consumer Protection Division, which include the Bagwis Program, Consumer Advocacy, accreditation and issuance of business licenses,

permits, registration, and authorities, and monitoring and enforcement of Fair Trade Laws. ## CDA 4A underscores role of women in cooperatives

The CDA IV-A conducted an inspection where it was found that the majority of the cooperatives in the 4th district have deficiencies in Gender and Development (GAD) compliance. Through this seminar, the CDA aims to address gender concerns among cooperatives by helping cooperatives craft their GAD Policy Manual, Plans, and Budget. In a press release, the CDA explained that they aim to advance gender equality in the cooperative sector by ensuring that everyone is given an equal opportunity to participate in and benefit from cooperative activities. ## PDLs of Quezon District Jail get livelihood training on vegetable production

**PAGBILAO, Quezon** – Selected persons deprived of liberty (PDL) at the BJMP Quezon District Jail got a unique livelihood skill, package of technology/seed and gardening materials from the Department of Agriculture (DA)-CALABARZON as they immersed themselves in vegetable production and culture management practices last February 8, 2023. According to BJMP – Quezon, the activity was done and similarly patterned with previous cooperation of the Jail Bureau with other sectors, such as the Gulayan sa Paaralan and the Gulayan sa Piitan to encourage the community to plant vegetables. In his message, Agricultural Program Coordinating Officer, Dr. Eduardo R. Lalas emphasized the importance of attaining food self-sufficiency of the jail community through their learned skills and continue

cultivating vegetables even after they have been released out of jail. "This would be done for them because farming inside the prison compound could be one of the best ways to introduce reforms and promote productivity among PDLs," said Lalas. Meanwhile, Quezon District Jail Warden, Jail Supt. Jack Lord B. Cariño has high hopes that the training they received, especially for probationers, will equip them with a means of sustainable livelihood, adding that jail management ensures that released PDLs will be supported all throughout as follow up extension. Jail Officer-2 Joeferie Barbacena Anglo on the other hand said, the Bureau of Jail Management and Penology in partnership with government and non-government organizations conducts trainings on vegetable production to enhance PDL agriculture skills and knowledge particularly in organic farming. **(RMO/PIA Quezon with reports from BJMP-Quezon)**

## 'Pambansang Pabahay' to generate work for Filipinos

**QUEZON CITY (PIA)** -- To prepare for the expected surge in demand for construction workers once the Pambansang Pabahay para sa Pilipino Program is fully implemented this year, the Department of Human Settlements and Urban Development (DHSUD) is collaborating with the Technical Education and Skills Development Authority (TESDA) to improve the skills of housing industry workers. Secretary Jose Rizalino Acuzar of the DHSUD mentioned his anticipation of a rapid rise in the demand for construction workers in the upcoming months as President Ferdinand R. Marcos Jr.'s "Pambansang Pabahay" program is expected to launch at full capacity. Pointing out that a shortage of skilled workers is currently one of the issues they are facing when construction reaches its peak, Secretary Acuzar said, "We have a problem with the availability of skilled workers." To tackle this challenge, DHSUD started discussions with TESDA Director General Danilo Cruz as early as October last year. This proactive measure aims to equip construction workers with the necessary skills and knowledge to meet the workforce demand of housing project development. Acuzar also stated that the housing department is currently in communication with TESDA to organize training programs for skilled

workers such as carpenters, plumbers, electricians, and those involved in the finishing touches of masonry work. "Kaya kami po ay nakikipag-usap sa TESDA para magkaroon ng training para sa kanila," he emphasized. TESDA has also conveyed its support for increasing the labor force in the housing and construction industries, as well as enhancing skillsets. "Right now, we are looking at all angles and aspects to prepare for the beginning of actual implementation of the Pambansang Pabahay on the ground. We are fast-tracking construction so that we can adjust with the projected increase in cost," stated Acuzar. He added that they require a sufficient workforce to ensure that they can construct and deliver the houses on schedule for fellow Filipinos. The administration's flagship mass housing program aims to build one million housing units every year for the next six years to bridge the growing housing gap. According to DHSUD, the project is expected to create around 1.7 million job opportunities annually, including positions for construction workers. This significant number of jobs is anticipated to aid the government's efforts to recover from the pandemic and advance the Marcos administration's 8-point economic agenda. **(EEDC/PIA-CPSD)**

## DENR Calabarzon recognizes private sector's role in advancing environmental causes

Present during the event was Mayor Anthony Genuino, Vice Mayor Josephine Sumangil - Evangelista, municipal councilors, and other LGU officials. According to Mayor Genuino, he believes in the importance of breastfeeding and the health benefits it provides to infants' nutrition.

The chief executive added that he supports the strengthening of partnership and collaboration between the Municipal Nutrition Action Office, Municipal Health Office, and Gender and Development Office, and LATCH Los Baños to advance the causes of children and mothers' health.

**MANILA** — The Philippine Textile Research Institute (PTRI) has invested PHP25 million to boost natural dyes (NatDyes) production in the country, an executive said Monday. Under the "Colorimetric and Performance Standardization of NatDyes Produced in Various Natdyes Hubs in the Philippines" project, the PTRI has been helping at least five communities to produce natural dyes powders. These communities are located in Occidental Mindoro, Bukidnon, Abra, Antique and Rizal. Communities in Mindoro, Bukidnon and Abra are commercially producing indigo powders, while the other two communities are engaged in Philippine indigo cultivation and propagation as an additional livelihood. "Aside from Philippine indigo, there are other identified natural dye sources that we

could use as textile colorant. The PTRI has documented over 100 natural textile dye sources (botanicals) and we are adding to this list because there are many untapped natural colorants in our nation," PTRI officer in charge Julius Leaño told the Philippine News Agency. He said the Indigo plant (*Indigofera tinctoria*) grows well in tropical climate. "In the Philippines, this is predominantly commercially grown in Abra and Occidental Mindoro, and Bukidnon. Among our list of natural dye supplies, this plant dye is the most promising due to its color quality and community-scale manufacturing," Leaño said. Indigo, he said, is one of the commercially available dyes in the Philippine market, and therefore, ensuring the integrity, purity, and authenticity of this natural dye is critical.

"Compared to other natural colorants, the simplicity and purity of its chromophore system makes it appropriate for developing a template protocol or standard for natural dyes," said Leaño. Conventional dyers utilize synthetic colorants during the dyeing process and could pose potential harm and hazard to the environment, according to Leaño. "With the use of natural colorants, we can partake in reducing this environmental risk," he said, adding that the Vice Mayor Sumangil-Evangelista also lauded the generosity of breastfeeding mothers who donated their breastmilk for a good cause. (Breastfeeding as Response to Emergencies made more Accessible through Science and Technology) community-engaged human milk bank, which is a tripartite partnership between the Provincial Government of Laguna, LATCH Los Baños, and the University of the Philippines Los Baños (UPLB). ## SC upholds victory of Negros Oriental governor

**MANILA** – The Supreme Court on Tuesday dismissed the petitions questioning the result of the Negros Oriental gubernatorial race between Pryde Henry Teves and Roel Degamo. In a statement, the high tribunal said it upheld the win of Roel Degamo and has junked the petitions filed by Teves and Grego "Ruel" Degamo against the Commission on Elections (Comelec).

"The Court found that the Commission on Elections en banc did not commit grave abuse of discretion in issuing its Resolution in SPA No. 21-085 (DC) dated September 1, 2022 in favor of Roel Degamo," the SC said.

The Comelec en banc affirmed the resolution of the Second Division, which ruled Grego "Ruel" Degamo as a nuisance candidate and annulled Teves' proclamation as the provincial governor.

The votes obtained by Grego Degamo was

credited in favor of Roel Degamo.

The final recount showed Roel Degamo got 331,726 votes while Teves had 301,319.

Teves relinquished his post in October last year after the SC did not grant his motion for a temporary restraining order.

The SC echoed the poll body's observation that it was only for the 2022 elections that Grego Degamo used "Ruel" as his nickname.

There was no violation on the right to due process of Teves even if he was not impleaded in the petition filed by "Roel" against "Ruel".

"Moreso, the number of votes he has garnered will remain the same, with the Comelec proceeding merely on the appreciation of the votes cast by the voters and determine whether all of the votes obtained by the declared nuisance candidate will have to be credited in

## CTA rejects condo firm's tax credit claim

**MANILA** – The Court of Tax Appeals (CTA) has turned down the claim for a P3.185 million refund of a Makati condominium corporation which failed to prove that it indeed paid the said amount to the Bureau of Internal Revenue (BIR). In rejecting the claim for a PHP3.185 million tax refund of Pacific Plaza Condominium Corp., the CTA said it did not prove entitlement to the claim and that the payment to the BIR was erroneous.

The company did not present receipts that proved its entitlement to input tax credits allegedly used to pay the value-added tax (VAT) to the BIR, according to the CTA.

The CTA, citing precedents, said condominium association dues are not subject to VAT since no sale, barter or exchange of goods or properties or sale of a service are involved.

However, the tribunal said the "taxpayer has the burden to show that it has strictly complied with the conditions for the grant of the tax refund. Here, petitioner (taxpayer) is duty-bound to prove every minute aspect of its entitlement to the claimed VAT-refund. In the absence of proof of wrongful payment, the Court has no other recourse but to deny petitioner's claim for refund of erroneously paid VAT."

In 2012, the BIR issued a memorandum circular clarifying that association dues, membership fees and other assessments/charges collected by a condominium corporation are subject to VAT since they constitute income payment or compensation for the service it provides to its members and tenants.

It was subsequently struck down and voided by the Supreme Court. **(PNA)**

## SC affirms liability of ex-DTI chief for disallowed bonuses

**MANILA** – The Supreme Court has affirmed the state auditors' ruling that held Peter Favila, a member of the Monetary Board, liable for PHP4.539 million in disallowed bonuses granted to board members of the Trade and Investment Development Corp. (Tidcorp) while he was serving as Department of Trade and Industry (DTI) secretary.

The decision made public this week ruled Favila is solidarily liable as approving officer and recipient.

He was directed to settle the amount representing disallowed productivity enhancement pay, developmental contribution bonuses, grocery subsidy and anniversary bonuses paid between 2005 and 2010.

In 2012, the Commission on Audit (COA) issued a notice of disallowance (ND) on

the disbursement vouchers and the corresponding checks for Tidcorp's board of directors, which included Favila.

The COA said the disallowed amount constitutes double compensation.

In 2015, the COA Corporate Government Sector affirmed the ND as Tidcorp board members who held their positions in ex-officio capacity had no right to receive additional compensation since their compensation were already paid by their respective principal offices to which they were attached, except for a PHP500 per diem for every board meeting attended.

"In fine, without the prior approval of the President and being in clear circumvention of law and the Constitution, the questioned allowances are deemed illegal," the court said.

In 2020, COA junked the motion for reconsideration filed by Favila who sought for a reversal of the ruling. Favila argued that he received the benefit and allowances in good faith, noting that the extra compensation was authorized by a board resolution and the Tidcorp Charter.

Tidcorp, designated as the Philippine export-import credit agency in 2002 by virtue of Executive Order No. 85, is mandated to stimulate, increase and develop the export of goods and services, and to facilitate investment in strategic sectors for the country's development by extending guarantees, insurance, credit and related technical assistance to viable enterprises. **(PNA)**

RA 11701 was signed into law by former president Rodrigo R. Duterte on April 13, 2022.

It shall take effect on Feb. 24 or after 15 days from its publication. **(PNA)**

## Rules on night shift differential pay for gov't workers out

**MANILA** – The Civil Service Commission (CSC) has announced the implementing rules and regulations (IRR) of the law granting night shift differential pay to government employees.

In a statement Monday, the commission noted that Republic Act (RA) 11701 grants compensation premium to government employees, including those in government-owned or controlled corporations (GOCCs), who are occupying the positions or items of division chief and below or their equivalent. This is regardless of the status of their appointment, whose official working hours fall between 6 p.m. and 6 a.m. of the following day.

The premium is also granted to incumbents of division chief positions and below or their equivalent,

who are designated as officers-in-charge to executive or managerial positions when they are still bound to observe the work hours between 6 p.m. and 6 a.m. of the following day.

The law granting night shift differential pay is a much-deserved additional benefit for employees who are relied upon to keep government operations running 24/7, he added.

On the other hand, the law does not cover government employees with regular work schedules falling between 6 a.m. and 6 p.m.; those whose services are required, or are on call, 24 hours a day, such as the uniformed personnel and others as may be determined by the CSC and the Department of Budget and Management (DBM); and workers under job order or contract of service.

The night shift differential pay shall be at a rate not exceeding 20 percent of the hourly basic rate of the employee, as authorized by the head of agency. In the case of public health workers, the rate shall not be lower than 10 percent of their hourly basic rate.

The amount necessary for the initial implementation of the law and rules shall be charged against the existing appropriations in case of national government agencies; for local government units, from their respective funds subject to the provisions of Sections 325 and 331 of the Local Government Code of 1991; and for GOCCs and their subsidiaries, from their respective corporate funds.
