TAGAYTAY DRUG REHAB CENTER CELEBRATES 58TH FOUNDING ANNIVERSARY

TRECE MARTIRES CITY, Cavite (PIA) — The Department of Health-Tagaytay Treatment and Rehabilitation Center (DOH-TTRC), the country's first drug rehabilitation center, marked its 58th founding anniversary in a celebration held on March 27 at The Bayleaf Cavite in General Trias City.

The celebration which carried the theme "Looking Back, Moving Forward," highlighted the nearly six-decade journey and success of the rehabilitation center in changing the lives of drug dependents.

Secretary of the Interior and Local Government Benjamin C. Abalos Jr. graced the event as the guest of honor and speaker.

The DOH-TTRC, formerly manned by the National Bureau of Investigation (NBI) and the Philippine National Police (PNP), is the first treatment and rehabilitation center in the country that began in 1965. In 2005, the Department of Health took over the operations of the center by the Republic Act No. 9165 or the Comprehensive

Dangerous Drugs Act of 2002,

From 20 drug dependents, the center has grown into a complex treatment and rehabilitation center that can accommodate up to 300 patients. It is maintained and supervised by employees from different fields of expertise ranging from medical officers, psychiatrists, psychologists, and social workers.

The DOH-TTRC continues to serve with the mission to provide individualized, evidence-based, and holistic treatment and rehabilitation services to Persons Who Use Drugs (PWUDs) and their families, to sustain their long-term recovery and to help them improve their quality of life. Joining SILG Abalos and DOH in celebrating the center's success were DILG Usec. Margarita N. Gutierrez, DOH Usec. Camilo Pancratius P. Cascolan, DILG Provincial Director Lionel L. Youth Summit against drug use launched in Cavite

IMUS CITY, Cavite (PIA) — The Cavite Police Provincial Office spearheaded a youth summit recently in an effort to empower youth as partners in the government's continued fight against illegal drugs. CAVITEX C5 Link Segment 2 construction set with new contractor deal

TRECE MARTIRES CITY, Cavite (PIA) — The

Metro Pacific Tollways Corporation (MPTC) through its subsidiary, Cavitex Infrastructure Corporation (CIC), signed a contract with a new contractor, the China Road and Bridge Corporation (CRBC) to lead the Phase 2 construction works at the CAVITEX C5 Link Segment 2.

The signing ceremony between the two conglomerates with CIC represented by its President and General Manager, Mr. Raul L. Ignacio, and CRBC Philippine branch General Manager Mr. Ren Xiaopeng signaled the commencement of the construction works. (Ruel Francisco, **PIA-Cavite with reports from MPTC**)

Bridge are among them. CIC and CRBC target to start phase 2 of the construction for the CAVITEX C5 Link Segment 2 this first quarter of 2023, and sees opening it to the public before the year ends.

CAVITEX C5 Link Segment 2 is a 1.9-kilometer, 2x3 lane expressway that will connect CAVITEX R-1 (Coastal Rd.) from Paranaque Toll Plaza to Sucat thru R-1 Interchange. It is expected to reduce travel time to Sucat Road from CAVITEX R-1 and vice versa by 10 minutes.

Cavite diocese urges faithful to attend Sunday Masses in person

MANILA — The Diocese of Cavite urged the faithful to physically attend Masses in churches every Sunday.

In a circular letter, Bishop Reynaldo Evangelista said the public is encouraged to be present and participate in Masses especially on Sunday as the earlier Church order prohibiting them to attend Church activities due to the coronavirus disease 2019 (Covid-19) threat will soon be lifted.

"For this reason, the faithful are enjoined to be physically present and actively participate in all Sunday Eucharistic celebrations, while still observing minimum health protocols," he said.

"This is in view of the weakening of the strain of the coronavirus 2019 (Covid-19), vaccination of the whole population, and the encouragement of the Catholic Bishops' Conference of the Philippines (CBCP) for the faithful to return to Sunday masses in Churches," Evangelista added.

In October 2022, the CBCP has released a circular urging the faithful to physically attend Sunday Masses in churches amid the weakening situation of the coronavirus pandemic. Likewise, it reminded them to carefully observe health protocols for their protection against the virus. (PNA)

Cavite town's cityhood plebiscite set July 8 - Comelec

MANILA — The plebiscite for the conversion of the municipality of Carmona in Cavite into a component city will be held on July 8.

This is based on Commission on Elections (Comelec) Resolution No. 10901 made public on Monday.

At the same time, the poll body has scheduled the Information and Campaign Period from June 8 to July 6.

During the period, it is prohibited to remove, destroy, deface, and tamper lawfuleplebiscitepropaganda materials; appointment or hiring of new employees or promotion or giving salary increases; release of public funds; vote-buying and vote-selling; and construction of public works.

The plebiscite period in Carmona, Cavite will be from June 8 to July 15. Republic Act 11938 has approved the holding of the plebiscite for the town to be converted into a component city. (PNA)

Not allowed during the plebiscite period are the carrying of firearm and other deadly weapons; maintenance of reaction forces; transfer of officer or employee in the civil service; suspension of local elective officials; and illegal release of prisoners.

A liquor ban would be implemented while campaigning is prohibited on July 7, the eve of plebiscite day. On plebiscite day, voters may cast their votes from 7 a.m. to 3 p.m.

The canvassing of votes by the Plebiscite Board of Canvassers is expected around 6 p.m., to be followed by the proclamation of the plebiscite results.

Talakag veggie, coffee farmers to benefit in DOST's tech for livelihood

Around 800 vegetable and coffee farmers are expected to benefit from the recent technology assistance in Talakag, Bukidnon made possible with the partnership of the Department of Science and Technology and the Local Government Unit of Talakag.

To minimize waste and stabilize prices in times of oversupply of vegetables and to provide farmers with a reliable source of income, DOST has recently turned over a vacuum packaging technology that enables the farmer-members of Balugto Hope Agroforestry Association Inc. These sets of machines will enable the farmers to produce value-added products with longer shelf life.

The equipment provided includes vegetable cutters, vacuum packaging machines, digital weighing scales, washers, and stainless steel tables, and more. The 250 farmer-members across the municipality are expected to benefit from this intervention.

The association aims to produce a variety of vegetable packs, such as chopseyu, pinakbet, and for pancit, which they plan to sell in the malls of Cagayan de Oro City.

During the turnover on February 21, 15 members were trained on the basic operation and maintenance of the newly turned-over machineries. DOST will also be training them on Good Manufacturing Practices and Food Safety.

The processing plant, a joint counterpart of the LGU and the beneficiary is currently being furnished to be compliant with the standards of the Food and Drug Administration, for the ease of their future License to Operate application.

Marcos to Pag-IBIG: Help DHSUD address housing backlog

MANILA — President

Ferdinand R. Marcos Jr.

on Tuesday called on the Pag-IBIG Fund to assist concerned agencies in addressing the country's housing backlog of more than 6.5 million.

"I call upon the Fund to further build on this growth and momentum to provide and to improve the lot of the Filipino workforce, and also to significantly assist in addressing our housing backlog as an industry leader in home mortgage financing," he said during the Pag-IBIG Fund Chairman's Report for the unveiling of its 2022 performance and the dividend rates on the members' savings, held at the SMX Convention Center in Pasay City.

He challenged the Pag-IBIG Fund to "work closely" with the Department of Human Settlements and Urban Development (DHSUD) to find effective strategies to ease the country's housing situation.

The Pag-IBIG Fund is a government-owned and -controlled corporation (GOCC) under the DHSUD.

Marcos likewise enjoined its officers and employees to be guided by the principles of transparency and accountability in carrying out their mandate. "It goes without saying that as public servants, we must maintain the trust and the confidence reposed in us by government institutions, especially those financial in nature and more importantly by the people," he said.

He noted that maintaining this trust is a "crucial" part of building upon the Pag-IBIG Fund's accomplishments and achieving the administration's goals in housing.

Marcos also acknowledged developers, employers, housing industry players, and other partners for their invaluable contributions to the continued success of the Pag-IBIG Fund.

"It is this partnership that brings the success to the Fund and for that once again, we thank you for that partnership and that coordination with the government," he said.

The President underscored the need to strengthen those partnerships and double down on efforts to provide adequate access to decent and affordable human settlements.

He also recognized the central pillar of the Pag-

IBIG Fund – its 2.6 million-strong members.

"With the members' continued support, the Pag-IBIG Fund has grown into a financially strong and secure institution, boasting more than PHP827 billion in total assets," he said.

Marcos also exhorted members to remain "ever-productive" in their employment and commercial pursuits to continue to sustain the Pag-IBIG Fund.

The Marcos administration aims to achieve its goal of building 1 million housing units per year or 6 million by the end of its term through the "Pambansang Pabahay para sa Pilipino": Zero ISF (Informal Settler Family) 2028 Program.

Highest dividend rates
Meanwhile, Marcos also congratulated the Pag-IBIG Fund for achieving its highest dividend rates since the pandemic.

"And for that, I congratulate you and you should pat yourselves on the back and give yourselves a round of applause," he said. "It is very encouraging that through the years, that in spite of periods of volatility, uncertainty, and sometimes very complex challenges, including the supervening pandemic, the Pag-IBIG Fund has remained true to its original vision and that is to provide a secure savings program, a dependable and affordable housing – to be able to give dependable and affordable housing loans for the benefit of its members."

The Pag-IBIG Fund's Regular Savings dividend rate for 2022 reached 6.53 percent while its Modified Pag-IBIG 2 (MP2) Savings rate increased to 7.03 percent per annum.

Pag-IBIG Fund Chairperson and Department of Human Settlements and Urban Development (DHSUD) Secretary Jose Rizalino L. Acuzar said Pag-IBIG posted its best performing year in 2022 as the agency's net income reached a record-high of PHP44.5 billion, a 28 percent increase from the PHP34.69 billion the year before.

The agency also reported several record-high figures for the year, with home loans reaching PHP117.85 billion; total membership savings collected amounting to PHP79.9 billion, and loan payments amounting to PHP127.42 billion. (PNA)

Tinalo ni Diones si Tran Van Dien ng Vietnam, ang 2021 Southeast Asian Games (SEAG) bronze medalist, na nagsumite ng 15.73m para sa silver medal at si Ronnie Malipay ng Bohol na pumangatlo sa 15.34m. "I think I did okay. It's my new season's best for 2023," the back-to-back silver medalist in the SEA Games said. "Salamat sa panalo. Sana mapanatili ko ang momentum sa mga susunod na kaganapan."

Umaasa ang 5-foot-11 na tubong Libmanan, Camarines Sur na tumalon ng mahigit 16 metro sa Cambodia SEA Games na nakatakdahan sa Mayo 5 hanggang 17. Hawak ni Diones ang national record na 16.70m na naitala niya sa 2017 edition ng tournament na ito na inorganisa ng Philippine Athletics Track and Field Association (PATATA).

Sa parehong taon, nakakuha siya ng pilak sa 22nd Asian Athletics Championships sa Bhubaneswar, India.

Gayunpaman, tulad ng karamihan sa mga atleta, ang kanyang pagsasayay ay naapektuhan ng pandemya.

"Mahirap kasi intermittent yung training. Malaking factor yung two-year pandemic kaya mahirap ibalik yung 16.70," said Diones, who is being coached by Jojo Posadas.

Nasungkit ni Diones ang silver medal nang tatlong sunod sa SEA Games noong 2017 sa Malaysia, noong 2019 sa Pilipinas at noong 2022 sa Vietnam.

Samantala, pinamunuan ni Nolan Crespo ang men's open 100m, kasunod ng landas ng kapwa Filipino-American na si Kristina Knott na namuno sa women's side.

Tumakbo si Crespo ng 10.89 segundo upang talunin sina Amatus Somaghai ng Indonesia (10.92) at Muhsin Firdau Al-Rashid Hj Md Idris (10.96). Ang 5-foot-7 Crespo ay isang senior sa kolehiyo na Kumukuhang cognitive science sa University of California sa San Diego.

Bilang isang junior, na nagaugnay ito sa Azusa Pacific University Last Chance, na nagaatakda ng bagong rekord sa paralaran na 10.36.

Samantala si Tokyo Olympian Knott ay naggala ng 11.87 segundo upang talunin sina Malaysian Zaidatul Husniyah Zulkifli (12.02) at Lianne Diana Pama ng Unibersidad ng Santo Tomas (12.08).

Sa men's Open decathlon, inangkin ni John Mike Lera (City of Ilagan-National Team) ang panalo sa kabuuang 510 puntos. Pumapangalawa at pangatlo sina Primo Luciano Legis Lopez (383) at Jose Matteo Crisostomo (379) ng Ateneo de Manila University, ayon sa pagkakasunod.

Ang mga gold medalists sa under-20 category ay sina Methasit Khrampinit ng Thailand (men's 400mH), Gabriel Cervantes (men's 5,000m walk), Nicko Alas (men's shot put), Hussein Lorana (men's 800m), Angel Saysay (women's 800m), at Karen Mae Pelegria (women's 100m).

Sinimulan ng San Miguel Aerocity Inc. (SMAI) ng SMC ang programa matapos ang buwanang food assistance para sa 8,000 pamilya ng mga mangingisda sa mga bayan ng Rosario, Tanza, Naic, at Ternate.

Ang programa ng kumpanya ay sang-ayon na social and environmental performance standards ng International Finance Corporation (IFC) para sa New Manila International Airport (NMIA) project na itatayo sa Bulakan, Bulacan.
