## CAVITE PROV'L GOVT CELEBRATES 2023 WOMEN'S MONTH

TRECE MARTIRES CITY, Cavite (PIA) – The Cavite provincial government capped off the celebration of this year's women's month with a day full of activities in honor of the remarkable role of women in society.

The Cavite Gender and Development Focal Point System and the Provincial Social Welfare and Development Office spearheaded the celebration held on March 29 at the provincial gymnasium.

The program offered various medical services and activities for all women participants such as eye and general check-ups, breast examinations, health risk assessment and nutrition counseling, family planning services, HIV counseling and testing, HPV vaccination, and oral prophylaxis.

Vice Governor Athena Bryana Tolentino who graced the event also presented the Provincial Gender and Development

(GAD) Code to enlighten the public on the programs and projects of the provincial government geared towards empowering women.

A total of 3,718 vacancies for local employment and around 80 for overseas employment were offered. Some 64 applicants were interviewed and 22 were hired on the spot. **PICAD**

### Job Caravan in Maragondon

The third leg of "Trabaho sa Kabataang Kabiteno" mega job fair caravan was conducted on March 29, 2023 at Maragondon Town Plaza spearheaded by the Cavite Provincial PESO in collaboration with the Sangguniang Kabataan Provincial Federation.

The caravan aimed to

provide career prospects for Cavite youth. Mr. Noah M. Caasi, the Municipal Administrator of Maragondon, began the job fair caravan with a message of support for the event and emphasized the importance of employment creation for the youth.

Ms. Rizalie P. Enero, PPESO head and Mr. Rodel Vincent T. Bae, head of the Provincial Youth and Sports Development Office (PSYDO), also gave brief statements encouraging participants to take advantage of the job fair and underscoring the government's commitment to assisting young people in obtaining work.

The job fair caravan featured booths from various companies and industries, including AQUAVIR International, Inc., Building Better Lives Manpower Services International, Inc., Caishen Marketing Service, Inc., DLB International, Inc., Enomoto Philippines Manufacturing, Inc.,

Eyequest International Manpower Services, Inc., House Research & Development (HRD) Singapore Pte., Ltd., Lazurite Titanium 8 Life Insurance Agency, Inc. (PRU Life UK), Lead Resource Management Corp., Pasig Industries, Inc., Philippine Seven Corporation, Powerlane Resource Corp., Sanford Marketing Corporation (SM Savemore Market) - EPZA, Star World International Manpower & Placement Agency, Inc., and Synergy Experts Labor Service Cooperative.

In total, 3524 job vacancies for local employment were offered.

During the interview process, a total of 38 individuals applied for the job, out of which 10 were selected and offered employment right away.

Likewise, Police and NBI clearance processing were also offered at the caravan.

Overall, the "Trabaho sa Kabataang Kabiteno" mega job fair caravan was a positive step towards supporting the youth of Cavite in finding employment. The event underlined the government's dedication to job development as well as the Caviteños perseverance in the face of adversity. **PICAD**

## PSA CRS Lipa City Outlet implements faster release of documents under CRS-ITP2 project

Starting 30 March 2023, the Philippine Statistics Authority (PSA), Regional Statistical Service Office IV-A has implemented the Civil Registry System – Information Technology Project 2 (CRS-ITP2) to its frontline service in Lipa City. Under CRS-ITP2, the services provided by PSA CRS Lipa City Outlet will provide faster and more efficient services.

Documents can now be released within an hour compared to the previous two-hour waiting time for the release of documents after paying for it. Mr. John Paul Rubio, one of the clients during the "Go Live" shared that it took only 30 minutes for him to get his

documents, from screening of requirements to the release of his requested birth certificate.

Regional Director Charito C. Armonia together with CRASD Chief Wilma A. Villafuerte graced the CRS-ITP2 "Go Live" roll out at the outlet. They gave freebies such as CRS-ITP2 shirts and brochures to the first five clients.

The CRS-ITP2 involves the computerization of the civil registry operations of the PSA and is designed to collect, store and manage civil registry documents and the specimen signatures of all city and municipal registrars using imaging technology. It also aims to enhance accessibility, security and quality service for citizens requesting civil registry documents. The following are the services offered at CRS Lipa Outlet:

1. Copy Issuance of birth, marriage and death certificate from the CRS database with a fee of Php155.00

2. Issuance of Certification of No Marriage (CENOMAR) if no marriage record appears in the national Indices of Marriage. Otherwise, an Advisory on Marriages shall be issued. Application fee is Php210.00

3. Issuance of Certification as to the non-availability of death record or CENODEATH in the PSA CRS database with a fee of Php210.00

4. Viewable online – it is an alternative to copy issuance, the resulting image of the document is made accessible through the web using an access code. However, the document image on the web is available only for 60 days. Application fee is Php130.00

5. Doc Print - those who availed of Viewable Online may also opt to get a copy of birth, marriage, and death certificates including CENOMAR and CENODEATH by presenting the access code at the CRS Outlet with an additional fee of Php80.00 for the printing on security paper (**SECPA**).

## 4PH Program to boost the country's Sustainable Development GoalsDG

QUEZON CITY, (PIA) – The

PDP 2023-2028 explicitly states the establishment of livable communities as among its key transformation strategies under the social and urban development sector, "by upgrading and planning human settlements such that an integrated use of space will bring people closer to work, recreation and transit options." This is anchored to the country's commitment to the United Nations' Sustainable Development Goal 11 to make cities and human settlements inclusive, safe, resilient and sustainable. Thus, to provide the housing needs of the Filipino people, President Ferdinand R. Marcos Jr., through the Department of Human Settlements and Urban Development (DHSUD) has crafted the Pambansang Pabayahan para sa Pilipino Housing (4PH) Program.

In a statement, DHSUD Secretary Jose Rizalino Acuzar explained the relevance of the 4PH Program, particularly on maintaining economic growth rate and creating more resilient jobs, as targeted in the Philippine Development Plan (PDP) 2023-2028.

"As we pursue the mission to build and dispense one million housing units per year, we are also espousing township development that will ensure sustainable co-existence of all elements and players in a housing community," Acuzar said. Congruently, the 4PH Program pursues innovative strategies to maximize the use of land resources, particularly the vacant, idle, blighted and underutilized government and private-owned lands for housing and mixed-use

development.

In addition, it targets to optimize land utilization, especially in highly urbanized and component cities through prioritizing vertical housing and adopting township development models. "We give weight to the fact that the country's population growth remains as one of the fastest in Asia, yet our spatial legroom remains constant. It literally maintains its original size and shape, prodding us to strategize on its use while protecting everything that inhabits it," Acuzar said.

Statistics from local housing boards indicate approximately 3.7 million ISFs in the country, half a million of whom are in Metro Manila. Living under poor conditions, they occupy blighted areas, within easements, beside railways, waterways, esteros, among other dangerous areas. This poses serious risks to their health and exposes them to hazards and natural disasters.

The 4PH Program, thus, focuses on developing low, mid to high-rise projects near the sources of livelihood of target beneficiaries. Indisputably, most of these areas are found in the metropolis or in the center of urban areas where informal settler families (ISF) persistently thrive.

"The DHSUD, in partnership with LGUs, envisions to transform informal settlements and blighted areas into better residential developments with reasonable open spaces. In aid of this, we must clean and rehabilitate waterways and esteros into parks and walkways, and promote onsite or near-site in-city housing," the

## BSP: Balance of risks to inflation still on the upside

MANILA – The balance of risks to inflation outlook for the next two years is still on the upside despite another slowdown in the rate of price increases, the Bangko Sentral ng Pilipinas (BSP) said Wednesday. Citing its latest inflation assessment, the BSP said

housing chief said.

With the right strategies in place, Acuzar is confident to reach the flagship program's target of bridging the country's 6.5 million housing gap moving from ground up toward sustainable development. (dhsud/pia-ncr)

in a statement that "the effect of supply shortages on domestic food prices remains a concern, while the potential impact of higher transport fares, increasing electricity rates, as well as above-average wage adjustments in 2023 point to the broader-based nature of price pressures."

The BSP thus vowed to continue to adjust its monetary policy stance as necessary to "prevent the further broadening of price pressures, as well as the emergence of additional second-order effects."

"The BSP also continues to call for the timely and effective implementation of non-monetary government measures to mitigate the impact of persistent supply-side pressures on inflation," it added.

The Philippine Statistics Authority (PSA) reported the second consecutive month of deceleration of inflation rate to 7.6 percent in March from last February's 8.6 percent, bringing the average inflation for the three-month period to 8.3 percent.

Core inflation, which excludes volatile oil and food items, meanwhile, accelerated to 8 percent last month from 7.8 percent in February.

March's inflation rate was within the central bank's 7.4 percent to 8.2 percent projection for the month.

The BSP said it is "consistent with the overall assessment that inflation will remain elevated over the near term before gradually decelerating back to target range towards end-2023."

The government's inflation target until 2024 is between 2 percent and 4 percent and the BSP forecast inflation to average 6 percent this year and 2.9 percent next year. (PNA)
