CAVITE CONDUCTS A LEARNING VISIT AT NCDA AND RESOURCES FOR THE BLIND, INC.

In its continuous thrust to capacitate persons with disability officers and focal persons in Cavite, the provincial government, thru the Office of the Provincial Governor – Office of the Provincial Persons with Disability Affairs Officer headed by PDAO Officer IV Marie Shiela Antenor-Haloc, initiated an Orientation of Disability Programs and Services and Agency Visits at the National Council on Disability Affairs (NCDA) and Resources for the Blind, Inc. (RBI) in Quezon City last April 20, 2023.

The learning visit aimed to familiarize participants with the selected agencies' programs and services and gain new insights into the delivery of effective programs and services for the disability sector.

The event was joined by almost 50 PWD advocates consisting of some of the members of the Provincial Council on Disability Affairs, headed by 1st District Board Member Romel R. Enriquez, PDAOs, and Persons with Disability focal persons from the different cities and municipalities in Cavite.

The team was warmly welcomed by NCDA Executive Director Joniro F. Fradejas.

His message emphasized that individuals with disabilities themselves or social workers are the most suitable candidates to head the disability affairs office, as they possess a deep understanding of the needs and desires of people with special needs.

Mr. Randy Calseña, the Regional Programs Coordinator, discussed the programs and services including the policy formulation and program development coordination framework of the NCDA.

Atty. Walter Jason Alava provided updates on disability laws such as RA 7277 or the Magna Carta for Disabled Persons, RA

11228, an Act Providing for the Mandatory PhilHealth Coverage for All PWDs, RA 10747, or the Rare Disease Act of the Philippines, and RA 10754, An Act Expanding the Benefits and Privileges of PWDs.

The highlight of the activity was a tour of the NCDA and Disability Resource and Development Center (DRDC) which was facilitated by Ms. Delfina Baquir and Atty. Walter Jason Alava, Regional Programs Coordinators, where the participants had a glimpse of some of their facilities and offices which include the Information, Education, and Communication Division, Office of the Executive Director, Broadcast Studio Room, Prayer Room, E-Library, and their ramp with breathtaking views that connects from the 7th floor to the ground.

After the visit to NCDA, the group then proceeded to the RBI where they were welcomed by the team headed by Ms. Lily Torrente, RBI Executive Director.

Ms. Lorinda Ang, Resource Development Department Head shared the history of the RBI.

Some of the RBI programs and services were also tackled such as the Going Beyond Reading and Nivea Project, Bookshare and E-Library, Higher Education and Employment, Siloam-RBI Mobile Library Demo, and the Eye Care/Low Vision Services.

Ms. Torrente encouraged the attendees to refer individuals with visual impairment to RBI for assistance so that they can support them to achieve their fullest potential in life. Following the discussion, a tour of the RBI facility commenced which included visits to the Braille production room, low vision center, and Gabay Project area.

RDC, partners stage grand Innovation Day Expo in NorthMin

In celebration of the National Innovation Day on April 21 as mandated by the Philippine Innovation Act and the vibrant innovation ecosystem of Northern Mindanao led the Regional Development Council (RDC) in region 10 and partners to stage a three-day exposition of innovation impact, interactive experience and investment opportunities activities in April 20-22, 2023 at SM Uptown, Cagayan de Oro City.

The three-day event was made possible through the leadership of the lead convenor, the National Economic Development Authority. The co-convenors are the Regional Research, Development and Innovation Committee through the Department of Science and Technology; Regional Inclusive Innovation Centers (RIICs) through Department of Trade and Industry, and the Cagayan de Oro Chamber of Commerce as lead program coordinator.

Several partner government agencies have also contributed resource speakers, technologies, and innovation. Among these agencies are the Department of Information Communication and Technology (DICT), Department of Agriculture, PHILHEALTH, Intellectual Property Office of the Philippines, Philippine Information Agency, Technical Education and Skills Development Authority, and more. Partner state universities and colleges, various consortia, innovation hubs, LGUs, and the SM CDO uptown are also active partners of this event.

As one of the leading catalysts for innovation in the Philippines, DOST showcased its program, projects, and technologies for MSMEs, people's organizations, students, and industry-partners anchored in the theme, "Strengthening the Innovation Ecosystem in Region X."

Among the highlights of the agency is the showcasing of DOST Technology Hub, an online portal/website that serves as a catalog of scientific and technological innovations and services. More than a thousand DOST technologies are now readily accessible to everyone. This includes processes on adoption, transfer, and commercialization.

In a recorded message, Sec Renato U. Solidum Jr congratulates the organizers for the conduct of the event. He encouraged stakeholders to sustain efforts to strengthen the innovation ecosystem in Northern Mindanao.

"The innovation ecosystem in Northern Mindanao is vibrant, that is why we have prepared three days of activities centered in the three thematic areas that we think are very important to move the

innovation ecosystem forward: Innovation Impact, Interactive Experience, and Investment Opportunities," said DOST-X Officer-in-Charge, Engr. Romela N. Ratilla during the opening ceremony.

The DOST exhibition is inspired by the event's three thematic areas: For innovation impact, DOST has highlighted various programs and projects that support and boost the innovation initiatives in the region. For interactive experience, the Regional Standards and Testing Laboratories have prepared interactive games for science enthusiasts. For investment opportunities, technical staff are ready to assist walk-in clients on their inquiries and provide them tech-based games with exciting prizes.

Also the crowd magnet is the Planetarium setup in partnership with the Philippine Atmospheric, Geophysical and Astronomical Services Administration, Mindanao Division led by Mr. Anthony Joseph R. Lucero. Parents brought their kids to experience the Planetarium and then proceeded to view the exhibits and listened to innovation talks.

Innovation talks included technology pitching, accomplishments from innovation centers, technology business incubators, success stories from MSMEs innovation fund grants from DICT, investment opportunities from Pilipinas Shell Foundation, Crowd Funding and parametric insurance as response to disaster risk and climate change from CLIMB's Insurance.

The national innovation day is aimed to promote public awareness and national support for innovation and highlight milestones of government and private sector initiatives. All current innovation-related events are encouraged to be conducted in the month of April for the said celebration.

During the opening ceremonies RD Mylah Faye Aurora B. Cariño of NEDA presented the Regional Innovation Agenda of Region 10. This is the guiding framework, strategies and goals of the innovation players collectively.

AMBIT or Amihanang Mindanao Breakthrough Innovations and Technologies Awards proposal was bared by DOST-10. AMBIT awards are designed to honor innovators and enablers in the innovation ecosystem.

The National Innovation Day celebration is anchored to RA 11293 or the Philippine Innovation Act. This act is adopting innovation as a vital component of the country's development policies to drive inclusive development, promote the growth and national competitiveness of MSMEs.

Modernization bill aims to minimize and prevent casualties and property losses from earthquakes and volcanic eruptions

As we all know, the Philippines is in the Pacific Ring of Fire, where volcanic eruptions and earthquakes are common.

However, probably many of us do not know that the country has 24 active and 27 are potentially active volcanoes. And out of these 24 active volcanoes, only 10 are being monitored. Moreover, of the 10 monitored active volcanoes only two—Taal and Mayon—have complete monitoring systems.

The human and economic impacts of an insufficiently equipped active volcano is high. Cabalian Volcano, an active volcano located in Southern Leyte, does not have sufficient monitoring instruments. If its activity is not monitored, 240,000 individuals, and 30 airports could be affected by volcanic ash.

Meanwhile, the Philippines also lags in earthquake monitoring, with only 117 seismic stations, while Taiwan, which is one-tenth the size of the Philippines, has 194.

In a consultative meeting held on 18 April 2023, at the Philippine Institute of Volcanology and Seismology of the Department of Science and Technology (DOST-PHIVOLCS) headquarters in Quezon City, Director Teresito C. Bacolcol shared all the data and information that would further justify the urgency of the passage of the DOST-PHIVOLCS modernization bill.

The DOST-PHIVOLCS modernization bill aims to modernize the operations of the agency and enhance their ability to provide timely and accurate information, warnings, and recommendations to the public, government agencies, and other concerned stakeholders in the event of natural disasters.

The bill includes allocating funds, which will be around seven billion, for the acquisition and maintenance of state-of-the-art equipment, infrastructure improvement, research and development, and capacity building of DOST-PHIVOLCS personnel.

In his presentation, Dir. Bacolcol explained the need to strengthen the monitoring systems and capability of DOST-PHIVOLCS. He said that the DOST-PHIVOLCS needs to add more seismic stations in the country to effectively increase the detectability and locate small earthquakes particularly for faults that exhibit low activity prior to large events. In addition, a denser network would help reveal active faults that have no clear surface expressions.

On the other hand, for tsunami

monitoring, through this modernization bill, DOST-PHIVOLCS plans to establish at least 50 more stations for tsunami detection for coastal communities at risk to tsunamis, develop effective warning systems, and install sensors offshore close to tsunami sources.

Dir. Bacolcol also said that 21 out of 24 active volcanoes have incomplete hazard maps, putting at risk 28 provinces. Meanwhile, 27 potentially active volcanoes have incomplete hazard maps, putting 17 provinces at risk. He also emphasized that only 38 out of 82 provinces have complete earthquake hazard maps.

"Filipinos would greatly benefit from the passage of this modernization bill. Many of us are aware of the impacts of destructive earthquakes and volcanic eruptions. Casualties, property losses, all of these will be prevented or minimized if we have adequate monitoring equipment across the country. This will greatly help us formulate policy recommendations and guidance to our LGUs and communities," said Dir. Bacolcol.

On the other hand, when it comes to the status of the bill, House of Representatives' S&T Committee Secretary Donald Amado Montes Caballero shared that the DOST-PHIVOLCS Modernization Bill has already been approved at the committee level. A substitute bill is being consolidated from the 12 measures presented in the House of Representatives. He explained that after this, it will be referred to the Committee on Ways and Means and to the Committee on Appropriations, after which a committee report will be crafted. The bill will then be presented to the plenary deliberations for the approval of the House of Representatives.

The DOST-PHIVOLCS modernization bill is introduced in the Congress by representatives Joey Sarte Salceda, Ron P. Salo, Carlito S. Marquez, Ralph G. Recto, Anna York P. Bondoc, Michael L. Romero, Angelo Marcos Barba, Ferdinand Martin G. Romualdez, Yedda Marie K. Romualdez, Jude A. Acide, Manuel Jose M. Dalipe, Ferdinand Alexander A. Marcos, Rufus B. Rodriguez, Jurdin Jesus M. Romualdo, Richard I. Gomez, Joseph Gilbert F. Violago, Jeyzel Victoria C. Yu and Dante S. Garcia.

This stakeholders' consultative meeting was spearheaded by the DOST-Legislative Liaison Office, in partnership with the DOST-PHIVOLCS and the Committee on Science and Technology of the House of Representatives. The objective was to get inputs and insights from key stakeholders from the local government units, other national government agencies, academic institutions, and private sectors for the further improvement of the provisions indicated in the draft bill. Catch up immunization drive continues as cases of measles, rubella rise in CALABARZON

CABUYAO CITY, Laguna (PIA) — The Department of Health has urged parents to have their children vaccinated against measles-rubella and polio noting an "alarming" rise in measles and rubella cases in Region IV-A in the first quarter of 2023.

Dr. Gloria Balboa, DOH Assistant Secretary for Health Policy and Infrastructure Development, said a slowdown in the vaccination of children was observed during the Covid19 pandemic and that cases of measles and rubella doubled for the first three months of the year.

From 30 cases in 2022, there are now 62 cases of measles and rubella in the Calabarzon region, from January 1-April 15, 2023, the DOH Center for Health Development IV-A said.

Balboa described the increase as alarming and urged parents to get their children immediately vaccinated.

"Ito yung i-spread nating news sa ating mga kapitbahay, sa ating mga kamag-anak na kapag meron silang mga chikiting na 0 to 59 months ay dalhin na po sa pinaka-malapit na health center para mabakunahan. Ito po yung isang pagpapatunay na mahal ninyo ang inyong mga anak," Balboa said.

She added: "Magpasalamat po tayo na sa dami ng sakit, may mga sakit na pwedeng ma-preventan ng pagbabakuna. Meron tayong panlaban na pwedeng gamitin. So let's avail of this, wag natin itong ipagwala lang bahala."

The government's series of ceremonial immunization drive against measles-rubella and polio continued in Cabuyao City in Laguna on April 25 prior to the nationwide vaccination campaign next month.

In attendance were Laguna Governor Rami Hernandez, 2nd District Rep. Ruth Mariano Hernandez, Cabuyao City Mayor

Dennis Hain, Department of the Interior and Local Government (DILG) IV-A Regional Director Ariel Iglesia, representatives from the Philippine Pediatric Society-Southern Tagalog Chapter and local officials and employees.

Hundreds of parents together with their kids in superhero costumes attended the launching of the Chikiting Ligtas: Measles Rubella-Oral Polio Vaccine Supplementary Immunization Activity (MR-OPV SIA) at the Cabuyao Athletics Basic School (CABS), Brgy. Banay-banay, Cabuyao City.

The DOH targets to immunize at least 95% of children from nine months to 5 years old against measles and rubella, and children from 0 months to 5 years old against polio.

Cabuyao City Mayor Hain, meanwhile, thanked DOH IV-A and the DILG IV-A for their continued support to the communities in the region, and appealed to parents in the city to express their support to the initiatives being done by the government.

Governor Hernandez also showed his support to the programs of the DOH and DILG and reiterated the importance of public health in the province as shown during the COVID-19 pandemic. Public health remains the priority of his administration, according to the governor.

"Mga kalalawigan po natin sa Laguna, iisa po ang ating direksyon bawat siyudad bawat munisipyo isa ang ating direksyon. Priority natin ang kalusugan sa lalawigan ng Laguna."

Under the MROPV SIA 2023 campaign, the DOH will employ different strategies to reach the public.

Personnel and volunteers will conduct house-to-house vaccination while free vaccines will be made available in health centers, markets, plazas, and malls. (CH/PIA-Laguna)

First space cooperation programme to help Ph develop better response to disaster, climate change

QUEZON CITY, (PIA)

— The first space cooperation programme in the region, will help Philippine authorities develop national systems by using European Union's (EU's) earth observation satellites data in the country's disaster mitigation and climate change adaptation and food security strategies.

On Monday, (24 April 2023), the Philippine Space Agency (PhilSA), the Department of Science and Technology (DOST), and the EU launched the Copernicus Capacity Support Action Programme for the Philippines (CopPhil) worth approximately Php 610 million or €10 million.

According to the PhilSA,

the EU's earth observation flagship programme, Copernicus provides free environment and climate data derived from a constellation of satellites—the Sentinels—which monitor the earth and its many ecosystems 24-hours daily. This free information aims to help public authorities, businesses, and international organisations mitigate climate change impacts and build a sustainable future for all.

During the launch, Science and Technology Secretary Renato Solidum welcomed Copernicus and the Copernicus programme in the Philippines as "A long-awaited cooperation on an innovative system that will provide the Philippines new opportunities to develop earth observation applications for disaster risk reduction and management,

environmental protection, and climate change adaptation."

"The Agency welcomes this partnership with the European Union as it strengthens the domestic space value chain, particularly the ability to process and use satellite images and spaceborne data to better manage, and protect our environment and natural resources, and be better prepared in the face of disasters and climate change," PhilSA Director General Joel Marciano Jr. said.

H.E. Luc Véron, European Union Ambassador to the Philippines, said that "The Copernicus programme for the Philippines is a pioneer initiative in Asia and Asia

Pacific and a starting point for a larger programme on Digital Connectivity. The programme will enhance capacities for a stronger and more shock-resilient Filipino economy and society."

"In the long term the European Union is exploring the possibility to create a network of Copernicus partners in the ASEAN region aside from other parts of the world. The uptake of innovative technologies such as Copernicus will trigger growth, jobs and modernisation of digital infrastructures that can be used in many sectors in the Philippines", Ambassador Véron said. PH is 5th worldwide in 'zero-dose children' -UNICEF

QUEZON CITY, (PIA) -- Trust in giving vaccines to toddlers dropped by 25 percent amid the COVID-19 pandemic, making the Philippines one of the countries with the most number of "zero-dose children" in the world.

"Of the 67 million children globally, who missed out on routine vaccination between 2019 and 2022, 48 million did not receive a single routine vaccine, also known as 'zero-dose.' The Philippines has one million zero dose children, the second highest in East Asia and the Pacific Region, and the fifth highest globally," according to UNICEF Tuesday, in line with the observance of World Immunization Week 2023.

The agency said that public perception of the importance of vaccines for children against various diseases has decreased in 52 of the 55 countries studied.

"According to the Vaccine Confidence Project and published today by UNICEF, the perception of the importance of vaccines for children declined by about 25 [%] in the Philippines and by more than a third in the Republic of Korea, Papua New Guinea, Ghana, Senegal, and Japan after the start of the pandemic," UNICEF said in a statement earlier.

Only China, India and Mexico maintained or improved the perception of the importance of the vaccine.

In most countries, people aged 35 and under appeared to be more likely to have low trust

for children after the pandemic began.

However, overall support for vaccines remains high at the moment. In half of the 55 countries surveyed, 80 percent said it was important for children.

Among the routine vaccinations given in the Philippines are against tuberculosis, hepatitis B, polio, pneumonia, measles, mumps, rubella, etc.

Vaccine hesitancy in the Philippines According to UNICEF, which is a United Nations agency that responds to youth welfare, vaccine hesitancy in the Philippines can be attributed to cultural factors and fear of the health of vaccines.

"At the height of the COVID-19 pandemic, scientists rapidly developed COVID-19 vaccines that saved countless lives. But despite this historic achievement, fear, and disinformation about all types of vaccines circulated as widely as the virus itself," said Catherine Russell, executive director of UNICEF.

"This data is a worrying warning signal. We cannot allow confidence in routine immunizations to become another victim of the pandemic. Otherwise, the next wave of deaths could be of more children with measles, diphtheria, or other preventable diseases."

It can be recalled that those opposed to vaccination against COVID-19 protested during the height of the deadly virus in the Philippines. (PIA-NCR)

PAO appeals acquittal of dentists who nixed to treat HIV patient

MANILA — A discrimination suit was filed before the Supreme Court (SC) by the Public Attorney's Office (PAO) Wednesday in behalf of an individual infected with human immunodeficiency virus (HIV) who was refused treatment by his dentists.

In a petition, the PAO asked the High Tribunal to review the Court of Appeals' (CA) decision that denied the complainant's appeal on the decision handed by the Taguig City Metropolitan Trial Court (MeTC) regarding the criminal complaint he filed against Dr. Sarah Jane Mugar and Dr. Mylene Guevarra-Igrubay.

The man, a Makati resident, filed the complaint for alleged violation of Sec. 40 of RA 8504, otherwise known as the Philippine AIDS Prevention and Control Act, before the Taguig court, which acquitted the two.

Court records show that the complainant, on Valentine's Day of 2017, sought treatment for his left molar, and after an initial examination it was determined that the molar needed to be extracted. However, he was informed that he needed to first undergo clotting or bleeding diagnostic

test. Upon his return, following the completion of the test, he was informed by the dentists that they cannot conduct the molar extraction because they do not have ultraviolet-type sterilization equipment.

"Obviously, the excuse given by Dr. Mugar and Dr. Guevarra-Igrubay was hard to believe considering that EDC (the dental clinic) boasts of advance dental equipment on its website. (The complainant) was even asked to secure a clearance so that an appointment can be made. The reason for the denial was apparent -- this is because (the complainant) is afflicted with HIV," the PAO said.

The complaint said that "in the Philippines, laws on anti-discrimination are already in place. But unless the law is enforced and the state recognizes acts of discrimination, discrimination will never end."
