CAVITEX converts 'cash lanes' to 'cash, RFID'

PARAÑAQUE CITY (PIA) The local government of Parañaque announced Wednesday that a number of "cash lanes" of the Manila-Cavite Expressway (CAVITEX) has been converted into "cash and RFID lanes."

According to a post on Parañaque City Mayor Edwin Olivarez's Facebook page, the conversion was done to support the Department of Transportation's implementation of the 100% cashless transactions via the Radio Frequency Identification (RFID) system.

Two leftmost Southbound lanes at the Parañaque Toll Plaza has been converted to a 'mixed lane' along with

the said toll plaza's two leftmost Northbound lanes. One lane of the Northbound Kabihasnan Toll Plaza was also converted.

Motorists may avail of the RIFD by going to the nearest Easytrip station, fill out the application form, and pay the initial load of P200. The Easytrip account will be activated within 24 hours

The RFID system for toll payments in Cavitex uses a small, self-contained communication device that is mounted on the vehicle's windshield or head lamp to enable radio frequency communication and pass through the toll gates with ease. (PIA-NCR)

MANILA - The Supreme Court (SC) has upheld the conviction of a man for murdering his childhood friend following altercations over illegal electric lines in their area.

In a 12-page decision dated September 2 written by Associate Justice Ramon Paul L. Hernando and made public Tuesday, the high court's Second Division ordered accused Eddie Manansala alias "Eddie Pusa", who was sentenced with reclusion perpetua (over 40 years imprisonment), to also pay PHP300,000 in damages to the family of his victim, Armando Ramos.

Closed-circuit television (CCTV) footage presented by the prosecution showed that Manansala entered the house of the victim on Severino Reyes St. in Tondo, Manila, and shot him.

Manansala, who denied the crime, claimed he had known Ramos since he was 13 years old and that he was the one doing the repairs for his electricity and water supply.

Despite the favors he did for him, Manansala claimed that Ramos bore ill feelings towards him because of the illegal power connections he installed.

He was arrested by police on Nov. 5, 2013 at the house of a friend in San Jose Del Monte City, Bulacan, three days after the incident. (PNA)

Pag-IBIG Fund grants 60-day grace period, offers special loan restructuring to aid borrowers

PASIG CITY (PIA) -- The Pag-IBIG Fund has announced the granting of a 60-day grace period on all loan payments as well as a special loan restructuring program for home loan borrowers in its efforts to provide members financial relief amid the pandemic.

According to Pag-IBIG, Secretary Eduardo D. del Rosario of the Department of Human Settlements and Urban Development and Chairman of the 11-member Pag-IBIG Fund Board of Trustees, said they have granted a one-time 60-day grace period on payments of all loans in accordance with the Bayanihan to Recover as One Act or Bayanihan 2, while providing its housing loan borrowers in arrears with a Special Housing Loan Restructuring Program to help update their accounts and keep their homes.

"We heed and support President Duterte's call to help our fellow Filipinos who are experiencing financial hardships brought about by the COVID-19 pandemic. We recognize that this pandemic con-

tinues to impact jobs and businesses in the country," said del Rosario in a release.

Del Rosario added that under Pag-IBIG Fund's guidelines, the granting of the 60-day grace period will be applied automatically to all loan payments on the agency's Multi-Purpose Loan, Calamity Loan, and Housing Loan which fall due from September 15 until November 14, 2020. The grace period will give borrowers payment reprieve without incurring any penalty, and interest on interest.

"Under the Bayanihan 2 law, the grace period covers loan accounts with up to three months in arrears. But under our approved Pag-IBIG guidelines, we will cover loan accounts with up to nine months in arrears so we can help more borrowers, specifically those whose incomes were affected when community guarantines were first declared in mid-March. And while the accrued interest is payable runtil December 31 under the Bavahihan 2. Pag-IBIG

Fund will allow payment of accrued interest on a stagdered basis during the remaining term of the loan, thus providing for an even longer and easier payment term for our borrowers," he said.

The Special Housing Loan Restructuring Program, meanwhile, aims to further help Pag-IBIG housing loan borrowers save their properties from foreclosure. Under the program, borrowers whose finances have been affected by the pandemic may renegotiate the terms of the loan and secure a more affordable payment term. Borrowers can soon apply for the restructuring program online by visiting the Virtual Pag-IBIG juntil December 15, 2020.

"After our string of 'best year ever,' this is the time for Pag-IBIG to show how much we care about our member-borrowers. Under Bayanihan 1, we granted a grace period to 4.77 million borrowers and approved nearly 300,000 applications under our 3-month payment moratorium program. And now,

UN-WFP Donates Motor Vehicles to Bureau of Customs

IN line with the Bureau of Customs' (BOC) commitment to enhance security and enforcement capabilities, the BOC on September 28, 2020 received 4 motor vehicles from the United Nations World Food Programme (UN-WFP). The turnover was done at the OCOM Conference Room, Port of Manila.

The ceremony was attended by BOC Commissioner Rey Leonardo B. Guerrero together with the Deputy Commissioners. On the part of UN-WFP, Mr. Mate Persson, World Food Programme Philippines Representative and Deputy Country Director turned-over the vehicles.

Initially, the vehicles were surrendered by the UN-WFP to the BOC for proper disposition as these were already used but were not allowed to be sold locally as imported tax-exempt.

Through close coordination between the Bureau and UN-WFP it was decided that the vehicles be donated instead to the BOC as part of the agency's enhancement of the logistical and enforcement capabilities.

Consist of 3 Landcruiser SUVs and 1 BMW motorcycle, the motor vehicles shall be used to improve logistical performance and overall operational capability of the BOC to eliminate smuggling in the country. In his statement, BOC Commissioner Rey Leonardo B. Guerrero expressed his grattitude to the UN-WFP. He is optimistic that the vehicles will greatly improve the mobility of the Bureau's Enforcement and Security Service (ESS) which is responsible for anti-smuggling and other law enforcement activities. Hontiveros urges increased budget for local disease surveillance amid surge of COVID-19 critical cases

SENATOR Risa Hontiveros called for an increase in the 'alarmingly low' funding allocated for local disease surveillance under the 2021 Proposed National Budget after the Department of Health (DOH) reported a 2% surge in COVID-19 critical cases.

The approved allocation for Epidemiology and Surveillance Units (ESUs) meant to collate and validate data during disease outbreaks, according to Hontiveros, is 79% lower than the requested funding of the DOH. "P547M ang hiningi ng DOH, pero nasa P112M lang ang ibinigay para sa Epidemiology and Surveillance Units (ESU). This particular budget allocation raises questions about our priorities," she said.

"Hindi dapat babaan ang pondo habang dumarami ang nagiging kritikal dahil sa COVID-19," Hontiveros added. "We must fully support the DOH's efforts to find the cause to prevent further spread of the virus by allocating more funds for the ESUs."

The ESUs, Hontiveros said, are mandated by law under RA 11332 or the Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act, to 'prepare us to prevent and control disease during a crisis like this by collecting and monitoring data'. The senator expressed her dismay that only 2 of 79 provincial ESUs, 11 of 16 regional ESUs and 9 of 135 city ESUs are functional.

"Ang taas ng pondo natin sa hiring ng contact tracers, pero kanino sila magrereport kung walang ESU? Sasayangin din natin ang bilyon-bilyong piso kung magiging chopsuey lang pala ang proseso natin. for granted. Laging huli

ang galaw natin kasi huli din ang datos natin. By under-funding ESUs, parang binugbog pa natin yung pilay na nating health response." Hontiveros said. Hontiveros highlighted that even areas outside of the National Capital Region (NCR) that were able to maintain zero infections since the start of the year are now reporting cases 'because of slow contact tracing and streamlining of data'.

"Dapat masigurado natin na mamuhunan ang mga systema natin for data monitoring and validation hanggang sa mga munisipal, sa buong bansa. Kahit ilang libong contact tracer ang i-hire natin, hindi ito magkakaroon ng silbi kung walang ESU na maglilinis ng datos," she said.

Hontiveros reiterated her concerns about the wrong priorities of the 2021 budget, citing a Php 16.4 B lump-sum dedicated to the funding of the National Task Force to End Local Communist Armed Conflict during a public health crisis.

"With issues of possible government-linked propaganda pages on social media surfacing, it raises the question about what this lump-sum can be abused for. Inuna pa natin ang paghahabol sa mga diumanong komunista kaysa sa paglalaban sa sakit kung saan apektado ang buhay at kabuhayan ng lahat ng Pilipino. Mas dapat ilagay iyan sa health budget natin kaysa maging posibleng fake news fund pa ito," she said.

"Ang isa sa pinakamalaking pagkukulang ng pandemic response natin ay ang pagkukulang sa datos natin. Tumataas at lumalala ang mga kaso dahil hindi pa natin nakikita ang buong imahe ng COVID-19 sa bansa. If we channel our funds correctly, we will save Filipinos' lives and money. That must be our priority first and foremost, "Hontiveros concluded. *PR*

He also mentioned that they conducted a mangrove assessment in Noveleta, Cavite for the planned establishment of science-based mangrove site in partnership mangrove site in partnership with the Forest Foundation Phil-ippines and the Zoological So-

ippines and the Zoological Society of London, and reviewed the draft five-year work plans of eight People's Organizations under the Community-based Forest Management. With regard to the efforts of the regional department under the Intensified Forest Protection and Anti-Illegal Logging Program, Tamayo said the office through its Enforcement Division and its counterpart units at the field offices strictly monitor the operacounterpart units at the field offices strictly monitor the operation of lumber dealer and wood
processors, closely coordinate
with the law enforcement agencies, deputizes volunteers as
Environment and Natural Resources Officers, conduct close
monitoring of illegal environmental activities in forest areas
through the LAWIN System,
and immediately respond to the
threats observed on field and to
the citizen reports on environthe citizen reports on environ-mental violations via the 8888 hotline.



In terms of improving land administration and management, Tamayo said the regional department already started implementing the Rapid Land Tenure Appraisal in Santo Tomas, Batangas and Magallanes, Cavite to hasten land titling under the DENR in the said areas. Tamayo further updated that they entered into an agreement with 11 Mineral Production Sharing Agreement (MPSA) holders and two Peoples Organizations for the "Offset Bamboo Plantation Program" within the Upper Marikina River Basin Protected Landscape in Antipolo City, in celebration of the World Bamboo Day last September 18, 2020 and as a way to uphold responsible mining. In response to the Covid-19 situation, Tamayo said the DENR Calabarzon initiated a Compassion Project as per Bayanihan Act of 2020, wherein, the donations collected from the officials and staff are used to procure personal protective equipment, hygiene and sanitation items.
