

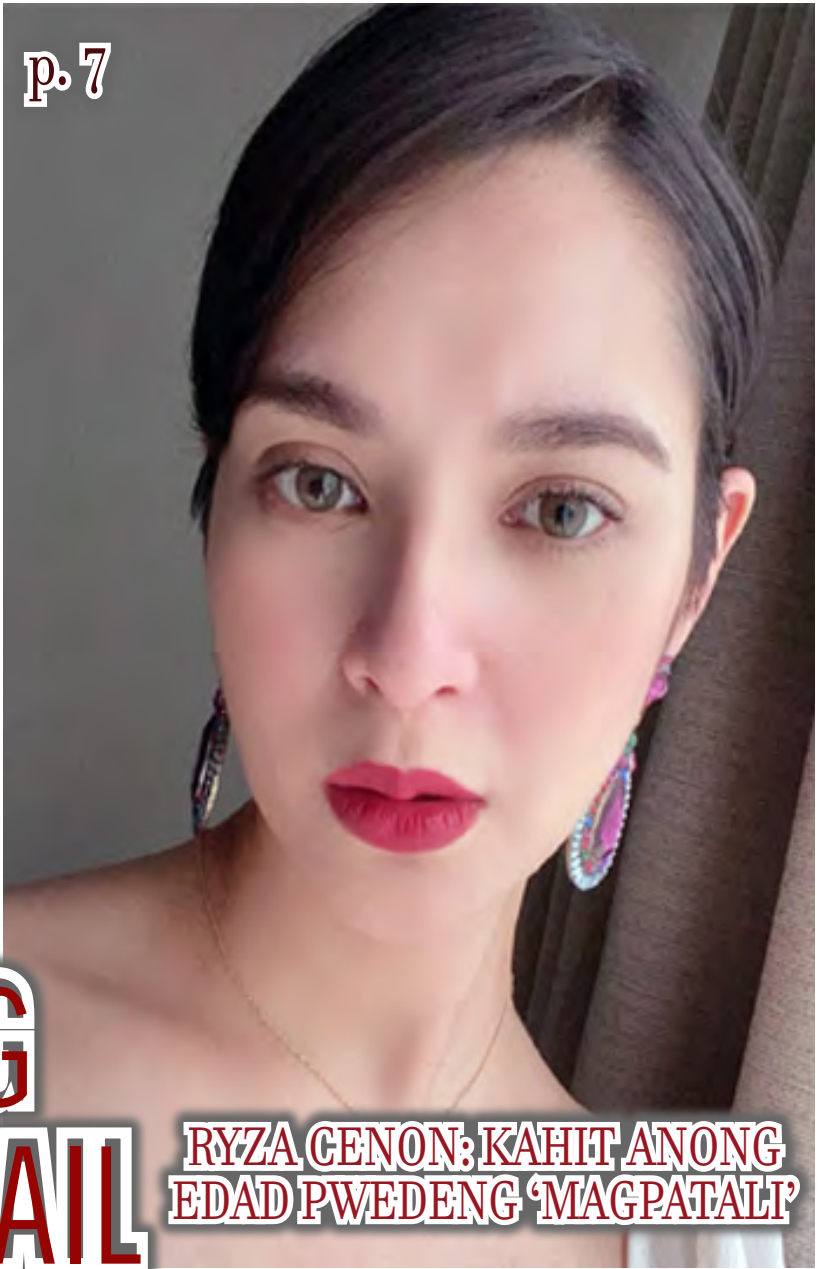

NAGING epektibo ang isinagawang dayalogo sa mga 'mayores' ng bawat grupo sa Cavite Provincial Jail.

Sinabi ni Provincial Jail Warden Gil Torralba, imbes na galugarin sa bisa ng "Oplan Galugad" ang piitan ay pinili nito ang pakipag-dayalogo sa mga mayores sa bawat grupo upang hikayatin ang nasasakupan nilang dormitoryo at boluntaryong isurender ang kanilang mga deadly weapons.

Umabot sa 63 pirasong deadly weapons ang isinurender ng mga inmates sa kanilang mga mayores. Ayon kay Torralba, ang ginawang dayalogo sa halip na Oplan Galugad ay isang hakbang din bilang pag-iingat sa COVID 19 para sa kanilang mga staff na mag-sasagawa ng paggalugad sa loob ng provincial jail.

Bukod sa dayalogo, isang Para-Legal Service ang

binuo rin ni Torralba kung saan ilang tauhan nito ang makikipag-usap sa mga matatagal nang inmates upang bigyan ng legal assistance para sa matatagal na nilang kaso at mabigyan ng panibagong pag-asa na posible pa silang makalaya.

Sa bagong pamumuno ni Torralba, pinapayagan rin ang mga inmates na makausap ang mga malalayo o 'di makabisitang mga kaanak sa pamamagitan ng E-Dalaw, isang online face to face communication.

Sa kabuuan, nasa 569 ang bilang ng mga inmate sa walong dormitoryo, 70 sa kanila ay mga kababaihan, pinakamaraming kaso pa rin ang droga na may 346 inmates, 287 sa kanila ang kalalakhian.

Si Torralba ay naupong bagong Provincial Jail Warden nitong Octubre. **GENE ADSUARA**

DOH-CALABARZON inaugurates Botika ng Bayan in Trece Martires City

CALAMBA CITY, Laguna (PIA) --DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) today inaugurated the fourth Botika ng Bayan (BnB) in the region located at the City of Trece Martires, Cavite.

"Sa tulong ng ating lokal na pamahalaan ay pananatilihin natin ito at bibigyan ng wastong pangangalaga upang hindi mapabayaanan at ito ay ating palalaksin sa pamamagitan ng pakikipag-ugnayan sa mga pribadong pharmaceutical companies upang sila ay makapaglagay ng mga gamot na dito sa BNB upang ang mga pasyente ay hindi na maghanap kung-saan-saan pa para sa kailangan nilang gamot at ito rin ay makukuha ng libre," Regional Director Eduardo C. Janairo stated in his message during the opening of the BnB at the city health office.

He added the collaboration with private multinational companies will provide the needed essential medicines and will ensure adequate supply for all BnB outlets.

Among the essential medi-

cines that are available includes paracetamol, antibiotics, topical ointments, anti-thrombotic, anti-inflammatory, antihyperlipidemic, anthelmintic, oral hypoglycemic, vitamins, micronutrients, antacids and other essential drugs for asthma, hypertension, diabetes and dyslipidemia even for family planning.

The Trece Martires BnB was made possible through the effort and cooperation of the city government. The outlet will provide quality outpatient pharmacy services to the residents of the city, especially the underprivileged patients.

The three other BNBs are located in Sta. Maria, Laguna, Mauban, Quezon and in Magallanes, Cavite.

Calamansi farmers train on product development, waste utilization

LOS BANOS, Laguna (PIA) --Oriental Mindoro

farmer-leaders, processors, and representatives from the private sector and government gained a good grasp of the calamansi processing industry and the opportunities and challenges in a seminar recently conducted by the Southeast Asian Regional Center for Graduate Study and Research in Agriculture (SEARCA). Government agencies represented included the Departments of Agriculture (DA), Science and Technology (DOST), and Trade and Industry (DTI).

Held virtually, the seminar focused on calamansi waste utilization and product development opportunities. It aimed to enable the participants to recommend interventions and strategies for potential calamansi products and enterprises.

The capacity building activity is under the project "Upgrading the Calamansi Value Chain towards Improving the Calamansi Industry of Oriental Mindoro" funded by the DA-Bureau of Agricultural Research (DA-BAR) and jointly implemented by SEARCA, University of the Philippines Los Baños (UPLB), Tokyo University of Agriculture (Tokyo NODAI), Mindoro State College of Agriculture and Technology (MinSCAT), and the local government of Victoria, Oriental Mindoro, said Dr. Pedcris M. Orencio, SEARCA Program Head for Research and Thought Leadership.

He explained that the project aims to bring together the strengths of the research institutions, in collaboration with the local government units, private sector and industries to address the technical and market constraints that confront the calamansi industry.

Dr. Orencio said the collaboration operationalizes SEARCA's Academe-Industry-Government (AIG)

to prevent illness.

Among the other municipalities who also applied for a BNB license to operate with the Food and Drug Administration namely San Luis and Tingloy in Batangas, Montalban in Rizal, San Narciso and Quezon in the province of Quezon. **(PIA-4A/DOH-CALABARZON)**

interconnectivity model to strengthen agricultural innovations and promote market-driven agribusiness models towards increased productivity and income of farmers and stakeholders. According to SEARCA study leader Dr. Matilde Maunahan, the seminar took off from the results and recommendations of the value chain analysis and the stakeholders' validation workshop to set the tone for further initiatives in calamansi enhancement and product development. Oriental Mindoro Provincial Agriculturist Christine Pine discussed the calamansi industry roadmap of the province. She explained the current production trends, products and markets, and the major constraints along the calamansi value chain. She said Oriental Mindoro is envisioned to be the number one supplier of quality fresh and processed calamansi products that are compliant with good agricultural and manufacturing practices and standards catering to both domestic and international markets.

University Researcher II Fides Tambalo of the University of the Philippines Los Baños (UPLB) discussed the food and non-food products derived from calamansi by-products like pulp, rind, and peels and their market potential. She said non-food products include essential oil, pharmaceutical and cosmetic products.

On the other hand, DOST-Industrial Technology Development Institute (ITDI) Senior Science Research Specialist Oliver C. Evangelista introduced the calamansi dietary fiber, which is an insoluble type of dietary fiber that can be derived from the pulp and peel of the calamansi fruit. He said the product prototype can be in the form of tablet, powder, and cookies.

Representatives from several institutions and the private sector gave their perspectives on the topics discussed and possible ways forward towards improving the calamansi industry of Oriental Mindoro. Those who expressed their support and pledged their commitment on behalf of their organizations were Ms. Corazon O. Sinnung, Regional Focal Person for the High Value Crops Division of DA-Region IV-B; Ms. Rachel B. Montero,

Andanar lauds Laguna for highest Covid-19 recovery rate

STA. CRUZ, Laguna -- The province of Laguna, which used to be one of the coronavirus disease (Covid-19) hotspots in earlier months, is now among areas with the lowest Covid-19 active cases and rising as the local government unit (LGU) with the highest recovery rate at 91 percent.

During the Pagdalaw sa Laguna: "Explain, Explain, Explain" conference on Wednesday, Presidential Communications Operations Office Secretary Martin Andanar lauded the development of the Covid-19 situation in Laguna.

The conference aims to present and bring closer to the people the programs and services of the national government amid the pandemic, and provide an avenue for stakeholders to acquire and share updates on the Covid-19 situation of the locality.

"Kailangan po natin maipakita sa buong Pilipinas kung gaano po kagalang ang Laguna na maresolba ang kaso ng Covid-19. We need to inspire yung iba pang probinsya sa labas ng Laguna at maipakita kung paano nagkakaisa ang LGUs dito. We should show the entire Philippines how united we are laban sa Covid-19 (We need to show the whole Philippines how well Laguna handled the Covid-19 cases. We need to inspire other provinces outside of Laguna and show that LGUs are united here. We should show the entire Philippines how united we are against Covid-19)," he said.

He said Laguna's accomplishment would serve as "symbol of hope" and good examples that can be emulated by other provinces as the country continues to grapple with the Covid-19 infections.

In previous months, high numbers of Covid-19 infections were reported in Metro Manila, Bulacan, Cavite, Laguna, and Rizal, prompting the National Task Force Against Covid-19 (NTF Covid-19) to des-

ignate Cabinet members to oversee said areas.

Andanar is the designated "Big Brother" of the anti-Covid coordination for Laguna, linking gaps among LGUs and state agencies and ensuring synchronized Covid-19 responses.

As of November 3, Laguna has a total of 13,925 recoveries and has only 1,063 active cases of Covid-19. It has so far logged 312 deaths.

Andanar assured that aside from Covid-19, the government maintains commitment to assist and respond to areas affected by typhoons and the pandemic, while bringing timely information needed in emergency cases and dismissing disinformation.

SC APPROVES MAGISTRATE'S EARLY RETIREMENT

MANILA – The Supreme Court (SC) on Tuesday confirmed the early retirement of one of its magistrates.

"The Court approved the application for disability retirement of Justice Priscilla Baltazar-Padilla effective today, 3 November," the SC Public Information Office said in a press statement.

No other details were provided by the court.

Baltazar-Padilla was appointed by President Rodrigo Duterte to the High Court last July, replacing Associate Justice Andres Reyes Jr., who retired in May.

Padilla joined the judiciary in 1996 as Presiding Judge

of Branch 29 of the Metropolitan Trial Court of Manila.

She was promoted to Presiding Judge of the Regional Trial Court of Manila Branch 38 in 2000. In 2006, she was appointed Associate Justice of the Court of Appeals and held the position for 14 years until her appointment to the Supreme Court.

She graduated from the Lyceum of the Philippines in Intramuros, Manila, and placed 5th in the 1984 bar examinations.

She is Duterte's 14th appointee to the High Court and would have reached the mandatory retirement age of 70 in 2028. **(PNA)**

CA orders release of Chinese man in drug bust

MANILA – The Court of Appeals (CA) has ordered the release of a Chinese national nabbed by agents of the Philippine Drug Enforcement Agency (PDEA) in a series of operations in Manila five years ago, which resulted in the confiscation of more than a kilo of shabu.

In a decision dated Oct. 29 and made public Tuesday, the CA's Eleventh Division reversed and set aside the Manila Regional Trial Court (RTC) Branch 7's decision against Jinshi Xu and ordered his immediate release from detention.

The court, in ruling in favor of the Chinese national, said only a barangay kagawad (councilor) was present during the marking, physical inventory, and photograph-taking of the seized items and that there was no representative of the National Prosecution Service (NPS) or the media even as the PDEA agents "had ample time to ensure the presence of the required witnesses considering that they were able to search the residence of accused-appellant by virtue of a search warrant". Xu was arrested on Sept. 19, 2015, by joint opera-

tives of PDEA Regional Offices 4-A (Calabarzon) and 11, who arrested Maribeth Hizon near a pharmacy on Taft Avenue, Pedro Gil, Barangay 690, Malate, Manila after she sold the contraband weighing approximately one kilogram, with an estimated street value of PHP1.2 million to an undercover PDEA agent who acted as a buyer.

However, Xu, the subject of the buy-bust who made the deal with the poseur-buyer, did not appear at the agreed meeting place but instead sent Hizon, his live-in partner, to hand over the illegal drugs during the transaction.

Two hours later, a follow-up operation led to the arrest of Xu and his 19-year-old cohort, Magaling Kurt, during a search of his rented condominium unit at the Empire Plaza Condominium, G. Masangkay Street, Barangay 264, Zone 24, Tondo, Manila.

Seized inside were one plastic bag containing suspected shabu weighing 114.1931 grams worth PHP137,000, a digital weighing scale, and a self-sealing plastic bag containing assorted drug paraphernalia. **(PNA)**

PH eyes P6-T borrowing to support economic recovery

MANILA – The government is keen on borrowing PHP3 trillion each in 2020 and 2021 to help boost funds for economic recovery, even as the main revenue-generating agencies have been posting upticks in their collections.

In a Viber message, National Treasurer Rosalia de Leon said the borrowing program will still be implemented even with the positive revenue performances of the Bureau of Customs (BOC) and the Bureau of Internal Revenue (BIR).

Economic managers said the increased borrowing for this and next year will be used to finance programs targeted to address the impact of the pandemic. On Tuesday, the BOC said it exceeded its PHP48.4-billion collection goal for October 2020 after revenues reached PHP50.9 billion.

It said last October is the fifth consecutive month

This collection, however, has declined compared to the PHP150.48 billion it collected in September last year.

As of the July 28, 2020 referendum meeting of the inter-agency Development Budget Coordination Committee, the BIR was tasked to collect PHP1.68 trillion this year while BOC's target was PHP506.15 billion. **(PNA)**

DENR CALABARZON PARTNERS WITH THE PRIVATE SECTOR IN THE ADOPTION OF NATIONAL GREENING PROGRAM SITES IN BATANGAS PROVINCE

The Department of Environment and Natural Resources (DENR) CALABARZON officially enters into an agreement with four companies for the adoption of selected National Greening Program (NGP) graduated sites in Lian, Calatagan and Balayan, Batangas, on October 29, 2020.

Puting Kahoy, Lian, Batangas established in 2013. TMP adopted a 10-hectare mangrove plantation in Brgy. Binubusan, Lian, Batangas established in 2016. And, SCPC-SLGPC adopted the identified 50-hectare NGP plantation in Barangay Patugo, Balayan, Batangas.

The department identified and selected the said areas for the reforestation project as the same suffered damages due to negligence and other unforeseen force majeure, hence, are needing further enhancement and rehabilitation.

The companies shall prepare and submit its respective development plans for

the reforestation project areas, mobilize the community by providing manpower and counterpart resources in the maintenance and protection of the said areas, provide counterpart resources intended for labor, materials and other contributions for the implementation of the project, and protect the existing man-made and natural vegetation and promote conservation of biodiversity within the project areas.

The regional department, on the other hand, shall assist the said companies in preparing its respective development plans, provide appropriate planting materials, and render technical assistance in species-site matching plantation establishment, proper protection and maintenance of planted seedlings and oth-

er assistance that may be required in the implementation and sustainability of the reforestation project. The MOAs with SLTEC, ADI and SCPC-SLGPC have an effectivity of 5 years. On the other hand, the MOA with TMP has an effectivity of 3 years. Such terms may be extended or renewed upon mutual written agreement of the parties.

The DENR-CENRO Calaca, Batangas has remaining 4,802.54 hectares NGP graduated sites which are potential for adoption. NGP graduated sites are areas within the previously established NGP plantations which need assistance from other government institutions or private sectors for continuous maintenance. **PR**

OPAPP welcomes study hailing PH as among Top 50 safest countries

MANILA – The Office of the Presidential Adviser on the Peace Process (OPAPP) has welcomed the results of a recently published study, which listed the Philippines as among the top 50 safest countries in the world in 2019.

Presidential Peace Adviser Carlito Galvez Jr. noted that peace is a shared responsibility among all stakeholders and that the current gains in peace and security are due to the collective efforts of the government and the public.

"We are glad to be recognized as among the safest countries in the world. Thanks to our law enforcers, peace workers, and everyone who has made a commitment to peace, we are moving forward as a peaceful, progressive, and resilient nation," Galvez said in a press release issued on Tuesday.

The 2020 Global Law and Order report by global analytics firm Gallup was based on interviews of around 175,000 respondents, across 144 countries and areas in 2019. Respondents were asked the following questions:

--In the city or area where you live, do you have con-

fidence in the local police force?

--Do you feel safe walking alone at night in the city or area where you live?

--Within the last 12 months, have you had money or property stolen from you or another household member?

--Within the past 12 months, have you been assaulted or mugged?

The Philippines registered a global index of 84, similar to Australia, New Zealand, Poland and Serbia.

Meanwhile, Singapore and Turkmenistan ranked first and second, respectively, both gaining a global index of 97.

DA allots PHP1-B fund for crop insurance, other aid for farmers

MANILA – The Philippine Crop Insurance Corporation (PCIC) has a PHP1 billion available indemnification fund to pay for the losses incurred by farmers following the onslaught of typhoons Rolly and Quinta, the Department of Agriculture (DA) said on Tuesday. "The farmers only need to coordinate with their respective regional government offices for assistance," Roy Abaya, DA director for field operations service, said in a virtual conference.

Farmers with registered farmlands may avail of the crop insurance, he added. Other than the PCIC, the Agricultural Credit Policy Council (ACPC) will provide those affected by the calamity with PHP25,000 from their Survival and Recovery (SURE) loan program.

At present, ACPC has a standby fund of PHP300 million wherein a loan of up

to PHP25,000 (PHP5,000 for emergency and PHP20,000 for recovery) will be provided, with zero interest and no collateral payable in 10 years, Abaya said.

DA's quick response fund (QRF) also maintains some PHP400 million, he said, adding that farmers can avail of this by presenting their damage reports.

"Depende kung ano ang nasira sa kanila (Depending on what was damaged in their properties), we can provide," he said.

As of noon of November 3, DA recorded some PHP2.56 billion losses in the agriculture industry.

"These financial assistance are on top of the available

reserve seeds that will be distributed to the affected farmers," Abaya added.

On Monday, DA Secretary William Dar said they will be facilitating the distribution of 133,000 bags of rice seeds and 17,545 bags of corn seeds for replanting. For the livestock and poultry industry, DA will also shoulder the distribution of medicines and biologics. It will also provide small ruminants and native chickens to those heavily affected by the calamity.

For the fisheries sector, the agency is readying some 10 million pieces of tilapia and milkfish fingerlings as well as fishing gears and paraphernalia for distribution. **(PNA)**

NHA OKs 2-month amortization suspension

MANILA – The National Housing Authority (NHA) has approved a two-month suspension of amortization or lease payments from residential account holders in all existing housing projects, NHA general manager Marcelino Escalada Jr. announced on Tuesday.

In a statement, Escalada said the suspension of amortization also covers commercial, industrial and institutional (CII) accounts. Escalada said the move came after the housing department issued a memorandum circular on Oct. 9, pursuant to the Republic Act No. 11494 also known as 'The Bayanihan to Recover as One Act.'

Escalada said the NHA targets to help its member beneficiaries and CII awardees/lessees ease

The qualified individuals to avail of the amortization are those with individual accounts or community associations, estate, and non-estate-based CII accounts within the regions (with updated accounts as of Oct. 31, 2020) and active accounts (with arrears of up to three months as of Oct. 31, 2020).

According to the NHA, there is no need for housing beneficiaries to apply for the moratorium, as it will be automatically processed for all existing residential and CII account holders.

The suspended amortization dues will not incur delinquency or additional interest charges, NHA said, adding that delinquency interest for CII accounts will be waived.

The NHA has earlier suspended its collection of amortization payments to its housing beneficiaries for three months—from March 16 to June 15, during the outbreak of the coronavirus disease 2019 in the country. **(PNA)**

BOC hits its revenue collection target for the 5th consecutive month

AMID these challenging times, the Bureau of Customs (BOC) continues to showcase its positive monthly collection for the fifth month since June 2020. Consistent with its mandate to collect lawful revenues for the country, BOC yet again surpassed its monthly target collection by 5.2% or P2.5 billion.

For October 2020, BOC collected a total revenue of P50.9 billion against its target of P48.4 billion.

Based on the preliminary report from the BOC-Financial Service, seven out of the seventeen collection districts exceeded their target for the month: Ports of Batangas, Manila, Zamboanga, Subic, Clark, Limay, and Cebu.

As of date, BOC collect-

ed P448.950 billion since January reflecting the 88.7% of the 2020 target collection – P506.150 billion.

BOC's positive revenue collection performance is attributed to the improved valuation and intensified collection efforts of all the ports, gradual improvement of importation volume and the government's effort in ensuring unhampered movement of goods domestically and internationally considering the pandemic situation.

Commissioner Rey Leonardo Guerrero once again commended the collective effort of the men and women of BOC who, despite the risk to their health and safety, showed their unwavering commitment and dedication to service. **PR**

Laguna execs air concerns on restarting industries, repatriation

SANTA CRUZ, Laguna (PIA) -- Local chief executives have expressed their concerns on recovering from the coronavirus diseases's impact on the health and livelihood of their constituents.

Together key agencies such as the Department of Health, Department of Trade and Industry, Department of Foreign Affairs, Department of Agriculture and the Philippine Information Agency - CALABARZON, Presidential Communications and Operations Office Secretary Martin Andanar continued the third leg of the 'Explain, Explain, Explain: Pagdalaw sa Laguna' to bring the national government's support to towns which have been reeling from the pandemic and its effects.

Dubbed as the country's slippers capital, Liliw municipal Mayor Ericson Sulibit proposed that the DTI resume its 'One Town, One Product' campaign, which proved very helpful in improving local livelihood in the past.

Aside from the resump-

tion of the OTOP, the local chief executive also suggested that assistance be given to hog raisers whose livelihood were damaged by the African Swine Fever.

Mayor Lourdes Arcasetas, whose town of Nagcarlan is only a few kilometers away, admitted that they share the same problem.

Arcasetas said most of her constituents, who mostly rely on agriculture and the booming pasalubong industry, are also suffering the pandemic's effects on their livelihood.

DTI Undersecretary for Consumer Protection Group, Atty. Ruth Castelo said that various programs such as: Negosyo Centers; Go Lokal! which provides MSMEs (micro, small and medium enterprises) access to stores and retail operators, and develop their products to become commercially viable; Livelihood Savings Program, and consumer care webinars for online sellers, are readily available to help them restart their livelihood.

Aside from restarting industries, Santa Cruz municipal Mayor Edgar San Luis said he is also concerned about the health risks of the Balik Probin-sya program.

"[Paano po ang] coordination with workers from high risk municipalities na nagpopositive sa company at dinanadala sa ibang municipality ng walang pasabi?" San Luis asked. [How do we coordinate with workers from high risk municipalities who tested positive in their companies, and are brought to other municipalities without informing (the concerned local government units)?]

Provincial governor Ramil Hernandez assured his colleague that as local chief executives, they are authorized to implement health protocols and impose sanctions to violators in order to protect their constituents.

ANG Ordinance No. SP-2942 ay ipinatutupad na ng pamahalaang lokal ng Quezon City.
