## LGU GENTRI TURNS OVER PRINTING EQUIPMENT TO PUBLIC SCHOOLS

GENERAL TRIAS, Cavite (PIA) – The local government here recently turned over printing equipment to the Schools Division of General Trias in support to the New Normal in the education sector.

Mayor Antonio 'Ony' Ferrer handed over three (3) units of Riso Comcolor with high speed inkjet printer (1 unit with offset stapling) and printing capacity of 120 pages per minute. The machine has a 24/7 printing operations capability, sorting function, and built-in standard hard disk used for printing modules, and activity sheets/worksheets.

Aside from the printing equipment, the LGU also provided more than 300 desktop computers including computer tables to the Schools Division.

The LGU will also ensure the continuous supply of bond papers and printer inks to the schools for utilization of the teachers in the preparation of Weekly Home Learning Plan (WHLP) and other teaching tools to monitor the learning progress of the students using the different learning modalities in education.

## DOLE, DA; LUMAGDA NG KASUNDUAN SA GIP

DAANG propesyonal sa agrikultura ang nakatakdang i-deploy sa iba't ibang tanggapan at proyekto ng Department of Labor and Employment (DOLE) sa ilalim ng programa nitong Government Internship Program (GIP).

Sa kasunduang nilagdaan kamakailan nina Labor Secretary Silvestre Bello III at Agriculture Secretary William Dar, daang technical at agricultural biosystem engineer at mga nagtapos ang magtatrabaho sa Department of Agriculture na tinatayang pupuno sa kakulangan para sa pangangailangan sa propesyon ng agrikultura.

Sa ilalim ng kasunduan, ang mga propesyonal sa agrikultura ay ide-deploy sa iba't ibang proyekto at tanggapan ng gobyerno.

Sinabi ni Bello na batay sa JobsFit Labor Market Information Report 2022, maraming trabaho sa sektor ng agribusiness ang in-demand ngunit mahirap mapunan. Kabilang dito ang Agricultural Economist, Animal Husbandry, Aqua-culturist, at iba pa sa sektor ng agricultural at biosystems engineering.

Ang in-demand occupation ay mga bakanteng trabaho na paulit-ulit na inaanunsiyo ng establisiyimento at industriya at may mataas na turnover o replacement rate.

Ang hard to fill occupation ay mga bakanteng trabaho kung saan nahihirapan ang kompanya na punan ito sa dahilang hindi kwalipikado ang mga aplikante o walang suplay ng mga aplikante. Nahihirapan din ang mga employer na punan ang mga trabahong ito dahil karamihan sa kwalipikadong aplikante ay mas pinipiling magtrabaho sa ibang bansa, naghahanap ng mas mataas na sahod o may problema sa iskedyul sa trabaho o lokasyon.

Sinabi ni Bello na bagama't itinutuon ng Pilipinas ang ekonomiya tungo sa manufacturing at service, ito pa rin ay isang agrikulturang bansa kung saan mahigit sa isang-katlong bahagi ng labor force ay nagtatrabaho sa agrikultura na binubuo ng pagsasaka, pangingisda, forestry at livestock.

## SC reprimands ex-gov't corporate counsel Jurado

MANILA - The Supreme Court (SC) has reprimanded former Government Corporate Counsel Rudolf Philip B. Jurado in an administrative complaint filed against him two years ago. In a 10-page decision dated Oct. 14 and released on Monday, Associate Justice Henri Jean Paul B. Inting said the court "reprimanded and sternly warned (Jurado) that a repetition of an offense of this character would be much more severely dealt with."

The complaint had been filed in connection with Jurado's issuance on July 25, 2017, of Opinion No. 174 extending the licensing jurisdiction of the Aurora Pacific Economic Zone and Freeport Authority (Apeco) which covered gaming licenses normally covered by the Philippine Amusement and Gaming Corporation (Pagcor).

On May 28, 2018, during a speech after the signing of the Ease of Doing Business and Efficient Government Service Delivery Act, President Rodrigo Duterte publicly announced Jurado's dismissal from the Office of the Government Corporate for overstepping his authority by allowing Apeco to issue gaming franchises beyond its juris-

Jurado, as then Government Corporate Counsel, should not only avoid all impropriety but also should avoid the appearance of impropriety in line with the principle that a public office is a public trust. Verily, any act that falls short of the exacting standards for public office shall not be countenanced," the court reminded Jurado.

## CA affirms dismissal of ex-solon's staff head in pork barrel mess

MANILA - The Court of Appeals (CA) turned down the appeal of a former chief of staff of a lawmaker in the House of Representatives seeking to void her dismissal over alleged anomalies in the use of pork barrel funds in 2007. In a decision dated Nov. 5 and made public on Tuesday, the appellate court's Special Sixteenth Division denied the petition for review filed by Hiram Diday Pulido and affirmed the dismissal order of the Office of the Ombudsman against her for grave misconduct and conduct prejudicial to the best interest of the service.

#### PETITION

PETITIONER through counsel unto this Honorable Court most respectfully states:

1.That petitioner is of legal age, married to the respondent, Filipino citizen and a resident of #11404 M. Reyes St., Brgy. Mabuhay, Carmona, Cavite but presently staying at Classic Flat 9 Misrah I Barrieri Msida Malta, being an Overseas Filipino Worker.

She is represented by the PUNZALAN FAUSTINO PUNZALAN MARASIGAN & ASSOCIATES LAW OFFICES where she may be served with the Honorable Court processes;

2. That respondent is also of legal age, married to the petitioner, Filipino citizen and a resident of Blk. 7B Lot 33 Brgy. Gregoria De Jesus, GMA, Cavite, where he may be served with the Honorable Court summons and other processes;

3. That petitioner's parent had been separated and she was previously staying with his father in Marinduque until sometime in 1990 when petitioner spent the school vacation with her mother in Carmona. Cavite:

4. That after her vacation, petitioner's father didn't fetched her in Carmona, Cavite constraining the petitioner to stay with her mother and later on, enrolled as third year high school student at Carmona High School;

5. That during her stay in Carmona, petitioner met new classmates and friends, one of whom is the respondent Marlon Dominguez;

6. That after their initial meeting, respondent courted the petitioner until the former won the heart of the petitioner. They started their relationship as boyfriend-girlfriend while they were both in forth year high school;

7. That petitioner and respondent's relation was on and off until they become intimate, which her mother later on discovered. Petitioner's mother became so uneasy of their relationship that one night, while they were staying at their house all by themselves, petitioner and respondent were just considered to have eloped;

8. That after the "pamamanhikan", petitioner and respondent finally got married on June 14, 1992 at the Philippine Independent Church in Biňan City, Laguna. Petitioner was surprised how she was able to get married to the respondent, being a minor at that time. Copy of their Certificate of Marriage is hereto attached as Annex "A"

9. That after the wedding, petitioner stayed with her parentin-law. Respondent meanwhile was able to get a job and their relationship as husband and wife started smoothy;

10. That later on, petitioner noticed changes with the respondent until she discovered that respondent has an extra-marital relation with his co-employee that resulted to their separation;

11. That petitioner still stayed with her in-laws until after two (2) months when the respondent came back. Petitioner was hoping that respondent would change and gave the respondent a second chance, accepting him to her fold;

12. That petitioner then got pregnant and delivered their first baby on July 13, 1993, who was given the name John Paul M. Dominguez. Copy of his certificate of Live Birth is hereto attached as Annex "B"

13. That respondent again landed a job but he started to have vices such as gambling and oftentimes goes out with his colleague leaving the petitioner and their child alone at the house;

14. That these vices had been the subject of several arguments between the petitioner and respondent that resulted to physical violence by the later against the former. These happened several times to the extent that respondent burnt petitioner's clothes aside from asking the petitioner to leave their house;

15. That petitioner endure all the pain for the sake of their child, hoping that respondent will somehow realized his mistakes and they could start anew with their child. Petitioner being fully aware of the adverse effect of having a broken family;

16. That petitioner was then able to have work but the respondent became too jealous about it. Respondent would often, during their arguments, uttered words like "May pinagmamalaki ka na dahil may trabaho ka!":

17. That these insecurities manifested the narrow thinking of the respondent. Petitioner never complained about the salary of the respondent, petitioner never asked for money from the respondent nor even asked how much was the respondent's salary;

18. That the alimpsed of hope came when petitioner got pregnant with their second child and again, their relation started smoothly. However, like before it was just temporary for the respondent became more physical whenever they have arguments. Copy of the Certificate of Live Birth of their second child is hereto attached as Annex "C"

**19**. That petitioner sometimes will go to the work with black eve and hematoma to different parts of her body as a result of the physical abuse of the respondent but would still stay because of their children. Petitioner suffered too much pain not only emotionally but physically but these pain could temporarily be healed whenever she looked upon her children;

20. That respondent the applied for work abroad and was able to work in Dubai. Petitioner then learned that respondent again had an affair with another women in Dubai but could not do anything;

21. That sometime in February 2007, respondent went back to the Philippines to attend the wake of his parent. After the burial, petitioner and respondent talk that again resulted to their arguments and separation:

22 That respondent went back to Dubai and petitioner learned after several years that respondent had a relation and living with another woman, with whom he had previous relation:

23. That mindful of the welfare of his children, petitioner was then able to work abroad and finally had come to realize that the change she hoped for would no longer come and it was then that she has finally decided that enough was enough and she had to stand up for her rights because if she would let this pass again, the little concern and respect she has for herself would forever be aone:

24. That petitioner with the help of her friend was able to consult with a lawyer and after telling her story was advised to have his marriage declared null and void considering her minority at the time of marriage.

25. That after securing the necessary documents with the National Statistics Office including the petitioner's Certificate of Live Birth which is hereto marked as Annex "D", it was shown that petitioner was only 16 years old and 10 months at the time of her marriage with the respondent on June, 1992 having been born on July 26, 1975;

26. That under Section 5 of the Family Code, it is provided that:

"ARTICLE 5. Any male or female of the age of eighteen years or upwards not under any of the impediments mentioned in Articles 37 and 38. may contract marriage"

27. That relative hereto, Section 2 of the same Code provides for the essential requisite of marriage. Quoted hereunder is the said provision:

"ARTICLE 2. No marriage shall be valid, unless these essential requisites are present:

(1) Legal capacity of the contracting parties who must be a male and a female and

(2) Consent freely given in the presence of the solemnizing officer

28. That further. Section 4 of the same Code provides the effect of the absence of any of the essential requisites of marriage. Again, pertinent portion of the provision is hereto guoted:

"ARTICLE 4. The absence of any of the essential or formal requisites shall render the marriage void ad initio, except as stated in Article 35.

x' x X х

29. That without being repetitious, petitioner being a minor was only sixteen (16) ten (10) months at the time of her marriage with the respondent on June 14, 1992 and has no capacity to enter into marriage. Hence, her marriage should be declared void ab initio in accordance with the afore-quoted provisions of the Family Code:

30. That lastly, petitioner and respondent have not, during their marriage, acquired any real properties.

WHEREFORE, premises considered, it is most respectfully prayed of the Honorable Court that judgement be rendered

declaring the marriage between the petitioner. Airvn Mirambil-Dominguez and the respondent. Marlon Dominguez, held on June 14. 1992 be declared null and void *ab initio* due to the absence of one of the essential requisites of marriage that is legal capacity of the petitioner in accordance with Articles 2, 4 and 5 of the Family Code.

Other relief's just and equitable under the premises are likewise prayed for.

## Quezon City's new city pound set to open on Q1 of 2021

CALOOCAN CITY (PIA) --The Quezon City government is set to open a 450square meter city pound to provide better temporary shelter services for stray animals.

Mayor Joy Belmonte announced on Monday that the city government is currently fast-tracking the construction of a new city pound at Empire View Subdivision in Barangay Payatas, expected to be completed by the first expected to quarter of 2021.

It has its own surgery room for neutering of dogs and cats, and for other animals needing immediate medical attention. There are also separate cages for sick animals to prevent the spread of infection.

Compared to the temporary shelter for animals situated in the same barangay where a number of stray animals are placed in a single room, the new city pound will have individual cages.

'Gusto nating magkaroon ng mas maayos na temporary shelter ang stray animals na mahuhuli sa ating mga lansangan. Sa bagong city pound, may partition ang cages para nakahi-hiwalay ang mga hayop," Belmonte said. Aside from these, the two-

storey city pound will also house the QC Veterinary Department - City Pound Division Office and a cashier to facilitate faster payment of fee for adoption or claiming impounded animals.

Belmonte also expressed willingness to partner with animal welfare groups to manage and improve the handling of impounded animals. The mayor is currently in talks with the
