### URBAN VERTICAL GARDENING TO BOOST TMC's FOOD SECURITY

TRECE MARTIRES CITY, Cavite (PIA) – The City Government here concluded the three-day training seminar for the Urban Vertical Garden-ing Project on November 20, 2020.

The project is one of the sustainable projects of the LGU in partnership with the City Agriculture Office and the Local Housing Office under the Resettlement Government Assistance Fund (RGAF) that is expected to boost the food security of the city.

Vertical gardening is one of the types of urban gardening that the city government is encouraging its residents to learn, with limited space for planting, it would help address the threat to food production and ensure proper nutrition of the community during health crisis.

Residents of Sunshine Ville, Southville 2 Phase 3, and Golden Horizon participated in the training. During the last day of the training, Mayor Gemma Lubigan led the distribution of garden tools and free seedlings which would help them start their own vegetable garden in their

MANILA - President Rodrigo R. Duterte has appointed Justice Remedios Salazar-Fernando as presiding justice of the Court of Appeals (CA).

Presidential Spokesperson Harry Roque confirmed Fernando's appointment in a statement after she was sworn in by Chief Justice Diosdado Peralta on Wednesday afternoon.

"The Palace confirms that President Rodrigo Roa Duterte has signed the appointment of Court of Appeals Associate Justice Remedios Austria Salazar-Fernando as CA Presiding Justice on November 24, 2020," he said.

Before Duterte's appointment, Fernando was already the CA's acting presiding justice following the retirement of then-presiding justice Romeo Barza in August 2019

Roque expressed confidence that Fernando would do a great job as the CA's new presiding justice.

### Only authorized revenue officers cán do tax assessment: CTA

MANILA - The Court of Tax Appeals (CTA) has reiterated that investigations by unauthorized revenue officers cannot yield a valid tax assessment against a taxpaver.

In a 19-page decision by the CTA en banc dated November 18 and made public Wednesday, the court upheld an earlier ruling by

the CTA's Second Division in favor of Makati-based Lapanday Holdings Corp. The CTA division had canceled the Bureau of Internal Revenue's (BIR) final decision on the disputed assessment of PHP9.03 million against the firm, prompting the tax agency to appeal the case before the CTA en banc.

The CTA Second Division had found that the revenue officers who conducted the audit / investigation of Lapanday for the taxable year 2008 were not authorized through a Letter of Authority to perform the said tax investigation.



**1.**That petitioner is of legal age, married to the respondent, Filipino citizen and a resident of #11404 M. Reyes St., Brgy. Mabuhay, Carmona, Cavite but presently staying at Classic Flat 9 Misrah I Barrieri Msida Malta, being an Overseas Filipino Worker. She is represented by the *PUNZALAN FAUSTINO PUNZALAN MARASIGAN & ASSOCIATES LAW OFFICES* where she may be served with the Honorable Court processes;

2. That respondent is also of legal age, married to the petitioner, Filipino citizen and a resident of Blk. 7B Lot 33 Brgy. Gregoria De Jesus, GMA, Cavite, where he may be served with the Honorable Court summons and other processes;

**3.** That petitioner's parent had been separated and she was previously staying with his father in Marinduque until sometime in 1990 when petitioner spent the school vacation with her mother in Carmona, Cavite;

**4.** That after her vacation, petitioner's father didn't fetched her in Carmona, Cavite constraining the petitioner to stay with her mother and later on, enrolled as third year high school student at Carmona High School;

**5.** That during her stay in Carmona, petitioner met new classmates and friends, one of whom is the respondent Marlon Dominguez;

6. That after their initial meeting, respondent courted the petitioner until the former won the heart of the petitioner. They started their relationship as boyfriend-girlfriend while they were both in forth year high school;

**7.** That petitioner and respondent's relation was on and off until they become intimate, which her mother later on discovered. Petitioner's mother became so uneasy of their relationship that one night, while they were staying at their house all by themselves, petitioner and respondent were just considered to have eloped;

8. That after the "pamamanhikan", petitioner and respondent finally got married on June 14, 1992 at the Philippine Independent Church in Biňan City, Laguna. Petitioner was surprised how she was able to get married to the respondent, being a minor at that time. Copy of their Certificate of Marriage is hereto attached as **Annex "A**";

**9.** That after the wedding, petitioner stayed with her parentin-law. Respondent meanwhile was able to get a job and their relationship as husband and wife started smoothy;

**10**. That later on, petitioner noticed changes with the respondent until she discovered that respondent has an extra-marital relation with his co-employee that resulted to their separation;

**11**. That petitioner still stayed with her in-laws until after two (2) months when the respondent came back. Petitioner was hoping that respondent would change and gave the respondent a second chance, accepting him to her fold;

That after securing the necessary documents with the National Statistics Office including the petitioner's Certificate of Live Birth which is hereto marked as Annex "D", it was shown that petitioner was only 16 years old and 10 months at the time of her marriage with the respondent on June, 1992 having been born on July 26, 1975;

26. That under Section 5 of the Family Code, it is provided that:

"ARTICLE 5. Any male or female of the age of eighteen vears or upwards not under any of the impediments mentioned in Articles 37 and 38, may contract marriage"

27. That relative hereto, Section 2 of the same Code provides for the essential requisite of marriage. Quoted hereunder is the said provision:

"ARTICLE 2. No marriage shall be valid, unless these essential requisites are present:

(1) Legal capacity of the contracting parties who must be a male and a female and

(2) Consent freely given in the presence of the solemnizing officer

28. That further, Section 4 of the same Code provides the effect of the absence of any of the essential requisites of marriage. Again, pertinent portion of the provision is hereto quoted:

"ARTICLE 4. The absence of any of the essential or formal requisites shall render the marriage void ad initio, except as stated in Article 35.

x x x

x

29. That without being repetitious, petitioner being a minor was only sixteen (16) ten (10) months at the time of her marriage with the respondent on June 14, 1992 and has no capacity to enter into marriage. Hence, her marriage should be declared void ab initio in accordance with the afore-quoted provisions of the Family Code:

30. That lastly, petitioner and respondent have not, during their marriage, acquired any real properties.

WHEREFORE, premises considered, it is most respectfully prayed of the Honorable Court that judgement be rendered declaring the marriage between the petitioner, Airyn Mirambil-Dominguez and the respondent. Marlon Dominguez, held on June 14. 1992 be declared null and void *ab initio* due to the absence of one of the essential requisites of marriage that is legal capacity of the petitioner in accordance with Articles 2, 4 and 5 of the Family Code.

Other relief's just and equitable under the premises are likewise prayed for.





### **Private Sector Partners** of DENR CALABARZON adopt hundreds of hectares forest and mangrove areas in Quezon and Laguna

Calamba City, Laguna – The Department of Environment and Natural Resources (DENR) CAL-ABARZON has officially signed a Memorandum of Agreement (MOA) with SMCGP Philippines Power Foundation, Inc. (SMCGPFI) last November 18, 2020.

As stipulated in the MOA, the DENR CALABARZON and the SMCGPFI will launch a coral reef rehabilitation program in the municipality of Pagbilao, Quezon, under the Ridge to Reef Conservation program of the SMCGPFI and under the Coastal and Marine Ecosystem Management Program (CMEMP) of DENR CALABARZON. The parties are also responsible for the adoption and the protection of 115 hectares of National Greening Program (NGP) and other fruit trees plantation, a 300-hectare NGP Rattan Plantation located within three (3) Barangays in Pagbilao, and 106-hectare stream bank NGP indigenous plantation under Adopt a River Program within two (2) barangays in Pagbilao. An additional 150-hectare of mangrove is also included and is located within nine (9) Barangays in Padre Burgos, Quezon.

DENR CALABARZON and the SMCGPFI also entered a tripartite MOA with the partner People's Organization (PO), the Mananabas Multi-Purpose Cooperative, where the parties will be responsible for the protection and rehabilitation of the 75-hectare NGP rubber upland plantation in Brgy. San Antonio, Kalayaan, Laguna.

DENR CALABARZON Regional Executive Director Nonito M. Tamayo reminded that environmental concerns are a shared responsibility with other sectors. He encourages the public to aim to increase the Region's forest cover up to 30%, or around 480,000 hectares. "With the help of civic groups we can achieve the target in the years to come", he added. He added that our forest cover is being assessed every 5 years and the next assessment after this year is on the year 2025. In closing, RED Tamayo said, "[our] Forests are the lungs of the Earth".

These initiatives are under the program of "Tayo Ang Kalikasan" of the DENR, which aims to restore, rehabilitate, and increase our forest lands among others. PR

### Hontiveros to DSWD: Fully enforce mental health programs for typhoon survivors

"MILLIONS have been affected by these devastating typhoons. With crisis upon crisis, we are at risk of free-falling into a deep mental health crisis if we don't act swiftly. Mental health should be front and center along with food, water, and sanitation in evacuation centers.'

This according to Mental Health Act author Senator Risa Hontiveros who urged the Department of Social Welfare and Development (DSWD) to fully enforce its mental health (MH) programs for typhoon survivors, even after they leave the evacuation centers. She flagged the 'snailpaced' implementation of the disaster-related MH programs since the Department of Health (DOH) and DSWD reported that guidelines were still being crafted.

"The crisis is happening right now. We need to fasttrack guidelines and roll out services immediately. MH is an invaluable part of rebuilding our lives after a crisis. MH issues like anxiety and depression make it much harder for typhoon survivors to recover. This will affect their work, their schooling and can scar their relationships if we do not heed their needs promptly," she said.

nagagamot "Hindi ang mental health problems overnight. It is important that the services they receive aren't one-time, bigtime. We should monitor the survivors to ensure that they receive therapy as needed and medicine if prescribed," she added.

Hontiveros said that mental health should be integrated in the disaster risk reduction and management (DRRM) plan of the country "from planning to monitoring, at both national and local levels, and from readiness to resilience". She said it is important to learn from Yolanda, whose survivors are still experiencing anxiety and post-traumatic stress disorder (PTSD) seven years later because of the late MH response.

"MH issues are a roadblock to transitioning back to regular life. en and eggs. In Quezon, 35,523 farmers, fisherfolk, and IPs will benefit from the program, and 80,000 beneficiaries for the entire CALABARZON region, said DA-4A Regional Director Arnel de Mesa. The DA has partnered with the Development Bank of

the Philippines (DBP), and rice farmers' and poultry industry groups to implement the CFSMFF program nationwide.

The DA-4A Regional Field Office (RFO) also allotted P640-M worth of various agricultural inputs, including P120 M for the establishment of the Sari-aya trading post and cold storages in Candelaria and Tayabas.
