Prayoridad sa mga guro para sa COVID vaccine, isinulong

LUNGSOD CALOOCAN (PIA) -- Hinimok ni Senator Win Gatchalian ang National Task Force Against COVID-19 na isali ang mga guro, kabilang ang mga punong-guro at kawani ng mga paaralan, sa mga grupong unang mabibigyan ng bakuna kontra COVID-19.

Ayon sa Chairperson ng Senate Committee on Basic Education, Arts and Culture, ang pagpapabakuna sa mga guro ay mahalagang hakbang sa ligtas na pagbabalik sa mga paaralan. Aniya, makatutulong ito upang makampante ang publiko bago muling magkaroon ng face-to-face classes sa buong bansa.

Ani Gatchalian, ang halos isang milyong (900,000) mga guro at mga nonteaching staff ay nagsisilbing mga frontliners upang patuloy na makapag-aral ang mahigit dalawampu't dalawang (22) milyong mga mag-aaral sa pampublikong mga paaralan. Paalala ni Gatchalian, ibinubuwis ng mga guro at kawani ng mga paaralan ang kanilang buhay at kalusugan upang ihanda at ipamahagi ang mga learning materials para sa distance learning, kabilang ang mga self-learning modules na ginagamit ng halos siyamnapung (87) porsyento ng mga mag-aaral.

Dagdag ni Gatchalian dapat bigyang prayoridad ang muling pagbubukas ng mga paaralan ngayong nalalapit na ang pagkakaroon ng bakuna. Ayon sa mambabatas, mahalaga ang muling pagbubukas ng mga paaralan upang hindi lumala ang krisis sa edukasyon na kinakaharap ng bansa. Pero dapat pa rin aniya na ipatupad nang mahigipit ang mga health protocols tulad ng pagsusuot ng face masks, physical distancing, at palagiang paghuhugas ng mga kamay.

"Dahil ang ating mga guro, mga punong-guro, at kawani ng mga paaralan ay nagsisilbing mga frontliners sa pagpapatuloy ng edukasyon, nararapat lang na mabilang sila sa mga unang makakatanggap ng bakuna laban sa COVID-19. Mahalagang hakbang ito upang matiyak nating ang pagbabalik ng ating mga mag-aaral sa mga paaralan ay magiging ligtas," pahayag ni Gatchalian.

Ipinaliwanag ng senador na bago pa tumama ang pandemya, ipinakita ng mga global assessments na Programme for International Student Assessment (PISA) 2018, Trends in International Mathematics and Science Study (TIMSS) 2019, at ng Southeast Asia Primary Learning Metrics (SEA-PLM) 2019 na nahuhuli ang mga magaaral sa bansa at hirap silang matutunan ang mga tinaguriang "basic competencies."

Noong nakaraang Oktubre, tinukoy ng United Nations na ang pagpigil sa pagkalat ng COVID-19 ang pinakamahalagang hakbang upang muling makapagbukas ang mga paaralan. Kamakailan naman ay nanawagan din ang United Nations Educational, Scientific, and Cultural Organization (UNESCO) na bigyang prayoridad ang mga guro sa pagpapamahagi ng bakuna kontra COVID-19.

Bagama't wala pang tiyak na petsa kung kailan unang ipapamahagi ang mga bakuna, naghahanda na ang Department of Education (DepEd) para sa limitadong face-to-face classes sa mga piling paaralan na matatagpuan sa mga lugar na walang banta ng COVID-19. Aniya dapat tiyakin ng mga paaralan at ng mga lokal na pamahalaan na ang mga guro at mga kawani ay makatatanggap ng suporta pagdating sa testing at pagpapagamot.

> DBP readies financial aid package to support LGUs

CALOOCAN CITY (PIA) --State-owned Development Bank of the Philippines (DBP) is collaborating with local chief executives and the Department of Finance in coming up with a package of financial assistance to help local government units (LGUs) bounce back from the crippling effects of the pandemic, according to DBP President and Chief Executive Officer Emmanuel G. Herbosa. Herbosa said the financial assistance package includes subsidies on interest payments on new loans to the LGUs as well as funding support to affected industries in their constituencies.

"DBP recognizes that LGUs are the fulcrum of inclusive development," Herbosa said. "We are one with them in formulating responsive actions that would hasten response and recovery efforts despite prevailing challenges."

as a niche market, providing credit and advisory service to projects that spur the local economy. As of end-June, DBP has disbursed P35.95-Billion in loans to 349 LGUs nationwide.

Herbosa said the bank is working towards unifying its initiatives under one umbrella loan program that would serve as the platform for the National Government's stimulus package for LGUs.

He said that with the anticipated release of stimulus funds under the recentlyenacted Republic Act No. 11494, or the Bayanihan to Recover As One Act, DBP can offer LGUs loan packages at lower interest and longer payment terms of up to 15 years.

"These types of interventions would greatly benefit lower-tier LGUs, as they scale up social and economic interventions for their constituents and boost their resiliency against future downturns," Herbosa said. (PIA NCR)

Public warned vs. passport assistance from FB groups, strangers

MANILA – The Department of Foreign Affairs (DFA) has warned the public against seeking passport assistance from strangers offering services on Facebook and other social media chat groups.

The DFA Office of Consular Affairs said it received reports on Filipinos who booked their passport appointment with help from strangers online and ended up paying more.

"The department received reports today from passport applicants who booked their passport appointment with assistance from unknown individuals online and ended up paying more than what the DFA collects for passport issuance, and receiving tampered application forms and/or incorrect instructions, such as advice to pursue their appointment at a schedule or Consular Office different from the actual appointment schedule and site," it said in an advisory sent to reporters late Tuesday.

Solon wants textbooks converted into digital formats

MANILA – A lawmaker at the House of Representatives on Tuesday pushed for the swift passage of a measure mandating the conversion into electronic copies and other digital formats of all textbooks amid the shift to blended learning during this pandemic. Camarines Sur Rep. Luis Raymund Villafuerte proposed House Bill No. 8020 requiring the digitization of all contents used by publishers participating in the Public School Textbook Program (PSTP) to address the recurring shortage of printed modules in

public schools. "It is no secret that textbooks in public elementary and high schools are limited in number and, as (a) result, our students are forced to share or borrow from one another," Villafuerte said. "This difficulty is even more evident in the time of Covid-19 when who made an appointment with a third party and are doubtful of the authenticity of their application, to contact its hotline at 8234-3488 to verify their applications. "Applications that were made through a third party will be accepted for processing only after the appointment and the identity of the applicant has been verified, and processing will only be done at the Consular Office where the appointment was made," it said.

Passport appointments can be booked directly through https://passport.gov.ph.

While passport appointment slots are limited due to the coronavirus disease 2019 (Covid-19) protocols, it said applicants with urgent travel requirements, such as overseas Filipino workers, may email oca. cl@dfa.gov.ph for accommodation in DFA Aseana or at the nearest Consular Office by sending an appointment request by email to the concerned office directly. To protect the intellectual property rights of both the authors and publishers of the textbook, Villafuerte said the implementation of the scanning or conversion must comply with the provisions of the Intellectual Property Code of the Philippines.

He said the e-books and digital format copies of the textbooks shall also be made available and accessible to all public school students in a manner deemed appropriate and reasonable by the Department of Education (DepEd). (PNA)

GenTri opens COVID-19 Molecular Laboratory

GENERAL TRIAS CITY, Cavite (PIA) -- The city government here recently inaugurated the city's first COVID-19 Molecular Laboratory located in Barangay Manggahan.

Mayor Antonio 'Ony' Ferrer along with Deputy Chief Implementer and 'Testing Czar' Secretary Vince Dizon led the inauguration and opening of the facility. GenTri Medical Center and Hospital President & CEO Dr. Jerrimo Genuino, MD., Vice-Mayor Morit Sison, and members of the Sangguniang Panglungsod were present to witness the significant event. Managed by the General Trias Medical Center and Hospital (GTMCH), the city's COVID-19 Molecular Laboratory is part of the LGU's counter measures against COVID-19 to mitigate the threat on the health and safety of Gentriseños and contain further spread of the disease.

The facility is equipped with the best technology in terms of equipment, the BD Max Machine and BIO-RAD CFX 96 RT-PCR, which are expected to contribute much to the continuous facilitation of the Aggressive Community Testing in the city for a faster and efficient release of test results.

Since the ground breaking of the facility on September 14, 2020, the preparation of documents for the accreditation by the Department of Health (DOH) was fast tracked.

With the GTMCH medical team confident that the Molecular Laboratory was 100% ready and compliant with the standards set by the DOH and the RITM, the first visit and inspection was done November 6.

Further improvements had to be made for its final approval and accreditation paving the way to the formal launching and inauguration on December 12, 2020.

Meanwhile, according to the latest COVID-19 update reported by the City Epidemiology and Surveillance Unit (CESU), there were 6 recovered patients and 1 new confirmed case recorded as of December 17, 2020.

Total Confirmed cases were 2.198 out of which 22 are Active cases while the total number of Recoveries from the additional recovered patients are now at 2,137 and 39 fatalities from the disease brought by the COVID-19.

While these figures manifest a significant decline in the rate of infection and a high percentage of recoveries from the disease, the officers of the city government thru the city health office continuously remind the public to remain safe thru the observance of the minimum health standards set by the Inter-Agency Task Force. 34K CALABARZON farmers benefit from DA's seeds, fertilizers support

CALAMBA CITY, Laguna (PIA) -- About 34,000 farmers in the provinces of Cavite, Laguna, Batangas, Rizal and Quezon (CALABARZON) had been the beneficiaries of the quality seeds and fertilizers distributed by the Department of Agriculture (DA) Region **IV-CALABARZON** in line with the implementation of the Rice Resiliency Project (RRP) under the Plant, Plant, Plant Program.

Empowered by the goal of achieving higher rice productivity this wet-cropping season, the DA Region IV-CALABARZON has successfully delivered and distributed the quality seeds and fertilizers to rice farmers across the region.

According to a terminal report on November 13, 2020, DA's RRP has catered for 10,222 hectares benefiting 8,736 rice farmers in the region. Through RRP, the regional office has distributed 80,995 bags of fertilizers to 24,109 farmer-recipients in CALA-BARZON.

For the Rice Competitiveness Enhancement Fund (RCEF)-Seed Program, 27,426 hectares of rice areas by 25,518 farmerrecipients was planted with RCEF seeds. Aside from seeds, 15,478 rice farmers received 45,420 bags of fertilizers under the RCEF Seed Program.

Meanwhile, 3,000 hectares of inbred seed allocation were distributed for non-RCEF areas under the Expanded Inbred Rice Production, followed by 13,408 fertilizer bags. About 2,964 farmers and 3,183 farmers, respectively, have already made the most of the support by DA through their respective city and municipal agriculture offices.

On the other hand, through its Expanded Hybrid Rice Production, DA's RRP has allotted a total of 1,187 hectares of hybrid seed allocation for 1,116 rice farmers who have farmlands suitable for hybrid rice seeds. Also, the regional office has distributed hybrid rice

seeds to additional 6,186 hectares of rice lands. A total of 4,656 farmers made the most of this supplementary intervention under DA's RRP. About 22,167 bags of fertilizer accompanied this hybrid distribution to a total of 5,448 farmers under RRP's Expanded Hybrid and regular hybrid rice production.

Mr. Armando Ramos, president of the Anak Bukid Samahan ng Magsasaka ng Brgy. Sipa Inc. in Padre Burgos, Quezon, is one of the recipients of the expanded inbred seeds component of DA's RRP. He expressed his utmost gratitude to the regional office for choosing their farmers' association as one of the project's beneficiaries.

"Napakalaking tulong po ng mga natatanggap naming libreng inputs mula sa DA. Malaki po ang aming natitipid dahil hindi na po namin kailangan pang bumili ng mga butong pananim at pataba. Bago pa man po dumating ang handog na pananim at abono na buhay ng RRP, ako po ay umaani lamang ng nasa 250 balde (isang balde ay katumbas ng 10 kilo) ng palay. Ngayon pong dumating na sa amin ang RRP, ang aking 0.75 hectare na lupa ay umaani na po ng nasa 320 balde," Mr. Ramos proudly said.

Mrs. Prima R. Misiera, secretary and bookkeeper of the Anak Bukid Samahan ng Magsasaka ng Brgy. Sipa Inc., is a recipient of RRP's expanded hybrid and inbred seed components. She expressed her appreciation to DA for its continued support towards rice farmers in their municipality.

"Ngayon pong nakakatanggap na kami ng libreng abono mula sa DA at sa proyekto nitong RRP, nababawasan po ang aking gastos. Hindi ko na po kailangan pang bumili ng mataas na halaga ng abono sa labas. Bilang isang babaeng magsasaka, ako rin po ay isang ina. Kung kaya naman lubos ang aking pasasalamat sa DA sa mga handog ninyong libreng butong pananim at tanggap ng libreng binhi abono. Sana po ay magtuluy-tuloy pa po ang inyong pagtulong sa amin. Sa pamamagitan po ninyo at ng mga proyektong gaya ng RRP ay natitiyak na namin ang masaganang ani at mataas na kita," Ms. Misiera said.

Mrs. Emerlita Magno, member of Samahan ng Maliliit na Magsasaka ng Ibabang Kinagunan in Agdangan, Quezon and a recipient of DA RRP's expanded hybrid seed component, shared her experience as one of the many recipients of hybrid seeds and fertilizers in their municipality.

BOC records high 94% performance in customer service

THE Bureau of Customs was cited by the Citizens' Complaint Center for acting upon and resolving 94.41% of complaints coursed from January to October 2020 through the Malacañang's 8888 Hotline.

The Bureau of Customs, through its Customer Assistance and Response Service (CARES) and concerned offices, resolved a total of 270 of the 286 tickets based from the 8888 Agency Statistics January-October 2020. Moreover, 10 pending tickets were already resolved back in November while the remaining 6 tickets or 2.1% are just awaiting feedback. According to Director Bernadette Casinabe of the Citizens' Complaint Center, the 8888 was established to serve as a mechanism where citizens may report their complaints and grievances on acts of red tape as defined under Republic Act No. 9485, as amended by RA No. 11032. This also include reports on corruption activities of any national government agency and other government corporation, financial institution, or instrumentalities.

During the same period, the BOC also processed and resolved 100% or 520,507 tickets corresponding to various issues and concerns coursed through the Customer Care Portal System (BOC Portal) such as inquiries on online filing, accreditation, balikbayan box, among others. On the same platform, the BOC maintained the average response time of 0.84 day per ticket and average resolution rate of 4.31 days. Although affected by the community quarantine and its restrictions, the Bureau of Customs remains committed to deliver outstanding customs service and concurrently improve systems, processes, and information dissemination. Danny Kingad eyes another title shot

MANILA – Filipino mixed martial arts sensation Danny Kingad has expressed his desire to fight again for the ONE flyweight title.

Kingad said on Wednesday he is ready to challenge the winner of the Adriano Moraes - Demetrious Johnson clash on February 24 for Moraes' championship belt.

"I would love to fight the winner of that fight sometime in the near future," he said.

Johnson, a former flyweight champ at the UItimate Fighting Championship, set up a title showdown against Moraes for the ONE Championship gold after beating Kingad in the final of the ONE Flyweight Grand Prix, which took place at ONE: Century in Tokyo on Oct. 12, 2019.

Kingad's first loss in his career actually came against Moraes when the latter submitted the former through a rear-naked choke in their title showdown at ONE: Legends of the World in Pasay City on Nov. 10, 2017.

He, however, said he has learned from those defeats and is ready for a rematch against either Moraes or Johnson.

"I believe I've changed a lot since facing either of them, and they will be surprised," Kingad said. On what kind of Kingad would show up if he gets a title shot outright will depend on how the prolonged hiatus has affected him much, fitness-wise. In what would have been his first match since January, Kingad was scheduled to face former champ Kairat Akhmetov at ONE: Big Bang 1 on December

SSS on contribution hike:We need to implement the law

MANILA – Social Secu-rity System (SSS) offi-cials said on Wednesday they have listened to the clamor of employers and some business groups to defer the contribution hike in the state-run pension fund, but the scheduled increase in contribution rate is mandated by law. "As much that the SSS

would like to support the clamor of the public that the intended increase to be de-ferred, actually we are not going to do that because the basis for such increase is a legislative act," SSS senior vice president and chief legal counsel Voltaire Agas said in a virtual press conference Wednesday.

Under the Social Service Act of 2018, the SSS shall implement contribution rate hike in 2019, 2021, and

SSS president and chief executive officer Aurora Ignacio announced in the same virtual event that the state-run pension fund will push through with the contribution rate increase from 12 percent to 13 percent starting January 2021. Ignacio said the mini-

mum monthly salary credit (MSC) will also increase from the current PHP2,000 to PHP3,000 starting next year, while also hiking maximum MSC from the current PHP20,000 to PHP25,000. SSS chief actuary Edgar Cruz explained how the rate increase will impact on the members' contribution to the SSS.

For members with MSC of PHP3,000, the monthly contribution will increase from PHP370 to PHP400 starting January 2021. For those with MSC of PHP10,000, it will in-crease from PHP1,210 to PHP1,310. For those with MSC of PHP20,000, contribution will bitch contribution will hike from PHP2,430 to PHP2,630.

"The purpose of this man-dated contribution rate in-crease was made by the legislature. Because as we all know in 2017, we had a PHP1,000 across the board pension benefit increase for our pension-ers, and that benefit adjustment or increase was not funded. So it will put risk the sustainability of the fund, such that this legislated increase. We're just supposed to allow the SS fund to be restored to where it was prior to grant of the 2017 increase," Agas said.

He added that the coro-

(Covid-19) pandemic has "taken heavy toll" on SSS cash flows due to decline in contribution collection and higher claims on unemployment insurance coupled with the expanded

"Because of these, any delay of implementation --which is mandated by the law -- will seriously endan-ger not only the fund, but equally important, in peril the SSS' ability to provide prompt and much needed financial assistance for members during this pan-demic," the SSS executive said.

Cruz said per last valua-tion, the SSS fund life is projected to be 2054.

"The fund is expected to be depleted and we have to think ways to extend to perpetuity," he said. "The SSS is there to provide for retirement security of all members, not just the current pensioners, but the current workers who are contributing and who will become future pensioners as well as even the genera-

tion yet unborn." The SSS also launched the Workers' Investments and Savings Program (WISP), which will be rolled out by January 2021. Those members with MSC

exceeding PHP20,000 are automatically enrolled in WISP.

For instance, those with MSC of PHP25,000 are mandated to be included in the WISP. Their monthly contribution will also increase from the current PHP2,430 to PHP3,280 come next month. Cruz said those with MSC

exceeding PHP20,000 make up 20 percent of total

SSS members. Under the WISP, members are entitled to retirement, total disability, and death benefits in addition to the

Regular SSS Program. SSS will invest a significant contribution under WISP in risk-free government secu-rities and a modest portion will be invested in equities in blue-chip corporate investments.

Earnings realized from investments will also be distributed proportionately based on members' contributions. This means that the bigger the contribution, the higher the earnings that the member stands to receive.

To date, SSS projects that base return of investments of 4.5 percent and investment income under WISP is tax-free. (PNA)

Skipping passion for safety: An old lantern maker's tale

MANILA – While the corona-virus disease 2019 (Covid-19) pandemic may have caused a negative impact on everyone's lives, it sure taught an old man to make an unselfish gesture of skipping tradition, giving way, hold his passion, and take a back seat.

This year, Efren Tiodin resisted and finally decided to restrain himself from joining Pampan-ga's Giant Lantern Festival for this year, thinking of the health and welfare, not of himself, but of the people whom he works with.

"Ayaw kong magsimula sa akin, baka sa akin magsimula yung pandemic dito sa Pampanga o kaya merong magkaroon ng pandemic sa mga tauhan ko, yun ang iniiwasan ko (I don't want it to start from me, I fear that an outbreak in Pampanga may start from me or somebody that works with me gets infected, that is what I am trying to avoid)," said Tio-din during an interview with the

Philippine News Agency. Tiodin is a known giant lantern maker in San Fernando who never missed a year in joining the Giant Lantern Festival. For 37 years, he continuously shared his passion and talent in designing and participating in building the giant lantern. He said he started with commercial lantern-making back when he was in high school when he was 13 years old out of pure passion. It later became his bread and butter. From then on, he tried to learn more of the craft and develop

his skill, learning from the se-nior craftsmen of their town. However, things turned out differently for Tiodin this year as strict health protocols and the concern he has for his coworkers pushed him to skip the tradition. Tiodin admits that while ob-

serving the younger genera-tion as they build their lan-terns, he still feels a bit of envy in his heart.

However, Tiodin said he has no regrets and feels happy that these young people in their area have learned the craft well and can continue the tradition despite the Covid-19 pandemic. Tiodin, who entered the world

of making giant lanterns in 1983, is now a senior citizen. Based on the Inter-Agency Task Force for Emerging Infectious Diseases guideline, he is not allowed to go out as he is more vulnerable to contract the disease and could even pass it on to others.

Recalling the earlier times, he said that only rich people then can have lanterns made for them.

"Nung panahon na yun, pag nagkaroon ng parol sa isang bahay sigurado mayaman eh mgayon kahit simpleng pa-mumuhay lang pwede kang magparol sa bahay pero noon pag me nakasabit na parol siguradong mayaman yan. Mga mayayaman lang ang nakakapagpagawa ng parol (During those times, if someone has a lantern in his house, one is pretty sure that an owner is a

rich man, but now, even ordi-nary persons may have lanterns at home. Before only the rich ones can afford a lantern made for him)," Tiodin said. He said joining the giant lantern festival gave him much satisfaction as it was his dream.

"My passion is designing gi-ant lanterns for exhibits. I was not after the prize money but for the honor, the recognition, and the chance to be able to leave a legacy," said Tiodin in Filipino.

During his younger years, Tiodin said his inspiration in making the lanterns are the older lantern craftsmen he was working with.

But now that he is in his senior years, Tiodin said the younger ones have become his inspiration, on how they will follow in his footsteps.

He said that he only hopes that the younger generation of Pampanga lantern crafts-men will be able to accomplish those that he was not able to do

This is the reason why, even if he did not join this year's lan-tern festival, he does not hesitate to give his opinion and share whatever knowledge he has with the young lantern makers.

"Wag kang magdamot sa iyong nalalaman I-share mo sa iba wag mong itago yun ang inspirasyon ko para sa mga bata (Do not be selfish with your knowledge, share it with others, that is my inspiration for the younger generations), he said.

This way, Tiodin said that the giant lantern festival that started in Pampanga 112 years ago will continue in the generations to come.

Right after he made the decision not to join this year's fes-tival, he immediately advised their barangay chairman about

Funding for making a giant lantern entry comes from the

barangay. He said that upon hearing his decision, their barangay chairperson decided not to join the festival and use the funds instead to assist their constituents.

Having grown old in this craft. Tiodin said that the most essential ingredient in winning the festival is that a lantern must be able to transcend a

message. Brighter message For this year, had Tiodin was given the chance, more than giving hope, his lanterns message would be "love one another'

Love, Tiodin said, would be able to help everyone surpass whatever difficulties we en-counter in life.

He proudly shared his masterpieces, his collection of all the designs he made for the past vears.

Beaming with pride that for 37 years, he made those, giving honor to their barangay.

He plans to donate these to the city government when he finally retires from the craft.

Palace assures Filipinos of improved lives in 2021

MANILA – Malacañang expressed confidence on Wednesday that Filipinos' lives MANILA will improve in 2021, despite the coronavirus disease 2019 (Covid-19) crisis that ravaged

the Philippine economy. In a press statement, Presi-dential Spokesperson Harry Roque said the government's "Ingat Buhay para sa Hanap-buhay (Protect Life for Livelihood)" campaign would help reboot the country's economy and allow Filipinos to recover from the impact of the Covid-19 pandemic.

"Ingat buhay para sa hanapbuhay (Protect life for livelihood) will continue to be our direction in 2021 with the opening of more industries to revitalize our economy and stimulate growth for the betterment of the lives of our people next year and be-yond," Roque said. Roque's statement came after

the Nov. 21 to 25 survey of the Social Weather Stations (SWS) found that many Filipinos believe their quality of life got worse in the past 12 months. The SWS poll revealed that 62 percent of Filipinos felt their life worsened, while only 14 percent were convinced that their life got better this year.

However, the latest number of Filipinos who said their life got worse was lower than the 82 percent recorded in September 2020.

Roque said the poll results no longer came as a surprise since the country is still grap-pling with the Covid-19 pandemic.

Comelec allots P116-M for May 2022 canvassing system

MANILA – The Commission on Elections (Comelec) has allotted more than PHP116 million for the purchase of some 2,200 Consolidation and Canvassing System (CCS) laptops to be used in the May 2022 national and local polls. Based on its Invitation to Bid, the poll body has set PHP116,160,000 as Approved Budget for the Contract (ABC) for the purchase of laptops, each priced at PHP52,800, for consolidating and canvassing consolidating and canvassing

"The Comelec now invites bids for this Procurement Project. Bids received in excess of the ABC shall be automatically re-jected at Bid Opening," it said. Under the contract, the CCS laptops must be delivered to its Laguna warehouse in five tranches over five months from May to September 2021. The first tranche, composed of 220 units, must be delivered by May 30 next year; 440 units by June 30; and 440 by July 30

Another 440 units should also be delivered by August 30 and the final 660 units by Septem-

It's better to stay at home and celebrate sa kung sino man ang usual na kasama mo sa bahay (It's better to celebrate with whoever you are with at home)" she said.

Jheng believed being at home with the family is the best way to enjoy the holidays, as it brings family members closer.

"It is much happier when you are with your family. You give time to your family," she said.

Apart from the pandemic, Jheng was also among thousands of residents affected by the recent flooding in Marikina.

While the local government and the people work together, Jheng said the city has yet to recover from the aftermath of the typhoon.

She encouraged the public to adhere to the government's health protocols and safety measures to prevent risks of getting Covid-19 infection.

The foundation encour-aged residents to help their community through a 'cash for work' program.

'Cash for Work' incentivizes every community to clean up homes and neighborhoods by paying each participant PHP1,000 per day even if they are cleaning their own homes.

Both Tinedero and Almodiente said they are asking for help from the government so they could start a new livelihood.

"Sa ngayon po, konting salu-salo na lang muna sa hapag para sa Pasko. Masaya na po ako doon (Right now, we'll just get by if there is food on the table for Christmas. I will be happy for that already)," she said.

Typhoon Ulysses hit landfall on Nov. 11, devastating parts of Luzon including the Bicol region and Metro Manila.

The National Disaster Risk Reduction and Management Council recorded over 25,000 displaced persons throughout 273 barangays.

CALOOCAN CITY (PIA) -- The Climate Change Commission (CCC) today joined various government agencies, experts from different industries, advocates for climate resilience, and members of the aca-deme to launch, "Climate Change and Food Security Analysis," a research initia-tive created by the World Food Programme (WFP) to determine the impacts of climate change to food security, nutrition and livelihood in the Philippines and to identify the appropriate solutions.

The virtual event featured Mr. Mats Persson, officer-in-charge and Deputy in-charge Country Director, World Food Programme; Mr. Ste-Weise, Managing phen Director, Alliance of Biodiversity and International Center for Tropical Agri-culture (CIAT); the Office of Cabinet Secretary Karlo Nograles, head of the Zero Hunger Task Force in the Office of the President; Director Alicia Ilagan, De-partment of Agriculture; Director Restituto Macuto, Sustainable Sustainable Livelihood Program and National Program Manager of EPAHP NPMO, Department of Social Welfare and Develop-ment (DSWD); Dr. Azucena Dayanghirang, Executive Director, National Nutrition Council; and Mr. Jerome Ilagan, Chief of Policy Research and Development

Division, CCC The virtual event was held to formally launch the Climate Change and Food Security Analysis, includ-ing the introduction of its objectives, time, and ex-pected outputs. Likewise, the event aimed to generate interest in the study by making the argument for climate change and its impact on food security in vulnerable communities.

CCC welcomes WFP's PH climate, food security analysis initiative

The report revealed that aside from conflict, climate change is one of the main drivers of global hunger. Climate change impacts are also undermining ag-ricultural production. Par-ticularly vulnerable are smallholder farmers living in the earth's more fragile environments.

More than 80% of the world's most food-insecure people are being hit by extreme weather such as drought and flooding, as well as by other stresses as pest infestation land degradation. such and Changes in climate are affecting the production of staple crops—wheat, rice and maize—in both tropical and temperate regions. This situation is set to worsen as temperature increases and becomes more extreme, and rainfall becomes more unpredictable.

In his opening statement, Mr. Persson said, "Climate

variability and extreme

weather events are among the key drivers behind the recent increase in global hunger and one of the leading causes of severe food crisis. To fill in the undeniable gap between climate change and food insecurity, WFP forged a partnership with the International Center for Tropical Agriculture and initiated a research study of the Phil-ippines Climate and Food Security Analysis." Dr. Weise said, "It is evi-dent that the the dimete in

dent that the climate is impacting food security in ways and in intensity we have not experienced before. Just this year, for example, the Philippines had to bear the brunt of multiple typhoons that took lives, and caused damage and losses worth billions of pesos in the agriculture sector. If anything, this is a signal for organizations like ours to work closely to-gether along with national authorities and institutions to build greater resilience in the food systems of the Philippines." In 2020, President Rodrigo

Roa Duterte signed Execu-tive Order No. 101 which created the Inter-Agency Task Force on Zero Hunger (IATFZH). This aims to put an end to the hunger prob-lem in the country by 2030. The WFP has extended its support of this Task Force and its initiatives to help the country achieve its goals. Mr. Ilagan commended the Climate and Food Security Analysis as it is consistent with the country's Nation-ally Determined Contrially

butions under the Paris Agreement. On the promise of food security, he expects that the results of the analysis will lead to a complementary and anticipatory adaptation mecha-nism that is founded on scientific drivers presented in partnership with the Intergovernmental Panel on

Climate Change (IPCC) and local experts. He added that, "The Na-tional Panel of Technical Experts from the Climate Change Commission can also share their views on how to do multi-scenario, multi-hazard impact projections; inasmuch as the productivity of the sector lies not only on the natural hazards but the complementary implications of other growth drivers such as land use, land industry optimization and industry optimization and incentives, green jobs creation, and the building of people's movements so that they could start invest-ing consistently with the Agriculture and Fisheries Modernization Act."

Although the launch of the Philippines Climate and Food Security Analysis was delayed due to the COVID-19 crisis, attendees of the virtual event have stated that this should not impact the goal of the study.

Likewise, they hope that the pandemic will provide additional aspects for critical analysis on food security and climate change.

This virtual event was organized by WFP in partnership with the CIAT, with the participation of the Zero Hunger Task Force. (PIA)

DBP inks pact with DA for cash subsidies for marginal farmers and fisherfolks

CALAMBA CITY, Laguna (**PIA**) --State-owned Development Bank of the Philippines (DBP) has signed an agreement with the Department of Agriculture (DA) for the distribution of cash subsidies to around 900,000 marginal farmers under the DA's Cash and Food Subsidy to Marginal Farmers and Fishers (CF-SMFF) program, a top official said.

DBP President and Chief Executive Officer Emmanuel G. Herbosa said that this newly-developed DA program utilizes financial technology through the use of an e-voucher system to ensure more efficient and transparent program implementation.

"Through the e-voucher system, beneficiaries can claim their cash assistance of P3000 each at any DBPaccredited payout center by presenting their government-issued ID and the unique reference code sent via text message by the implementing agencies," Herbosa said.

DBP is the seventh largest bank in the country in terms of assets and has a branch network of 129 branches including 11 branch units, which are mostly situated in underserved areas of the country.

Under the CFSMFF, eligible marginal farmers and fisherfolk who are enrolled in the Registry System for Basic Sectors in Agriculture will receive a subsidy of P5,000 each – P3,000 in cash and P2,000 worth of food items

A total of 890,794 farmers and fisherfolk are expected to benefit from the program. Out of these number, 346,534 are coconut farmers, 287,128 fisherfolk, 198,023 are corn farmers, 29,702 are sugarcane farmers, while the remaining 29,407 are members of the indigenous communities.

Herbosa said DBP has been working closely with DA on a number of financial inclusion initiatives during the past year such as cash aid disbursements under the Rice Competitiveness Enhancement Fund and enrolment with DBP of over 5,000 farmer-members. He said DBP and DA likewise partnered in the im-
