Kabilang dito sina Nieves Manalili dela Cruz, isang kagawad ng Barangay Alima; Danica L. Morales na tumatayo bilang ama at ina ng kanyang pamilya habang nagtag-trabaho ang kanyang asawa bilang isang Overseas Filipino Worker (OFW); Narcisa Enriquez- Barangay Health Worker mula sa Barangay Aniban 2 at katuwang ng mga Senior Citizen sa kanilang mga programa; Mitos Sayaman na patuloy ang pagtulong sa kanyang mga kapwa babae sa gitna ng pandemya; Kimberly Joy Cuevas na boluntaryong nagbabantay kasama ang mga barangay tanod at tumutulong sa pagluluto ng pagkain ng kanilang kabarangay.

Hindi naman alintana ni Te-

resa Ramos ang panganib habang ginagampanan niya ang kanyang tungkul bilang tagakolekta ng basura sa kanyang barangay. Bukod dito, nagtatra-baho rin si Ramos bilang isang pedicab driver bilang dagdag kita na siyang pangtugon sa pangaraw-araw na pangangailang ng kanyang pamilya.

Kung hindi naman siya nagsisilbi sa tanggapan ng barangay, namamasada naman si Maria Jonalyn Espiritu gamit ang kanyang pedicab bilang karagdagang kabuhayan ng kanyang pamilya.

Isa naman si Julie Dianne Fernando sa mga nagsilbi bilang contact tracer na kumuha ng datos ng mga Person Under Investigation (PUI) at Person Under Monitoring (PUM) sa mga lugar na inilagay sa lockdown.

Ayon sa lokal na pamahalaan, bagamat may kaya sa buhay si Fernando ay pinili nitong gumamit ng bisekleta sa tuwing pumapasok trabaho sa Bacoor City Health Center (Alima). Aktibo rin sa iba't ibang programa ng barangay si Imelda Angeles ng Barangay Dulong Bayan. Bilang isang health worker, bahagi rin si Angeles ng Barangay Health Emergency Response Team (BHERT) at palagiang tumutulong sa mga cleanup drive sa kanilang komunidad.

Maging ang mga lider ng barangay na sina Aida Borja, Mary Ann Sacari, Matilde Dumali, Maribel Paraizo, Maria Lourdes Bautista, ay kinilala rin para sa kanilang hindi matatawarang serbisyo sa kani-kani lang nasasakupan sa kabilang pandemya.

Nagbuwis naman ng buhay si Emlyn Patrocino na sa kabilang ng makailang beses na nagpositibo sa COVID-19 ay patuloy pa rin siya sa pagkokonduktu ng monitoring sa mga kaso ng COVID sa kanilang barangay.

CARABAO HEALTH CARAVAN

To monitor the number of carabaos that can produce milk and to increase the number of pregnant carabaos in Tanza, Cavite, Provincial Veterinary Office in partnership with the Department of Agriculture – Philippine Carabao Center in UP Los Baños conducted Carabao Health Caravan in the area thru its Municipal Agriculture Office on March 8, 2021. A total of 197 carabaos underwent health checkup,

deworming, vitamin injection and antibiotic injection.

Other activities done were breeding services such as pregnancy diagnosis wherein 32 carabaos tested positive out of the 92 carabaos that underwent the procedure, ovarian palpation and artificial insemination. Carabao profiling and ear tagging and calf drop monitoring was also done.

BatMC chief is first CALABARZON comorbidity to receive Sinovac jab

CALAMBA CITY (PIA)

-0 Batangas Medical Center (BatMC) Chief, Dr. Ramoncito C. Magnaye, became the first medical worker with comorbidity in the CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) region to receive COVID-19 vaccines from Chinese drugmaker, Sinovac during the recent national vaccination rollout in the province.

Magnaye led the charge of around 300 healthcare workers at BatMC who received their vaccines during the ceremonial COVID-19 vaccination for health workers held in this hospital.

"Dr. Magnaye is the first individual with comorbidities to receive the vaccine. Although he has a choice not to accept the vaccine due to health reasons, he decided to do it to show that the vaccine--whether Sinovac pa yan or Astrazeneca--ay safe na gamitin," Janairo said, assuring that the

inoculation on the BatMC chief was greenlit by his physician.

Janairo personally administered the vaccine on Dr. Magnaye.

At 58 years old, Dr. Magnaye is living with diabetes, hypertension and undergoes a regular dialysis. Despite his health, the physician chose to be vaccinated to show his colleagues that they are safe.

"Magpasalamat po tayo at tanggapin kong anung baka nang ibinigay sa atin dahil lahat naman po ito ay ligtas at epektibo para sa ating kalingtasan para malabanan ang Covid-19," he encouraged.

The Department of Health has already allotted a total of 1,011 doses to the hospital. Despite the arrival of the vaccines, Magnaye reminded the public to continue practicing minimum health protocols and to remain vigilant, in order to prevent the virus from spreading. **(PB/DOH 4-A)**

PGC establishes partnership with Batangas LGUs for disaster readiness

Trece Martires, Cavite (PIA) – The Provincial Government of Cavite headed by Governor Jonvic Remulla convened a meeting for the Taal Volcano eruption evacuation plan together with Presidential Legal Counsel Atty. Salvador Panelo, Vice Governor Ramon 'Jolo' Revilla III, Cavite 8th District Local Chief Executives, LGU heads in Batangas province and village chiefs, on March 2, 2021 at the Tagaytay City Convention Center.

This was done in the wake of the continued activities of the Taal Volcano for the past several days with the Alert Level 1 maintained in the area.

"Bilang paghahanda, bukas po ang mga bayan dito sa 8th District ng Cavite para sa mga evacuees kung sakaling sumutok ang Bulkan Taal," Remulla assured the LGU heads from the neighboring province of Batangas and added further, "Kung kinakailangan po ng higit pang evacuation center, ang buong Cavite ho ay bukas at handa kayong kupukupin."

(In preparation, the towns here in the 8th District of Cavite are open for evacuees in case Taal Volcano erupts," Remulla assured the LGU heads from the neighboring province of Batangas and added further, "If more evacuation centers are needed, the whole of Cavite is open and ready to accommodate you.)

Cavite Provincial Disaster Risk Reduction and Management Office (PDRRMO) Head Eloisa Rozul assigned partner municipalities, with one Batangas town within the proximity of Taal Volcano having a partner town in Cavite.

Base on the latest Phil-Volcs Bulletin as of March 2, 2021, in the past 24-hour period, the Taal Volcano Network recorded forty-eight (48) volcanic earthquakes and forty (40) volcanic tremor episodes with durations ranging from one (1) minute to one and

a half (1.5) minutes. Alert Level 1 (Abnormal) is maintained over Taal Volcano. DOST-PHIVOLCS reminds the public that at Alert Level 1, sudden steam-driven or phreatic explosions, volcanic earthquakes, minor ashfall, and lethal accumulations or expulsions of volcanic gas can occur and threaten areas within the Taal Volcano Island (TVI).

The LGUs and all stakeholders are reminded to be vigilant and prepared for any eventualities. (Ruel Francisco with reports from Dennis Abrina)

Headed by the Office of the Provincial Governor together with the Cavite Mayors' League, a joint coordination meeting with Batangas Mayors (of Agoncillo, Laurel, Lemery, Talisay and San Jose) and Cavite Mayors (of Silang, Indang, Alfonso, Gen. Aguinaldo, Mendez, Amadeo, Magallanes), with their Barangay Captains and MDRRMOs was held at Tagaytay City earlier this morning to ensure that all concerned citizens of the LGUs will be rescued once the eruption of Taal Volcano takes place.

PNP personnel completes TESDA's driving training program

PASIG CITY (PIA)-- Personnel from the Philippine National Police (PNP) recently completed the Driving NC II Training Program of the Technical Education and Skills Development Authority (TESDA).

TESDA Secretary Isidro Lapeña personally awarded the 25 police personnel who completed the sessions through the Quezon City Lingkod Bayan Skills Development Center. Lapeña was also joined by TESDA-NCR Regional Director Florencio Sunico and other officials from the PNP.

The quality driver training, conducted through one-on-one practical teaching, was conducted by TESDA-certified instructors.

The Driving NC II, which takes a minimum of 118

hours to complete, trains drivers in operating light motor vehicles classified under the Land Transportation Office Restriction Code 1 and 2, transporting passengers and loads over specified routes to local or district location, and performing minor vehicle repairs and other minor servicing.

Various TESDA training programs are open for police personnel as part of their partnership to provide skills training to PNP – bringing TESDA's Technical-Vocational Education and Training (TVET) closer to Filipinos.

Meanwhile, another batch of 25 personnel from the PNP likewise started their training under the same driving program. (PIA NCR)

Use of KyusiPass contact tracing app now required for QC businesses

CALOOCAN CITY (PIA)

-- Business establishments in Quezon City are now required to use the KyusiPass digital contact tracing app for their employees and consumers to further strengthen the city's contact-tracing capability amid the rise in the number of COVID-19 cases in the city.

Mayor Joy Belmonte issued this directive, among others, in the revised guidelines released on March 5, 2021 in relation to the latest issuances by the Inter-Agency Task Force and the Department of Trade and Industry (DTI).

KyusiPass, a contact

tracing app powered by SafePass, can help the city keep track of the visitors of every establishment within its jurisdiction.

"As far as practicable, all business establishments in QC must use our Kyusi Pass app to make contact tracing easier and faster for early detection of the virus," said Belmonte.

Under the latest guidelines, Belmonte directed business owners to secure a dedicated QR Code per establishment from the Business Permits and Licensing Department to tag its location.

"For clarity, a lessee inside a larger establishment, like individual stores inside malls, should have its own contact tracing log," said Belmonte.

Establishments that rely on manual contact tracing must encourage their customers to bring their own pen for logging in their name, address, and contact number.

Digital copies of these logs should be readily available to the City Epidemiology and Disease Surveillance Unit (CESU) for any given time should contact tracing be necessary. (PIA NCR)

NCR, Central Visayas, Calabarzon top active Covid-19 cases list

MANILA — The National Capital Region (NCR), Region 7 (Central Visayas), and Region 4-A (Calabarzon) have reported the highest number of active cases of coronavirus disease 2019 (Covid-19).

In its Covid-19 situation report released on Monday evening, the Department of Health (DOH) said NCR has 14,699 active cases, followed by Central Visayas at 6,023, and Calabarzon at 3,690 -- totaling to 24,412 out of 36,043 active Covid-19 cases in the country.

These three regions also reported the highest number of new cases — NCR with 1,540, Central Visayas with 495, and Calabarzon with 347.

Rate of spread

The DOH's current measure of Covid-19's ability to spread, or the Rt value, is at 1.23 ± 0.02 as of February 21.

"Based on the latest data, we are 95 percent confident that $Rt = 1.23 \pm 0.02$, which means each infected individual was infecting an average of 1.23 other persons around two weeks ago," the DOH said.

Lowering this value to less than one, it said, would mean that an infected person, on average, is infecting less than one person, and would eventually stop the transmission of the disease.

"Lowering this value is made possible through efforts such as social distancing, wearing of PPE (personal protective equipment), and other means to stop the spread of the virus," the DOH said.

On Sunday, the DOH said a total of 26,354 Covid-19 tests were administered to 24,633 individuals, with 2,259 or 9.17 percent returning positive with the disease.

In total, it said 9,068,396 tests were administered to 8,542,733 persons, with 667,341 or 7.81 percent returning positive with Covid-19.

Crackdown on violators

Meanwhile, the Department of the Interior and Local Government (DILG) has

ordered the police force to go after those ignoring minimum health protocols.

"So nag-utos po si DILG OIC (officer-in-charge Bernardo) Florece na tinatwag na crackdown sa mga nagva-violate ng ating mga minimum health standards at mga health protocols (On orders of DILG OIC Bernardo Florece, there is now a crackdown against those who violate minimum health standards and protocols)," he said in a Laging Handa briefing.

Malaya also urged local government units and their police forces to increase the number of police officers in populous areas in Metro Manila and other parts of the country as part of the efforts to stop the surge in Covid-19 cases.

He added that local ordinances related to Covid-19 protocols should be strictly enforced in line with this measure.

First time offenders will be given a warning while those on their second and third violations can be fined or imprisoned. (*with report from Lloyd Caliwan and Priam Nepomuceno/PNA*)

Hontiveros: Babae at bayanihan ang kailangan sa pagbangon

FOR this year's celebration of International Women's Day, Senator Risa Hontiveros asserted that women and the Filipino spirit of bayanihan are key in our COVID-19 recovery.

The senator, who chairs the Senate Committee on Women, Children, Family Relations and Gender Equality, has consistently put the spotlight on gender inequality, especially during the COVID-19 crisis.

"Babae at bayanihan ang dapat maghari para tunay na makabangon ang pamiliyang Pilipino. The pandemic only exacerbated the multiple burdens women already carry. If we want to wholly recover from this crisis, we need to band together to better support our women," she said.

Hontiveros adds that women's empowerment and support is particularly needed during a health crisis, because, according to the World Health Organization (WHO), 70% of the health and social workforce is made up of women.

In a 2019 analysis, WHO then emphasized that investments in the health workforce could lead to women's economic empowerment. For instance, while majority of healthcare

workers are women, they earn, on average, 28% less than men.

"Karamihan ng ating health workers ay babae, hindi lang dito sa Pilipinas kundi sa buong mundo. Kung mapalakas natin ang benepisyo at suporta sa bawat isa sa kanila, mas agrang makakabangon ang buong mundo mula sa pandemya," the senator said.

In this light, Hontiveros, along with other women senators, is set to file a bill for gender-responsive and inclusive protocols to address the gender-differentiated needs of women during COVID-19, and other public health concerns, emergencies and disasters.

"Ang krisis pangkalusugan at ekonomiya ay mas masosolusyunan kung gawin nating prayoridad ang ating kababaihan. Patong patong na ang bigat na dala ng ating mga babae — mga nanay, nars, guro, domestic workers, at marami pang iba. Akayin natin kami. Maging bayani tayo para sa isa't isa," Hontiveros concluded. PR

BOC-PCAG Collects Php

247,369,347.16 Additional Revenues for January to February 2021

THE Bureau of Customs, through the Post Clearance Audit Group (PCAG), posted additional revenue collection of Php 247,369,347.16 from January to February 2021 as a result of its intensified post-clearance audit verification and investigation of importers suspected to have violated the provisions of RA 10863 or the Customs Modernization and Tariff Act (CMTA).

According to PCAG, six (6) outstanding Final Demand letters were collected and forty-eight (48) applications for the Prior Disclosure Program (PDP) were filed from January to February 2021. Of the total PDPs filed, 31 were from Mechanically Deboned Meat (MDM) importers under audit tallying a total amount of Php 67,596,830.74, while 13 PDP applications were from Rice importers under audit amounting to Php 6,741,407.0.

PCAG also reported on the status of previously issued ANLs with six (6) PDP ap-

plications approved and seven (7) Final Audit Reports (FAR) completed. These resulted in the issuance of six (6) new Demand Letters amounting to Php 41,173,506.53 and one (1) Clean Report Findings. The Demand Letters shall become final and demandable upon the lapse of fifteen (15) days from receipt thereof by the importer.

Meanwhile, 28 ANLs were issued from January to February 2021, 17 of which are importers in the coffee industry, 10 in the oil and petroleum industry, and 1 consignee issued with ANL due to compliance issues based on the profiling conducted.

The Post Clearance Audit Group is optimistic that additional revenues will still be collected from post-clearance activities for the remaining months of 2021. Presently, there are still eleven (11) outstanding Final Demand Letters amounting to Php 6.9 billion which remain unpaid

and will be referred to the BOC Legal Service for the filing of the necessary collection suit.

The Bureau of Customs remains committed to carrying out its mandate of protecting government revenue by suppressing all illegal and irregular activities of unscrupulous importers through the Bureau's strengthened post-clearance audit efforts. PR

MANILA – Only 71 out of a total of 654 examinees passed the 2020 Special Bar Examinations for the Shari'ah Courts, the Supreme Court (SC) announced on Wednesday. In a statement, the high court said the top 10 passers are: Mocsir, Mohammad Hisham M. (87.075 percent); Saidamen, Ramayana D. (86.975 percent); Marangit, Mohammad Mojib D. (85.075 percent); Paglala, Julamin A. (84.625 percent); Pumbaya, Aina M. (83.525 percent); Ali, Sittie Aina M. (83.200 percent); Mamarungas, Nasihah S. (82.075 percent); Abubacar, Johari C. (82.025 percent); Panandigan, Raima P. (81.100 percent); and Taha, Nornisah M. (80.950 percent). This translates to a 10.8 percent passing rate for

CA affirms dismissal of Tolentino libel complaint vs. Ted Failon

MANILA – The Court of Appeals (CA) has denied an appeal by former Metropolitan Manila Development Authority (MMDA) chairman and now Senator Francis Tolentino questioning the dismissal of a libel complaint he filed against broadcaster Ted Failon in 2017.

In a six-page resolution dated March 5, the appellate court denied the motion for reconsideration filed by Tolentino, saying its decision on the case last year "stands".

"In sum, the motion for reconsideration has not raised any matter or cogent argument that we have not already considered and resolved in our decision dated July 7, 2020," the court said.

In its original decision penned by Associate Justice Pablito Perez, the CA's 12th Division dismissed the criminal complaint and ordered the Cavite Regional Trial Court (RTC) Branch 18 to cease and desist from the proceedings.

Aside from Failon, known as Mario Teodoro Etong in real life, the CA also cleared ABS-CBN's "Failon Ngayon" program story editor and head writer Gerald Oro, segment producer Abigail Lucas-Rondilla and executive producer Irene Grace Manotok.

The libel case involved a report on the purchase of second-hand motorcycles by the MMDA, which Tolentino then headed, "with

the examinations chaired by Court of Appeals Associate Justice Japar B. Dimaampao.

The examiners were lawyer Melchor Rey K. Sadain (Persons, Family Relations and Property), Dr. Asnavil G. Ronsing (Jurisprudence [Fiqh] and Customary Laws [Adat]); Dean Norhabib Bin Suod S. Barodi (Procedure in Shari'ah Courts), and Dr. Jamel R. Cayamodin (Succession, Wills/Adjudication, and Settlement of Estate). Dimaampao said that the examinations "will go down in history as the second-lowest passing percentage", after the 7.69 percent passing rate recorded in 1983.

The Shari'ah Bar exams were held on Jan. 19 and 26, 2020 at the Court of Appeals Centennial Building, Ma. Orosa Street in Manila. (PNA)

Tolentino appealed the DOJ ruling while the prosecutors filed a motion to withdraw the information. Failon took the case to the CA after the lower court judge failed to act on the prosecutors' motion.

Ruling in favor of Failon and his team, the CA said they had acted within their rights.

"Certainly, if we are to remain faithful to the dictum that public office is a public trust. Some leeway should be given to the public to express disgust or discontent – even if such expression is sometimes acrid, harsh, critical, vitriolic, and accusatory. The interest of society and the maintenance of good government demand a full and free discussion of public affairs," it said.

The CA also ruled that the lower court erred in saying actual malice is a matter of defense, which is the burden of the accused.

"We reiterate that as an essential element in cases involving public officials with respect to matters within the public's legitimate inter-

DOJ eyes skills training program for fiscals in HR, EJK cases

MANILA – Justice Secretary Menardo Guevarra on Wednesday said the government is finalizing a training program to improve the investigative skills of prosecutors assigned to handle alleged cases of extra judicial killings and human rights violations.

"We have implemented one (project) without any funding (from the UN)-the human rights summit last December. The next one will be a training program to enhance the investigative skills of prosecutors assigned to AO 35 cases," Guevarra told reporters.

The DOJ is part of the Administrative Order 35 Task Force, the inter-agency committee on extra-judicial killings, enforced disappearances, torture, and other grave violations on the right to life liberty, and security of persons.

The DOJ is scheduled to execute a project document to allow the funding for projects lined up in collaboration with the United Nations (UN).

Meanwhile, Guevarra expressed misgivings about a statement attributed to Ravina Shamdasani, spokesperson for the UN Office of the High Commissioner for Human Rights (UN OCHR), reacting to the reported death of nine individuals in last weekend's search warrant operations conducted by the police in Calabarzon.

"Anyone, including the OH-CHR, must have sufficient information before making a judgment," Guevarra said.

Guevarra on Monday said they will dig deeper into these incidents.

The Philippine National Police earlier confirmed that six individuals in Rizal, two in Batangas, and one in Cavite died in "search warrant operations".

It added that six others were arrested -- three each in Laguna and Rizal while nine are still at large -- eight in Rizal and one in Batangas. (PNA)

On April 18, 2014, the victim was taken by Sandhu to a room, blindfolded and struck in the head. They then boarded a vehicle which traveled for around five hours.

When the vehicle stopped, the victim got an opportunity to escape, ran, hailed a taxi and told the driver to bring him to Paco, Manila. He then sought the help of Majinder Kumar, president of Kalsadiwan Inc. Indian

Sikh Temple. Gurinder denied the charges and claimed he was in Legazpi City, Albay at the time the crime was committed. He denied ever meeting the complainant or having been in Bataan and Las Piñas.

"Verily, private complainant's positive identification of his captors, accused-appellant and co-accused Gurjdwinder Singh and Baldev Singh, must prevail over accused-appellant's lame denial and alibi," the CA ruled.

The two other co-accused remained at-large. Associate Justices Myra V. Garcia-Fernandez and Zenaida T. Galapate-Laguiles concurred with the ruling. (PNA)

CA affirms conviction of Indian who kidnapped compatriot

MANILA – The Court of Appeals (CA) has upheld the conviction of an Indian national who kidnapped and detained a fellow expatriate recruited to work for a lending business in the Philippines. In a 22-page decision rendered March 4 and written

by Associate Justice Fernanda Lampas Peralta, the CA Special Second Division upheld the Las Piñas City Regional Trial Court (Branch 255) decision convicting Gurinder Pal Singh for serious illegal detention and sentencing him to reclusion perpetua.

The victim, Sandhu Jag Jiwan Singh, was recruited by Gurjdwinder Singh Sandhu, to work in the Philippines for a monthly salary of PHP50,000. He arrived in the Philippines on June 6, 2011 and was met at the airport by the suspect, Baldev Singh, Surinder Pal Singh, and Joginder Singh. They took him to accused Sandhu's house in Sta. Maria Subdivision, Bataan, where he was kept while working without pay for the accused's money collection business. The victim claimed that his

Santa Rosa HCWs get first AstraZeneca jabs in CALABARZON

CALAMBA CITY (PIA) - Healthcare workers in the City of Santa Rosa are banking on the vaccines against COVID-19 to provide them extra protection as the region's frontliners against the pandemic.

At least 150 health workers from Qualimed Health Network Santa Rosa received their vaccines last Sunday, March 7, during the rollout of the national vaccination program in this city.

The national government has allotted an initial batch of 150 AstraZeneca vaccines and 350 Sinovac vaccines for medical frontliners, making them the first private hospital outside Metro Manila to receive

vaccines from the World Health Organization-led COVAX facility.

It is expected that these will be administered within the next few days.

Health workers led by AC Health Chief Operating Officer and President, Dr. Edwin Mercado, Senior Vice President for Medical Affairs, Dr. Manuel Roxas and Qualimed Santa Rosa Medical Director, Dr. Lilibeth Maravilla were among the first to receive their vaccines from the British Drugmaker, as a show of their trust in the national vaccination program.

"The best vaccine is the one available right now. Hindi natin pwede hintayin ang susunod na bakuna

dahil walang katiyakan kung kailan at paano ka mae-expose. Lahat ng bakunang nilalabas ng gobyerno ay dumaan sa masusing pag-aaral ng Department of Health at Food and Drug Authority." Mercado assured his fellow medical workers.

As one of the priority sectors in the inoculation program, medical workers at Qualimed need not much convincing as almost 100% of their 378 employees have already signed up for the program.

"Vaccination is one of the stepping stones para sa pagtatapos ng pandemy. Kung hindi magpapabakuna ang mga tao, hindi tayo uusad," Hospitalist, Dr. Sue Anne Chanel Kua said.

The city government has secured 300,000 doses of Astrazeneca vaccines to augment the national vaccination program for their healthcare workers.

"Gusto natin syempre protected ang ating healthcare workers, first of all," said Santa Rosa City Mayor Arlene Arcillas, who graced the event to show the local government's support in the health sector's initiative.

Through the vaccines secured through a tripartite agreement, Arcillas said the vaccines will be beneficial especially to the economic frontliners in their city.

As one of the economic players in the region, Santa Rosa City houses five (5) industrial hubs, where residents within and outside the city are earning their livelihood.

It is expected that more priority sectors in the city will be inoculated against the disease within the next few days. Arcillas said they are also waiting for the arrival of 100,000 doses of COVID-19 vaccines made by American drugmaker, Moderna.

"Yung hindi mako-cover ng national [government], we will cover it. And we're very happy that soon, Moderna will arrive because we reserved 100,000 [vaccines]. Yung hindi mako-cover, kasama na yung economic frontliners natin, iko-covering city and the private sector," the local chief executive assured. (PB)

Mga Calambeño, walang dapat ikatakot sa bakuna – Mayor Chipeco

CALAMBA CITY, Laguna (PIA) – Walang dapat ikatakot ang mga residente ng Calamba City, Laguna sa bakunang gawa ng Chinese biopharmaceutical company na Sinovac, ayon kay Mayor Justin Marc 'Timmy' Chipeco.

Paalala ng punong lungsod sa publiko na huwag maniwala sa mga sinasabi ng iba tungkol sa bakuna gayong wala namang malinaw na ebidensiya ang mga ito. "Huwag ho tayong madaan agad sa takot, sa bagay na hindi natin alam. Ang maganda po alamin natin, pag-aralan natin ng mabuti," pahayag ng alkalde sa panayam sa kanya ng UNTV News.

"Karapatán ng bawat isa kung anong gusto niyang gawin sa katawan niya at naiintindihan namin 'yon bilang opisyales. Pero, tinuturan din namin kayo na pag aralan kung anong makakabuti sa inyo at huwag lang madadaan kung ano ang takot na idinudulot ng ibang tao na wala namang dahilan," dagdag nito.

Ito ay kasunod ng mga kurikalat na impormasyon na hindi epektibo ang Sinovac vaccine na nagdudulot ng agam-agam sa publiko. Ayon pa sa alkalde na epektibo ang Sinovac vaccine dahil ginawa ito sa tradisyon na paraan.

"Ang Sinovac, bagaman gawa sa China, they use the traditional method of manufacturing the vaccines, which is killing the virus itself at ini-introduce sa katawan natin so that our immune system can identify it," pahayag ni Chipeco.

"Ang personal na opinyon ko, na wala namang masamang epekto yon kasi yung ginagawang sistema at proseso ay ginawa na rin sa proseso na matagal na panahon na nating ginagawa."

Kung papayagan umano ng national government ay mauunang magpapabakuna si Mayor Chipeco upang maalis ang agam-agam ng mga nasasakupan nito sa Sinovac vaccine.

Sa ngayon ay hinihatay na lamang ng pamahalaang lungsod ng Calamba ang pagdating ng bakuna upang masimulan na ang vaccination rollout sa lungsod.

Public-private partnership key to addressing Covid-19 in Santa Rosa City — Mayor Arcillas

SANTA ROSA CITY, Laguna (PIA) — For Santa Rosa City Mayor Arlene Arcillas, the key to resolving the coronavirus disease 2019 (Covid-19) pandemic is through active partnership between the public and private sectors.

In her message during the AstraZeneca vaccine rollout in Qualimed Hospital - Santa Rosa on Sunday, March 7, Arcillas underscored that the combined efforts of the city government, national government, and private sectors especially with the Ayala Corporation have enabled them to ease the effects of the Covid-19 pan-

demic.

"We were able to weather this pandemic because of the partnership of the national, local and of course the private sectors—and that happened in the City of Santa Rosa," Arcillas said. This was emphasized by Mayor Arcillas as she expressed her gratitude to the Ayala Corporation for supporting and helping the city in its Covid-19 response and other health programs. She said the Qualimed Hospital managed by the Ayala Corporation was the first to establish an RT-PCR laboratory and isola-

tion facility in the city.

Mayor Arcillas added that the Qualimed Hospital will be one of its partners in rolling out the citywide vaccination drive as they tap private hospitals in the city to serve as vaccination centers.

"Ayala Corporation has been helping us all through these years. I'm very happy because in the City of Santa Rosa, public-private partnership truly works and it is happening now," the City Mayor said.

Arcillas also thanked the National Task Force Against Covid-19 for authorizing them to secure doses of AstraZeneca vaccines through a tripartite agreement. She said the vaccines would benefit not only the residents of Santa Rosa but also the private sectors and economic frontliners within the city.

She also expressed hope that the public-private partnership would remain in Santa Rosa not only in its Covid-19 response programs but also to other initiatives of the city government.

Meanwhile, the Ayala Corporation also believes that "the best way to beat the virus is for the public and private sector to work together collaboratively."

Ayala Corporation President and Chief Operating Officer Fernando Zobel De Ayala said with the help of the government, they were able to establish an RT-PCR testing laboratory to perform Covid-19 tests.

He said since the opening of the laboratory and Covid-19 facilities they were able to perform almost 150,000 of tests throughout our network of labs and triage over 500,000 patients across their Qualimed Hospitals and healthway clinics.

"This is proof of how a successful partnership between the government and the private sector ultimately translates to improve healthcare services for more Filipinos," the Ayala Corporation President and COO said.

On Sunday, March 7, the Qualimed Hospital – Santa Rosa began its Covid-19 vaccination program for its medical healthcare workers after receiving the AstraZeneca vaccines from the national government. At least 150 medical frontliners, received AstraZeneca jabs during the rollout of the vaccination program. (FSC)

San Pablo HCWs receive first Laguna COVID-19 jab

SAN PABLO CITY, Laguna (PIA) - Local healthcare workers (HCWs) are hopeful that the national vaccination program will help protect themselves from the 2019 coronavirus disease (COVID-19) as the frontliners in the nation's road to recovery from the pandemic.

The Department of Health Region IV-A (DOH-CALABARZON) has rolled out its COVID-19 vaccination program in Laguna province at the Laguna Provincial Hospital - San Pablo City District Hospital (LPH-SPCDH) last March 6, where around 200 medical frontliners were inoculated against the disease.

It is expected that the remaining 126 vaccines will be administered to medical frontliners within the second week of inoculations.

A total of 1,067 Sinovac vaccines were allotted in Laguna province. It includes Laguna Provincial Hospital and San Pablo District Hospital (334), Laguna Medical Center (415) and Dr. Jose P. Rizal Memorial District Hospital (318).

Meanwhile, around 326 vaccines are expected to be administered within the first two days of the vaccination rollout in the city.

In his message, DOH-CALABARZON Regional Director Eduardo Janairo III assured medical frontliners that the vaccines were carefully studied.

"May mararamdaman kayo na hindi ko matatawag na adverse effects after vaccination, pero ito ay pansamantala lamang at isang patunay na gumagana ang bakuna sa ating katawan," Janairo said.

San Pablo City District Hospital OIC Chief, Dr. Edgar Palacol, Intensive Care Unit nurse Marvic Umali, provincial pathologist Dr. Imelda Palacol, and Department of Surgery head, Dr. Francis Ravera were among the first to be given their vaccines as a sign of their trust in the national vaccination program.

For Palacol, getting inoculated against the disease was not a difficult decision to make as he believes in the programs of the Department of Health, including the vaccines they vouch for.

"Ang pinaka-safe na bakuna ay approved ng FDA, ng WHO, ng ating DOH at kung ano ang unang nandito. Kalaban natin ang oras, kailangan natin ma-reach ang herd immunity sa bansa para maiwasan ang pagkalat ng COVID-19," Palacol said, referring to the Food and Drug Authority and the World Health Organization, who vouch for the quality of vaccines before they are distributed in the country.

The arrival of COVID-19 vaccines also helped boost the morale of the medical staff of LPH-SPCDH, who are at the frontlines in the city's fight against the pandemic.

No adverse reaction was reported among the first vaccinees, who underwent check-ups at a Post Vaccination area immediately after receiving their shot.

Similar to its simulation, medical equipment was placed within the compound in case of emergencies during the vaccination.

Meanwhile, Governor Ramil Hernandez, Vice Governor Katherine Agapay, Mayor Loreto Amante and Third District Board Member Abi Yu joined Janairo and Assistant Regional Director Paula Paz Sydiengco, as a sign of the province's support in the national vaccination program, which aims to protect the Filipino people against the coronavirus.

Although he was willing to be inoculated to show his support in the national vaccination program, Hernandez assured that local officials are willing to wait for their turn.

"Papaunahan natin ang frontliners. Nakapaghintay nga tayo ng isang taon, ano ba naman ang ilang araw lang na mahintay tayo para mauna ang mga dapat mauna," Hernandez said. (PB)

Calabarzon ops legitimate: PH Mission to UN

MANILA – The Philippine Mission to the United Nations in Geneva defended as "legitimate" the law enforcement operations in Calabarzon that resulted in the deaths of nine activists and the arrest of six others on March 7.

This came in the wake of a statement from the Office of the High Commissioner for Human Rights (OHCHR) that denounces what it describes as "arbitrary killing".

"We are appalled at OHCHR prejudging legitimate police operations on Sunday in the Philippines vs persons possessing dangerous firearms and explosive devices. We regret this overreach of OHCHR's mandate -- clearly uninformed of facts on the ground," the Philippine Mission said over Twitter on Tuesday night. It said there is "no basis

for calling deaths resulting from these operations as arbitrary killing," adding that these were carried out "strictly within the bounds of law, on 40 search warrants secured by the police after a rigorous legal process."

When deaths occur during operations conducted by security forces, investigations are "automatically" launched in the Philippines, it added.

"And this will be true for the search ops in Luzon last Sunday," it said. "We ask OHCHR to correct hasty opinions favoring violators of the law & instead support efforts to uphold law & order."
