

## DTI CALABARZON AWARDS EQUIPMENT TO WOMEN MICRO ENTREPRENEURS

CALAMBA CITY, Laguna (PIA) --The Department of Trade and Industry Region 4-A turned over equipment for Coffee Women Micro Entrepreneurs in Laguna and Cavite in support to the celebration of the 2021 National Women's Month celebration with the theme, "Juana Laban sa Pandemya: Kaya."

Under the Supporting Women's Economic Empowerment in the Philippines Project or GREAT Women Project 2, the equipment were handed over to women beneficiaries on March 16, 2021 in Calamba City and on March 17, 2021 in Amadeo.

The GREAT Women Project 2 is a project funded by the government of Canada that seeks to improve the economic empowerment of women micro entrepreneurs (WMEs) and their workers through improving competitiveness and sustainability of WMEs and the enabling environment for women's economic empowerment.

"The COVID-19 pandemic has brought numerous challenges to many businesses, especially to our WMEs. We are hoping that through this technology assistance to our WMEs in the CALABAR-ZON region, we would be able to enhance the productivity and competitiveness of our WMEs and to aid in their capital lost and decreasing sales," said DTI CALABARZON Director Marilou Q. Toledo.

In Laguna, five sets of coffee storage equipment were awarded to Michael Pillas of Elbi Coffee Hub, a foot sealer to Lucilyn Villanueva of Mabato Coffee and HVC Agriculture Cooperative and a coffee cupping set to Michelle Dela Cruz of Casile Guint-

ing Upland Marketing Cooperative.

In Cavite, a tabletop coffee grinder was given to Agnes Madlansacay of Café Amadeo Development Cooperative, a commercial coffee grinder each to Olivia Lansang of Olivia's Coffee Seed Shop and Arsenia Lopez of She Brews Coffee, and a foot sealer to Bettina Grace Belardo of Belardo Coffee Enterprises.

Eleanor Medina, owner of ESM Food Products and a beneficiary of the Packaging and Labeling Project under the Industry Cluster Enhancement Program, was awarded with packaging prototypes with the improved logo and packaging label design. The ICE Program seeks to develop priority industries through institutional development, industry strengthening and cross sector collaboration among government, private and nongovernment organizations across the different areas in the value chain.

In the recent efforts, the Philippine Commission on Women, the lead executing agency for the project in partnership with other agencies of the Women's Economic Empowerment - GREAT Women Project 2 (WEE-GWP2), rolled out an impact study in 2020, which assessed the situation of the WMEs.

The study revealed that majority of the WEE-GWP2 enrolled WMEs had been hard hit. Majority of respondents reported to have stopped production and operation. Employees and members of the organizations accounted 75% decrease to no sales at all, and 64% said they no longer have enough capital available. (CPP, PIA-4A with report from DTI-CALABARZON)

## Cavite LGUs commence respective COVID-19 vaccination programs

TRECE MARTIRES, Cavite (PIA) --Several cities and municipalities in the province commenced their COVID-19 vaccination program to immunize medical health workers both in public and private institutions against the disease.

This is in the wake of the nationwide implementation of the government's COVID-19 vaccination program using AstraZeneca vaccines from the COVAX facility of the World Health Organization (WHO) and the Sinovac vaccines from China.

The cities of Tagaytay, Bacoor, and Trece Martires City held their respective localities' vaccination rollout on the same day, March 10, 2021.

Tagaytay City Mayor Agnes Tolentino, a medical professional, helped administer AstraZeneca vaccines to Dr. Warren Roraldo, a medical surgeon at the Tagaytay Medical Center and Dr. Rafael Rodriguez, TMC Director. The vaccines were part of the first batch of vaccines for the 585 healthcare workers in the city.

In Bacoor, the city government recorded a total of 1,464 health workers vaccinated as of Friday, March 19, 2021 since the city's official vaccination rollout held at the Southern Tagalog Regional Hospital on March 10. The LGU targets a total of 2,200 health workers and medical practitioners from both public and private hospitals and clinic in the city.

Meanwhile, about 124 doctors, nurses and other frontline health workers of the Gen. Emilio Aguinaldo Memorial Hospital in Trece Martires were vaccinated during the rollout held at the converted "Bakuna Center" of the Women's Health building located within the compound of the provincial hospital.

On the other hand, the City of Imus' Drive-Thru CoViD-19 Vaccination site at the Robinson's Place Imus ensured the quick and safe distribution of the vaccine to almost a thousand medical frontliners from both public and private hospitals in the city as of Friday,

March 19, 2021. The initiative of the city government is the first drive-thru set up in the country.

Dasmariñas City Mayor Jenny Austria-Barzaga, a nurse by profession personally supervised the launching of the facilitation of the COVAX at the De La Salle University Medical Center (DLSUMC). The Mayor gave the first iab of the first dose of the AstraZeneca vaccine to two distinguished physicians of the DLSUMC, Dr. Roberto Espos, and Dr. Charles Yu on March 15, 2021. This is the first batch of health frontliners of the more than 1,700 target beneficiaries in said medical facility.

In the City of General Trias, the official launching of the city's COVID-19 vaccination program, inoculated a total of 120 medical health-care workers using the first dose of the vaccines from the 184 vials of the Astra-Zeneca vaccines provided by the national government.

The vaccination rollout of the LGU Tanza was held at the Tanza Specialist Medical Center with the hospital's pediatrician, Dr. Alma Anakay receiving the first jab of the Astra-Zeneca vaccine as well as Municipal Health Officer Dra. Ruth Punzalan. The target beneficiaries in the municipality are more than 60,000 frontliners including teachers, uniformed personnel and other municipal frontliners.

municipal govern-The ment of Carmona launches its CoViD-19 vaccination program today, using the 961 doses of AstraZeneca vaccines that were personally received by Mayor Roy Loyola and Rep. Dahlia Loyola on March 20, 2021. And, March 21, the municipal government of Noveleta led by Municipal Health Officer Dra. Hilda Bucu received the vaccines and personally supervised the safekeeping procedure in the cold ttorage facility until the official launch of the locality's vaccination program on March 23, 2021. # Rizal post-pandemic tourism banks on art, religion, and nature-DOT

CALAMBA CITY (PIA) Tourism in the province of
Rizal under the new normal will bank on its cultural
landmarks, scenic views,
and adrenaline-inducing
nature activities, the Department of Tourism Region IV-A (DOT IV-A) reveals after making its final
preparations for the CALABARZON Tourism Circuit
launch.

Regional Director Michael Palispis led the tourism circuit validation in Rizal province, together with representatives from the Department of Health, Philippine Information Agency, Rizal Travel Agencies Association, Inc., and local tourism officers, to assess the readiness of travel destinations included in the tourism circuit in accepting clients, as prescribed in the public health and safety protocols of the Inter Agency Task Force Against COVID-19

Agency Task Force Against COVID-19.
"They have identified Faith, Fun, Adventure, and Nature for Rizal. That's why we can see the destinations we have visited during the past few days puro outdoors and with a touch of arts and culture," Palispis said of the tourism activities that will be highlighted in promoting tourism in Rizal province.
Set to be marketed as the

Set to be marketed as the Faith, Fun, Adventure and Nature destination in the region, the DOT and DOH evaluated a diverse set of destinations, such as the Antipolo Cathedral, Antipolo Pasalubong Center, Hinulugang Taktak Falls,

ATV Adventure Rizal, Flor's Garden, Cloud 9 Sport and Leisure Hub, Christ the King Church in the Sky, Blanco Family Museum, Nemiranda Art Cafe, Pinto Art Museum, Angono street murals, and Taytay tiangge.

"For Rizal Province, we

"For Rizal Province, we have just conducted our final validation of the destinations included in the clusters. We have visited the city of Antipolo, Angono, Taytay, and Cainta. So we had our validation in Angono which is the art capital of the Philippines and we visited several art galleries. Hopefully in the next few months we can lunch the cluster of Rizal," Palispis said.

More commonly known as the Green Corridor Initiative, this flagship project of the DOT IV-A aims to safely reopen the region for tourism.

Under the new normal, the Green Corridor Initiative plays a vital role in maintaining regional diversity, improving environmental quality, offering economic opportunities as well as protecting heritage and culture in the region.

Together with the DOH, Tourism Promotions

# Case surge resets ATA oral arguments to April 6

MANILA - The Supreme Court (SC) on Monday announced that oral arguments on petitions questioning Republic Act No. 11479, or the Anti-Terrorism Act (ATA), will resume on April 6 after concerns were raised over the rising number of coronavirus disease 2019 (Covid-19) cases.

In a notice, Clerk of Court Edgar O. Aricheta said that "due to the alarming increase of Covid cases, the court has ordered the suspension of the continuation of the oral arguments set for March 23.

The Department of Health reported 8,019 new cases and 103 recoveries on Monday.

The fifth day of oral arguments was to hear the opinions of former Chief Justice Reynato Puno and former Solicitor General Francis Jardeleza.

Puno and Jardeleza have been designated by the Court as amici curiae (friends of the court).

Solicitor General Jose Calida, representing the government, has yet to be heard, too.

A total of 37 petitions were filed questioning RA No. 11479, signed by President Rodrigo Duterte on July 3, 2020.

During the previous oral argument on March 2, Associate Justice Edgardo delos Santos said terrorist attacks over the years have chilling effects on survivors and witnesses.

Delos Santos issued a reaction after petitioners during the fourth day of interpellation claimed that the law has a chilling effect on the rights of the petitioners.

Delos Santos interpellated former Bayan Muna representative partvlist Neri Colmenares on the so-called chilling effect of the legislation.

"Do you mean to say you fear the passage of the law? The law has its chilling effect on the rights of petitioners. How about those from Metro Manila and the nearby places? Can the chilling effect be quantified?" he asked.

Citing figures earlier cited by Associate Justice Amy

Lazaro-Javier, delos Santos asked Colmenares for his comment in connection with the 78 documented bombings in Mindanao since 1971, which he said resulted in "hundreds if not thousands of victims including children, pregnant women, elderly or old people who are either maimed beyond recognition and died or decapitated, dismembered or severely injured".

"I think you will agree with me that this gruesome picture of violence and death has a chilling effect on the survivors and witnesses of the senseless bombings," delos Santos said.

Colmenares insisted that intelligence work would suffice.

For his part, Associate Justice Ricardo Rosario questioned the petitioners' insistence that police work without the new law, mentioning the September 11, 2001 bombings in the United States.

"The way I see it, terrorism is a much complex crime requiring as it does, some elaborate planning precision timing, perfect execution, and a vast network of conduits and accomplices to carry out," he said.

Rosario said terrorism is nothing compared to common crimes as murder, theft, or robbery.

"A fine example is the 9/11 attack which, from media accounts, was successfully launched because of the painstaking planning and the commitment of the perpetrators. Given the terrorist's commitment to succeed and considering the elaborate planning and furtiveness in the preparation and execution and the damage that it causes don't you think the authorities should be given somewhat more slack in dealing with it?" he said.

He said terrorism is not a simple conspiracy that can be discovered overnight or with little time at all, "like in other common crimes and where conspirators are brought to justice because of some timely sleuthing skills". (PNA)

## Senate resolution calls for protection of judges, lawyers

MANILA - The Senate on Wednesday adopted a resolution condemning the rampant killings and acts of violence against members of the legal profession and urging President Rodrigo Roa Duterte to take the necessary steps to ensure their safety and protection. Senate Resolution No. 691 was introduced by Senate Minority Leader Franklin Drilon and Senators Juan Edgardo "Sonny" Angara, Pia Cayetano, Francis "Kiko" Pangilinan, Aquilino "Koko" Pimentel III and Francis "Tol" Tolentino. All senators were made coauthors of the resolution.

"We condemn, in the strongest sense, the killings of and acts of violence against members of the bar and bench. To not act nor speak will be an act of cowardice," Drilon said in his sponsorship speech.

"We further urge the President to undertake the necessary steps in ensuring the safety and protection of the judges, prosecutors

and lawyers. We ask that he lays out definitive solutions and actions to address the rampant and unspeakable violence and killings. We petition for prompt, impartial and efficient investigation and prosecution of the cases. We seek justice for our slain colleagues," he added.

Drilon said in the last 20 years, 100 lawyers were murdered.

He cited a Department of Justice (DOJ) data which showed that 54 members of the legal profession had been killed since 2016. Of that number, he said 13 were prosecutors and eight were judges. The DOJ data showed that only five of the cases had actually reached the courts.

He said the Free Legal Assistance Group (FLAG) had pegged deaths at an even higher number at 61. Aside from the killings, Drilon said there were also threats, harassments, intimidations, surveillance and some other forms of attacks, such as the rapid escalation of red-tagging against lawyers.

He said the legal community was shaken early this month by a request from a police lieutenant from Calbayog City asking the Calbayog Regional Trial Court for a list of lawyers who represent terrorist/communist group personalities.

'The situation is made worse by the lack of general condemnation of prompt and efficient investigation, and impartial prosecution, Drilon said. "This horrendous pattern of taking lives and violence, impunity,

Drilon said the failure to condemn, investigate and prosecute the brazen killings against the legal community and bring the perpetrators to justice is an act of injustice in itself.

He said lawyers, pros-

ecutors and judges play a crucial role in the administration of justice in the country, especially in representing the most marginalized members of the community.

"They should be able to exercise their sworn duties and represent their clients or dispense justice without threats, persecution and fear for their safety and their lives," he added. (PR)

Mga psychologists, health professionals, social workers, paraprofessionals, at social workers ay ilan lamang sa magsisilbing mga facilitator para sa naturang programa. Tatalakayin naman ng mga modules na gagamitin sa programa ang mga usapin tulad ng child development, home

development, pagtuturo ng magandang asal, at pag-kakaroon ng malusog na kapaligiran para sa mga kabataan.

Sa isang survey na isina-gawa ng Social Weather Stations (SWS), halos siyamnapung (89) porsyento ng mga pamilyang may kasaping nag-aaral (edad lima hanggang dalawampu) ang nagsasabing mas nahihirapan sila sa blended learning kung iha-hambing sa face-to-face classes. Lumabas din sa naturang survey na anim-napung (60) porsyento ng mga pamilya ang naglalaan ng mas maraming oras sa pagtuturo at kadalasang ang ina ang nagtuturo sa mga anak.

# **Hontiveros: Include COVID-19** among occupational diseases under gov't compensation program for employees

SENATOR Risa Hontiveros on Wednesday urged the Department of Labor and Employment (DOLE) and Employees Compensation Commission (ECC) to declare COVID-19 as an occupational disease so that workers can avail of insurance and other benefits that are demandable under the Employees Compensation Act and Employees Compensation Program.

"Workplaces and mass transportation are the new 'hot spots' of virus transmission. Dapat nang aksyunan ng gobyerno ang panawagan na 'occupational gawing disease' ang COVID-19 to ensure that the workers who will contract the disease while at work or in transit will be compensated under the national policy for employment injury benefits," she said.

explained Hontiveros that once Covid-19 is listed by ECC as a workrelated disease, workers will be entitled to medical benefits, compensation for lost income, and even funeral services in the event that the employee dies from the disease.

This measure, according to the Senator, is very crucial especially with the rising cases and spread of new variants of COVID-19 that led to the imposition of stricter quarantine protocols in the National Capital Region (NCR), Laguna, Cavite, Bulacan and Rizal.

"Pinabalik ang manggagawa sa trabaho pero kulang na kulang ang pag-aalagang ibinibigay ng gobyerno. Huwag natin silang tratuhing parang imortal. Hindi curfew o checkpoints ang kailangang kundi garantisadong proteksyon sakaling mahagip o tamaan sila ng virus," Hontiveros said.

Hontiveros also stated that there may be no infection in the work place but a worker may be infected in transit to and from his work place. She believes that this should also be compensable.

"Hindi na dapat maging burden pa ng empleyado na patunayang nakuha niya ang virus sa kanyang trabaho. Dahil ang mismong pag-byahe ng mga manggagawa mula sa bahay papasok ng trabaho sakay ng mga pampublikong sasakyan ay work-related sacrifice na ginagawa na ng mga manggagawa," she added.

The Senator furthered that the unified workplace and community disease surveillance database, a mandate she introduced in the 2021 budgets of DOLE, Department of Interior and Local Government (DILG) and Department of Health (DOH), should help ECC establish that the COVID-19 was indeed acquired at the work place.

Hontiveros, who filed the Balik-Trabahong Ligtas bill in the Senate, also said that had the government prioritized the safety of workers as they went back to their work places, the cost of reviving the economy would not be as heavy and fatal to both the workers and the industry.

"Hindi pa huli ang lahat para ituwid ang pagkakamali. Huwag lang puro lip service ang 'excellent' performance. Kung magpapatuloy ito, itinutulak lang ang mga manggagawa sa bingit ng walang-katapusang pangamba, sakripisyo at pagkagutom," she concluded. PR

# Retiring SC chief cites '10-point' gains

MANILA – Chief Justice Diosdado Peralta on Monday cited the gains made by the judiciary during his watch at the last flagraising ceremony he attended at the Supreme Court (SC).

SC chose to forgo the usual honor guards and other events when the highest court official retires in light of ongoing health precautions against the coronavirus pandemic.

Peralta's optional retirement will take effect on March 27, a year ahead of his mandatory retirement.

He cited the achievement of his Ten Point-Program, which focuses on four core areas: efficiency, integrity, security and service.

"Under my helm, the Supreme Court has formulated and approved 18 procedural rules and guidelines meant to improve the administration of justice and address the problem of clogged court dockets. We have restructured and streamlined the plantilla of various offices, divisions, and services of the Court so as to guarantee security of tenure for the employees and to improve our processes," he said in his speech.

Peralta also cited the establishment of the Judiciary Public Assistance Section to promptly receive and act on concerns, issues, suggestions, and other relevant matters, including complaints against erring court officials and employees.

"We have also formally organized the Judicial Integrity Board to further prevent and curb corruption in the Judiciary," he added.

In addition to the procedural and institutional reforms, the past year saw the SC address "the various concerns and issues related with the task of judicial administration that were necessitated by the Covid-19 pandemic".

SC issued Administrative Circulars adopting measures to protect the safety and health of the court employees and court users, such as the daily court operations with skeleton staffing; restricting entry into Halls of Justices to only those with official business; reinforcing physical distancing within court premises; the constant sanitation of court premises and monitoring of the health of court personnel; the restructuring of various faceto-face training programs and activities of the Court into hybrid or blended learning platforms; and the conduct of online trials and hearings in all the courts.'

# Climate change drove ethnic tribes to Philippines: study

MANILA - A landmark study has revealed the complex shared origins, inter-relatedness, and genetic diversity of the Filipino people. Taking advantage of the

latest advances in genomics and computational biology, a team of researchers investigated into the Filipino DNA (deoxyribonucleic acid).

They looked into 2.3 million molecular DNA markers that were known to differ between various populations.

The markers from more than 1,000 individuals, representing 115 Philippine cultural communities, were comprehensively analyzed.

"This finally gives us a clearer picture of who we are as Filipinos, where we came from, and our sense of relatedness." Carlo Ebeo, Board of Trustee member of the National Museum that was involved in the study, said.

in the study, said.

It was revealed that, through time, the Philippines was inhabited by at least five major waves of human migration, starting with Northern and Southern Negritos as the first Filipinos, then followed by Manobo, Sama, and Cordilleran-related populations.

It was previously thought that the search for new arable lands by expanding farmer populations was the main reason for driving population migrations, such as the dispersal Austronesian-speaking groups into the Philippines.

Role of climate change However, Sweden-based Filipino scientist Dr. Maximilian Larena, who co-led the study, challenged this view.

"Our findings suggest that instead of farming, climate change may have played a more important role in driving the mass movement of populations in various directions," he said.

The significant geographic changes may have prompted the migration of Manobo and Sama-related ancestral groups from Borneo into southern Philippines and Cordilleran-related ancestral groups from southern China-Taiwan area into the various islands of the Philippines.

The arrival of Manobo, Sama, and Cordilleranrelated groups resulted in interbreeding with resident Negritos.

Interestingly, some Cordil-

lerans remained to be the only Filipino ethnic group that did not show evidence of historical interbreeding with Negritos. They are the only ones in the world who remained to be the unadmixed descendants of Basal East Asians, the study showed.

"This affirms that Cordillerans were isolated for quite some time, which is evident on the retention of distinct indigenous cultural practices and presence of immense linguistic diversity in the region," Dr. Adrian Albano, a Kalanguya Cordilleran from Ifugao State University and co-author of the study said

the study, said.
Additional minor genetic signals were also detected in some Filipino ethnic groups, including Papuan, South Asian, and European genetic ancestry.

The Papuan-related ancestry is found among the coastal ethnic groups of southeastern Philippines. This likely reflects a westward migration or gene flow of Papuan-related ancestry from Papua New Guinea or the Bismarck's archipelago into eastern Indonesia and subsequently into southeastern Philippines.

The South Asian or Indianrelated genetic signal was detected among the Sama Dilaut and other coastal Sama ethnic groups of southwestern Philippines.

The signal was dated to 500 to 1000 years ago, coinciding with the time when there was increased maritime trading activity between Island Southeast Asia and India.

The European genetic signal was only detected in one percent of all individuals investigated, indicating a limited genetic legacy of the Spanish Colonial Period.

# Banks implement shortened operating hours for 2 weeks

MANILA – Several banks implemented shortened operating hours starting Monday until April 4 after the government reimposed stricter quarantine measures in the National Capital Region (NCR) and four nearby provinces.

The Philippine Savings Bank (PSBank) said its branches in Metro Manila, Bulacan, Cavite, Laguna, and Rizal started to operate from 8:30 a.m. to 3 p.m. This schedule will be from Monday to Friday.

"Clearing cut-off for check deposits will be at 3 p.m.," it said in an advisory Monday.

On the other hand, PSBank branches outside NCR and the four provinces will keep their regular banking schedule of between 8:30 a.m. to 4 p.m. "except for Cebu Lapu-Lapu (9:30 a.m.-5 p.m.) and Cebu Consolacion (9 a.m.-4:30 p.m.).

"PSBank encourages everyone to do their share in preventing the further spread of Covid-19 by practicing restricted mobility and staying at home. PSBank mobile/online banking services are available 24/7 for customers' banking needs," it said.

For one, Metro Manila now has a uniformed curfew hour of between 10 p.m. until 5 a.m.

Among the policies that will take effect from March 22 until April 4 are travels in and out of NCR are primarily for buying essentials like groceries and medicines, going out for work, and returning to homes for residents.

Staycation is allowed within NCR and the four provinces but only for those aged 18 up to 65 years old.

Senior citizens and persons with disabilities (PWDs) are allowed to go out for exercise.

Restaurants are allowed to provide deliveries, takeout, and outdoor dining services. (PNA)


