



Sa official COVID-19 bulletin, iniulat ng DOH 4A na pumalo na sa kabuuang 100,440 ang kabuuang bilang ng kumpirmadong kaso ng COVID-19 sa rehiyon magmula noong Marso 2020.

Calamba City exempts elderly, PWDs from documentary fees

CALAMBA CITY (PIA) -

Senior citizens, persons with disabilities (PWDs), and single parents in this city no longer need to pay for medical certificates, and other documents from private institutions.

Last March 22, the Calamba City Council approved their City Ordinance No. 708, which aims to exempt senior citizens, PWDs, solo parents, and indigent citizens from paying for the issuance of documents from private institutions, including hospitals and schools. Documents that can be requested for free include medical certificates, statements of account, hospital bills, medical abstracts, price quotations, school grades, certificates of enrollment, and similar or related documents.

Applications for these documents that are either

unpaid, or not yet paid in full, are also covered in the ordinance.

Residents who may enjoy this privilege must present their proof of identification, such as Senior Citizen ID, PWD ID, Solo Parent ID, or Certificate of Indigency issued by the City Social Services and Youth Development Office (CSSYDO), or the barangay chairperson where the applicant is residing.

Along with the barangay chairpersons, the CSSYDO will update their records to determine the indigent residents in their areas of jurisdictions.

Institutions that will violate the ordinance will be fined from P1,000 to P5,000, or imprisoned for not more than sixty (60) days, at the discretion of the presiding court. **(PB)**

COVID-19 bed capacity sa dalawang ospital sa Laguna, puno na

CALAMBA CITY, Laguna (PIA) — Umabot na sa full

bed capacity para sa mga pasyenteng may COVID-19 ang dalawang pribadong ospital sa Laguna dahil sa tumataas na bilang ng kaso ng nakahahawang sakit.

Sa abiso ng Perpetual Help Medical Center sa Biñan City, sinabi nito na umabot na sa full bed capacity ang kanilang ospital para sa mga pasyenteng may COVID-19 at okupado na rin ang kanilang mga intensive care units.

Mananatili naman anilang bukas ang kanilang ospital para sa mga non-covid patients, outpatient diagnostics and centers, at emergency room services.

Sa Calamba City, nagnanunsiyo rin ang Calam-

ba Doctors Hospital na hindi muna ito tatanggap ng mga pasyenteng may COVID-19 dahil umabot na sa 'maximum allocated bed capacity' para sa mga pasyenteng may COVID-19 ang kanilang ospital.

Malapit na rin anilang mapuno ang kapasidad ng kanilang emergency rooms na hanggang sa ngayon ay may mga pasyenteng naghahintay na ma-admit.

Nag-abiso rin ito sa mga pasyenteng may COVID-related conditions na magtungo muna sa ibang ospital hanggang sa sandaling maaari na silang tumanggap ng pasyente.

Mananatili naman anilang bukas ang kanilang outpatient at inpatient services para sa mga non-covid cases.

Sa pinakahuling ulat ng Department of Health Region 4A, umabot na sa 3,258 ang bilang ng aktibong kaso ng COVID-19 sa Laguna, matapos itong makapagtala ng 145 panibagong kaso ngayong Martes, Abril 6.

Kasama ang Laguna sa mga lugar na isinailalim sa enhanced community quarantine hanggang Abril 11 upang mapababa ang pagdami ng kaso ng COVID-19. **(FSC)**

LGU Naic turns over new command center to Coast Guard

TRECE MARTIRES CITY, Cavite (PIA) --The local government of Naic turned over to the Philippine Coast Guard (PCG) last March 29, a newly constructed building that will serve as command center of the PCG stationed in the municipality.

Naic Mayor Junio Dualan led the turn over of the P1.3M one-storey, two-room building located within the compound of the Cavite State University (CavSU)-Naic campus in Barangay Bagong Kalsada to PCG NCR-CL Commander, Commodore Leovigildo Panopio.

"Ito pong bagong tanggapang Coast Guard-Naic ay pinaglaanan po natin ng budget para sa higit na pagpapalawig ng pagbabantay sa baybay dagat ng ating bayan," said Mayor Dualan.

(We had allocated budget for this new office of the Coast Guard to further strengthen their surveillance of the coastal areas in our municipality.)

PCG Cavite Provincial Commander Lt. Michael Encina and Naic Councilor Raffy Dualan, Chair of the Committee on Fisheries and Aquatic Resources witnessed the simple ceremony held at the Seaside Resort and Hotel.

Lt. Encina in an interview said, "Higit pa po namin papagtigtingin ang aming trabaho bilang mga bantay baybayin dagat para sa kaligtasan ng mga mangisda at turismo sa bayan ng Naic, bilang suporta sa LGU."

Judiciary workers now included in A4 vaccination group

MANILA – The Supreme Court (SC) on Monday said its request for inclusion in the priority vaccination group A4 was granted by the National Task Force (NTF) Against Covid-19. A request was sent to NTF chief implementer Secretary Carlito Galvez Jr. on March 31, seeking to consider justices, judges and court personnel of the Philippine judiciary as frontline government workers whose functions are essential at all times, especially during the pandemic. "With the NTF's favorable action on our request, the details of implementation shall be immediately worked out in order to swiftly roll out the inoculation program soonest," acting Chief Justice Estela Perlas-Bernabe said in a notice to court workers. She said the NTF informed them that vaccines arriving this month shall have allotment for the judiciary. A4 is composed of non-medical public and private essential workers who face clients but cannot consistently meet minimum health standards like air circulation, physical distancing and limited exposure time. In February, the Supreme Court (SC) announced it will be procuring Covid-19 vaccines, approved during an en banc session held on Jan. 26, for all justices, judges, officials, and personnel of the judiciary. No fatalities, oil leak in tanker-ship collision off Cavite: PCG

MANILA — The mariners aboard a tanker and merchant ship that collided Wednesday off the coast of Cavite are “in good condition” while no oil leaks have so far been detected Wednesday, the Philippine Coast Guard (PCG) said.

Based on its report Thursday, the PCG station in Cavite received a phone call regarding the incident at 9:50 p.m. on Wednesday and deployed a response team to the collision site. “Per the initial report, the PCG found out that Rich Rainbow, registered under the flag of Panama, was loaded with gasoline, while Ivy Alliance, registered under the flag of Marshall Islands, was loaded with coal when the accident oc-

curred,” the PCG said. MV Rich Rainbow, a motor tanker, was headed to China from the Philippines while the Marshall Islands-registered MV Ivy Alliance, a bulk carrier, was headed to the Philippines from Indonesia.

“While waiting for the marine protests that will be filed by the concerned shipping companies, the Coast Guard Station Cavite conducts necessary preparations for the availability of technical experts who will conduct marine casualty investigation,” the PCG said.

On Thursday morning, both vessels were issued a notice of detention until further investigation has been made. (PNA)

Pandemic affected NCR Plus urban poor residents get skills, livelihood training from PCUP

CALOOCAN CITY (PIA) — Presidential Commission for the Urban Poor Chairperson Usec. Alvin Feliciano on Tuesday assured urban poor residents will be provided with adequate capability building programs and livelihood training to help soften the impacts of lockdowns brought by the COVID-19 pandemic. Feliciano said enabling poor households, particularly within the National Capital Region (NCR) Plus bubble, through sustainable livelihood and income-generating strategies to become more resilient is key to achieving healthy, vibrant and diverse communities of the future. A huge chunk of urban poor residents has engaged in the informal economy, which has been temporarily shut down by the government in order to minimize COVID-19 infections. He said their target is to hold training and seminars for those who have lost their jobs, livelihoods, and income during the pandemic despite the recent rise of

COVID-19 cases in Metro Manila, Bulacan, Cavite, Laguna, and Rizal.

“The PCUP’s programs and projects benefiting the marginalized sectors in urban areas should not be put on hold,” he emphasized. “The Commission will always be reaching out to the urban poor members because they are among the most vulnerable and always the first ones severely affected by the lockdowns,” he added.

“They need our support even more now since it’s ECQ again. The commission will continue to assist with programs that will help them earn to survive daily,” Feliciano further said. The official said after seeing the pandemic hit hard to urban poor communities this year, they will “start focusing even more on their recovery.”

In the National Capital Region, urban poor members residing in Caloocan, Malabon, and Quezon City are among the PCUP’s priority targets for empowerment. (PIA NCR)

DENR eyes more biodegradable waste recovery nationwide

MANILA — The Department of Environment and Natural Resources (DENR) is seeking the increased recovery of biodegradable wastes by local government units nationwide. The DENR already began coordinating with the Department of the Interior and Local Government (DILG) regarding such matter as recovering and composting biodegradable waste helps reduce the volume of trash for collection and disposal, according to DENR Undersecretary Benny Antiporda.

“Biodegradables are about 52 percent to 58 percent of solid waste generated in our country,” he said. Properly segregating waste is essential in recovering biodegradables, he noted. Segregation “shall refer to a solid waste management practice of separating different materials found in solid waste in order to promote recycling and re-use of resources and to reduce the volume of waste for collection and disposal,”

278 more cops beat Covid-19

MANILA — The Philippine National Police’s (PNP) coronavirus disease 2019 (Covid-19) recovery tally has reached 13,846 after 278 more police officers recovered from the illness. In an update on Wednesday, PNP deputy chief for administration, Lt. Gen. Guillermo Eleazar, also reported that 208 police officers have contracted the disease.

This brought the PNP’s cumulative number of Covid-19 cases since March 2020 to 16,430, with 2,544 active cases and 40 deaths.

Meanwhile, the number of police personnel who have been vaccinated against Covid-19 has reached 4,387, with 2,865 receiving China’s Sinovac and 1,522 inoculated with the British AstraZeneca.

A total of 1,063 personnel have received the second dose of Sinovac jabs. (with Lloyd Caliwan/PNA)

according to Republic Act 9003 (Ecological Solid Waste Management Act). According to the National Solid Waste Management Commission (NSWMC), biodegradable waste can be mixed with soil, water, air and biological additives or activators to produce compost.

Biodegradable waste includes leftover food, fruit and vegetable peelings, soft shells, seeds, leaves, flowers, twigs, branches, stems as well as entrails of fish, fowl and other animals, noted NSWMC. Antiporda said DENR plans to ask LGUs about the state of biodegradable waste in their respective areas. DENR wants to find out where and how LGUs are disposing biodegradable waste, he continued.

Since continuing onslaught of African swine fever (ASF) reduced hog raisers’ demand for leftover food which they feed pigs, he said LGUs must clarify how this biodegradable waste is being handled.

“One thing we want to ask LGUs is how they’re dealing with biodegradable waste,” he said.

In its Jan. 2, 2021 press release, DENR announced its plan to provide industrial-grade shredder-composter machines this year to 178 LGUs within Manila Bay.

Such plan aims to help the LGUs comply with RA 9003 and reduce flow of waste into Manila Bay, noted DENR.

DENR reported already turning over the first batch of shredder-composter machines to LGUs of San Fernando City as well as Apalit, Candaba, Guagua and Magalang towns.

The areas are in Manila Bay region’s Pampanga province.

DENR will continue providing LGUs nationwide technical and other capability-building assistance for handling waste in accordance with RA 9003, assured Antiporda.

He noted LGUs must strive to comply with RA 9003 so the country can better address its waste problem, however.

“National government can’t do it alone,” he reiterated. (PNA)

Dumaguete diocese ready for ‘call of faith’ amid health crisis

DUMAGUETE CITY — The Diocese of Dumaguete is looking forward to respond to the call of faith amid the challenges posed by the prevailing health crisis. This, as the diocese marked its 66th founding anniversary, just a day after it also officially launched on Easter Sunday its celebration of the 500th year of Christianity in the Philippines. “What we are trying to do in the diocese is actually the same challenge that the 500th year anniversary of Christianity in the Philippines is presenting to us – the need to look back, to look at the present, and what do we need to do to move forward, especially as a response to the call of faith in our times,” Bishop Julito Cortes told the Philippine News Agency in an interview Monday afternoon, referring to the coronavirus disease 2019 (Covid-19) pandemic.

The challenge of the Holy Father, Pope Francis, to the Roman Catholic Church in the Philippines during its 500th year anniversary, is “to continue with our mission of propagating the faith and the truth about Jesus Christ and at the same time, to look into the needs of our poor and especially those who are in the peripheries of the community”, he said.

Since it was created on April 5, 1955, there have been four bishops appointed to head the diocese—the late Bp. Epifanio Surban, Bp. Angel Lagdameo (retired), Bp. John Du (now the Archbishop of Palo, Leyte), and the current Bishop Cortes.

“Aside from the celebration of the 500th anniversary of Christianity in the Philippines, today is also the 66th anniversary of the Diocese of Dumaguete, and basically, we still have the same challenges,” Cortes said.

The challenge, he said, is to look back at what has happened, adding that they are “grateful for the achievements and contributions of the past bishops who have served the diocese”.

He said each one of the past bishops had “uniquely contributed from the gifts that the Lord has given them and their responses at the particular time that they were in.”

He said Surban, the pioneering bishop of Dumaguete, was faced with

the challenges of creating structures needed as a young and new diocese.

What was special about Lagdameo was that he convoked the first Synod of Dumaguete, which was really the “highlight of his ministry”, he said.

Du, with his special gift for “fiscal life and stability” of the diocese, added more structures when it was already celebrating its golden jubilee in his time, he added.

Cortes said he recognizes the need to “look into the present situation and challenges in the next five to 15 years that I hope I will be able to exercise as the bishop of Dumaguete”.

One of his achievements is having put in place a Diocesan Pastoral Assembly (DPA), similar to a synod but more of pastoral in nature, to look into a practical approach of things to do “rather than a theological approach”, he said.

The two-year journey of the DPA concluded in September 2015, which included talking to the people and mapping out directions and the steps to take “in order to move forward as a people of God”, he added.

The next step after the journey is the creation of a diocesan pastoral plan, headed by Msgr. Glenn Corsiga and all the diocesan commission heads that are part of the diocesan pastoral council, the prelate said.

On Easter Sunday, Cortes launched the diocese’s celebration of the 500th year of Christianity, along with other dioceses in the country, with a liturgical rite that opened the Jubilee Door for this particular celebration, at the Cathedral of St. Catherine of Alexandria in this capital.

Those who would pass through the Jubilee Door, provided one has completed the conditions such as going to confession, receiving Holy Communion, and offering prayers for the intentions of Pope Francis, will receive a plenary indulgence once a day for every single visit, for himself/herself, or for the souls in Purgatory, Cortes said.

There are nine Jubilee Churches in the diocese for this, namely, the Dumaguete Cathedral, and the Catholic parish churches in Bayawan City, Siaton, Dauin, Sibulan, Tanjay City, Jimalalud, San Jose, and Siquijor, Siquijor. (PNA)

BOC EXCEEDS MARCH COLLECTION TARGET

Consistent with its mandate to collect lawful revenues for the country and despite the effects of pandemic, the Bureau of Customs surpassed its March 2021 collection target by 14.2% or P6.8 billion based on the preliminary report.

The P54.5 billion March collection against the P47.7 billion March collection target continues to highlight the Bureau's consistent and positive monthly collection for the 3rd month in 2021. Notably, this year's March collection is higher than the P44.6 billion March 2020 actual collection by 22.1% or P9.8 billion.

Thirteen of the seventeen collection districts exceeded their target for the month of March namely, the Port of San Fernando, Port of NAIA, Port of Batangas, Port of Iloilo, Port of Cebu, Port of Tacloban, Port of Surigao, Port of Cagayan De Oro, Port of Zamboanga, Port of Davao, Port Subic, Port of Clark, and Port of Limay.

For the period of January

1, 2021 to March 31, 2021, the Bureau of Customs collected P148.0 billion surpassing its target by 10.5% or P14 billion against the P134.0 billion collection target (January to March 2021). Moreover, the cumulative actual collection is higher by 1.9% or P2.7 billion compared to the P145.3 billion collection in Jan-March 2020.

The BOC's positive revenue collection performance is attributed to the improved valuation and intensified collection efforts of all the ports. Despite this, the Bureau maintains its border security measures against undervaluation, misdeclaration and other forms of technical smuggling and collect lawful revenues.

Commissioner Rey Leonardo Guerrero commended the efforts of the District Collectors and the men and women of the Bureau of Customs who, despite the risk to their health and safety, showed their unwavering commitment and dedication to service. **PR**

CALOOCAN CITY (PIA) -- Presidential Anti-Corruption Commission (PACC) Chairperson Greco Belgica has urged the public to text their dissatisfaction or grievances through 8888 Citizens' Complaint Center or 0906-6927324. "We ask the public to report complaints on govt programs, policies through our hotline 8888, or through official mobile number 0906 6927324," Belgica said during the latest edition of the Laging Handa public briefing hosted by the Presidential Communications Operations Office. The official said grievances can also be sent via email at complaints@pacc.gov.ph or through the official Facebook Page of PACC. "We can fight corruption if we work together, or if someone will stand up against it," he said.

It was earlier announced by PLDT, together with its mobile subsidiary Smart and PLDT Enterprise, that subscribers of both Smart and Sun networks can submit their complaints to 8888 for free to the service platform. The 8888 SMS system serves as an additional communication channel for the public to send their complaints or grievances on corruption in any government agency, available 24/7.

Meanwhile, Belgica also an-

nounced that the PACC launched "Project Kasangga Tokhang Laban sa Korapsyon" as it intensified efforts to clean up the bureaucracy.

He said the project aims to encourage all government officials to join in the advocacy of President Rodrigo Roa Duterte against corruption and work with the PACC and officials who will investigate corruption cases.

"We encourage all government officials to join the anti-corruption efforts," he said.

During its launching, he said officials and employees of the Bureau of Customs were asked to sign the anti-corruption manifesto in a bid to curb graft and corruption in government agencies.

Belgica said aside from the BOC, among the priority agencies to be looked into include the Department of Public Works and Highways, and Bureau of Internal Revenue. "Also, other priority agencies are the Department of Health, Bureau of Immigration, Department of Agriculture, and local government units, through the DILG [Department of the Interior and Local Government]," he added.

"We will use technology and automation for faster processes and systems such as reporting and investigation, among others," he further said.

"Bong" Go had told him about the appointment of Gesmundo.

Gesmundo, who will serve as the country's 27th top magistrate, takes over Diosdado Peralta who retired on March 27.

He is the fourth SC chief picked by Duterte and will serve until November 6, 2026.

Gesmundo first secured a seat in the SC in August 2017.

Prior to his appointment to the SC, he served as Associate Justice of the Sandiganbayan. Gesmundo obtained his law degree from the Ateneo de Manila University in 1984 and passed the Bar examinations the following year.

He entered government service as trial attorney at the Office of the Solicitor General in August 1985. He was named Assistant Solicitor General in 2002.

Senior Associate Justice Estela Perlas-Bernabe and Associate Justice Ramon Paul Hernando also applied for the SC post. (PNA)

Sa ulat kay Labor Secretary Silvestre Bello III, sinabi ni Overseas Workers Welfare Administration head Hans Leo Cacdac na 502,581 OFW ang ligtas na naiuwi sa kani-kanilang probinsiya matapos sumailalim ng Covid tests at quarantine protocols sa iba't ibang hotel.

Binubuo ng 1,471 OFW ang huling batch na nakaui sa kani-kanilang tahanan nitong Sabado de Gloria.

Sa hiwalay na ulat ng DOLE-International Labor Affairs Bureau (ILAB), may 645,071 OFW ang naapektuhan ng pandemya at 627,576 sa mga ito ang nawalan ng trabaho.

Ayon kay ILAB Director Alice Visperas, 49,698 na OFW na nawalan ng trabaho ang humiling na makauwi ng bansa samantalang 75,297 ang piniling manatili sa kani-kanilang lugar.

Batay sa record ng ILAB, tumaas ang bilang ng OFW na nahawahan ng sakit. Nitong Abril 4, nagtala ito ng 17,495 komiprimadong kaso ng Covid ng mga OFW batay sa ulat ng 40 Philippine Overseas Labor Offices mula sa iba't ibang bahagi ng mundo.

Sa nasabing bilang, 10,155 ang gumaling, samatalang 938 naman ang nasawi.

Sinabi ni Bello na patuloy ang pamahalaan sa pagbibigay ng tulog sa mga nawalan at apektadong OFW.

"Hindi tatalikuran ng pamahalaan ang pangako nito na bibigyan ng kinakailangang tulog ang ating mga OFW. Patuloy natin silang tutulungan hangga't kakailanganin nila," wika ni Bello.

Sa ngayon, umabot na sa P5.043 bilyon ng DOLE-AKAP ang naipamahagi sa 497,122 OFW, anuya.

Ang AKAP ay isang beses na tulong pinansiyal na \$200 o P10,000 bawat kwalipikadong apektado o nawalan ng trabahong OFW.

Maliban sa AKAP, nagbigay din ng tulong-pinansiyal, pagkain at medikal ang DOLE sa mga OFW
