## REVILLA: BACOOR TWIN PROJECTS SAGOT SA KAWALAN NG TRABAHO

**Bacoor City** – Panahon para lalong magtulungan upang buhayin ang ekonomiyang nilugmok ng pandemya at isulong ang Duterte legacy. Nanindigan si Bacoor City Mayor Lani Mercado-Revilla na ang panukalang 420-hectare reclamation projects na isinusulong ng lokal na pamahalaan ang magiging solusyon sa kakulangan ng kabuhayan at trabaho para sa kanyang mga constituents at maging sa mga nakatira sa karatig-bayan nito na nawalan ng hanap-buhay dahil sa coronavirus (COVID-19) pandemic. “Sa panahon pong ito na marami sa ating mga kababayans, kasama na ang libu-libong OFW na nawalan ng hanap-buhay at mapagkakaitaan dahil sa coronavirus, mas lalo po nating kailangan isulong ang proposed reclamation project na ito,” sabi ni Revilla. Paliwanag ng alkalde na base sa mga naunang estimasyon, ang twin reclamation projects ay maaring makapagbukas ng higit-kumulang 700,000 na mga trabaho hindi lamang para sa mga residente ng Bacoor kundi maging sa mga kalapit-bayan nito ang ng probinsya ng Cavite. Dagdag pa ni Revilla, ang proyekto ay inaasahang makakalikom ng P1.8 bilyon na kita ng lunsod mula sa turismo. “Sa gitna ng matinding krisis dulot ng COVID-19, dapat po ay magkaisa tayo at magtulungan lalung-lalo na sa paghanap ng mga paraan para maahanon ang mga kababayans nating nawalan ng trabaho at walang makain. Tulad ng panawagan ng ating pangulong Rodrigo Duterte, kailangan magtulungan upang maibsan ang paghihirap ng ating mga kababayans,” saad ni Revilla. “Bukod pa po dyan, yung karagdagang buwis mula sa proposed reclamation projects at mga negosyong itatayo doon ay malaki ang maitutulong para magka-

roon tayo ng pondo para tugunan ang problema ng mga kababayans natin na higit na nangangailangan ng tulong ngayon dahil sa pandemya,” dagdag niya. Kung matatandaan, nag-sagawa ng mga public hearings ang lokal na pamahalaan kasama ang Department of Environment and Natural Resources (DENR) para sa panukalang proyekto at idiniin ni Revilla na ang mga kabutihang maidudulot ng mga proyektong ito ay hindi makakaapekto sa kapaligiran at kalikasan. Bukod sa dagdag na trabaho, nilinaw rin ni Revilla na ang mga reclamation projects na ito ay may kaakibat na in-city relocation at livelihood programs na sumisiguro sa kapakanan ng mga maapektuhan ng informal settler families (ISF) at mga manggingisa sa lunsod. “Una sa lahat, marami sa mga maaapektuhan ng reklamasyon ay nagtatra-baho sa Bacoor din lang. Sila ay ililipat sa loob din lang ng siyudad ng Bacoor at mabibigyan ng kasegu-ruhan sa pambahay. Kaya mananatili sila sa kanilang hanap-buhay at walang dislokasyon na mangyayari,” paliwanag ni Revilla. Ang in-city relocation at ang job generation component ng proyekto ay naaayon sa mga istratehiya ng National Economic Development Authority (NEDA) na nakasailalim sa Manila Bay Sustainable Development Master Plan. Kasama rito ang pag-upgrade ng mga informal settlement sa pamamagitan ng ligtas, abot-kaya at formal na housing na mayroong basic services at mga economic opportunities. Ayon pa kay Revilla, sisiguruhin niya na hindi maapektuhan ang kabuhayan ng nasa industriya ng tahong at talaba at mananatili ang kabuhayang ito na nakakapagbigay ng higit sa 6,000 galon ng tahanan arawaraw. ### TRECE MARTIRES CITY, Cavite (PIA)

Cavite Governor Jonvic Remulla shared on his FB page June 24 the updates on the COVID-19 status in the province and the new ordinance on alcohol intoxication recently approved by the Sangguniang Panlalawigan.

The province has a total of 502 COVID-19 cases with 195 recoveries and 36 deaths from the disease, according to the latest data recorded by the Provincial Health Office (PHO) Cavite.

In his post, the governor cited the prediction of Dr. Charles Yu, a member of the medical team at the De La Salle Medical-Health Science Institute (DLSM-HSI) that

the number of COVID-19 cases in the province will blow after two weeks from June 1, 2020 when NCR was placed to GCQ status. The data indeed proved correct with 80% of the new cases were either employees in NCR or had traveled to NCR.

He also reported that 90% of the total deaths from the COVID-19 were senior citizens thus, the strict implementation of the prohibition for residents 60 years old and above for leaving their residences is very much in as they are of high risk for infection.

Meanwhile, the Targeted Testing of more than 1,000 medical frontliners in the province were completed with only 12 persons tested positive for the COVID-19. Police personnel follow next in the list of Targeted Testing to commence next week.

On the other hand, Governor Remulla shared some details on the recently approved ordinance known as the “Public Intoxication Ordinance” approved by the Sangguniang Panlalawigan during their recently concluded council meeting.

The ordinance states that police personnel in the province will be provided with alcohol breath analyzer to test motorists and pedestrians suspected of alcohol intoxication.

Once a suspected driver or pedestrian fails on the alcohol breath analyzer test thru excess in the blood alcohol limit, they shall automatically be fined and the driver will be charged and jailed for driving under the influence of liquor.

Governor Remulla reminded it is okay to drink within the confines of their homes but once outside, the law is in effect.

“You can have fun but don’t be a danger to others,” Gov. Jonvic said. (Ruel Francisco, PIA-Cavite with report from the official FB page of Gov. Remulla)

Kawit LGU launches #ProjectHiram in support of SMEs

**KAWIT, Cavite (PIA)** -- Mayor Angelo Aguinaldo recently launched #ProjectHiram, one of the local government’s projects under #AlagangAguinaldo to help micro and small businesses in the town.

“COVID-19 had hit us hard especially the micro and small businesses in our country. As your Mayor, I wish to help you and your livelihoods recover. That’s why we’re launching #ProjectHiram, a financial lending program to help grow our micro and small Kawiteño entrepreneurs!” stated Mayor Aguinaldo.

The project primarily aims to jumpstart the economy by supporting the small businesses that suffered losses due to the pandemic and who are trying to keep their business afloat.

Eligible applicants are those who are self-employed, micro or small entrepreneurs engaged in legitimate livelihood for at least 1 year prior to declaration of ECQ on March 16, 2020; registered/majority owner, aged between 18 yo - 65yo; with a business asset of not more than Php500,000.00. For owners beyond 65yo, a co-borrower will be required by the Kawit LGU/Business Permit & Licensing Office.

A minimum loanable

amount of Php35,000 to a maximum amount of Php50,000 can be availed thru the lending program with zero interest payable in one year, or a 6% service charge for loans payable in 12 months. A six month grace period for the payment of the principal loan amount is one of the reliefs that could be extended to borrowers.

Documents required for the application are: 1 valid ID with picture, previous and updated business registration documents, accomplished application form which can be downloaded from the LGU website, a picture of the business establishment as well as the pieces of equipment, machines and inventory of stocks/goods, and a proof of residency such as barangay clearance of non-derogatory record or barangay certificate of residency/proof of billing with the same address with the ID.

Applicants may submit the complete requirements at the Business Permit and Licensing Office-Kawit LGU which will be subject for credit review and evaluation. (Ruel Francisco, PIA-Cavite with report from the official FB page of Mayor Angelo Aguinaldo)

## Comelec warns public against fake voter's ID

**MANILA** – The Commission on Elections (Comelec) on Thursday warned the public against unscrupulous persons producing fake voter identification (ID) cards.

“The ‘fake news’ that a person has to be a registered voter in order to receive government aid during this Covid-19 (coronavirus disease 2019) national health crisis, seems to have created a market for fake voter identification cards. Anyone who claims to be able to produce a ‘Comelec-issued voter ID’ is a scammer who is trying to take advantage of the public,” Comelec spokesperson James Jimenez said in a statement.

This came amid recent reports that the National Bureau of Investigation (NBI)

arrested two individuals for allegedly producing and selling online spurious voter’s ID cards.

Jimenez reiterated that a person need not be a registered voter to be able to get financial assistance from the government during the health crisis.

Earlier, DILG Undersecretary Jonathan Malaya said being a registered voter is not a factor in determining who gets into the list of beneficiaries of the government’s social amelioration program.

Jimenez, meanwhile, reminded the public that the poll body has stopped issuing voter’s IDs since 2012. “The Comelec has stopped issuing (voter’s) IDs, in anticipation of the launch of the National ID system,” he added. (PNA)

## LGUs should mainstream urban agriculture - SEARCA

**CALAMBA CITY, Laguna (PIA)** --The Integrated Urban Agriculture Act (HB 3412) has been approved by the House Committee on Agriculture last June 17. HB 3412 seeks to promote an integrated urban agriculture to address food security problems affecting the country, which were exacerbated by the COVID-19 pandemic.

The bill's author, Negros Occidental Rep. Jose Francisco Benitez, said HB 3412 intends to address the serious food security problem by introducing "game-changing solutions" that include "maximizing available spaces and utilizing emerging agricultural technologies and methods."

"Local government units (LGUs) are in a strategic position to perform a catalytic role in promoting urban agriculture," the Southeast Asian Regional Center for Graduate Study and Research in Agriculture (SEARCA) asserts in its policy paper on policy imperatives to promote urban agriculture among local government units in the Philippines.

The policy paper is jointly authored by Dr. Rico C. Ancog and Dr. Glenn B. Gregorio of SEARCA and the University of the Philippines Los Baños, House Representative Arlene B. Arcillas, Erlinda C. Creencia of the Santa Rosa city government, Victorino

Aquitania of CLEI-Local Governments for Sustainability--Southeast Asia, Department of Agriculture-Bureau of Plant Industry (DA-BPI) Assistant Director Gerald Glenn F. Panganiban, and Garry A. Hidalgo of Farm Factory and Rotary Club of Bay. They brought to the policy paper their collective experience in a diverse mix of sectors that include the academe, science and technology, environment, agriculture, private industry, civil society, legislature, and local government.

"It will be strategic for local government units to implement an Urban Agriculture Strategy to sustainably mainstream it in local governance," the SEARCA policy paper authors stress. Studies have shown that planning for urban agriculture tackles a combination of already existing urban issues in livelihood and income opportunities, food availability and accessibility, and, in many cases, conflicting land uses.

SEARCA Director Dr. Glenn B. Gregorio said "the challenge of optimizing limited space, including high-risk areas, is addressed by the Comprehensive Land Use Plan (CLUP) of LGUs and, as such, it provides the most appropriate and likely the most effective platform to mainstream urban agriculture."

The SEARCA paper points out the need for LGUs to

pass an ordinance institutionalizing, developing, and promoting urban agriculture, including mainstreaming it in the CLUP and Local Climate Change Action Plan to ensure funding and support by the city or municipal council.

Under HB 3412, in coordination with DA and Cooperative Development Authority (CDA), LGUs will tap neighborhood associations and people's organizations to undertake community gardening.

The SEARCA paper highlights that the capacity of the barangay officials on urban agriculture would be very critical to operationalize the plans and projects. As they formulate their own development plan, the barangays are in the best position to identify or vet in identifying appropriate open spaces for urban gardening and in exploring potential funding sources to support urban agriculture.

Dr. Ancog and his co-authors also emphasize that "the role of the city or municipal agriculture officers is crucial to sustain urban agriculture initiatives with strong partnerships and collaboration with government line agencies such as DA-BPI and local state universities and colleges."

The HB 3412 has provisions for granting of incentives to participants in urban agriculture as well as for granting of loans extended by government and

private banks to participating individuals, corporations and partnerships.

The SEARCA paper pushes for the passing of ordinances for tax reduction schemes, lease agreements, and zoning mixed-use areas that would afford an enabling environment to encourage LGU constituents to engage in urban agriculture.

Since exploration of financing schemes would be essential to sustain efforts on urban agriculture by LGUs and its partners, the SEARCA chief said his team indicates that "the Agriculture Office of every LGU can allocate budget for urban agriculture in the Annual Investment Plan, organize farmers' associations and cooperatives, and through private and industry partners, among others."

In addition to the proposed urban gardening sites under HB 3412, the SEARCA paper advocates for open space and parks managed by LGUs to be planted with both agricultural crops and ornamental plants, which can also boost tourism and be a learning place for schoolchildren.

"With the ongoing food security challenge brought about by the COVID-19 pandemic, implementing urban agriculture projects has never been more urgent" said Dr. Gregorio. (PIA-4A/SEARCA)

# JUDGES GROUP SLAMS 'ABUSIVE CRITICISM' ATTACKS VS. JUDICIARY

**MANILA** – The Philippine Judges Association (PJA) on Monday cried foul over "abusive criticism and unfounded innuendoes" meant to discredit the judiciary, following last week's conviction of Rappler executive editor and chief executive officer Maria Ressa for cyber libel.

In a statement, PJA president Felix Reyes said they strongly denounce these abusive attacks and criticisms hurled against the courts, judges, and the judiciary. He added that the judiciary is being dragged and vilified "because a decision was rendered in a manner not acceptable to the parties therein".

"These attacks do a grave disservice to the principle of an independent judiciary and mislead the public as to the role of judges in a constitutional democracy, shaking the very foundation of our democratic government," he said. Reyes said the public must come to grips with the vital role of the courts in a functioning democracy and that courts settle controversies based on facts and law, stressing that facts are established by evidence and

the law is applied to the facts established. "Abusive criticism and unfounded innuendoes hurled against courts and judges erode the public's trust and confidence in the very institution tasked to protect the people's rights," Reyes added. Citing Supreme Court precedents, he added that "personal attacks, criticisms laden with political threats, those that misrepresent and distort the nature and context of judicial decisions, those that are misleading or without factual or legal basis, and those that blame the judges for the ills of society, damage

the integrity of the judiciary and threaten the doctrine of judicial independence". A Manila court found Ressa and former Rappler researcher-writer Reynaldo Santos Jr. guilty of cyber libel. Manila Regional Trial Court (RTC) Branch 46 Judge Rainelda Estacio-Montesa sentenced the two to imprisonment ranging from six months and one day to six years. Ressa and Santos were ordered to pay the complainant, businessman Wilfredo Keng, PHP400,000 in moral and exemplary damages. (PNA)

He is optimistic that the advantages of being an accredited member of the program will ensure that trade within the region shall flourish even more as the program allows importers and exporters to transact with AEO member organizations
