ORDER

Let the Office of the Solicitor General, the Local Civil Registrar of City of Dasmariñas, Cavite, the Civil Registrar General, and all other persons concerned be furnished with copies of this Order.

Petitioner is directed to furnish the Office of the Solicitor General, and all the respondents copies of the Petition within ten (10) days from receipt hereof.

Notify all parties concerned of this Order.
