DA TO PUT UP PERMANENT FARMER COOP-RUN KADIWA SITES NATIONWIDE

MANILA – Department of Agriculture (DA) express Secretary Francisco Tiu hitting Laurel Jr. on Tuesday fishery bared plans to establish "permanent" and farmer cooperatives-run Kadiwa stores to further advance the administration's food security and affordability "We hitargets.

During post-State the of the Nation Address (SONA) forum, Laurel said the DA aims to build 1,500 Kadiwa stores in the next three years to serve all municipalities and cities nationwide in compliance with the directives of President Ferdinand R. Marcos Jr. to ensure sustainable operations of Kadiwa centers to provide cheaper agricultural goods to Filipinos.

"Ang gagawin natin ay ilelevel up natin from mere pop-up stores, gagawin nating (What we will do is to level up from mere popup stores, we will establish) permanent brick and mortar stores from all over the Philippines," he said.

In the long run, he said the operations of Kadiwa stores would be under farmers' and fisherfolks' cooperatives to ensure that wholesalers and retailers will be "honest," and help prevent profiteering.

plano natin is "Ang cooperative-run ito eventually. So iyong mga farmers at fishers mismo ay makaka-diretso sa consumers para lumaki ang kita ng farmers at fisherman at bumaba naman ang bilihin (Our plan is to eventually make it cooperative-run. So, farmers and fishers will directly go to our consumers so they can increase their income while lowering price of basic goods)," Laurel said.

The Department of and Local the Interior (DILG), Government vowed meanwhile, to mobilize local government units to help realize these programs and advance the administration's food security and economic development.

Agri-fishery production

Laurel, meanwhile, expressed optimism in hitting the country's agrifishery production growth with the help of irrigation infrastructures.

This is despite the effects of the El Niño phenomenon and the looming La Niña.

"We have more irrigated lands as mentioned by the President. In Jalaur, 32,000 hectares and another 45,000 hectares na nabigyan ng (that were given with) solar irrigation that will definitely increase production," he said.

"Sa La Niña naman as long as walang malaking bagyo, I think naman mas mataas ang produksyon (For La Nina as long as there's no strong storm, I think we will have higher production)," he said, hoping to hit a 1 to 2 percent growth performance for 2024.

The DA earlier expressed confidence in achieving 20.4 million metric tons (MMT) of palay (unhusked rice) production for the year, higher than last year's 20.06 MMT production.

Rice imports

Laurel said the country's lowering of tariffs on imported rice would not result in 4.7 MMT of rice importation, as projected by the United States Department of Agriculture (USDA).

The Marcos administration earlier approved the reduction of tariff on imported rice from 35 to 15 percent under Executive Order No. 62.

"I don't think the lowering of tariffs will really increase importation. There's no real bearing in my opinion. The only reason na magincrease ang (to increase the) importation is because of demand not because of lowering of tariffs," Laurel said.

As of July 11, the DA has reported the arrival of 35,594 MT of imported rice from around 302 approved sanitary and phytosanitary import clearance under the lowered tariffs.

To date, the country's imported rice is now at 2.37 million MT. (with a report from Lloyd Caliwan/PNA)

DBM: P42B allocated for irrigation in 2025 budget MANILA-The government as Congress' basis for the

MANILA – The government has allocated PHP42 billion for 2025 to further strengthen the country's irrigation systems, the Department of Budget and Management (DBM) said Tuesday.

Speaking at the post-State of the Nation Address discussions in Pasay City, Budget Secretary Amenah Pangandaman said the allocation is in line with the priority thrust of the administration of President Ferdinand R. Marcos Jr. of achieving food security by strengthening the agriculture sector.

"As [President Marcos] mentioned in his SONA, we are strengthening our irrigation system nationwide. We have allocated PHP42 billion for our irrigation system nationwide next year," Pangandaman said.

The irrigation budget is part of the 2025 National Expenditure Program (NEP), which will serve

as Congress' basis for the General Appropriations Bill (GAB).

In his third SONA on Monday, Marcos reiterated the government's commitment to build and rehabilitate more dams to help boost agriculture production and ensure food security.

The government is also focusing on constructing solar-powered irrigation facilities, the President said, citing the newly launched Cabaruan Solar-Powered Pump Irrigation Project in Quirino, Isabela, the largest of its kind in the Philippines.

The Chief Executive also mentioned the Jalaur River Multipurpose Project in Iloilo that could irrigate 32,000 hectares of land.

"Moving forward, irrigation dams will supplement all our other bulk water projects to ensure water security for our people, especially in the underserved areas," the President said. (PNA)

DOJ reforms to protect innocent, charge the guilty

MANILA – Reforms undertaken by the Department of Justice (DOJ) in the preliminary investigation process will protect the innocent from unwarranted charges and ensure that the guilty will be made to answer for their crimes, a senior DOJ official said Wednesday.

newly-signed Department of Justice -National Prosecution Service (DOJ-NPS) Rules on Criminal Investigation changed the landscape in criminal investigation and prosecution by ensuring there is a higher degree of proof, there is a quantum of proof or evidence needed for the filing of cases," Undersecretary Raul Vasquez said during the 2024 Post State of the Nation Address (SONA) discussions.

The DOJ-NPS 2024 was signed by Justice Secretary Jesus Crispin Remulla at the Kalayaan Hall in Macalañang on July 10, with President Ferdinand R. Marcos Jr. as witness.

Under the new rules, the standard of proof was raised from probable cause to prima facie evidence with reasonable certainty of conviction.

Vasquez said the new rules also call for more immersive

participation by prosecutors in the investigation phase to ensure quality indictments and help weed out harassment suits.

"This is to ensure that only quality cases are filed, one that is supported by evidence, real, testimonial, and other corroborative witnesses, in order that the wrongdoers or criminals would really be brought to bear before the bar of justice, but at the same time, and more importantly, it is also assures that the innocents need not needlessly be charged in court nor incarcerated," he said.

"We will also try to formalize the close coordination between law enforcement and the prosecution in order that only trial-ready and evidence-supported cases will be filed." Vasquez also pointed out that efforts have been initiated for the establishment of a Forensic Institute, which would make investigations science-based, in terms of criminal investigations and prosecutions.

"This is also useful in terms of calamity and disaster control because, with the higher capacity of our doctors and medical practitioners in terms of forensic science, we would be able to determine the real causes of death," he said. (PNA)

Ex-councilor charged over shooting of Laguna journo

MANILA – A complaint for attempted murder has been filed against a former city councilor and son of a barangay chairperson in Laguna over the shooting of a local journalist, the Presidential Task Force on Media Security (PTFoMS) said Wednesday.

According to the PTFoMS, the Malacañang's arm in charge of ensuring media security in the country, the case was filed last Monday, just a week after Marc Angelo Barrios of Laguna Patrol was shot by unidentified gunmen aboard a motorcycle.

Undersecretary Paul Gutierrez, PTFoMS executive director, commended the Criminal Investigation and Detection Group (CIDG) for immediately responding to the task force's request for a deeper investigation of the incident.

"This again showed that the established mechanism by the government to address any violation in the right to life, liberty, and security of all members of the press is working efficiently," Gutierrez said.

The initial police report said two motorcycle riding suspects fired seven times at Barrios, while he was on his way home to Brgy. San Gregorio in San Pablo City on the evening of July 15. He was miraculously unharmed although his motorcycle was damaged by the attack.

The suspects then sped off toward an unknown destination.

The CIDG accompanied Barrios in the filing before the Prosecutor's Office a case for frustrated murder against the principal suspect.

The task force refused to name the suspect "pending the result of the evaluation of the complaint by the attending prosecutor."

Gutierrez also thanked the local police for its immediate assistance to Barrios after the incident. (PNA)

178 new PAO lawyers to help deliver justice for indigents

MANILA — Department of Justice (DOJ) Secretary Jesus Crispin Remulla on Monday welcomed the hiring of 178 new lawyers in the Public Attorney's Office (PAO), saying it will boost the services provided by the agency to indigent litigants.

"Gone are the days when some may think that access to justice in the Philippines is exclusively for the wealthy. Today, under the Bagong Pilipinas political vision, we level the playing field between the rich and the poor in terms of having access to legal services," Remulla said in a statement.

Remulla thanked the Department of Budget and Management (DBM) for approving the creation of 178 new Public Attorney's (PA) positions across the country.

The DBM has created some 56 PA 2 and 122 PA 1 positions at the PAO under the DOJ, which will require PHP336 million annual budget.

"I also would like to extend my appreciation to Budget Secretary Amenah Pangandaman in going the extra mile to address the legal needs of our country," Remulla said.

The program is part of the administration of President Ferdinand R. Marcos Jr.'s Bagong Pilipinas campaign to ensure that no Filipino will be left behind on the nation's path to progress.

Section 3 of Republic Act 9406 mandates the PAO to render free legal representation, assistance, and counseling to indigent individuals in criminal, civil, labor, administrative, and other quasi-judicial cases.

Based on PAO data, the agency handled 787,124 cases and assisted 849,914 clients in 2021.

In 2022, these numbers rose to 850,753 cases and 900,079 clients.

The new PA positions will be lodged under the district offices of the PAO by region, as proposed by the PAO, to provide flexibility to the agency head in their deployment to the different cities and municipalities, taking into consideration the workload and volume of cases being handled by the offices concerned.

Among others, public attorneys represent indigent litigants in various legal cases, conduct research, prepare legal documents, appear in trials and hearings, and engage in legal outreach activities such as inquests, jail visitations, and barangay legal outreach initiatives.

The move, according to the DBM, will ensure that PAO can fully comply with the prescribed ratio of public attorneys to organized court salas, enhancing its capacity to serve the legal needs of indigent Filipinos. (PNA)

Budget deficit declines in June

MANILA – The national government's budget deficit went down to PHP209.1 billion in June from PHP225.4 billion a year ago as revenue collection grew faster than government expenditures.

The Bureau of the Treasury's (BTr) cash operations report released on Wednesday showed that revenues during the month amounted to PHP296.5 billion, higher by 10.93 percent than last year's PHP267.3 billion.

Data showed that the Bureau of Internal Revenue's collection amounted to PHP172.5 billion, up by 4.71 percent year-on-year, while collections by the Bureau of Customs slightly increased by 0.67 percent to PHP74.6 billion.

The BTr brought in PHP7.4 billion in June, declining by 30.99 percent from the 2023 comparable collection due to lower dividend remittance and income from BTr managed funds.

June collections from other offices, which include other non-tax, including privatization proceeds and fees and charges, surged to PHP39.8 billion, more than twice the level registered a year ago.

Government expenditures, meanwhile, amounted to PHP505.6 billion, outperforming the previous

year's PHP492.7 billion actual expenditures by 2.62 percent. "The increase was mostly attributed to the implementation of capital outlay projects of the Department of Public Works and Highways, and the Department of National Defense under its Revised AFP Modernization Program, the preparatory activities of the Commission on Elections for the 2025 National and Local Elections, and the higher National Tax Allotment shares of LGUs," said the BTr. "The growth of June spending was, however, tempered by lower subsidy releases and net lending assistance to (GOCC) government-owned and controlled corporations," it added.

For the first half of the year, the budget gap widened to PHP613.9 billion, 11.27 percent higher than last year but 7.24 percent below the PHP661.8 billion midyear program due to the better-than-programmed revenues. Total revenue collections

Total revenue collections as of end-June reached PHP2.15 trillion, up by 15.56 percent from last year, while expenditures reached PHP2.76 trillion, also higher by 14.58 percent and outpacing the PHP2.74 trillion midyear program by 0.90 percent. (PNA)

DTI approves P2.7-T investment projects under PBBM admin

MANILA - Investment promotion agencies (IPAs) under the Department of Trade and Industry (DTI) logged over PHP2.73 trillion worth of projects between July 2022 to May 2024.

The pledges came from registered with that DTIattached IPAs Board of Investments (BOI) and Philippine Economic Zone (PEZA), DTI Authority Secretary Alfredo Pascual recently told reporters.

these investment approvals, 658 projects worth PHP2.4 trillion were registered with the BOI and 432 projects worth PHP331 billion were approved by PEZA.

Pascual said investment commitments generate around 182,000 jobs, of which, 102,000 will come from projects registered with the BOI and 80,000 from PEZA-registered projects.

Trade chief noted the policy reform President Ferdinand R. Marcos Jr. within the first six months of his administration that allows 100-percent foreign ownership in renewable (RE) projects energy boosted the investment approvals of DTI-attached IPAs in the past two years. In 2023 alone, BOI PHP986.14 registered worth billion of investments, with biggest share coming from offshore wind projects.

In line with President Marcos' priority of ensuring food security, BOI noted a surge in agribusiness investments at PHP29.15 billion last year, 342 percent higher than the PHP6.6 billion pledges in this sector in 2022.

Pascual said the foreign trips of the Chief Executive and investment the missions that the DTI participated in the past two years helped in promoting Philippines as an investment destination.

said the Cabinet secretaries who were part of these overseas missions listened to the concerns of foreign investors and addressed the barriers to make the country more investor-friendly.

CREATE **MORE** "The (Corporate Recovery and Tax Incentives for Enterprises Maximize **Opportunities**

Reinvigorating Economy) really addressing those weaknesses the CREATE law... That's an important policy," the DTI chief said.

The CREATE MORE bill aims to streamline the process for tax refund and to further reduce corporate income tax to 20 percent from the current 25 percent.

The green lane is an important reform really attracting investors," Pascual added.

President Marcos signed Executive Order 18 in February 2023, creating One-Stop Action Center Strategic for Investments (OSAC-ŠI) at BOI that will fast-track the processing of permits and licenses of strategic investments, or those with high economic impact. concerned national government agencies and

local government units. Pascual also reported that since the creation of the green lane in BOI, the OSAC-SI facilitated 83 strategic projects with investments amounting to PHP2.45 trillion.

As of June 2024, there 231 investment are in DTI, including leads public-private partnership projects.

The investments in the pipeline have total value of USD76.6 billion.

Pascual said that as of July 19, there are 20 projects already operating in the country amounting to USD1.26 billion.

The investments came from the foreign investors' commitment to the Chief Executive during presidential visits the past two years.

The latest is the PHP12.8billion cement production facility of Japanese cement manufacturer Taiheivo Cement Corp. in San Fernando, Cebu which was inaugurated on July 18.

"[These] our progress in the implementation of the investment leads from the Presidential visits. What we have developed is a pipeline of projects. These projects will be realized over time," Pascual said. (PNA)

In a statement, the BSP, citing the results of its 2023 Report on E-Payments Measurement, said the share of digital payment transactions to total monthly retail payments in the Philippines grew from 42.1 percent in 2022 to 52.8 percent in 2023.

In a separate briefing at the BSP office in Manila, BSP officer-in-charge Mamerto Tangonan said this is equivalent to 2.62 billion said monthly payment transactions made digitally.

amounts to USD110 billion or PHP6.1 trillion or 55.3% of the total value of digital payments, a surge from 40.1% in 2022," Tangonan said.

The main contributors to the increase in e-payments were merchant payments which accounted for 64.9 percent of monthly digital payments volume, person-to-person transfers at 19.3 percent, and business-to-business supplier payments at 6.1 percent.

This is consistent with the growth in ownership of transaction accounts, which are mostly e-money accounts that are increasingly used for payments. "We take

pride in this achievement as proof that our pursuit of a cash-lite economy has consistently been progressing. We owe this to our citizens who are the foremost beneficiaries of a safe, efficient, and inclusive digital payments system," BSP Governor Eli Remolona Jr. said in a statement.

"As we serve their payment needs and deepen financial inclusion. we are ready to bring digital finance to new heights," he said.

Remolona, however, said that achieving the target is not the end goal.

What we would like to see are lives being transformed by our policies," he said.

The comparative PHP Bloomberg Valuation Service rate was slightly lower at 6.39 percent as of July 22 this year.

Comelec, PTFOMs sign MOA to protect media during elections

MANILA – The Commission on Elections (Comelec) and the Presidential Task Force on Media Security (PTFoMS) on Tuesday signed a memorandum of agreement (MOA) to ensure the safety and respect for the rights of the members of the press covering the elections.

Signing the MOA on behalf of the commission was Chairman George Erwin Garcia and for PTFoMS, executive director, Undersecretary Paul M. Gutierrez.

"This MOA is part of the continuing effort by the government Marcos to create a safe media environment for members of the press all over the country, especially during elections," Gutierrez said, recalling President Ferdinand R. Marcos Jr.'s instruction for the PTFoMS to work for a safer media environment for everyone. The MOA is the first of its kind between the Comelec, an independent constitutional body, and the PTFoMS, the government's mechanism to address all violations on the right to

The agreement also seeks to provide media practitioners with a safe and protected space, free from any unnecessary interference to perform their duty to report truthful election-related news.

Among others, the MOA seeks to consider any act of threat, harassment, illegal detention, torture, or physical violence to any member of the press a violation of the media's role under the Fair Election Act or Republic Act 9006, the Omnibus Election Code, or the Revised Penal Code, as the case may be.

Garcia, meanwhile, said he agrees with the MOA, considering that poll workers also suffer from the same level of threats, harassment, and loss of life being experienced by journalists during elections. "Ang dinaranas ninyo (journalists) tuwing eleksyon ay dinaranas din ng aming mga tauhan, partikular yung mga nasa field (What you [journalists] suffer during elections is also suffered by our staff, especially those in the field)," Garcia said.

He repeatedly emphasized the important role played by the media in achieving the poll body's mandate of conducting a clean, credible, free, honest, and orderly election.

Both officials said the provisions of the MOA take effect this October, the start of the filing of certificates of candidacy (COCs), and last until the end of the election period, or until June 11, 2025.

While violent incidents cannot be prevented, especially during elections, they expressed hope that the MOA would deter those contemplating harming members of the media from doing so, particularly among the candidates and their supporters.

Any media practitioner whose rights are violated during the covered period must report the incident immediately to the PTFoMS, which will immediately coordinate with the Comelec on the appropriate measures to be taken to address the incident.

The PTFoMS will also be responsible for attesting that the victim is a legitimate member of the press and assisting the victim in filing a formal complaint before the poll body. (PR)

DOST kicks off Handa Pilipinas in Cebu to advance Visayas resilience

2-year PBBM admin: 138K agrarian beneficiaries receive land titles

MANILA – Over 138,000 agrarian reform beneficiaries (ARBs) have so far received land titles under the administration of President Ferdinand R. Marcos Jr., according to the Presidential Communications Office (PCO).

A day before Marcos delivers his third State of the Nation Address (SONA), the PCO said in a social media post that a total of 138,056 ARBs have already received land titles from July 2022 to July 10, 2024

The PCO said it was in line with the promise of the President during his second SONA that he would continue to implement the agrarian reform program of the government.

Likewise, the PCO also noted how Marcos sfulfilled his promise in his first SONA in 2022 to pass a law that will "emancipate the agrarian reform beneficiaries from the agrarian reform debt burden." Marcos signed into law the Republic Act No. 11953 or the New Agrarian Emancipation

Act on July 7, 2023.

Marcos has promise

Marcos has promised to finish the agrarian reform program during his term.

The program started in 1972 when Marcos' father and namesake, the late President Ferdinand E. Marcos Sr., issued Presidential Decree 2 that set a land reform program in the country.

The President is set to deliver his third SONA on Monday at the Batasang Pambansa in Quezon City before a joint session of Congress. (PNA)

BOC collects P1.73-T in 2 years of Marcos admin

MANILA - The Bureau of Customs (BOC) on Tuesday reported that it has collected a total of PHP1.730 trillion in revenues during the first two years of the Marcos administration.

In a statement, the BOC said this figure was collected from July 2022 to May 30 this year, translating to a 8.07 percent increase as compared to its target collection of PHP1.501 trillion for this period.

This showed a surplus of PHP126.260 billion, it added.

Customs Commissioner Bienvenido Rubio said the BOC is committed to upholding President Ferdinand R. Marcos Jr.'s vision and ensuring that the agency remains a vital contributor to the country's progress and development. "The BOC continues to strive for robust collection

performance to support the government's funding of national projects. strengthened border protection and simplifying trade processes," it added. The BOC also thanked the President's mention of its efforts in his third State of the Nation Address, which included the seizure of over PHP2.7 billion worth of smuggled agri-fisheries products.

The President also mentioned the forthcoming implementation of Administrative Order No. 23, which introduces pre-border technical verification and cross-border electronic Invoicing for import commodities.

The Chief Executive said this aims to establish a more secure, harmonized, and streamlined trading environment, with the BOC at the forefront of its execution. (PNA)

Good time to buy condo as POGO exodus corrects pricing: Colliers PH

MANILA – While the order of President Ferdinand R. Marcos Jr. for a total ban of Philippine offshore gaming operators (POGOs) may hurt real estate developers, particularly the condominium market, it also opens opportunity to local investors to buy residential units at a corrected price.

Colliers Philippines director for research Joey Bondoc told the Philippine News Agency (PNA) in a phone interview Tuesday that the price correction in the residential market in the National Capital Region (NCR) due to the POGO exodus will create a new demand for the developers.

Bondoc said that even before the order of President Marcos in his third State of the Nation Address (SONA) to totally ban POGOs, there was already an exodus of POGO at the height of the coronavirus disease 2019 pandemic.

He added that around that time, vacancy rate in the fourth quarter of 2021 was at 17.9 percent. The current vacancy rate is at 17 percent.

"The total banning of POGO will only dampen the already slow takeups for residential units. It will also exacerbate the rising residential vacancy and slower growth in prices and lease rates," he said, adding that vacancy rate could hit 19 percent with the total ban on POGOs.

But Bondoc added that this condition has corrected the

prices in Metro Manila's residential market.

During the surge of condominium takeups in 2019 attributed to the demand from POGO workers, Colliers Philippines data showed that the price per square meter increased by 10.9 percent quarter-on-quarter in the fourth quarter of 2019.

From a double-digit growth in price increase in the residential market at the height of offshore gaming operations in the country, Bondoc said the POGO exodus has eased price growth rate in Metro Manila at around 2 to 3 percent over the next two years.

"It already corrected even the President made that directive. The lease rates are already recovering but in a corrected manner as we see rents to increase between 2 to 3 percent from 2024 to 2026," he added.

Supply and demand

Bondoc said developers have delivered 11,300 residential units in NCR in 2023, which is close to the 11,700 units turned over in 2018 due to the surge in demand from POGO employees.

"Take note that these are projects that were launched at the height of the POGO demand in 2018," he said.
Bondoc said despite the

POGO exodus, these new units are expected to be taken up by local investors, especially overseas Filipino workers. (PNA)
