# PNPA GROUND BREAKS **NEW GRANDSTAND NAMED** AFTER MARCOS SR.

CASTAÑEDA, **CAMP** SILANG, Cavite (PIA) Senator Imee Marcos personally led on Monday, 29 the groundbreaking and laying of time capsule for the proposed Philippine National Police Academy (PNPA) parade ground named after former President Ferdinand E. Marcos Sr.

The construction of Ferdinand President Edralin Marcos Sr. Field is dedicated and named the former president who is considered and acknowledged 'Father of PNPA'.

The grounds will be equipped with a 2-story grandstand with the size of 30M x 160M. The ground floor will serve as a holding and receiving area with a VIP room and conference rooms.

While the second floor will serve as the stage with a VIP room, an audio-visual room, an bleachers office. and which can accommodate approximately 1, 200 seats. On the other hand, the parade ground will also have a LED wall similar to those located in its old parade ground and an open field with a total area of 30,591 square meters.

Senator Marcos likewise witnessed the successful Incorporation Rites of the PNPA Sandirangan (SANDIgan ng Bayan paRA sa Lupang SinilaNGAN) Class of 2028 wherein the Senator is the guest of honor and speaker.

In her message to the 332 new cadets, the Senator unveiled her proposed Senate Bill 409 for the modernization of Philippine National Police, as well as another bill that would provide free legal assistance to police, soldiers, BJMP personnel, and Coast Guard to face lawsuits or complaints in court

#### Jail congestion rate in Calabarzon down to 591 percent — BJMP

CALAMBA CITY, Laguna (PIA) - The Bureau of Jail Management and Penology Region IV-A reported a jail congestion rate of 591 percent, down from 676 percent based on last year's figures.

In his presentation during the Kapihan sa Bagong Pilipinas episode with the Department of the Interior Government and Local (DILG) and its attached agencies, BJMP IV-A Regional Director JCSUPT Hilbert M Flor highlighted that congestion rate in all jail facilities in the region has decreased with remaining 22,421 inmates under their custody.

"We have observed here a significant reduction in the percentage of congestion in our facilities, not only here at BJMP Calabarzon but also nationwide. Our primary program is to lower the congestion rate, as this is one of the main challenges in providing various programs for our Persons Deprived with Liberty (PDL)," Flor said.

To prioritize their wellbeing, BJMP IV-A has been actively collaborating with numerous local government units and national government agencies to prepare the PDLs for their reintegration into society.

Flor said that 815 PDLs have undergone training and vocational courses the assistance of Technical Education the and Skills Development Authority (TESDA) as a way to erase the stigma for detainees once they were released from jails.

Aside from this, 1,908 PDLs passed the Alternative Learning System (ALS) for the year 2023 to 2024, 94 of whom have enrolled in college.

Flor added: "The goal is to eliminate any fear of accepting newly released inmates because have been provided with technical programs, such as those from TESDA and DICT, and have received certificates proving their readiness to work after their release."

Recently, additional facilities in the region including the Kanlungan sa Piitan San Pablo City District Jail - Reformatory Center and Morong Municipal Jail were inaugurated as part of the continued decongestion efforts of the bureau.

The jail bureau director then clarified that all jail facilities in Calabarzon are receiving the adequate amount of funding to carry out and implement their programs.

If additional funds are needed. they seek assistance from local government units and other service providers to address the needs of the PDLs.

Meanwhile, Flor urged the public, including the family of PDLs, to refrain from discriminating against inmates. the Instead. encourage and help them to start anew and take a new path after their release.

"They need your support for their transformations, and it is important that you contribute in their positive petrochemicals. Meanwhile.

samples gathered from Cavite City, Tanza, and Naic remain free from contamination.

"Nevertheless, Bureau maintains that precautionary а measure, fish harvested from areas where oil slicks are observed be deemed unsafe for human consumption," the BFAR announced in a bulletin.

Days ago, Cavite Governor Juanito Victor Remulla already signed Executive Order No. 38, series of 2024, where the provincial government declares Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, and Ternate, as well as the cities of Cavite and Bacoor as no-catch and no-sell zones for shellfish.

"There is a need to declare a no-catch and no-sell zone in the coastal areas in the province to ensure the health and well-being of Caviteños and the consuming public [from the effect of the oil spill]," the EO reads.

CALAMBA CITY (PIA) Citing the law that created the Philippine National Police (PNP) as a civilian agency, cops in the Calabarzon (Cavite, Laguna, Batangas, Rizal, and Quezon) region have found a better way to address local insurgencygoing deep communities and offering

During the Kapihan Bagong Pilipinas, Calabarzon PNP regional chief Brig. Gen. Kenneth Lucas cited the need for fellow cops to revisit the PNP mandate, embarking on its nature as a civilian agency.

As such, Lucas said that the PNP's role should be primarily focused on establishing rapport with the communities alongside the Calabarzon Regional Task Force to End Local Communist Armed Conflict (RTF-ELCAC) to maintain

the region's peace and order.

"With all the interventions undertaken Philippine National Police, in coordination with our counterparts like the Armed Forces of the Philippines, many have already surrendered through government programs like ELCAC," Lucas said.

Regional Mobile Force Battalion acting chief Lt. Col. Norman Rañon highlighted the surrender of more than 60 members of rebel groups.

"Here in Calabarzon, we have cleared [areas] through the hard work of the AFP and the PNP," Rañon was quoted as saying during the forum.

"Through our Regional [Lucas]'s Director leadership, we were able to convince families of people who went underground. We have programs supporting them [former rebels] like the Alternative Learning System by sending them to college with the support of other stakeholders."

RTF ELCAC has been working various stakeholders to relav government programs to rebel groups sympathizers. (PB/PIA-4A)

# **DOLE releases P6.1M** for oil spill-affected fisherfolk in Cavite

The Department of Labor and Employment (DOLE) in Cavite on Wednesday disbursed over PHP6.12 million to support 1,178 individuals in the municipality of Tanza, who have been impacted by the temporary fishing ban due to the oil spill in Bataan.

In a phone interview on Wednesday, DOLE-Cavite Provincial Director Marivic

The director adds that the reformation of PDLs are also in the hands of their families and friends and to further discourage them from doing inappropriate and illegal behavior such as trafficking contraband inside the jails. (CO/PIA-

CALAMBA CITY, Laguna Martinez said the funds had been allocated under the Tulong Panghanapbuhay sa Ating Disadvantaged/ Displaced Workers (TUPAD) cash-for-work program.

The beneficiaries whose livelihoods have been disrupted by the fishing ban received salaries for their temporary employment.

During the payout at the Capipisa Covered Court in Barangay West Capipisa, each beneficiary received PHP5,200 for 10 days of work.

"The TUPAD beneficiaries are engaged in coastal cleanup efforts in their area," Martinez said.

She also reassured other oil-spill affected fisherfolk in the municipalities of Maragondon and Ternate that assistance would be

provided to them, as the fishing ban remains in effect in several coastal towns in the province.

Martinez said assessments are underway in other coastal areas, including Bacoor, Rosario, Noveleta, Kawit, and Cavite City determine further assistance needed.

The next round of TUPAD payouts is scheduled on Aug. 9 in the town of Naic, she said.

The oil spill started on July 25 after MT Terranova sank off Limay, Bataan, carrying 1.4 million liters of industrial fuel oil. (PNA)

Quezon City - Senator Imee Marcos and Federation of Filipino Chinese Chambers of Commerce and Industry. Inc. (FFCCCII) President Cecilio K. Pedro announced their ongoing P60 million typhoon Carina relief effort during their talk at the Pandesal Forum of the 85-year-old Kamuning Bakery Cafe. This relief spearheaded by effort. FFCCCII and Senator involves Imee Marcos, 30 major Filipino Chinese business, cultural, and civic organizations, providing aid to flooded and hardhit areas of Metro Manila provinces nearby and such as Bulacan, Bataan, Pampanga, Tarlac, and Cavite. The eventual target is P100 million worth of donations for essential relief supplies like rice, canned sardines, and other necessities.

During the forum. Senator Marcos and Dr. Pedro gymnast congratulated Yulo his Carlos for unprecedented success in winning two Olympic gold medals in Paris, expressing high hopes that pole vault athlete EJ Obiena, boxers, and other athletes will also secure medals in the ongoing Olympiad. Dr. Pedro emphasized the importance of focusing on individual sports where height is not a crucial advantage, advocating for disciplines where the Philippines can excel globally, unlike basketball has height requirements. Senator Marcos advised Carlos Yulo and other Filipino sports winners to manage and invest their prize money wisely, seeking good and honest advisers. She also urged the government to revive grassroots sports programs similar to the successful Gintong Alay project of her late father, President Ferdinand E. Marcos, which nurtured champions like Lydia de Vega and Elma Muros.

Senator Marcos, former Director-General of the Experimental Cinema of Philippines (ECP), expressed her sadness over the August 4, 2024, passing of top movie producer Mother Lily Yu also eulogized Mother Lily and her late husband Remy Monteverde. recognizing them respected philanthropists within the Filipino Chinese business community. # **BSP launches e-learning** academy, financial education initiatives

MANILA - The Bangko Sentral ng Pilipinas (BSP) said it is working on online and innovative training platforms further broaden financial education (fin-ed) and strengthen consumer protection.

In a statement on Tuesday, the BSP said it launched the first batch of the BSP-BDO Foundation (BDOF) fin-ed e-learning modules, covering financial planning, budgeting and saving, and debt management, at the Innovative Financial Education Programs at the central bank's head office in Manila on Monday.

The central bank said it has also created the BSP E-Learning Academy (BELA), an online platform that provides e-learning courses on personal finance, economics, and central banking.

complements BFLA the BSP's existing fined programs that are delivered face-to-face and through other modalities.

The BSP said select stakeholders are testing BELA, which is expected to be fully accessible to the public by the second quarter of 2025.

During the launch, the central bank also signed fin-ed partnership agreements with the Social Department of Welfare and Development (DSWD), Department of Agriculture (DA), Credit Card Association of the Philippines (CCAP), BDOF, and BDO Unibank, Inc.

"Our initiatives are designed help to people safeguard credit cardholders from potential pitfalls, transform over 37,000 DSWD employees and 3,600 local social officers welfare into champions of financial literacy, and capacitate over 10.8 million Filipino farmers and fisherfolk through innovative educational tools.' Deputy Governor BSP Bernadette Romulo-Puyat

The BSP said the modules can be accessed through BELA and will soon be available on the e-learning platforms of the BSP's institutional fin-ed partners. Additional six courses being developed by the BSP-BDOF are the basics of investing, fraud and scams, financial consumer protection, digital financial literacy, Personal Equity Retirement Account, and relevant economic indicators

These will also be made available through BELA and to BSP's institutional partners.

The memorandum agreement (MOA) signed with the DSWD and the BDOF formalizes their cooperation in designing and implementing a fined program for DSWD employees and social welfare officers of local government units.

This will be part of the DSWD Academy's regular training program.

message In his support, DSWD Secretary Gatchalian said the launch of the innovative financial education programs of the BSP would bridge the gap and break barriers to the lack of accessible learning resources.

"It is imperative to shift towards greater financial independence and literacy as we embark on inclusive financial services for the Filipino people," he said.

The MOA signed by the BSP, DA, and BDOF, meanwhile, aims to consolidate fin-ed programs they developed for farmers and fisherfolk.

These include the games Fish N' Learn, which simulates real-life events that influence the financial behavior of fishermen and their families, and KITA Mo Na! (Kapital at Ipon Tungo sa Asenso), which emphasizes agripreneurship and good

credit standing. The BSP and CCAP also signed a MOA to craft a credit card e-learning course and provide stakeholders with learning resources.

# DBM OKs release of P5B for 2023 4Ps grants in arrears

MANILA – The Department of Budget and Management (DBM) has approved the release of PHP5 billion for the additional funding of the Pantawid Pamilyang Pilipino Program (4Ps), the government's flagship anti-poverty program under the Department of Social Welfare and Development (DSWD).

In a statement Tuesday, the DBM said the additional funds will be sourced from the 2023 Continuing Appropriations and used to cover the 2023 4Ps grants in arrears resulting in the deactivation/suspension of 4Ps beneficiaries to around 703.888 households.

"Makakatulong po ito para maibsan ang epekto ng inflation sa ating mga kababayan (This will help our countrymen cushion the impact of inflation). The DBM will do its part to streamline budget

processes so that our citizens benefit from faster and more efficient delivery of essential services such as our 4Ps," Budget Secretary Amenah Pangandaman said.

The allocation, according to Pangadaman, will allow the DSWD to continue its "critical work without interruption, providing much-needed assistance to our most vulnerable citizens."

In his third State of the Nation Address (SONA), President Ferdinand R. Marcos Jr. reported that over 420,000 households have graduated from the program or have been assessed as "self-sufficient" in just a year.

The 4Ps offers conditional cash transfers to indigent households to improve health, nutrition, and education outcomes. (PNA)

#### PTFoMS alarmed over murder raps vs. Masbate journos

MANILA – The Presidential Task Force on Media Security (PTFoMS) has requested the provincial prosecutor of Masbate for clarification on the filing of a murder charge against two local journalists, who were also accused of membership with a local communist terrorist movement.

executive **PTFoMS** director Paul Gutierrez, in a letter to Masbate Prosecutor Provincial Jeremias Mapula, sought assurance that he adhered to the provisions of the Department of Justice (DOJ) in identifying local broadcasters Beniamin Gigante and Jose Alfaro as members of the Communist Party of the Philippines-New People's Army (CPP-NPA) and that there are enough evidence pointing to them as participants in the killing of a certain Richard Bauso in Cawayan town on April 6.

Specifically, Gutierrez sought clarification if the purported membership of Gigante and Alfaro with the CPP-NPA was validated by the appropriate intelligence units of the Armed Forces of the Philippines and the Philippine National Police. Gutierrez reminded Mapula

that as the government's mechanism to address all violations on the right to life, liberty, and security of all members of the media, the PTFoMS is chaired by the Secretary of Justice "with the full support of all the attached agencies of DOJ, including the National Prosecution Service, of which you are a part of." Citing a media report, Gutierrez noted that in an earlier incident the local

Gutierrez noted that in an earlier incident, the local court recalled the warrant of arrest for Gigante, Alfaro and three other local journalists on July 26 over the killing of one Virgil Arriesgado in August 2022, with the criminal information also prepared by Mapula.

"In both incidents, it appeared these local media personalities were first accused of being members of the local communist terrorist movement in Masbate before being linked to the murder of the victims," Gutierrez said.

# Filipina wins FAO forest champions award in Italy

**MANILA** Filipina community leader Nida Collado has won the United Nations Food and Agriculture Organization's 2024 Wangari Maathai Forest Champions Award for her work in conservation and restoration in the Philippines.

The FAO-chaired Collaborative Partnership on Forests (CPF) presented the award during the 27th Session of the Committee on Forestry (COFO) in Rome, Italy on July 22.

Collado, the president of the Macatumbalen Community-Based Forest and Coastal Management Association in San Vicente, Palawan, had been championing environment protection within the community since 2002.

By 2009, she had mobilized projects from both government and non-government organizations, further encouraging community participation.

"From the few believers we had when we started, to being heard at the national level, and now standing here on the global stage, this journey has been incredibly meaningful for me and those who believed in and supported me," Collado said.

"Winning the Wangari Maathai Forest Champions Award proves that our efforts are worth cultivating and expanding."

To date, her group has reforested 1,450 hectares of denuded land and protected 400 hectares of

The candidates were evaluated based on four main criteria: overall impact, innovative aspects of the work, empowerment of others, and transferability and scale.

"Mrs. Collado's passion and innovative thinking have created lasting and positive change in forest management and restoration of mangroves – she is an inspiration for all of us," FAO Director-General Qu Dongyu said. Brazil's permanent

representative to the FAO, Ambassador Carla Carneiro, Barroso said many candidates deeply impressed them but Collado's extraordinary efforts towards sustainable forest management in San Vicente "left an indelible mark in her community, which made the jury unanimously agree to grant her the award.'

Philippine Ambassador Permanent Representative to UN Agencies Rome-based Neal Imperial said, "I am proud that a Filipina prime sustainable mover of forest management in the Philippines has recognized been the FAO. She is now a global inspiration for the protection and preservation of our remaining forest for the benefit of the present and future generations." Aside from being invited to attend the international award recognition ceremony, the winner also received a cash prize of USD20,000.

# FDA warns Pinoys vs. health products submerged in floodwaters

MANILA - The Food and Drug Administration (FDA) Tuesday reminded consumers anew not to purchase or use health products that have been submerged in floodwaters. Massive flooding prolonged power disruptions affected the National Capital Region and nearby regions due to Super Typhoon Carina and enhanced southwest monsoon or habagat.

These left several factories, warehouses, and establishments involved in the manufacturing, processing, packing, or storage of health products – including drugstores and retail outlets— submerged in floods.

In a public advisory, the FDA emphasized that the quality, safety, efficacy, and purity of such health products have already been compromised.

Hence, Department Circular 2012-014 or

"Disposition of Flood-Affected Health Products" must be implemented.

"This warns establishment and the public about health products that were submerged or otherwise affected by floods and are now being offered for sale or resale," it said.

Individuals who may have consumed affected health products are advised to consult their healthcare providers immediately especially if they have become ill.

Drugstores, retail stores and distributors are advised not to offer affected health products for sale, to return them to their sources, and to submit a report to FDA not later than one week.

Concerned food-drug regulation officers are instructed to identify affected establishments and conduct monitoring, and to seize damaged or affected health products. (PNA)

"We have started [the] music diplomacy [initiative] to bring our police closer to the community. We believe that this goes well with the marching orders of our President [Ferdinand


