PBBM EXTENDS OVER P360-M AID TO OIL SPILL-HIT RESIDENTS **IN CAVITE**

MANILA- Despite the weather, President Ferdinand R. Marcos Jr. on Wednesday personally handed over a total of PhP363,050,000 financial assistance and standby funds to over 33.000 fisherfolk and their families affected by the Bataan oil spill in Cavite.

Of this amount, PhP161,510,000 financial assistance from the Office of the President was extended to Cavite Gov. Jonvic Remulla. From this sum, PhP5,000 will be distributed to each affected fisherfolk and their families in the province.

President Marcos stated that the Bureau of Fisheries and Aquatic Resources (BFAR) also provided PhP18 million worth of post-harvest equipment, and training, financial assistance to the affected fisherfolk

The Department of Social Welfare and Development provided (DSWD) PhP69.47 million in various forms of assistance, including PhP3 million standby funds and PhP102.78 million worth of non-food items.

President Marcos noted that the Department of Labor and Employment (DOLE) has extended a total of PhP8.29 million in financial assistance to affected residents in Tanza and Naic, Cavite.

The DOLE is also offering livelihood programs affected residents Tulong through its Panghanapbuhay sa Ating Disadvantaged/Displaced (TUPAD) Workers Program.

The Department of Health is conducting (DOH) consultations, including health risk assessments and water testing, to ensure residents are safe from any harmful effects of the oil spill.

"Sa araw na ito, [ipinaaabot] ko ang aking taos-pusong pasasalamat at suporta mga mangingisda na naririto, kasama ang invong mga pamilya na kaagapay ninyo sa arawaraw," President Marcos said in his speech. "Asahan po ninyo na pamahalaan av gumagawa mga hakbang upang [maibsan] ang pinsalang naidulot ng mga insidenteng kagaya nito. Hangad namin na ang Presidential Assistance na aming handog sa bawat apektadong mangingisda ay makakatulong sa inyong pagbangon at magbibigay

President Marcos also mentioned that government is investigating the oil spill incident. He assured the residents of the government's continued assistance during these challenging times.

MANILA - The Philippine National Police Anti-Cybercrime Group (PNP-ACG) has warned the public against fraudulent phone calls from those pretending to be bank representatives.

after the PNP This, anti-cybercrime agents arrested 19 suspects, vloggers, including two who allegedly engaged in 'vishing' (voice phishing) targeting bank scams depositors, in an operation in Imus, Cavite last Aug.

In а statement PNP-ACG Thursday, director Brig. Gen. Ronnie Francis Cariaga said the operation stemmed from a confirmed intelligence report of online scamming activities in another vishing and scamming hub in Cavite.

vishing "From simple to spear phishing, the suspects use information obtained from credit card applications and ledgers or spreadsheets, likely taken from third-party service providers of the banks, such as business process outsourcing (BPO) companies," Cariaga said.

PNP anti-cybercrime agents nab 19 scammers, vloggers in Cavite

scammers use this information to access and siphon money from their victims' bank accounts," he said. Vishing is a fraudulent

practice of making phone calls by posing as bank representatives, convincing individuals to update their old card and reveal their bank account details, such as credit card numbers, as well as providing their One-Time-Pin (OTP).

search Armed with а warrant, the ACG operatives raided the area and arrested 19 people inside with the help of local police, barangay officials, and the Bangko Sentral ng Pilipinas.

PNP-ACG spokesperson Police Lt. Warren Mae Arancillo said two of those arrested are popular vloggers with thousands of followers.

Seized from them were several SIM cards, mobile devices, laptops, assorted bank documents, ledgers, and scripts that are being used to defraud the victims. The suspects will be charged with the violation of Republic Act (RA) 12010, or the Anti-Financial Account Scamming Act which was recently signed into law by President Ferdinand R. Marcos Jr..

Separate cases violations of RA 8484 Devices (Access Regulation Act of 1998), as amended, and RA 10173 (Data Privacy Act of 2012), both in relation to RA 10175 (Cybercrime Prevention Act) have also been filed against the suspects. (PNA)

Bacoor Assembly Act recognizes sacrifices for PH independence

MANILA - Senator Loren Legarda has underscored the importance of honoring Aug. 1 to recognize the sacrifices made for Philippine independence and inspire Filipinos to cherish and defend the nation.

In а news Legarda said the passage of Senate Bill No. 2690 or the Bacoor Assembly Act of 1898 Act which declares Aug. 1 of every year as a special working holiday, to be known as the Araw ng Paglalathala at Pagtatanyag ng Kasarinlan ng Pilipinas, "extends far beyond a simple historical date."

The measure aims to commemorate the Bacoor Assembly on Aug. 1, 1898, where President Emilio Aguinaldo, along with 200 municipal leaders, signed the Acta de Independencia drafted by Apolinario affirming Mabini. the independence country's and democratic ideals.

"This event represented a broad-based affirmation independence our and democratic ideals as articulated by Apolinario Mabini. By commemorating this date, we honor the sacrifices of those who fought for independence and celebrate the enduring legacy of freedom and solidarity," Legarda said in her manifestation after senators unanimously the bill on approved Tuesday.

Under the approved bill, the National Commission for Culture and the Arts is mandated to promote the historical significance of Aug. 1 and the events surrounding the Bacoor Assembly of 1898.

Meanwhile, the Department of Education shall develop and implement lesson plans that highlight the importance of this day, ensuring that students are educated about its relevance and importance. DOJ initiatives reduce jail, **court congestion in Calabarzon**

CALAMBA CITY, Laguna - The Department of Justice (DOJ) has made significant strides alleviating jail and court congestion in Calabarzon, the acting head of the National Prosecution Service-Region 4-A said Tuesday.

From July 2022 to March 2024, a total of 11,940 persons deprived of liberty (PDLs) were released following a comprehensive review of their records.

Additionally, the introduction of a new Case Build-Up (CBU) rule has resulted in the dismissal of 7,114 weak cases, reducing court docket congestion, according to Regional Prosecutor Josef Albert Comilang.

Additionally, Comilang said 3,474 PDL were granted parole, 1,684 were recommended for executive clemency, and

92 were granted executive clemency.

In a presentation at the Kapihan sa Bagong Pilipinas forum at Hotel Amihan in San Jose, San Pablo City, Comilang detailed DOJ's efforts to address jail and court congestion, as well as human rights issues within the region's criminal justice system.

"The DOJ has issued new guidelines to assess pending cases and recommend dismissal when there is insufficient evidence for conviction. This shift means that the rule on probable cause is no longer applied," he said. From the second quarter of 2023 to the first quarter of 2024, the CBU initiative resulted 3,516 convictions, 179 dismissals, and 62 acquittals out of 3,757 total court dispositions, he

High-value target yields P1.3-M shabu in Cavite buy-bust

MANILA - Agents of the Philippine National Police-Drug Enforcement Group (PDEG) have seized some PHP1.36 million worth of shabu from an alleged highvalue target (HVT) during a sting operation in Cavite province.

İn a statement Wednesday, PDEG chief Brig. Gen. Eleazar Matta said the suspect, alias 'Tomboy', 31, was nabbed during a sting operation in Barangay H-2, Dasmariñas City at 2:30 p.m. Tuesday.

Seized from the suspect were 200 grams of shabu and other non-drug pieces of evidence.

Matta said the suspect was brought to the Dasmariñas Police Station documentation.

The suspect will be charged with violation of Republic Act 9165 or the Comprehensive Dangerous Drugs Act of 2002.

The pieces of drug evidence were turned over to the Regional Forensic Unit 4A for laboratory examination. QCPD touts anti-drug gains Meanwhile, operatives of the Quezon City Police District (QCPD) confiscated illegal drugs valued at more than PHP66.5 million from January to Aug. 25.

QCPD director Brig. Gen. Maranan Redrico said these illegal drugs seized in 1,352 police operations carried out by the different police stations and units, resulting in the seizure of 9,554.49 grams of shabu and 12,846.00 grams of marijuana.

The substantial number of arrests and the significant amount of illegal drugs seized are a testament unwavering our commitment to eradicating the drug menace in our community. This success reflects the diligence and determination of our officers in their relentless fight against illegal drugs, Maranan said in a separate statement. (PNA)

PBBM OKs add'I funds for massive coconut planting, fertilization

MANILA - President replanting program and Ferdinand R. Marcos Jr. approved the additional funding for the massive coconut planting/ replanting and fertilization program of the Philippine Coconut Authority (PCA) for 2025.

Marcos gave his approval during a meeting Malacañang Tuesday

According to Presidential Communications Office additional (PCO), the funds would be used to implement the Philippine Coconut Industry Development

(PCIDP) 2024-2034. "Inaprubahan ni Pangulong Ferdinand R. Marcos Jr. ang dagdag na budget sa malawakang para coconut planting/ replanting program at fertilization program sa taong 2025, sa ilalim ng Philippine Coconut Industry Development Plan (PCIDP) 2024-2034 (President Ferdinand R. Marcos Jr. approved the additional budget for the massive coconut planting/

fertilization program for 2025, under the Philippine Coconut Industry Development Plan 2024-2034)," the PCO said in a Facebook post Tuesday afternoon.

"Ang PCIDP 2024-2034 tugon sa direktiba ni PBBM sa Philippine Coconut Authority noong October 2023 na gumawa ng detalyadong plano para sa pagpapaunlad ng coconut industry ng bansa (The PCIDP 2024-2034 is in response to PBBM's directive to the Philippine Coconut Authority in October 2023 to make a detailed plan for the development of country's coconut the industry)."

Marcos has expressed his intention to make the Philippines the world's No. 1 coconut exporter, seeing it as a "great opportunity" for the country's continued economic growth.

The PCA is looking to plant 100 million coconut trees by 2028. (PNA)

Marcos to media: Lead fight vs. fake news, uphold ethical standards

 President Ferdinand R. Marcos Jr. on Tuesday urged journalists to remain at the forefront of the fight against "fake news' and continue adhering to the most ethical and professional standards of journalism.

"I ask that you continue to adhere to the utmost ethical and professional standards of journalism free from sensationalism, bias. and personal motives," Marcos said during the oathtaking of newly-elected officers of various media groups at the Malacañan Palace.

"Help us see and address the weaknesses of our system, [and] continue to uphold our nation's best interests so that our country can continue to flourish," he added.

Marcos also acknowledged the critical role of the media in the grand-task of nation building, especially in helping the public make informed decisions.

"So, as you fulfill your

mandate, I urge you to remain at the forefront of our efforts in helping our people distinguish truth from misinformation, disinformation. malinformation," he said.

The President said that with the rise of social media. it has "become harder and harder" for ordinary citizens to "discern what is fake news, what is real news, what is propaganda, what is pure objective information".

"The mass, the volume of information is SO much because of our technological advances. It is so much that we must play a part in trying to help ordinary readers, citizens to discern what is news, what is propaganda, and what is just outright fakery," he said.

DOTr defers new tollway guidelines until Oct. 1

MANILA – The Department Transportation of (DOTr) deferred implementation of new tollway guidelines until Oct. 1 to allow toll operators to fine-tune their expressway operations.

DOTr Secretary Jaime Bautista announced the postponement of the policy from Aug. 31 to Oct. 1.

"We hope the concerned agencies and tollwav would operators use 30-day deferment the to fine-tune expressway operations and further intensify the public information campaign to enable tollway users to comply with the new guidelines," he said.

The revised guidelines, contained Memorandum Circular (JMC) no. 2024-01 signed on Aug. 1 by Bautista, Land Transportation Office (LTO) chief, Assistant Secretary Vigor Mendoza II. and Toll Regulatory Board (TRB) Executive Director Alvin Carullo.

The memorandum circular. once implemented, would impose penalties for lack of installed electronic toll collection (ETC) devices or insufficient load balance of the radio frequency identification (RFID), device well as strengthen the deputization by LTO of tollway enforcers.

It would update the responsibilities of the LTO, TRB, DOTr, tollway concessionaires, and users.

"These revised guidelines significantly should improve traffic along through expressways cashless or contactless toll plazas," Bautista said.

In an interview over Bagong Pilipinas Ngayon, TRB spokesperson Julius Corpuz said the

Marcos vows to 'do more,' as trust, nerformance scores improve

MANILA - President Ferdinand R. Marcos Jr. on Tuesday pledged to double his efforts in improving the Filipinos' lives, as he welcomed the increase in his trust and performance ratings in the latest survey by the OCTA Research Group.

In a chance interview on the sidelines of an event at Malacañan Palace in Manila, Marcos expressed gratitude that Filipinos were starting to appreciate his work.

"It is more like, 'yun nakikita na (people are beginning to see) [what we're doing]. We're really doing our best to alleviate the hardships na dinadaanan ng mga tao (that people are facing)," Marcos said.

"So, it's good to have that kind of result or statistic behind you. And again, every time this happens as far as I'm concerned, it seems to be people are beginning to understand what we are trying to do, they're beginning to feel the effects of it," he added. According to OCTA's "Tugon ng Masa" survey conducted from June 30 to July 5, Marcos' trust and performance ratings improved in the second quarter of 2024.

PBBM's trust, performance ratings improve: **VP Sara declines**

MANILA - Public trust and approval in the performance of President Ferdinand R. Marcos Jr. improved in the second quarter of 2024, while Vice President Sara Z. Duterte suffered a drop in the survey released by the OCTA Research Group on Tuesday.

OCTA's "Tugon ng Masa" survey conducted from June 30 to July 5 showed that Marcos' trust rating rose to 71 percent from 69 percent, posted in the first quarter of 2024.

Duterte's trust lowered by 3 percentage points to 65 percent from 68 percent recorded in the first quarter of 2024.

"This is the first time Ferdinand President "Bongbong" Marcos Jr. has registered a higher trust and performance rating than Vice President Sara Duterte-Carpio based on TNM surveys in the last three years," OCTA said.

"It must be noted that Duterte trust the performance and ratings continue to trend downward for the second straight quarter in 2024," the pollster added.

Marcos' trust increased by 8 percentage points due to an increase of 8 percentage points in Mindanao (56 percent from 48 percent), Duterte's bailiwick, OCTA noted.

Marcos earned the highest trust rating in Balance (80 percent), followed by Metro Manila (70 percent) and Visayas (69 percent).

OCTA said Marcos' trust rating also saw an increase by 22 percentage points among adult Filipinos belonging to Class ABC (74 percent), followed by Classes D (71 percent) and E (66 percent).

Marcos' Approval of performance was also higher by 3 percentage points to 68 percent from 65 percent recorded in the first quarter of 2024.

Marcos' performance score was highest in Balance Luzon (75 percent) and improved by 8 percentage points in Mindanao (56 percent).

His performance rating was also high in Metro Manila (68 percent) and Visayas (65 percent).

Based on the survey, Marcos also enjoyed an increase of 11 percentage points from adult Filipinos belonging to Classes ABC (71 percent), followed by Classes D (68 percent) and E (64 percent).

Meanwhile, Duterte's trust score remained highest in her bailiwick, Mindanao, which rose by 9 percentage points to 95 percent.

Her trust rating declined by 4 percentage points in Balance Luzon (52 percent from 48 percent) and 3 percentage points in Visayas (66 percent from 63 percent).

Duterte's trust score in Metro Manila was 60 percent.

highest trust score from adult Filipinos belonging to Class E, despite a decline by 4 percentage points from 68 percent to 64 percent. This was followed by Classes D (65 percent) and ABC (64 percent).

Duterte suffered declines in her performance ratings among all regions, with the highest in Metro Manila at 6 percentage points (50 percent from 56 percent) and Visayas at 4 percentage points (60 percent from 64 percent). Her performance score

remained high in Mindanao (92 percent) but reported lowest in Balance Luzon (48 percent).

performance Duterte's rating also decreased by 6 percentage points in Class E (65 percent from 71 percent) and 3 percentage points in Class D (60 percent to 57 percent). She posted the lowest performance rating from adult Filipinos belonging to Class ABC, which was at 56 percent. (PNA)

DOJ seeks funding to address prosecutor shortage in MIMAROPA

ODIONGAN, Rombion (PIA) — The Department of Justice (DOJ) is currently in discussions with the Department of Budget and Management (DBM) to secure funding for the additional prosecutor positions required in the MIMAROPA region.

MIMAROPA's OIC Prosecutor Regional Ross Rodriguez said this is based on the Prosecution Service Act of 2010 guidelines and a joint memorandum circular issued by the DBM and DOJ last year.

mentioned during He the Kapihan sa Bagong Pilipinas in Calapan City, Oriental Mindoro that there are currently 61 prosecutors in the region, but 57 more are needed to handle the workload adequately.

Despite the limited number

of prosecutors, Rodriguez highlighted that their disposition rate reached an impressive 99.39 percent in the first semester of the current year, with 6,480 out of 6,520 complaints resolved on time. This high performance suggests that, even with the shortage, the existing prosecutors are working efficiently.

Rodriguez pointed out that the lack of funding is not the only issue; there are also very few attorneys applying for these prosecutor positions.

He expressed gratitude to the prosecutors who manage to attend hearings across different locations despite their limited numbers, often taking on multiple cases to ensure that justice is served and every court hearing is attended. (PJF/PIA MIMAROPA-Rombion)

Budget deficit declines in July

government's budget deficit went down by 39.67 percent in July as revenue growth surpassed the increase in spending, the Bureau of the Treasury (BTr) said.

released Data on Wednesday showed that the budget deficit during the month declined to PHP28.8 billion from PHP47.8 billion in July last year.

The government incurs a budget deficit when spending exceeds its revenues.

For the first seven months of the year, the national government's budget deficit, however, reached PHP642.8 billion, higher by 7.21 percent compared to the same period in 2023.

Revenue performance

collections Revenue reached PHP457.4 billion in July, up 11.09 percent from PHP411.7 billion in July last year.

The BTr said tax collections, which comprised 88.07 percent of the total, grew 15.46 percent year year while non-tax revenues, accounting for 11.93 percent, contracted by 13.2 percent.

Collections for January to July, meanwhile, reached PHP2.6 trillion, surpassing

MANILA - The national the PHP2.3 trillion raised in the same period last year. Of the 2024 collections, 85.85 percent, or PHP2.2 trillion, came from taxes, which grew by 10.99 percent.

On the other hand, the nontax component contributed PHP368.8 billion, higher by 44.47 percent from last year.

Expenditures

The national government's expenditures, meanwhile, rose by 5.8 percent in July. disbursements "Julv reached PHP486.2 billion and were 5.8 percent or PHP26.7 billion higher than what was spent in 2023 partly due to the higher National Tax Allotment (NTA) share of LGUs," the BTr said.

expenditures Primary (net of interest payments) increased by 2.73 percent to PHP406.8 billion, while interest payments, likewise, rose by 24.9 percent to PHP79.4 billion. "This was due to the higher cost of financing and depreciation of the peso observed throughout the vear." the BTr said.

For January to spending amounted to PHP3.2 trillion, up by 13.17 percent from last year's PHP2.8 trillion. (PNA)

Investments (BOI) has approved a PHP1.2-billion investment project listed firm Monde Nissin Corp. for its automated and manufacturing processing of its butter coconut biscuits.

Data provided by the BOI Tuesday showed that this project was approved by the BOI Board last July 25 but has yet to be registered investment with the promotion agency.

Board already "The approved the project but the firm is yet to submit preregistration requirements, e.g., acceptance of the terms and conditions of their registration. They have not been issued the actual certificate of registration so they are not yet registered," BOI **Executive Director Evariste** Cagatan said.

BOI said the The manufacturing facility will be located in Brgy. Ilang, Bunawan, Davao City to cater to the Visayas and Mindanao markets.

MANILA - The Board of Monde Nissin's Davao factory is an addition to its existing butter coconut manufacturing biscuits plant in Sta. Rosa, Laguna for the Luzon market.

> The Davao City project is expected to employ 111 regular personnel.

> "Except for the manual preparation of materials, the whole butter coconut biscuits production and packaging of finished goods is fully mechanized using up-to-date and market appropriate technologies," the BOI said.

> It added that for the packaging and movement of finished goods, the listed company will employ automation advanced technology, which will require highly skilled workers.

This project supports the Department of Trade and Industry's (DTI) push for Industry 4.0, or the use of digitization in the manufacturing sector. (PNA)

Budget chief: Gov't to work harder to improve credit rating

MANILA - The Marcos administration would double its efforts to reach its fiscal goal of achieving an "A" credit Budget Secretary rating, Amenah Pangandaman said on Saturday.

welcomed Pangandaman global credit watcher Moody's affirmation of the Philippines' "Baa2" investment-grade credit rating.

"This is a positive development but this makes us only more determined to get an 'A' grade," Pangandaman said in a statement.

"I am confident that as long as we stay on track with our Agenda for Prosperity, with whole-of-government approach, we will achieve an "A" rating with Moody's under this administration."

Pangandaman expressed confidence that the country will soon get an "A" rating after 10 years of being at "Baa2."

Moody's on Thursday kept is "Baa2" rating for the Philippines since 2014, citing the country's economic reforms, fiscal consolidation efforts. and robust macroeconomic fundamentals as key factors. According to Moody's report, the passage of reforms over the past several years

to liberalize the Philippine

economy will support medium-

term growth potential by supporting a business-friendly environment and attracting foreign investments.

A "Baa2" rating means the Philippines has moderate credit risk while an "A" rating means obligations are subject to low credit risk.

Moody's is among the leading global credit rating agencies, publishing investor-oriented industry credit research, studies, and risk analysis.

Apart from Moody's "Baa2," the Philippines holds two "A-" ratings from Japan's Rating and Investment Information, Inc. and Japan Credit Rating Agency, "BBB" from Fitch Ratings, and "BBB+" from Standard & Poor's Global Ratings.

Senator Sherwin Gatchalian welcomed Moody's Investors Service's affirmation of the country's credit rating amid expectations of stronger growth and better fiscal position.

This bodes well with our legislative agenda of improving investor confidence attracting foreign investments critical for the country to underpin sustained economic growth," Gatchalian said in a statement.

DOF proposes P33.7-B budget for 2025

MANILA – The Department of Finance (DOF) is seeking a PHP33.75 billion budget for 2025 which will be used for efficient tax administration and public service, Finance Secretary Ralph Recto said.

"[O]ur proposed budget every year is always a faithful reflection of our strategic priorities under the Bagong Pilipinas brand of governance," Recto said in his presentation at the Senate budget hearing on Tuesday.

"The items discussed today are part and parcel of a larger effort to improve tax administration efficiency, deliver more responsive public service delivery, and provide economic prosperity for the Filipino people," he said.

The DOF's proposed budget for 2025 is 20.8 percent than the 2024 General Appropriations Act (GAA) level.

The agency's New General Appropriations constitute the largest portion amounting to PHP29 billion to support the DOF's core operations and priority programs.

Recto said this is in line with the DOF's key priorities to ramp-up digitalization enhance revenue administration by the Bureau of Customs (BIR). customs enhancement by the Bureau of Customs (BOC), better financial asset

Corporate Recovery and Tax Incentives for Enterprises to Maximize Opportunities for Reinvigorating the Economy (CREATE MORE) which is expected to generate more foreign direct investments in support of economic growth.

He said increasing foreign direct investments would lead to job generation, support domestic consumption, and further improve the country's fiscal position.

With the expected enactment of CREATE MORE and other measures supportive of economic development, Gatchalian expressed optimism that the country would secure an investment moving rating upgrade forward.

CREATE MORE is a priority measure of the administration of President Ferdinand R. Marcos Jr.

said now the Gatchalian country's economy has completed recovered from Covid-19 pandemic, "we expect our economy to grow, and we may even have an investment rating upgrade.' (Leonel Abasola/PNA)

In terms of allocation, 41.4 percent of the proposed budget is allocated to Personnel Services. 37.9 percent to Maintenance and Other Operating Expenses, and 20.6 percent to Capital Outlays.

"This is in line with our commitment to prioritize workforce development and infrastructure improvements like digitalization. In fact, we are making significant digital transformation investments across agencies," Recto said.

The BIR, the BOC, and the Insurance Commission (IC) lead the charge digitalization with a combined amount of PHP4.20 billion, while other agencies are allotted around PHP600 million.

"These investments are aimed significantly at enhancing taxpaver streamlining experience, trade processes, improving transparency," Recto said.

The BIR will receive the largest share of the budget, amounting to PHP17.68 billion or 54.4 percent of the total DOF proposed budget while the BOC's proposed budget amounts to PHP5.66 billion.

The BTr, on the other hand, has a budget allocation of PHP6.46 billion.

The other DOF offices have the following proposed budgets: IC (PHP1 billion); DOF - Office of the Secretary (PHP491.25 million); Bureau of Local Government Finance (PHP433.66 million); Research National Tax (PHP144.11 Center Privatization million); and Management Office (PHP111.06 million); and Central Board of Assessment Appeals (PHP18.05 million). "We will ensure that every peso is being stretched to deliver the biggest bang per buck for the Filipino people. Much like our triumphant Olympians, we will always go for the gold," Recto said. MANILA - The Bureau of Internal Revenue (BIR) said 15 more medicines for cancer, high cholesterol, hypertension, and mental illness are now exempted from value-added (VAT).

statement Wednesday, the BIR said Commissioner Romeo issued Lumaqui Jr. Memorandum Revenue Circular No. 93-2024 last Aug. 27, exempting from VAT certain medicines for cancer, high cholesterol, hypertension, and mental illness.

"The BIR is now a serviceoriented agency, includes the regular update of medicines that will fall under VAT-Exempt products. The BIR supports the government's thrust in helping the public have access to more affordable healthcare and medicine," Lumagui said.

The bureau said the circular was made in response to the updated of VAT-Exempt Products from the Food and Drug Administration, under Republic Act (RA) 10963 and RA 11534.

In January this year, the BIR exempted from VAT 21 medicines for diabetes, cancer, and hypertension. In March, it also exempted 20 medicines for cancer, hypertension, and mental

PMCJ: First Gen's appeal to subsidize fossil gas/LNG imports proves that it is costly, deadly

Quezon City, Philippines The Philippine Movement for Climate Justice (PMCJ) denounced the First Gen Corp. (FGP)'s undue pressure on the Energy Regulatory Commission (ERC) for cost recovery on imported fossil gas/LNG including the landed costs to the consumers will make the end users bear the brunt of energy rate hikes. Landed cost of imported fossil gas/LNG covers payment of costs during testing, commissioning and other commercial operations of fossil gas/LNG facilities.

notice of resolution The released by ERC last August 13, 2024, confirmed First Power Corporation (FGPC) is allowed to collect the pass-through cost of LNG that covers the loading, unloading, transportation, storage, regasification, and the actual transportation to the fossil gas receiving facilities for power generation. The consumers are already being burdened on the said costs as the energy price hike continues, following the ERC approval, seeing additional 32 to 33 centavos per kWh in Meralco rates starting from the October customer billing period.

In a manner of pressuring Lopez-owned FGP called on the ERC to issue guidelines for the recovery of its LNG investments. PMCJ called out ERC not to allow FGP to collect cost recovery on importing LNG. However, granting cost recovery for landed cost of LNG is still unacceptable since it is allowing the market distortion by the caused artificial competitiveness of expensive LNG imports.

"It is convenient for energy companies to import gas because of cost recovery and the provision of pass-through that continues to burden consumers. This policy will not allow the competitiveness development of the indigenous energy industry. Government must overhaul this policy as this will be burdensome to the economy in the long run," PMCJ National Coordinator Ian Rivera said. Artificially making fossil gas competitive through subsidies paid by consumers would be a barrier to renewable energy. This simply means that a stop to Fossil Gas expansion is a step forward to 100% Renewables. FGP, together with other companies, asserts that the use of LNG as an "alternative fuel" is included in the circumstances where it is permitted to be used given the depleting supply from Malampaya is insufficient for the supply of power needed by MERALCO. PMCJ, together with other environment-concerned organizations and individuals, have been proving it wrong.

"The 'transition fuel' narrative around LNG is not only misleading but also harmful. Instead of expanding indigenous and imported LNG, the government must focus on renewable energy since its energy efficiency is increasing compared to that of LNG and coal," Ian Rivera argued.

fossil gas proves that LNG importation is too expensive for energy companies to bear, and that these schemes instead pass the costs of importation to consumers through more expensive energy prices. This in turn creates an uncompetitive energy market where fossil gas is artificially competitive vis-à-vis indigenous sources of energy," Rivera explained. Subnational and local governments are taking the lead in shifting to renewables. "Local governments are increasingly learning about the benefits of renewable energy, such as the stable and cheaper energy, energy independence from volatile fossil fuel markets, and potential for investments, jobs, and development. The local government of Albay. for example, declared their intention to reach 100% renewable energy before 2030. LNG investments are contrary to supporting and expanding this trend," PMCJ Senior Energy Officer Larry Pascua said.

The Philippines has historically had the second highest cost of electricity in Asia due to its reliance on imported fossil fuels, especially given that the Philippine Energy Plan intends to increase dependency on LNG. "The government must end the policy of cost recovery in favor of the fossil gas/LNG giants as this will distort the market," Rivera stressed.

PMCJ asserts that the government must subscribe to their mandate of ensuring the people's needs first and not the private corporations. If the ERC allows such, it is a clear suicide attempt on developing countries like the Philippines as this will set a precedent case of allowing public subsidy which should have been used first for poverty alleviation and social services.

DOST, tech biz innovators start platform, programs for startups

MANILA – Strategic and Collaborative Alliance for Leveraging Ecosystem (SCALE NCR), a consortium of technology business innovators (TBIs), on Tuesday announced the launching of platforms to accelerate the growth of technology-based startups and business enterprises in Metro Manila.

SCALE National Capital Region (NCR) is among regional nine consortiums funded by the Department of Science and Technology-Philippine Council for Industry, Energy and Emerging Technology (DOST-PCIEERD), through the Regional Startup Enabler for Ecosystem Development (ReSEED) program.

In a press conference, Cristina Ibañez, TBI manager, said the SCALE-NCR plays a pivotal role in promoting and accelerating the growth of startups within the NCR as it "offers mentorship, funding opportunities, strategic partnerships, and specialized resources."

"By 2028, we envision to be the leader in start-up initiatives and entrepreneurial ecosystem in the country... we are committed to establishing a robust collaboration with various start-ups enablers in the country," she said. Ibañez added that SCALE NCR aims to improve Metro Manila's standing in the global startup ecosystem ranking, currently placed at 81st to 90th.

She said the development of the Startup Institute, a platform dedicated to providing education, resources, and mentorship, will equip different startup stakeholders with the necessary entrepreneurial skills and knowledge.

The pilot training sessions will be held on Sept. 20 and 23 at the Colegio of Muntinlupa, she added.

SCALE NCR will also launch its NCR Investors Network, a platform to enable startups, businesses, or projects seeking funding to connect with investors who can provide capital and valuable mentorship.

The network aims to promote startup investment education and

awareness by hosting workshops and seminars on trends, best practices, and opportunities in the investment landscape.

Meanwhile, engineer Romelen Tresvalles, regional director of DOST-NCR, said they have supported SCALE NCR in product prototyping and product validation stages for two years already.

She said the plans and technical support they provide will help startups cater to both local and international markets. (PNA)

SC validating report of data breach

MANILA - The Supreme Court (SC) on Wednesday said it is validating social media reports of a major data breach in its system, days before a new rule to digitize proceedings requiring litigants in lower courts are required to submit digital copies of their pleadings, goes into effect.

"We learned of the social media post about the alleged data breach, and our MISO (Management and Information Systems Office) is currently validating it. Rest assured,

the Court has invested in cybersecurity for its data and will continue to do so as we digitalize our processes," SC spokesperson Camille Ting said in a message to newsmen.

"All processes of the Court, including the Bar exams, are secure," Ting added.

The Bar examinations, which will be held online in multiple sites, will be held next month.

A social media post claimed that on Aug. 27, a "significant security breach" hit the Supreme Court, allegedly leading to the "exposure of highly sensitive legal data."

The supposed breach also includes data as to payment of legal fees which is handled by a local bank.

No evidence of breach

In a separate statement, the Supreme Court said it, along with its service providers, has "found no evidence of a breach or indication that sensitive data was compromised" as of Wednesday afternoon.

"The Court will continue to investigate further, employing the right amount of redundancy by approaching the investigation from many angles," it added.

Remulla said the DOJ already in close is collaboration with Social Department of Welfare and Development and is currently asking other concerned agencies, including the Department of the Interior and Local Government and the Supreme Court, to work together to address the problem. (PNA)

The SC said it would do another round of Vulnerability and Penetration Testing assessment (VAPT) as a precautionary measure, and has asked its providers and partners to do the same.

"We are also going to conduct another external review of our cybersecurity systems," it said.

"We assure the public that in its current efforts to digitalize court processes, the Court has always given priority to cybersecurity and taken the necessary precautions in terms of training, access, and the

use of the needed apps and hardware. We have layers of in-house and external cybersecurity."

The SC warned individuals who may be tempted to hack its data that its systems are professional, state-of-the-art, robust, and "capable of identifying and tracing the sources of any form of attack."

"We also remind the public that any attempt to gain unauthorized access or compromise our systems, as well as releasing sensitive and private data without proper authorization, are criminal acts," it added. (PNA)

DOJ reports 94% success rate on handled rape cases in 2023

MANILA – The Department of Justice (DOJ) was commended on Wednesday by senators after it reported that they were able to solve 94 percent of the 21,423 rape cases filed in court last year.

During the 2025 budget deliberation of the DOJ and its attached agencies in the Undersecretary Senate. Jesse Hermogenes Andres attributed success to the Training and Education Program for Law Enforcement Officers (Tepleo), which promotes the proactive involvement of prosecutors in case build-up.

The training seeks to strengthen the partnership between prosecutors and law enforcers, aiming for airtight cases and a reasonable certainty of conviction in court proceedings.

"It is the result of the close cooperation and coordination of the prosecutors and law enforcement agents where they are now on the same side gathering evidence together, the prosecutors guiding them and making sure that they have sufficient evidence gathered the right manner that is necessary for us to get the conviction under this higher threshold," Andres told senators.

With this "very good news," Senator Joseph Victor Ejercito said he is considering increasing the DOJ's budget for Tepleo. "From the very start, I was really concerned with this. If we need to increase the budget for trainings between the prosecution and the law enforcement agencies that will make our prosecution more efficient. Sabi ko nga kanina mas airtight na ngayon (As I said earlier it's more airtight now). 94 percent is really very commendable," Eiercito said.

The DOJ and its attached agencies are proposing to spend PHP40.58 billion next year, which is PHP1.11 billion higher than its PHP39.47 billion approved budget for this year.

Concerted effort vs OSAEC

Despite the success, Justice Secretary Jesus Crispin Remulla called for a whole-of-government approach against Online Sexual Abuse or Exploitation of Children (OSAEC), particularly on incestuous rape.

Remulla cited an estimate from a partner non-government organization, which reported that the number of OSAEC, including incestuous rape, in the country has reached more than 500,000.

"It's in epidemic proportions and people just keep silent about it. Hindi lang talaga pinag-uusapan pero napakabigat po na problemang ito (It is just not being talked about but this is a very serious problem) that we have to address sooner than later," he said. The DOJ chief warned that some online child pornography hubs can now

QUEZON CITY, (PIA) – The Public Attorney's Office (PAO) is keeping its line open for Filipinos in need of legal services such as legal counseling, among others.

PAO National Capital Region (NCR) Regional Public Attorney Revelyn V. Ramos-Dacpano stated that individuals with legal concerns can directly seek assistance to public lawyers either through face-to-face consultations or via phone calls.

"Ang legal counseling po namin ay hindi lang po 'yong face-to-face na legal counseling, we answer calls po. Ang aming mga lawyers po ay pwedeng magbigay ng counseling direct sa kanilang mga lines. Ang aming lines is open 24/7," said Atty. Ramos-Dacpano.

(Our legal counseling can be done not only through face-to-face legal counseling, we also answer calls. Our lawyers are ready to provide counseling directly through their telephone lines. Our lines are open 24/7.) The PAO can be reached by dialing (02) 8929 9436 loc. 106. Overseas Filipino Workers (OFWs) can also contact the said number to avail of necessary legal assistance.

As of June 2024, PAO-NCR alone has already provided a total of 105,224 counseling to its clients in Metro Manila.

Meanwhile, aside from legal counseling, the core services of PAO also include legal representation, administration of oaths and documentation, and inquest assistance.

"Mayroon din po kaming mediation conference kung saan sinusubukan po namin pagbatiin ang magkabilang panig in order to prevent po 'yong filing of cases in court at hindi na po mag-clog ang ating mga cases," Atty. Ramos-Dacpano added.

In addition, the PAO holds jail visitations to check on the situation of persons deprived of liberty (PDLs) and extend the necessary legal services that will cater to their welfare. "Ang primary goal po natin doon ay makita at madetermine po namin kung sino na po 'yong overstaying inmates para po makapagrecommend kami, makapagrequest kami sa Board of Pardons and Parole na kung pwede silang maka-avail ng parole," Atty. Ramos-Dacpano explained, highlighting the commitment of the Department of Justice (DOJ) to cater to the welfare of PDLs and their humane safekeeping.

[Our primary goal (in conducting this visitation) is to see and determine who among the inmates are already overstaying so that we can make a relevant recommendation or request to the Board of Pardons and Parole regarding the possibility of parole.]

To date, PAO-NCR successfully conducted a sum of 5,127 jail visitations.

This initiative to bring the legal services of PAO to grassroots communities is complemented by other multi-stakeholder efforts such as barangay legal information dissemination activities and legal aid caravans to further extend assistance. (JMP/PIA-NCR)


