DOJ VOWS ENHANCED JUSTICE SERVICE DELIVERY IN CALABARZON

SAN PABLO CITY, Laguna is illegal and punishable by (PIA) — The Department of Justice has reaffirmed its commitment to providing fair services to the public ensuring the enhancement of justice service delivery in the Calabarzon region.

During a recent episode of Kapihan sa Bagong Pilipinas, State Prosecutor Josef Albert Comilang, Officer-in-Charge and Regional Prosecutor of the National Prosecution (NPS) IV-A, Service highlighted their dedication to impartiality in offering free legal representation, counseling, and conducting preliminary investigations and prosecutions.

"We remain impartial during preliminary investigations. We do not favor any side or give preferential treatment. We represent the people of the Philippines, regardless of their financial situation. As long as they have a case filed in court, our office is here to assist them," Comilang said.

also assured the public that their office is committed to delivering timely justice and being a source of support for those in need.

"Our goal is to deliver real justice promptly and to be a beacon of hope for the helpless and voiceless. We stand up for those who need support because our justice system is fair and caring to everyone," Comilang added.

The regional prosecutor emphasized that the DOJ, through its attached offices like NPS and PAO, is committed to providing compassionate justice for all while maintaining accountability.

Lawyer Howard Areza of the Public Attorney's Office IV-A also reassured the public about their free legal services and condemned 'palakasan' patronage system, which involves bribing lawyers to gain favor

He pointed out that bribing or offering gifts to lawyers law, stressing that public attorneys are dedicated to serving everyone fairly.

"Do not he sitate to approach Public Attorney's Office because our legal services are available and free of charge. Please do not bring gifts or tokens; sometimes clients think mistakenly they need to offer something to receive service - that is not allowed," Areza said.

"Offering any form of gift is a serious offense; our lawyers could face legal charges and even lose their jobs," he added.

The agencies also shared their achievements providing legal services.

PAO Calabarzon reported that their office provided representation to 29,860 clients from January 2024 to June 2024 across various district offices in the region.

28,072 They handled criminal cases, 369 civil cases, 93 administrative cases, and 585 labor cases. They also conducted 5 242 jail visitations and offered 121,972 legal counseling sessions through various communication channels.

"Our district offices are available nationwide. including the most remote islands. Our services are free and cover criminal cases, including those for the complainants, as well as civil, labor, and administrative cases, extending to appeals and the Supreme Court," he

OFW families urged to embrace gov't financial literacy programs

CALAMBA CITY (PIA) -

The Overseas Workers Welfare Administration (OWWA) in Calabarzon encourages Overseas Filipino Workers (OFWs) to take advantage of the government's financial literacy programs to ensure the well-being and future of their families back home.

During the Kapihan sa Bagong Pilipinas, OWWA IV-A Program and Services Chief Francisca Lanuza said the contributions of OFWs benefit their families in many ways, including scholarship grants.

Throughout the years, OFWs have relied on OWWA for government welfare programs and assistance, especially when thev encounter problems abroad.

'Their contributions can help the families left behind in the Philippines avail of various benefits, such as our scholarship grants, Lanuza said.

"It Lanuza added, is important for OFWs and their families to continue paying their contributions, OWWA. especially to because every time an OFW encounters problems overseas, they have no the Department of Migrant Workers (DMW) led to more streamlined programs ensuring

"The DMW is there to support them, but it's better if two agencies cater to them," Lanuza added.

Aware of the financial problems faced by some OFWs, OWWA also offers training in financial literacy. where overseas workers can learn how to wisely invest their hard-earned money.

"We provide training on financial literacy because they have been working abroad for a long time, yet some still have no idea how to invest their money. We refer them to our partner banks to help them invest," Lanuza said.

According to the Bangko Sentral ng Pilipinas, OFWs bring in \$2.88 billion in personal remittances. which contribute to the country's economy. (PB/ PIA-4A)

DMW-Calabarzon issues OFW certificates within time frame in 2023

CALAMBA CITY, Laguna – The Department of Migrant Workers (DMW)-Calabarzon said Tuesday it processed 15,923 Balik-Manggagawa Overseas Employment (BM-OEC) Certificates within the designated time frame in 2023.

It also issued 5,341 BM-OECs within the process cycle time during the first semester of 2024.

During the Kapihan sa Bagong Pilipinas forum at Hotel Marciano here, Officer-DMW-Calabarzon in-Charge Karen Quilao highlighted the significance of the BM-OEC, being the exit clearance for overseas Filipino workers (OFWs) who are returning or vacationing abroad.

Quilao explained that when applicants have all required documents ready, including a valid visa and a verified employment contract, the BM-OEC is typically issued within the same day.

"The BM-OEC is designed to provide protection for OFWs, ensuring they are properly documented and informed before leaving the Philippines," Quilao stated. She cautioned **OFWs** against using fraudulent documents, which could lead

immigration checkpoints. It is crucial for workers to only deal with authorized entities to ensure a smooth departure process, added.

Quilao also reported that in 2023, there were 286,687 land-based workers and 113,231 sea-based workers deployed for international jobs.

For the first quarter of 2024, the numbers were 72,230 land-based and 23,606 seabased workers.

RDRRMC in Calabarzon assures aid for Enteng-hit areas

CALAMBA CITY (PIA) -The Disaster Risk Reduction and Management Council in Calabarzon said government aid is ready for dispatch in areas affected by Tropical Storm 'ENTENG.

Alvarez Carlos Eduardo III, Office of Civil Defense IV-A Regional Director, said the RDRRMC has placed Regional Emergency Center Operations under 'BLUE' alert status to ensure quick and seamless relief response in affected areas.

"The Regional DRRM Council is on top of the situation. At present, our Regional **Emergency Operations Center** is on Blue Alert Status and with the DSWD (Department Social Welfare Development-CALABARZON, we have already activated our Response Cluster."

Alvarez added: "We are in close coordination with all the regional-line agencies and our LGUs to ensure provision of necessary humanitarian assistance to our affected

population. The government is really working to manage the situation.

The DSWD Field Office IV-A has been coordinating with the Provincial Social Welfare Development Offices and (PSWDO) to ensure that the provisions of for the affected residents are on standby.

Barry Chua, Regional Director of DSWD IV-A, has also advised the City Government of Bacoor to utilize the Family Food Packs in their satellite warehouses as provisions for the affected families. Other LGUs with prepositioned food and non-food items are also preparing relief packs that will be distributed in the affected areas.

DMW IV-A steps up campaign to protect OFWs from online scams, illegal recruitment

CALAMBA CITY, Laguna (PIA) - The Department of Migrant Workers (DMW) in Calabarzon has intensified its campaign against online scams and illegal recruitment targeting overseas Filipino workers (OFWs).

During the Kapihan Bagong Pilipinas on Tuesday, September 3, DMW IV-A Regional Director Karen Quilao said their office has integrated anti-scam sessions into its pre-employment seminars for OFWs, equipping them with the tools and knowledge to protect themselves from online scams and fraudulent activities.

efforts "Our are being intensified because many OFWs continue to fall victim to these fraudulent schemes. The DMW's pre-employment seminar campaign aims prevent online scams providing training and by seminars to aspiring OFWs, they ensuring wellare informed before leaving the country to work abroad," Quilao explained.

The regional DMW chief added that the seminar covers topics such as identifying common scams, understanding the risks involved online in transactions, and knowing where to seek help if they encounter suspicious activities.

"When it comes to online scammers, this is also included in our anti-illegal recruitment campaign. ensure that all our compatriots who are leaving the country have attended the employment seminar so they are fully equipped when they work abroad," she stressed. Quilao also emphasized their

intensified campaigns against illegal recruitment and human trafficking to ensure that OFWs are less vulnerable to exploitation. She said the DMW IV-A is collaborating with local government units and various government agencies to investigate and trace these fraudulent activities.

Quilao affirmed the DMW's commitment to strengthening the agency's programs and services to ensure the welfare of OFWs and their families.

"We will also strengthen our training, seminars, and assistance to OFWs and their families to help them become resilient and improve their quality of life. The DMW will always be here for every OFW worldwide, as we are called 'Tahanan ng OFW."

Marcos assures implemention of all signed peace agreements with rebel groups

MANILA, (PIA) — President Ferdinand R. Marcos Jr. on Monday reiterated his administration's dedication to implementing all signed peace agreements with various rebel groups across the country, highlighting a commitment to lasting peace and development.

'Rest assured that can depend on vou this Administration to implement all signed peace agreements for security, inclusive progress, and stability not only in Mindanao but throughout our country," he assured during ceremonies commemorating the 28th anniversary of the 1996 Final Peace Agreement with the Moro National Liberation Front (MNLF), the event with the Office of the Presidential Adviser on Peace, Reconciliation and Unity.

Marcos pointed to ongoing peace processes groups such as the Moro Islamic Liberation Front (MILF) and KAPATIRAN, urging all stakeholders to contribute to a peaceful atmosphere leading up to the first Bangsamoro Autonomous Region Muslim Mindanao (BARMM) elections 2025.

DHSUD prepares for Tropical Storm 'Enteng' emergency response

QUEZON CITY (PIA) — As a proactive measure in anticipation of the potential impact of Tropical Storm "Enteng," the Department of Human Settlements and Urban Development (DHSUD) has mobilized its regional offices (ROs), including the National Capital Region (NCR), to be on high alert for emergency response operations.

DHSUD Secretary Jose Rizalino Acuzar has instructed Undersecretary for Disaster Response and Administrative and Finance Services, Randy Escolango, to issue a memorandum ensuring the preparedness of all ROs, especially those in areas like NCR that are likely to be significantly affected by the storm.

"We must always be proactive, ensuring our Regional Offices are ready to provide immediate assistance to our affected citizens," Secretary Acuzar emphasized.

In a memorandum issued

on Sunday, Undersecretary Escolango directed the Regional Directors from ROs in NCR, as well as Regions 1, 2, 3, 4A, 4B, 5, 6, 7, 8, and the Cordillera Administrative Region, to remain vigilant and on standby.

This directive follows the National Disaster

National the Disaster Reduction Risk and Management Council's Memorandum No. s. 2024. which calls for the activation or standby readiness of response clusters due to looming threat posed by "Enteng." As the head of the shelter cluster, DHSUD plays a critical role in the coordinated response.

"All concerned DHSUD Regional Offices are to be on standby immediately, closely monitoring their respective areas and facilitating emergency response and humanitarian assistance as required," Undersecretary Escolango stated.

Regional Directors have also been instructed to coordinate with Shelter Cluster members within their jurisdictions, leveraging all available communication channels To ensure prompt and effective action. daily situational reports are mandated from each region.

This heightened state of readiness is essential in ensuring that the densely populated NCR, along with other affected regions, can swiftly respond to any emergencies resulting from Tropical Storm "Enteng," safeguarding the well-being of residents and minimizing disruptions. (DHSUD/PIA-NCR/AVS)

DMW, OWWA ready to welcome OFWs with return opportunities

QUEZON CITY, (PIA) - Overseas Filipino Workers (OFWs) can rest assured that comprehensive reintegration services await them in the event they decide to return to their home country for good.

This commitment was strongly highlighted by Department of Migrant Workers (DMW) Secretary Hans Leo J. Cacdac in a Kapihan sa Bagong Pilipinas, citing that collaborative efforts are in place between concerned government agencies to improve the social protection support for OFWs through sustainable return opportunities.

We partner with other government agencies to further broaden the return opportunities for OFWs," said Cacdac, towards the goal of making overseas employment as a choice rather than a necessity to Filipinos.

"OFWs have shown their resilience so we, sa Bagong Pilipinas, susuklian natin 'yan with our own form of resilience at durability, at 'yan ang marching order mismo ng Pangulo-to be there in their utmost time of crisis and need for our OFWs. Kaya ganun ang aming mobilization of resources," he added.

(OFWs have shown their resilience so we, in Bagong Pilipinas, will return the favor with our own form of resilience and durability, and this is the exact marching order of the President-to be there in their utmost time of crisis and need for our OFWs. This explains the way we conduct the mobilization of our resources.)

The DMW primarily responds to the immediate needs of OFWs through the "Agarang Kalinga at Saklolo para sa mga OFWs na Nangangailangan" (AKSYON)

It is a budget allocation earmarked for the delivery of comprehensive assistance to distressed OFWs including emergency financial assistance as well as repatriation, legal, and other aid related to their labor migration and welfare.

The financial assistance provided to OFWs in distressed situations through the AKSYON Fund was recently increased from P25,000 to P50,000-P100,000 depending on the circumstances.

The AKSYON Fund is also being utilized to cover the legal fees of lawyers who are representing the OFWs seeking legal action against abusive employers and recruiters. As of July 2024, the AKSYON Fund was able to assist a total of 215,497 OFWs with total obligated amounting to P1.093.297.462.12.

In the aspect of helping OFWs build a financially-secure future

once they return to the Philippines, the DMW is working hand-inhand with the Overseas Workers Welfare Administration (OWWA) to develop sustainable livelihood programs.

Some 1,354 OFWs were able to establish their own businesses through the Livelihood Development Assistance Program (LDAP) of the DMW while 2,213 distressed OFWs were also given the opportunity to start their entrepreneurial ventures through OWWA's "Balik Pinas. Balik Hanapbuhay" Program.

Meanwhile, in partnership with the Department of Education (DepEd), the DMW and OWWA helped support 1,471 former OFWs who are passers of the Licensure Examination for Teachers (LET) to be reintegrated in the education system as public school teachers under the "Sa Pinas, Ikaw ang Ma'am at Sir" Program.

"Lahat ng ginagawa natin ay hindi lamang serbisyo kundi parangal sa ating mga mahal na OFWs at OFW families," Cacdac stressed.

(Everything that we do is not only in the name of service but also to give tribute to our beloved OFWs and OFW families.)

"Ito ang pang-Bagong Pilipinas. It is a comprehensive approach of how you deliver service. It is not just about listing, enumerating programs but kung paano ito hinahain," said OWWA Administrator Arnell Ignacio.

On the other hand, the DMW and OWWA jointly ensure that OFWs and their families can easily access service channels to file requests of assistance (RFA) for repatriation through the One Repatriation Command Center (ORCC).

Since its launching, the ORCC has become instrumental in resolving 26.994 cases related to repatriation out of the 33,650 RFAs received by the center and the OWWA satellite offices so far.

Through the ORCC, a monthly average of 910 OFWs return home safely to reunite with their families

in the country. In 2023, OFW remittances reached 37.2 billion USD or 3 percent higher than the recorded remittances in 2022 at 36.1 billion USD.

The said figure reflects the vital contribution of OFWs to economic growth and development which the DMW and OWWA hope for them to see and experience upon their return. (JMP/PIA-NCR)

Boracay to openMuslim-dedicated beach on Sent. 10

MANILA – Boracay is set to open a special beach dedicated to Muslim travelers in its push to become a more inclusive travel destination, a Department of Tourism (DOT) official said Friday.

The private cove for Muslim women inside the Boracay Newcoast will be launched on Sept. 10.

"Some Muslims can swim in public but other Muslims will prefer swimming in this (private area). And I'm sure those Muslims swimming in public, if they have a choice, (would also prefer that) because at present they don't have a choice," DOT Undersecretary for Muslim Affairs Myra Paz Valderrosa-Abubakar said on the sidelines of the Philippine-Malaysia Art Expo opening in Makati City.

The initiative was a suggestion by foreign diplomats based in the Philippines, including the ambassadors of Malaysia and Brunei.

"They (previously) had a meeting in Boracay and they mentioned to the mayor na sana merong private area sa Boracay (that hopefully there could be a private area for Muslims in Boracay)," she said.

"When we opened the idea to the mayor of Aklan, he said he will find an area and it's a good timing because Megaworld has a coast area doon na pwedeng gawing private cove for Muslim women (there that we can turn as a private cove for Muslim women)."

The Boracay Newcoast is in the northeastern portion of the world-famed island and also houses the Savoy, one of the Philippine hotels that recently secured a Halal

kitchen certification.

"President Bongbong Marcos mentioned during the State of the Nation Address about halal and Islamic tradition, so we're pushing for that and the Secretary as well is also pushing for more Halal offerings that we can do in the Philippines," Valderrosa-Abubakar said.

Science-based training

Making the Philippines Muslim-friendly is among the current thrusts of the DOT to diversify its tourism products based on the National Tourism Development Plan for 2023-2028.

In addition to expanding destinations, the DOT also laid plans to improve the training of frontline tourism workers through the halal modules developed by the Department of Science and Technology (DOST).

Calabarzon police seize **3k firearms from Jan.-Aug.**

CALAMBA CITY, Laguna - In preparation for next year's national and local midterm elections and to uphold peace and order, the Police Regional Office in Calabarzon (PRO-4A) has conducted 60,332 police operations from Jan. 1 to Aug. 31, 2024 that included the execution search warrants. checkpoints, arrests, patrols, and Oplan Bakal/ Sita and Oplan Katok.

During a presentation at Camp General Vicente Lim on Tuesday, Brig. Gen. Paul Kenneth Lucas, regional director of PRO-4A, reported that these

operations netted 2,929 firearms, of which 991 were confiscated and were for safekeeping.

The operations led to the arrest of 612 individuals, with 606 cases filed in court.

Lucas attributed these achievements to dedication of police officers and the active cooperation of the community in reporting illegal activities. "Our efforts to combat illegal firearms will continue until every weapon that could be used to harm others is removed from the streets," he said. (PNA)

GSIS extends emergency loan to storm-hit members, pensioners

MANILA Government Service Insurance System (GSIS) on Tuesday announced the extension of its emergency loan program to provide financial relief to members and pensioners in areas affected by Severe Tropical Storm Enteng as soon as it has obtained the list of areas declared under state of calamity.

This initiative builds on GSIS's ongoing emergency loan program, which has already been activated in several calamity-declared areas across the country.

Members and pensioners in areas affected by the southwest monsoon (habagat) and Typhoon Carina can apply until their respective deadlines: Oct. 26, 2024 for Baco and Pinamalayan, Oriental Mindoro; Oct. 25 for Rizal, and Batangas, National Capital Region; Oct. 29 for Bulacan and Pampanga; Oct. 31, for Camiling, Tarlac; Nov. 1 for San Andres, Romblon and Mabitac, Laguna; Nov. 5 for Ilocos Norte and La Union; Nov. 13 for Ilocos Sur; and Nov. 21 for Mangatarem, Pangasinan.

To qualify for the emergency active members loan. must reside or work in a calamity-declared area, not be on unpaid leave, have no pending administrative or legal cases, have no and demandable and have made at least six monthly premium payments prior to applying.

Their take-home net pay must not be less than PHP5,000, as stipulated by the General Appropriations Act. Old-age and disability pensioners must ensure that their net monthly pension remains at least 25 percent after deductions for loan amortization.

Members and pensioners with an existing emergency loan balance may borrow up to PHP40,000 to settle their previous loans, with a maximum net amount of PHP20,000. Those without existing balances may apply for a PHP20,000 The loan offers a low interest rate of 6 percent per annum, with a repayment period of three years.

Qualified members and pensioners can apply for the loan online through the GSIS Touch mobile app.

They may also submit their applications through GSIS Wireless Automated Processing System (GWAPS) kiosks located in GSIS branches nationwide. major government offices such as the Department of Education, provincial capitols, city halls, municipal offices, and select Robinson's and SM malls.

Calabarzon police reports 9 deaths due to 'Enteng'

CALAMBA CITY, Laguna The Police Regional Office (PRO)-Region 4A (Calabarzon) reported on Tuesday that their search, rescue, and evacuation during Tropical Storm Enteng led to the rescue of 179 individuals and the confirmation of nine deaths and six people still missing.

PRO4A Regional Director Brig. Gen. Paul Kenneth Lucas said 7,458 families 30,821 individuals are currently housed in

evacuation centers.

"Our teams are actively in engaged search and rescue operations, particularly in communities hardest hit by the storm," Lucas said. "We are also ensuring the welfare of our police officers residing in these impacted areas.'

He assured the public that the regional police is continuously monitoring flooded areas, to ensure the safety of residents.

DepEd salary differential out this month

MANILA - The Department differential in the education of Education (DepEd) on Tuesday said it is set to release PHP26.9 billion for the salary differential of all eligible public school teachers and non-teaching staff, in accordance with Executive Order 64 issued by President Ferdinand R. Marcos Jr. DepEd Secretary Sonny

Angara earlier confirmed that the Department of Management Budget (DBM) has approved the release of the salary

In a statement, DepEd Undersecretary for Finance Annalyn Sevilla said the salary differential for the January to August 2024 period will be released within the month.

"The September payroll is authorized to include these payments," she said.

Sevilla added that some DepEd regional offices are already processing the payment of salary differentials following the release of their Notice of Official Salary Adjustment (NOSA).

PH-China-developed diagnostic for autoimmune diseases complete by Dec.

diagnostic technology for autoimmune diseases being developed by Filipino and Chinese researchers is expected to be completed by December, Department of Science and Technology Secretary (DOST) Renato Solidum Jr. said Wednesday.

diagnostic "This tool can be used to detect autoimmune diseases such as arthritis and lupus. Developing a diagnostic tool like this is crucial to prevent the diseases from progressing," Solidum told the Philippine News Agency.

The tool, he said, is minimally invasive since it would only require blood samples, compared to biopsy that requires tissue samples.

"This would require blood samples as few as 1 ml. The result can be generated after a few days, which is also faster compared to processing biopsy results," he said.

The DOST and China's Ministry of Science and Technology (MOST) jointly funded the project, each allocating around PHP16 million.

"Local and Chinese from the researchers Tsinghua University have been undergoing high level research for this project," Solidum said, adding that the Philippine team is led

Economist: Inflation likely eased to within gov't target in August

MANILA - Headline inflation likely eased to within the government's 2 to 4 percent target in August following the uptick in July, an economist said on Tuesday.

In a Viber message, Rizal Banking Commercial Corporation chief economist Michael Ricafort said headline inflation likely decelerated to 3.8 percent last month from the 4.4 percent in July.

Ricafort said rice imports at a reduced tariff rate of 15 percent from 35 percent, on top of the lower world price of rice and other major global commodities, likely contributed to the downtrend.

"There could still be spillover effects on inflation by the Typhoon Carina and the recent habagat, but price freeze [is still] in effect in areas where state of calamity was declared up to 60 days or until September 24, 2024," he said. Ricafort said relatively stronger peso versus the US dollar could also reduce import costs and overall inflation.

Ricafort said headline inflation may likely settle within the Bangko Sentral ng Pilipinas'

target in the remaining months of the year.

He said this could justify further BSP rate cuts that would match any future Fed rate cuts from 2024-2026 to maintain healthy interest rate differentials.

The Philippine Statistics Authority is scheduled to release the August 2024 inflation data on Thursday.

DepEd warns public vs. fake P8K, P5K cash aid for students

MANILA - The Department of Education (DepEd) warned the public on Tuesday against fake cash aid for students circulating online.

The fake announcements promise to provide elementary to college students with cash assistance of PHP5.000 and PHP8.000 in exchange for their personal information.

The DepEd also previously intercepted similar assistance offers.

"The Department of Education warns the public about FAKE DepEd the cash assistance circulating online. DepEd reminds everyone to stay vigilant against misinformation," the advisory read.

the Among documents required to qualify for the bogus aid are Philippine Statistics Authority-issued birth certificates, identification, enrollment certificates, and the need to register via a clickable link claiming to direct to an online registration form.

The fraudulent posts illegally used the DepEd logo and pictures of President Ferdinand R. Marcos Jr. and DepEd Secretary Angara.

The DepEd urged the public to rely only on DepEd's official website and social media platforms on Facebook, X, and İnstagram.

The President said he trusts that Chavez, a long-time broadcast journalist before serving in the government, will "continue to serve with the same dedication and excellence that he has demonstrated in over three decades of public service; ensuring that the work we do is communicated effectively and immediately to the Filipino people."

"My only instruction to him:

MANILA - President Just tell the truth," Marcos bared.

"Congratulations, Cesar. It has come full circle for you," he went on.

In his first-ever media interview with the Malacañang Press Corps Communications as chief, Chavez said he will take an active role in communicating the government's policies on the West Philippine Sea issue, as well promoting in the Build administration's Better More Infrastructure Program and fighting misinformation disinformation.

He also bared that the President first offered the position to him in August 2022 which he turned down due to his commitment to the railway sector.

Chavez was named a presidential assistant on strategic communications in December 2023 with the rank of undersecretary. He also served as news anchor and station manager of DZRH and vice president of the radio station's parent company, the Manila Broadcasting Company.

Chavez will be the third Communications chief of the Marcos administration. In October 2022, Trixie Cruz-Angeles resigned as press secretary citing health reasons.

She was replaced by Cheloy Garafil as officerin-charge and eventually as full-pledged Secretary in January 2023. (PNA)

President Ferdinand Marcos, Jr., the PCC has charged 12 companies and individuals for violating the Philippine Competition Act in their handling of onion imports and trade.

The investigation revealed that these traders colluded to allocate sanitary and phytosanitary import clearances among themselves, allowing them to control over half of the Philippines' onion import volume.

Such actions constitute anticompetitive behavior, which is punishable under the Competition Act.

In addition to facing legal charges. the implicated traders have been ordered to pay fines totaling P2.4 billion. These individuals were

entrusted by the Department of Agriculture (DA) and the Bureau of Plant Industry (BPI) to ensure a stable onion supply, Tiu Laurel said.

"We can't allow a few individuals, driven by an insatiable lust for money, to exploit our farmers and consumers or, worse. sabotage our economy," he added.

He also said that the Department of Agriculture will consider blacklisting these traders and may withdraw the accreditation of cold storage facilities whose owners are found to be complicit with the scheme.

The PCC is a regulatory body mandated to implement the national competition policy and enforce Republic Act No. 10667 or the Philippine Competition Act (PCA), which serves as the country's primary competition law for promoting and protecting competitive markets. (GLG/ PIA-NCR)

SSS extending social security coverage to barangay execs

QUEZON CITY (PIA) — The Social Security System (SSS) is making steps to extend social security protection to barangay officials across the Philippines.

During the Liga ng mga Barangay's National Congress recently, SSS President and Rolando Ledesma barangay Macasaet urged captains kagawads and from approximately 42,000 become barangays to members of the SSS.

Macasaet said that many barangay officials serve their communities for decades without receiving separation pay or a monthly pension upon retirement. "Through the SSS membership, we are offering you an opportunity to secure a monthly pension when you retire from public service," he

encouraged officials He to obtain an SSS number, saving, "Even if you pay your contributions intermittently. that is fine. If you continue to pay until you reach at least 120 contributions, you will have a pension for life."

In addition to retirement SSS members benefits, would also be entitled to various perks, sickness. maternity. disability. unemployment, funeral, and death benefits.

Macasaet further highlighted the availability of SSS loan programs, such as salary and calamity loans, as well as additional coverage under the Employees' Compensation Program for work-related injuries or illnesses.

House Speaker Ferdinand Martin Romualdez advocating for the passage of a Magna Carta for barangay officials, which would allow local government units (LGUs) to allocate funds for their SSS contributions

Romualdez pledged to support legislative measures that would enable barangay officials to be SSS members at no cost.

Macasaet praised Romualdez and Isabela 6th District Representative Faustino A. Dy V for proposing the bill, emphasizing its significance for the country's barangay leaders.

To facilitate the registration process for barangay officials. SSS Executive Vice President for Branch Operations Voltaire P. Agas announced that the

agency set up 50 laptops staffed by personnel to assist officials in obtaining their SSS numbers. The SSS booth at the National Congress provided various online services, including account creation, contribution verification, and loan applications, ensuring that attendees could easily access essential services (AVs/PIA-NCR)

PBBM's newly proclaimed ecozones worth more than P1-B

MANILA – The Philippine Economic Zone Authority (PEZA) said the newly proclaimed ecozones in Iloilo and Batangas amount to PHP1.049 billion.

President Ferdinand R. Marcos. Jr. signed on Aug. 27 Proclamation Nos. 668 and 670 declaring The Grid in Iloilo and the expansion project at the LIMA Technology Center in Batangas as new ecozones, respectively.

In a statement Tuesday, PEZA said the cost of the expansion of the LIMA Technology Center amounted to PHP856 million, which is expected to be completed by the first quarter of 2025.

Proclamation 670 designated an additional 31.35 hectares of land as part of the Lima Technology Center Special Economic Zone (LTC-SEZ).

The LTC-SEZ is a project of Aboitiz InfraCapital. It currently hosts 169 locators

with more than PHP100 billion of investments, generating 65,000 direct employment.

Meanwhile, Proclamation 668 designated the 2,000 square meter land as a new information technology (IT) center in Iloilo.

PEZA said The Grid IT Center has an initial investment of PHP193 million.

It added that the IT center expects three IT and business process management (BPM) companies with investments of about PHP10 million and will create 250 jobs.

"In collaboration with other government agencies and industry partners, PEZA furthers its commitment in eco-zoning the Philippines towards inclusive and sustainable development – para sa Bagong Pilipinas (for the New Philippines)," PEZA Director General Tereso Panga said. (PNA)

Comelec eyes completion of own building by 2028

MANILA – The Commission on Elections (Comelec) is hoping to inaugurate its own main office in Pasay City by 2028.

Comelec chairperson George Erwin Garcia said the laying of the building's foundation will be completed in a maximum six months while the construction will begin next year.

The PHP8.225 billion budget will cover the construction the foundation and the ninestory building, which will have offices, warehouses, training facilities, event venues and even dormitories for employees. "Pipilitin natin na matapos sa loob ng tatlo hanggang apat na taon. Ito ay alay hindi lang sa mga kawani at opisyal ng Comelec kundi sa sambayanang Pilipino. Sa 2028 matatapos ang construction. We believe that once we start, the construction will be continuous)," Garcia said on the sidelines of the groundbreaking of the new egin building in Pasay City on Monday.

Garcia said additional funding may be needed for furnishing since the budget was computed and approved in 2019.

"Adjustments in the costings are necessary," he said.

The building will rise on a three-hectare property at the Central Business Park I - Island "A" in Harbor Drive. Currently, the poll body's main office occupies the 1st, 5th, 7th and 8th floors of the Palacio del Gobernador building in Intramuros, Manila. (PNA)

PH adds operating Islamic banking unit

MANILA — The Philippines now has two operating Islamic banking units (IBUs) that aim to enhance financial inclusion across the country.

In a statement Wednesday, the Bangko Sentral ng Pilipinas (BSP) said Maybank Philippines, Inc. started its Islamic banking operations last Aug. 14 after receiving IBU license from the central bank on July 4, 2024.

Prior to Maybank, BSP granted the first license to operate an IBU to CARD Bank, Inc. in June 2023.

Maybank is the first commercial bank in the country that operated an IRII

"Under BSP regulations, an IBU is (a) division, office, or branch of a conventional bank that operates in accordance with Shariah principles," the central bank said.

BSP Managing Director Judith Sungsai said Maybank's IBU marks a significant milestone in developing the country's Islamic financing.

She said the central bank supports the entry of new players in the Islamic banking sector by introducing regulatory reforms to encourage domestic and foreign banks to set up their IBUs here.

"The BSP will continue to work closely with industry players to ensure the robust and sustainable growth of the Islamic banking sector," Sungsai said.

According to its website, Maybank currently offers Shariah-compliant savings and current accounts.

It added this service is also available to both Muslim and non-Muslim customers.

Islamic financing will be soon offered once Maybank obtains Shariahcompliant funding. *(PNA)*

LTO extends deadline on ban vs. temporary plates until Dec. 31

MANILA – The Land Transportation Office (LTO) extended its deadline on the ban against the use of improvised and temporary plates for motor vehicles.

In a statement Monday, LTO chief, Assistant Secretary Vigor Mendoza II said instead of Sept. 1, the prohibition on temporary plates will take effect on Dec. 31.

"We ask motorists to claim and install their respective license plates as soon as they are available either in the car dealerships and replacement plates in our offices," Mendoza said.

The installation of license plates, he said, would help as a crime prevention measure as some are being used in criminal activities.

"Wala na pong backlog sa mga four-wheel vehicles so there is no reason for these vehicle owners not to claim and install them in their vehicles," he said.

However, he said there is still a backlog for motorcycle plates.

"[Motorcycle plates] po ay ang focus namin ngayon (Motorcycle plates are our focus today) in compliance with the directive from President [Ferdinand R.] Marcos to address all the backlog on license plates by June next year," Mendoza said.

He said the extension of the deadline would not diminish the LTO's efforts in coming up with measures to deliver unclaimed license plates to its owners.

LTO regional directors and district office heads, he said, have coordinated with local government units for the distribution of license plates.

LTO earlier issued a memorandum circular against the use of improvised and temporary plates after an initial investigation showed that registered owners of vehicles, especially newly bought ones, are not claiming their license plates from motor vehicle dealerships.

Following a meeting with the LTO in August, car dealerships said thousands of license plates remain unclaimed despite repeated attempts to contact vehicle owners. (PNA)

P40/kg of rice under Rice for All possible in Kadiwa stores by October

MANILA – The public may soon have access to PHP40 per kilogram of mixed imported and local well-milled rice in its Kadiwa stores in October, according to Department of Agriculture (DA) Secretary Francisco Tiu Laurel Jr.

In an interview with Anthony Taberna aired on Facebook late Sunday, Tiu Laurel said this is possible as retail prices in local markets are expected to drop to PHP45 per kilogram with the new stocks of imported rice coming in under the lowered tariffs.

President Ferdinand R. Marcos Jr. earlier ordered the implementation of Executive Order No. 62 or the lowering of tariffs on imported rice from 35 percent to 15 percent.

"Tingin ko mga October... Kung PHP52 ngayon dapat maging (I think by October... If it's PHP52 now, it should be) PHP45," Tiu Laurel said, referring to the PHP6/kg. to PHP7/kg. expected price decline in local markets under the lowered tariffs.

"Ang (The) Kadiwa, eventually, will be going, kung PHP45 na iyan sa market, sa Kadiwa (if that's PHP45 in the market, in Kadiwa) by that time should be PHP40, iyong (under the) Rice for All," he said.
Kadiwa's Rice for All program

intends to provide the general public with cheaper rice compared to the prevailing market price.

This is on top of the P29 program or the sale of PHP29/kg of aging but good quality stocks of National Food Authority (NFA) rice to members of the vulnerable sector including members of the Pantawid Pamilyang Pilipino Program (4Ps), senior citizens, persons with disabilities (PWDs), and solo parents.

Minimum market prices of rice have started to decline with the monitored prices of imported well-milled lowered to PHP45/kg on Aug. 30, from PHP48/kg and on Aug. 27, with imported regular-milled rice maintaining a minimum of PHP46/kg. level, based on the DA Bantay Presyo (price monitoring) report.

For the minimum prices of local commercial rice, local well-milled maintained a PHP47/kg level for the same period, with local regular-milled rice increasing from PHP43/kg on Aug. 27 to PHP45/kg on Aug. 30.

Tiu Laurel, meanwhile, said they are expediting procedures to further increase the number of Kadiwa stores nationwide. He said farmer cooperatives

DOLE 'finalizing' job fair for POGO workers

MANILA – The Department of Labor and Employment (DOLE) is finalizing the job fair that would help Philippine Offshore Gaming Operator (POGO) workers that would be affected by the closure of these establishments.

"It's still being firmed up and finalized. Profiling of the affected workers is expected to be completed within the week. Will provide you details once finalized," Labor Secretary Bienvenido Laguesma said in a message on Monday.

and entrepreneurs may use the name of Kadiwa to sell agricultural commodities in their areas, provided adherence to DA's Kadiwa procedures and operational systems.

"Mayroon na kaming naidentify na 1,000 plus actually. Pero iyong nakita na naming (We have identified more than 1,000. But what we have seen as) feasible to be exact, mga (around) 655."

The DA earlier expressed plans to open Kadiwa stores in Visayas and Mindanao in early September, with priority areas identified in Cebu, Maguindanao, and Sulu. (PNA)

Laguesma said the agency has profiled around 20,000 workers.

"If the remaining IGLs (internet gaming licensees, formerly known as POGOs) that have not submitted the list of their employees, I will submit the requested list, we can finish the profiling this week. Otherwise, we cannot complete it. DOLE, however, will send a team to these IGLs to follow up and secure the list," he said.

Laguesma said during profiling, workers are asked for their basic information.

"The profiling seeks to get info on the worker's personal circumstances(i.e age/ status) and nature of their work/salary level. On this basis, assistance may vary from employment facilitation through direct referrals or job fairs; livelihood projects or training, retraining and upskilling," he said.

President Ferdinand R. Marcos Jr., in his third State of the Nation Address in July, announced a total ban on POGOs and directed them to cease operations in the country by year end. (PNA)

SENATORS DISCUSS LEGALIZATION OF MEDICAL CANNABIS

Lawmakers the legalization of medical cannabis in the Philippines during its second reading at the Philippine Senate. Senate Bill 2573 sponsored by Sen. Robinhood Padilla and co-sponsored by Sen. Ronald "Bato" Dela Rosa proposes to legalize the use of cannabis for certain medical conditions.

This includes epilepsy, Parkinson's, Alzheimer's, anxiety, depression and even cancer pain. The House of Representatives recently passed House Bill 10439 on its third and final reading. This proposes the establishment of the Medical Cannabis Office under the Department of Health.

Representatives from PDEA, DOST DDB, DA will constitute and the MCO. Both Senate House Bills prohibit and the recreational use of cannabis. A prescription issued by a cannabistrained and certified medical practitioner Medical is necessary. cannabis will only be

scrutinized allowed in pharmaceutical forms such as capsule, oil, and suppositories.

The use of plants and parts such as buds or flowers will still be considered illegal and subject to penalties under RA 9165 or Dangerous Drugs Act. Through the technical expertise Bauertek Farmaceutical Technologies. the Philippines can manufacture medical cannabis.

The Philippines recently won the Grand Prize in the International Invention and Innovation Summit held in Krakow, Poland in May of this year. Twenty countries participated in 20 categories.

Philippine-made medical cannabis **CANCUR** won the Gold Medal in Pharmaceutical Category and the Grand Prize for the entire competition. The Department of Science and Technology and even President Ferdinand R. Marcos, Jr. recognized this global achievement of the Philippines.

Ayon pa sa kanya, may naitala na ring kaso human trafficking ng MIMAROPA at ito sa probinsiya ng

LUNGSOD NG PUERTO Palawan, partikular na ang insidente ng human trafficking na ang mga biktima ay mula sa bayan ng Roxas noong nakaraang taon, kung saan ay nasawi ang dalawang biktima.

Sinabi rin ni Gerodias na mayroon nang nakasuhan na illegal recruiters/ human traffickers ngunit ang record nito ay nasa kanilang main office.
