

## PDEA DESTROYS P777-M ILLEGAL DRUGS IN CAVITE

**MANILA** — The Philippine Drug Enforcement Agency (PDEA) on Thursday destroyed PHP777 million worth of dangerous drugs and controlled precursors and essential chemicals (CPECs) in Cavite province.

In a statement, PDEA said these include 1,474.92 kg. of solid illegal drug substances and 378.5 milliliters (ml) of liquid narcotics destroyed through thermal decomposition or thermolysis at the Integrated Waste Management Inc. (IWMI) in Barangay Aguado in Trece Martires City.

These substances are broken down into 66.72 kg. of shabu; 1,390.74 kg. of marijuana; 14.15 kg. of ecstasy; 428.44 grams of cocaine; 1.67 kg. of ephedrine; 1.07 kg. of psilocin; 206.5 ml of liquid shabu and 172 ml of liquid marijuana.

"The pieces of drug evidence were destroyed through thermal decomposition or thermolysis, which involves breaking down chemical compounds with the use of tremendous

heat. At 1,000 degrees centigrade, all dangerous drugs are decomposed or broken down," PDEA said. The illegal drugs were pieces of evidence seized from various anti-drug operations by PDEA, together with the Philippine National Police (PNP), National Bureau of Investigation, and other law enforcement and military units.

PDEA said the expeditious prosecution and disposition of drug cases prompted the immediate destruction of these drugs after these were presented as pieces of evidence.

Representatives from the PNP, Department of Justice, Department of the Interior and Local Government; local officials of Barangay Aguado, other law enforcement agencies; non-government organizations; and media partners joined key PDEA officials in witnessing the destruction activity.

PDEA said these illegal drugs were destroyed in compliance with orders from the court pursuant to the proper disposal of seized drug evidence as required by law. (PNA)

## Probation administration launches ladderized approach for offenders

**SAN PABLO CITY, Laguna (PIA)** — The Parole and Probation Administration (PPA) Calabarzon has launched the Therapeutic Community Laddered Program (TCLP), an innovative initiative aimed at guiding probationers through a structured path of personal and social development as they reintegrate into society.

In a recent episode of *Kapihan sa Bagong Pilipinas*, PPA Calabarzon Regional Director Shirley Fernandez highlighted that the TCLP is tailored to address the specific needs of offenders, promoting behavioral change through a supportive, community-driven approach.

"This TCLP is a process where a probationer works towards good behavior and conduct with the support of the TC Family," Fernandez said.

The program features a personal needs

assessment to identify necessary skills and tools for personal growth and social reintegration. It includes various activities such as skills training, health and wellness seminars, family counseling, and community service projects like tree planting. Participants advance through multiple levels of the program, each focusing on different areas of development to ensure successful reintegration.

Fernandez expressed confidence in the program's ability to aid offenders in their return to society and reaffirmed PPA's commitment to providing opportunities for rehabilitation and new beginnings.

"We believe that everyone deserves a second chance, and we are dedicated to helping them make positive changes," she stated.

## Youth participation vital in preventing community crimes – NAPOLCOM

### CALAMBA CITY, Laguna

— As part of the week-long observance of the National Crime Prevention Week 2024, the National Police Commission (NAPOLCOM) in Calabarzon underscored the importance of youth participation in ensuring crime-free communities.

Themed, "Kabataan Tarana, sa Crime Prevention, Kaisa Kal!" the 30th celebration of the NCPW highlighted the importance of capacitating and empowering the youth by conducting various information, education campaign efforts to equip them with knowledge needed to avoid becoming victims of potential crimes. According to lawyer Owen G. De Luna, Regional Director of NAPOLCOM Calabarzon, this year's NCPW focused on fostering a culture of vigilance and cooperation to instill a strong sense of responsibility and awareness to the young people.

"Youth play a crucial role in crime prevention. Young people need to be aware

of the crimes happening in their communities, as a lack of awareness could make them potential victims. It is important for the youth to actively engage in understanding how they can contribute in preventing crimes," De Luna said.

NAPOLCOM, together with police provincial offices in the region, will conduct month-long crime prevention seminar on schools with the key topic being cybercrime, as a way to raise awareness among the youth about how technology is used commit crimes, including sexual exploitation, cyberbullying, cyber extortion, fraud, identity theft, among others.

"Cybercrime has become extremely rampant nowadays – almost everyone, especially young people has a cellphone and almost everything now happens in cyberspace. Therefore, it is important for them to be informed and to share their knowledge as well on how to combat cybercrime."

While the NCPW primarily focused on giving protection to the youth from becoming victims, some are involved in various crimes and are often used by syndicates to become tools for crime due to their innocence.

The regional chief urged young individuals to change their paths and assured them that the government, primarily the Department of Social Welfare and Development (DSWD) and Philippine National Police (PNP), will provide support and interventions to aid their reintegration into society.

He also warned syndicates and adults who prey on the youth to refrain from exploiting them, as the law will hold them accountable for these offenses. (CO/PIA-4A)

## NIA-Calabarzon sells rice at P29 per kilo to 1K Quezon town residents

### CALAMBA CITY, Laguna

— The National Irrigation Administration-Calabarzon (NIA-4A) in Quezon province launched the "Murang Bigas sa NIA @ P29/kg" (Cheap Rice at NIA @ PHP 29/kg) program on Tuesday as part of the KabayaNIA agri-trade fair in Infanta town.

Vince Santoalla, public relations officer of NIA-4A, said in a phone interview that the program prioritized 1,010 beneficiaries, including senior citizens, Pantawid Pamilyang Pilipino Program members, single parents, and persons with disabilities.

Santoalla said the initiative was made possible through NIA's Rice Contract Farming partnership with the Federation of AGOS River Irrigation System Farmers IA in Infanta. The agreement, established in May, covers 79 hectares of rice farms encompassing the villages of Pilaway, Amolongin,

Binonoan, Langgas and Alitas.

"The heavy rains brought by Tropical Storm Enteng had minimal impact on the harvest, as farmers had begun harvesting in the last week of August," Santoalla noted.

He added that the NIA has also scheduled to sell cheap rice at its regional office in Pila, Laguna on Sept. 13.

On July 5, the Department of Agriculture launched the large-scale trial for P29-rice in 10 Kadiwa stores in the National Capital Region and Bulacan province.

Two more sites were added after two weeks in Bacoor, Cavite and San Pedro, Laguna.

Overall, the P29 program aims to benefit 6.9 million households nationwide with supplies coming from the stocks of the National Food Authority and harvest from contract growing programs of the NIA. (Zen Trinidad/PNA)

## DOST to use AI in weather forecasting for more frequent rain predictions

### MANILA (PIA)

— The Department of Science and Technology (DOST) is set to revolutionize weather forecasting by incorporating artificial intelligence (AI).

This initiative, announced by DOST Secretary Renato Solidum Jr. on Wednesday, September 11, aims to provide rain forecasts every 15 minutes, significantly increasing the frequency of predictions.

During budget deliberations for the DOST and its attached agencies, including the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), Solidum explained that the AI integration will replace the current three-hour computation cycle, enabling more timely and accurate weather information.

"Soon we will operate through our research program to use AI in weather forecasting. So instead of every three hours, our target is every 15 minutes," he said.

He added that the goal is to enhance PAGASA's forecasting capabilities to provide rain predictions for up to 14 days, compared to the current five-day forecast.

Senator Juan Miguel "Migz" Zubiri, who presided over the Senate finance subcommittee hearing, raised concerns about the number of operational Doppler radars in the country.

According to PAGASA Administrator Nathaniel Servando, only 11 out of 19 radars are currently operational, with some damaged and others needing

replacement. Solidum indicated that the country requires at least 21 radars to ensure redundancy in case some units fail.

"When it comes to Doppler radars, the reason we need 19 or 21 is because of redundancy. If one or several are not operational, the existing ones can cover," Solidum explained.

He noted that aging equipment necessitates replacements and that acquiring new radars involves a lengthy procurement process.

Zubiri expressed support for funding additional Doppler radars, highlighting that other countries can predict the exact timing of rain, a capability currently lacking in Philippine forecasts.

Solidum acknowledged the challenges of forecasting in an archipelagic nation, saying, "There is a big difference between continental meteorology and meteorology in an archipelago like the Philippines."

He also mentioned that PAGASA is moving toward impact-based forecasting, which assesses the effects of rain rather than simply predicting its occurrence.

"PAGASA produces several rainfall warnings and 24-hour rainfall forecasts, which disaster managers should read for their areas," Solidum said.

However, he noted that there is a need for standardized operating procedures at the local level to effectively respond to these forecasts. (JVD/PIA-NCR)

## TESDA holds annual 'world café of opportunities' for jobseekers

**CALAMBA CITY, Laguna (PIA)** — A total of 73 out of 400 Technical and Vocational Education and Training (TVET) graduates of the Technical Education and Skills Development Authority (TESDA) Laguna Provincial Office were hired on the spot during the 'World Café of Opportunities' job fair that bids to open employment opportunities, apprenticeship programs, and other forms of livelihood assistance for beneficiaries and applicants alike.

The program was held in celebration of TESDA's anniversary in August, adding to their continuous efforts to enhance the employability of graduates by directly linking them to industries and companies in need of skilled workers last August 15 at Santa Rosa City.

TESDA Laguna Provincial Director Zoraida Amper said during the Philippine Information Agency's Usapang PIA radio program: "The end goal of our training is not only for them to have a job, so we should also assist them in employment because that

is why you cannot say that your training is successful if our students are there will be no work."

The job fair offered a diverse range of opportunities for job seekers, participated by 33 local companies and 2 international companies. "There are jobs, opportunities and the TVET graduates will just go there to shop, like you are in this café so it is called the World Café of Opportunities," Amper added.

## PhilHealth to highlight enhanced benefit packages in 16th KBP

**QUEZON CITY, (PIA)** — The Philippine Health Insurance Corporation (PhilHealth) will showcase its enhanced benefit packages during the 16th episode of Kapihan sa Bagong Pilipinas (KBP), focusing on the improved delivery of accessible and affordable healthcare services as part of the vision for Universal Health Care (UHC).

Dr. Bernadette C. Lico, PhilHealth PRO NCR and Rizal Vice President, will lead the discussion on primary care services available through the KONSULTA (Konsultasyong Sulit at Tama) Benefit Package. This initiative provides comprehensive access to free healthcare services, including medical consultations, health risk screenings, selected laboratory tests, and essential medications from over 2,000 KONSULTA providers nationwide. The episode will also

address a projected 30 percent increase in case rate packages, reflecting PhilHealth's ongoing commitment to expand services and reduce out-of-pocket expenses for Filipinos seeking medical care.

On September 7, PhilHealth President and Chief Executive Officer Emmanuel Ledesma, Jr., reaffirmed the national health insurance system's dedication to enhancing benefit packages to alleviate the financial burden on Filipinos. "We hear the concerns of our kababayans about the high cost of medical treatment," Ledesma said. "We are expediting the improvement of benefits." Significant increases in benefit packages have been made for critical health issues, including breast cancer, dialysis, stroke, pneumonia, and asthma. Notably, the Z Benefit Package for breast cancer has surged from

## PhilHealth's Konsulta now offers more than 3x budget per patient

**QUEZON CITY, (PIA)** — Members of the Philippine Health Insurance Corporation (PhilHealth) can now avail of the enhanced Konsultasyong Sulit at Tama (KONSULTA) Benefit Package with an increased budget per patient rate from P500 to P1,700.

The said increase in the capitation rate forms part of PhilHealth's efforts to enhance the coverage of its services to ensure that every Filipino has access to affordable and quality healthcare, especially when it comes to primary care.

"We will continue expanding our benefits," said PhilHealth Senior Vice President for Health Finance Policy Sector, Dr. Israel Francis A. Pargas in the 16th Kapihan sa Bagong Pilipinas (KBP). "Pero ang isang mas magandang dapat po nating pagtuunan ng pansi is iyon pong ginagawa ng korporasyon para po makamit natin 'yung reforms under the Universal Health Care," he added, citing the need to instill among Filipinos the

value of preventive than curative care through the Konsulta Program.

(But one of the primary aspects that we need to set our focus on is the initiatives of the corporation in achieving the reforms under the Universal Health Care.)

Aside from the increase in budget per patient rate, the Konsulta Program also offers wider outpatient benefits including the expansion of essential drugs that can be availed from 21 to 53 select medications for conditions such as asthma, diabetes, and hypertension, among others.

The free laboratory and diagnostic exams under the Konsulta package which can help in the promotion of early detection also saw an increase from 13 to 15 types of tests with the inclusion of mammogram and ultrasound for breast cancer.

Most importantly, the Konsulta benefit package offers free check-up with a primary care professional towards the goal of improving public health outcomes through the provision of preventive health services.

At present, there are 2,797 accredited Konsulta providers in the country composed of government health centers and private clinics. Of which, 447 are from the National Capital Region (NCR).

Meanwhile, more than 23 million Filipinos are already registered in the PhilHealth Konsulta Program and 13.88 percent of the said number are Metro Manila residents.

Over 13 million has already been allocated to fund the healthcare services of Konsulta Program beneficiaries through first patient encounters.

By 2025, PhilHealth is projecting to further expand the services of the Konsulta benefit package to include other health priorities in line with the Sustainable Development Goals (SDGs). These include, in particular, healthcare services for maternal health, animal bite, and HIV (human immunodeficiency virus). (JMP/PIA-NCR)

## UPLB grad to new Iskolars ng Bayan: find balance in studies, personal life

"To become an Iskolar ng Bayan should be taken seriously. Passing the UPCAT requires excellence, and when they are finally studying at UP, I hope they will not be complacent."

On August 19, the UPLB administration led by Chancellor Dr. Jose V. Camacho welcomed 2,586 new students yearning for a world-renowned education the university offers.

"To be an Iskolar ng Bayan is to be given an opportunity for a world-class education and to use that education to make a difference in the lives of the Filipino people. You will be honed to proficiency in technical knowledge and skills. Aside from academic learning, you will also grow in character."

To Mark Ruwen de Guzman, who topped the University of the Philippines College Admission Test (UPCAT) for the school year, becoming an Iskolar was his only hope but acing the test was a welcome bonus for him.

"What I had in mind [taking the UPCAT] was to pass my first choice of course degree, but anything more than that never entered my mind. Maybe there was a bit of expectation, but [I know] it was not guaranteed."

Although graduation is four years away, De Guzman admitted that he plans to focus on research, an area in which the UPLB is best known.

"I am planning to pursue a career in research in the future. I'm eager to connect with the professors at UPLB to gain a deeper understanding of their work and learn from their expertise."

After graduating from UP Rural High School, Meanwhile, Lara Cassandra Banasihan, who landed fifth in this year's UPCAT, is proud to have experienced the quality of education only UP can provide.

Having spent her formative years at the UPLB high school, Banasihan hopes that her time at the state university will further hone her skills and contribute to her growth as a better citizen.

"I know that now that I'm in college, more is expected of me. But now, I can do more for our motherland," Banasihan, who is among the first batch of Accountancy students at UPLB, said.

She added: "As part of the pioneering batch, I am looking forward to forming an organization for BS Accountancy students with my classmates. I hope to interact and form meaningful bonds with them. And of course, get a 100 percent passing rate in the Board Exam."

Chancellor Camacho then advised students to take all of the hardships as a learning experience to become an even better version of themselves that can contribute to the advancement of the nation. "You have to embrace the challenges, both academic and personal, that you will face. Find and nurture your passions, and build lasting connections with your peers. UPLB will push you, nourish you, and help you grow to become the best version of yourself that you can be." (PB/PIA-4A)

## President Marcos distributes 129 patient transport vehicles to LGUs

**QUEZON CITY, (PIA)** — President Ferdinand R. Marcos Jr. led the turnover of 129 patient transport vehicles (PTVs), to local government units (LGUs) on Tuesday under the Medical Transport Vehicle Donation Program of the Philippine Charity Sweepstakes Office (PCSO).

During the distribution event at the Quirino Grandstand in Manila, Marcos emphasized the program's aim to enhance healthcare access and provide swift medical intervention, particularly in vulnerable communities and geographically isolated areas.

"The Medical Transport Vehicle Donation Program builds on our thrust to improve healthcare access and provide swift medical intervention," he said.

The President noted that the program is designed to deliver Type II Advanced Life Support Ambulances and Sea Ambulances specifically to underserved regions, ensuring timely assistance for victims in emergency situations.

"We will be giving these PTVs to provincial, city, and municipal governments to help ensure that their constituencies will be given the chance to pull through whenever they need these assets for rescue and healthcare," he added.

Marcos described the ambulances as essential resources for first responders, whom he referred to as "heroes in the medical field." He highlighted the importance of these vehicles in providing timely medical intervention, stating that they can make a critical difference in life-and-death situations.

The President also reiterated the PCSO's commitment to procure more PTVs, aiming for every municipality in the Philippines to be equipped with two vehicles.

"It is a vision worth every ounce of effort," he said, urging stakeholders to work diligently to turn this aspiration into reality.

He called on LGUs to use the donated vehicles

responsibly and efficiently, stressing the importance of prioritizing the welfare of Filipinos to achieve effective and life-changing impacts.

In total, the distribution included ambulances for 87 LGUs in the CALABARZON region, 25 in the Bicol region, eight in Central Luzon, six in the Cordillera Administrative Region (CAR), and three in Cagayan Valley.

## Dengue cases rise 33% amid climate concerns

**MANILA, (PIA)** — The Department of Health (DOH) has reported a 33 percent increase in dengue cases in the Philippines, with 128,833 infections recorded from January 1 to July 27, 2024, compared to 97,211 cases during the same period last year.

In a concerning trend, dengue cases in Central Visayas have also surged, surpassing the 15,000 mark from January to mid-August. The Department of Health-Central Visayas (DOH-7) reported 15,394 cases and 35 deaths as of August 17, a significant increase from just 7,132 cases recorded from January to June.

Bohol province has been particularly hard hit, reporting the highest number of cases at 5,165 and declaring a dengue outbreak.

Cebu follows with 4,592 cases, while Negros Oriental has recorded 2,689 cases and Siquijor 637.

In Metro Cebu, Cebu City leads the region with 1,360 cases and three deaths, prompting the Cebu City Health Department to propose a state of public health emergency to combat the rising cases. Mandaue City has reported 437 cases and one death, while Lapu-Lapu City has recorded 504 cases.

Meanwhile, Dr. Bayo Segun, a representative from the World Health Organization (WHO), highlighted the role of climate change in the rising incidence of dengue during the first Dengue Summit held in Manila last June.

### QUEZON CITY, (PIA)

— The Philippine Health Insurance Corp. (FinMaREP), which aims to reconcile accounts with hospitals to ensure accurate records and compliance with regulations.

He noted that the reconciliation process is part of PhilHealth's responsibility as a steward of public funds.

PhilHealth's commitment to client satisfaction is reflected in a recent survey conducted by Novo Trends PH, which revealed a client satisfaction rating of 94.57 percent nationwide, with the NCR office achieving an impressive 98.29 percent.

"Understanding and meeting the needs of our clients is paramount to our mission," Acoba emphasized.

The agency remains dedicated to improving services and ensuring that every Filipino benefits from accessible and quality healthcare. PhilHealth encourages members to utilize its communication channels for assistance, including a hotline and a callback service introduced during the pandemic.

"PhilHealth's doors are always open. You may connect with us through our official communication channels for any assistance or inquiries. Our hotline is 8662-2588," he said.

"Our members can also request a callback through the following mobile numbers: 0998- 857-2957; 0968-865-4670; 0917-127-5987 and 0917-110-98," he added.

He said just by texting "PHICallback<space>Mobile Number" to be called<space>details of concern" members can avail this callback feature, an innovation the agency introduced during the pandemic.

"We will continue with this service which was widely recognized by our members," he added.

In addition, Acoba said PhilHealth can also be accessed via "Click to Call" in the PhilHealth website, www.philhealth.gov.ph.

"In your personal computer or smartphone that is connected to the internet, just click the icon located at the bottom-right portion of our website and you will be directed to a live agent. This service is available 24 hours a day, seven days a week," he added.

"As we move forward, let us continue working together to ensure that no Filipino is left behind," Acoba said. "Our aim is to provide expanded and new benefits for the Filipino people." (**JCO/PIA-NCR**)

## DPWH, UP sign MOA for building projects in NCR, other regions

QUEZON CITY, (PIA) — The Department of Public Works and Highways (DPWH) and the University of the Philippines (UP) recently solidified their collaboration through the signing of a Memoranda of Agreement (MOA) aimed at initiating various building facility projects in eight (8) UP locations nationwide.

DPWH Undersecretary for Operations in Charge of Convergence Projects Eric Ayapana and University of the Philippines President, Atty. Angelo A. Jimenez, led the MOA signing encompassing a diverse range of projects including site development, construction, rehabilitation, and enhancement of UP facilities in key areas such as the National Capital Region and Regions 4A, 6, 7, 8, and 11.

"This partnership marks a milestone in the government's commitment to enhancing access to healthcare services and elevating the educational infrastructure at our leading institution of higher learning," said Undersecretary Ayapana. According to the DPWH, the combined allocation for the 10 projects outlined in the agreement stands at P1.8986 billion.

The flagship project of the MOA involves the construction of the Pediatrics and Adult Specialty Center, including clinics, training center, and healthcare workers' dormitory at UP Philippine General Hospital in Ermita, Manila, with a substantial budget of P1 billion.

Additionally, the DPWH will be overseeing the completion of structural and architectural work at Rizal Hall amounting to P100 million, as well as a project valued at P13.5 million aimed at increasing the carrying capacity of the College of Medicine inside UP Manila Campus along Taft Avenue, Manila.

The department will also implement the construction

and site development of the UP System Technology Innovation Campus in Dasmariñas, Cavite, with an allocation of P300 million earmarked for this purpose.

Moving to Regions 6 and 7, projects in the MOA include the rehabilitation of the UP Visayas School Building in Iloilo at a cost of P10 million, the construction of a new College of Law Building at UP Visayas Iloilo costing P100 million, and the expansion and operation of UP Extension Campus in Pandan, Antique, allocated P30 million.

Further, P25 million has been dedicated to enhancing the carrying capacity of the UP Manila School of Health Sciences in Palo, Leyte, while a P40 million allocation is set aside for the construction of a multipurpose building serving as a dormitory for UP Cebu on Gorordo Avenue, Cebu City.

The MOA likewise encompasses the site development of various structures at UP Mindanao in Davao City, including the School of Management, College of Humanities and Social Sciences Phase 1, College of Science and Mathematics, Center for Advancement of Research in Mindanao, including student dormitories, faculty and staff housing, administrative facilities, and library, with a budget of P140 million.

Signatories of the MOA are heads of UP Campuses, and DPWH Region 4A Director Jovel G. Mendoza, Region 6 Sonny Boy O. Oropel, Region 8 Director Edgar B. Tabacon, Region 11 Director Juby B. Cordon, Engr. Liberato R. Mercado from NCR Planning and Design Division, and Region 7 Construction Division Chief Joan L. Pitogo. Also present at the event were Senator Mark A. Villar and heads and representatives from the implementing DPWH District Engineering Offices. (JEG/PIA-NCR)

## BTr fully awards reissued T-bonds

MANILA — The Bureau of the Treasury (BTr) fully awarded the reissued seven-year Treasury bonds (T-bonds) during Tuesday's auction. With a remaining term of four years and eight months, the reissued T-bonds fetched an average rate of 6.058 percent. The average rate was lower than the 6.107 percent when it

was last reissued. The auction was 2.3 times oversubscribed with total tenders reaching PHP69.1 billion. With its decision, the BTr raised the full program of PHP30 billion, bringing the total outstanding volume for the series to PHP219.7 billion. (PNA)

Roble Shipping brought to the city this week the M/V Claudine Star, a newly refurbished 74-meter-long vessel operated by Star Philippine Inc., its sister company.

For over a decade, Cebu-bound people must travel more than two hours by land to Ormoc City port or

ports in the southern part of Leyte Island to catch a boat ride to Cebu City.

The vessel sails from Cebu to Tacloban three times weekly every Friday, Sunday, and Tuesday. The ship leaves Cebu at 8 p.m. and arrives in Tacloban at 7 a.m.

From Tacloban, the ship leaves at 2:45 p.m. every Saturday, Monday, and Wednesday and arrives in Cebu at 2 a.m. the next day.

Tacloban port used to be one of the country's busiest, with regular passenger sea vessel trips to Metro Manila and Cebu. Since 2008, Tacloban has had no liners left when Sulpicio Lines was suspended from passenger operations that year after the MV Princess of the Stars sank during the onslaught of Typhoon Frank. It had been used only by cargo ships.

The MV Tacloban Princess was sold to a local breaker, according to research published online by the Philippine Ship Spotter's Society. (PNA)

## Batangas teams up with DA, PCA to boost coconut, infra initiatives

**BATANGAS CITY** — The provincial government here has partnered with the Department of Agriculture (DA) and the Philippine Coconut Authority (PCA) in launching coordinated programs to promote the local industry. In an interview on Tuesday, Dr. Rod Bautista, Office of the Provincial Agriculturist (OPAg) head, said the partnership with concerned national government agencies (NGAs) will streamline efforts in strengthening sustainable and innovative farming systems.

The OPAg and PCA started planting more than 4,000 coconut trees last month under the Coconut Industry Revitalization Project.

"This is part of our campaign for the massive planting of coconut in the province. Likewise, the PCA also has a target to plant 100 million coconuts, so we also want to be part of their project," Bautista said.

President Ferdinand Marcos Jr. directed the PCA last year to plant 100 million coconut trees from 2023 to 2028 under the Coconut Planting and Replanting Project.

As part of their partnership, the provincial government donated a 10-hectare property in San Juan town, which is expected to provide additional

livelihood for residents.

Bautista said the lot where hybrid and dwarf coconuts are being planted may be expanded up to 30 hectares. The OPAg also took part in another tree planting ceremony at the Coconut Research and Demo Farm Launch in Tanauan City last week.

Governor Hermilando Mandanas said the tree planting activities are an integral part of providing a stable future for Batangueños. "With the help of the PCA and the local government, we believe we will achieve a more prosperous and vibrant coconut industry in our province," he said.

Mandanas said there are more valuable partnerships he discussed with DA Secretary Francisco Tiu Laurel last month to strengthen infrastructure projects to benefit the agriculture sector.

Bautista said the DA is looking to launch an agri-marine industrial port in the province next year which is regarded as a "complete agricultural port." Said project will also be coordinated with the provincial government's Deep-Sea Fish Ports and Regional Food Terminal project.

These projects aim to improve the storage and distribution of basic products such as sugar, molasses, grains, rice and fertilizer.

Meanwhile, OPAg is already finalizing the PHP10,000 financial assistance to be distributed this month to more than 2,000 farmers, as well as the fertilizer and pesticide distribution.

"These are our recovery efforts of farmers during the El Niño season for their replanting activities. We are encouraging our local farmers to reach out to our office so we can provide them with proper technology, pest management, and other important services to aid them as the rainy season begins," Bautista said. (PNA)

## SC affirms Bangsamoro Organic Law; rules Sulu not part of BARMM

**MANILA** — The Supreme Court (SC) on Monday upheld the validity of Republic Act No. 11054 or the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), but declared Sulu not part of BARMM after the province rejected the law's ratification.

In a unanimous decision, the Supreme Court granted the petition challenging Sulu's inclusion in BARMM but denied challenges to other aspects of the Bangsamoro Organic Law, according to a news release.

"The decision is immediately executory," the Court said. The Court declared unconstitutional the interpretation of the provision in the law directing the provinces and cities of ARMM (Autonomous Region in Muslim Mindanao) to vote as one geographical unit as including provinces that did not vote to be included.

"This violates Article X, Section 18 of the Constitution, which states that only provinces, cities, and geographic areas voting favorably in the plebiscite shall be included in the autonomous region," the Court explained.

"As Sulu rejected the Bangsamoro Organic Law in the plebiscite, it was wrong to include the province in BARMM," the SC said.

The Bangsamoro Organic Law, enacted on July 27, 2018, provided for the establishment of BARMM as a political entity and its corresponding basic governmental structure.

The BARMM's creation and determination of its territorial jurisdiction shall take effect upon the law's ratification by majority of the votes cast in a

plebiscite.

A plebiscite was conducted on Jan. 21, 2019, covering areas of then ARMM and Isabela City in Basilan and Cotabato City.

Another plebiscite was held on Feb. 6, 2019, in Lanao del Norte, municipalities in North Cotabato, and other areas that petitioned for voluntary inclusion.

The majority of the ARMM ratified the law, except for Sulu.

Despite this, Sulu was included in BARMM, prompting the province to file the present petition assailing the law.

Meanwhile, the SC ruled that the Bangsamoro Organic Law is constitutional because it does not make BARMM a separate state from the Philippines.

"The said law did not give it the power to enter into relations with other states, nor did it grant the BARMM its sovereignty," it said.

"The BARMM's autonomy is limited to its internal governance. The fact that it was granted greater autonomy than other territorial and political subdivisions does not imply separation from the national government."

The Court also upheld the parliamentary form of the Bangsamoro government.

"An autonomous region is not prohibited from prescribing a form of government that differs from the national government so long as it upholds democratic principles," it said.

"The Bangsamoro government is democratic, with the members of the Parliament elected by its people as representatives. In turn, the Bangsamoro Parliament elects a chief minister who shall exercise the executive powers of the Bangsamoro government."

## Truth is number one defense vs. propaganda: PCO chief

**MANILA** — Presidential Communications Office (PCO) Secretary Cesar Chavez on Monday said truth remains the most important defense to counter propaganda and political blogging. During the agency's budget hearing at the House of Representatives, Chavez underscored the importance of truthful, factual, relevant accurate, and timely information prevailing in a "free market of ideas".

This was his response when asked by Caloocan City Rep. Mary Mitzi Cajayon-Uy about how to distinguish the blurry line between bloggers and journalists.

"How do we counter political blogging? Truth is still the number one defense, truth is still the number one offense," Chavez said.

While Chavez acknowledged the challenge of political blogging driven by specific agendas, he said such efforts would eventually be isolated.

"We cannot avoid, we cannot control bloggers with a specific political agenda. That is a matter of fact. On their own, they will realize they will

be isolated," he said. Chavez said traditional media remains the "number one producer" of social media content in the country, adding that major media outlets continue like GMA, ABS-CBN, the Philippine Daily Inquirer, and Manila Bulletin continue to lead in generating digital content.

"Sila parin ang pinakamalaking bumubuo ng social media content. Mas maraming na-poproduce ang traditional media na mga digital content (They still create the bulk of social media content. More digital material is still produced by traditional media). Overwhelming majority of content being consumed by our people are not political blogging," he said.

### Fighting fake news

Chavez said the PCO will be holding a national information summit on Sept. 27-30 at the Development Academy of the Philippines to discuss three strategic issues: the role of artificial intelligence in media, governance, and local communities; combatting fake news; and the upcoming 2025 national elections.

Chavez also revealed his plan to issue a memorandum circular to designate a "fact-checking officer" in all PCO-affiliated agencies.

"Immediately after I took my oath as Acting Secretary of PCO, I met the Malacañang Press Corps and informed them [about] our initiative. In the next few days, I'll be issuing a memorandum circular address to all state media that means PTV-4, Philippine Information Agency, Radyo Pilipinas-Bureau of Broadcast Services, the Philippine News Agency, the IBC-13, and the PCO Proper that all of them will designate fact-check officer," he said.

"A fact check officer or anti-fake news officer will help us that we cannot be an instrument or a purveyor of fake news."

The PCO chief underscored the need for all state media to be vigilant and take the lead in combating fake news.

"Therefore, institutionally there is going to be fact-check officer in every Radyo Pilipinas, in every Philippine News Agency, in every Philippine Information Agency and state media and


