#### **WE SERVE BECAUSE IT IS** IN OUR DNA: MARCOS JR. **HONORS OUTSTANDING GOV'T WORKERS**

President Ferdinand R. Marcos Jr. said public service is fundamentally woven into the DNA of government workers, when he honored exceptional civil servants Wednesday at the 2024 Outstanding Workers Government awards ceremony, marking the 124th anniversary of the Philippine Civil Service. "We serve because we make a difference. We serve because it is in our DNA. We serve because we love the Philippines," Marcos said during the event held at Malacañan Palace, where he also emphasized the nuanced nature of government service, describing it as exciting, "challenging, and rewarding" despite common perceptions of bureaucratic tedium.

annual awards, The established in 1959 and reinforced by Marcos' father in 1975, recognize public servants who have made significant contributions to government efficiency and service delivery.

Marcos highlighted several awardees' achievements:

Α municipal department head from lloilo who transformed an abandoned fishpond into an eco-park, engaging over 1,000 volunteers to plant 150,000 mangroves.

Pioneers the Health Beyond Bars Program. providing healthcare and well-being activities for incarcerated individuals.

president praised the quality of work demonstrated bv the awardees, saying it "belies the general image of the civil servant as being a bit of a drudge and being not terribly imaginative.

Marcos also acknowledged unrecognized servants, calling them an "army of people who are working quietly" to serve the country.

The ceremony featured three award categories: the Presidential Lingkod Bayan, the Civil Service Pagasa, Commission and the Dangal ng Bayan

awards. Aside from the presidential plaque and medallion, gold-gilded an incentive of P200,000 was awarded to individual awardees, and P100,000 per member for group awardees.

Marcos concluded by government urging to workers remain transparent, accountable, and committed to serving with integrity, loyalty, and efficiency.

The event underscored the administration's vision of a "Bagong Pilipinas" (New Philippines), aiming for a "prosperous, progressive, and equitable society. (JCO/PIA-NCR)

#### **Tax court grants** NHFMC refund

MANILA - The Court of by the NHMFC. Tax Appeals (CTA) has granted the petition filed by a Special Purpose Trust (SPT) run by the National Home Mortgage Finance Corporation (NHMFC) seeking refund of PHP1.6 million representing erroneously paid final withholding taxes (FWT) on interest income payments to bondholders for the period 2019 to 2020. In a 14-page decision dated Sept. 17, the tax Division court's Third ordered the Bureau of Internal Revenue refund or issue a tax credit certificate sought in the petition filed by the Bahay Bonds 2 Special Purpose Trust (SPT) administered

The court noted that under statutes covering the nature and purpose of NHFMC, such bonds are low-cost or housing-related asset-backed securities (ABS) and that "the interest income arising therefrom is tax-exempt as expressly set out (in tax laws on the matter).

"The Supreme already upheld this tax exemption in a previous case also involving a refund claim by herein petitioner," the CTA said.

The tax court also said the petitioner SPT is required to return the same tax credit to the bondholders.

"While petitioner's right and entitlement to the refund sought has been established, the payment/ release of the refund granted in this case gives rise to petitioner's concomitant obligation to return the amount to its bondholders from whom the taxes were withheld," the court said.

#### **Comelec ready for influx** of registrants as deadline nears

MANILA-The Commission on Elections (Comelec) said Wednesday it is ready for a massive turnout of voter applicants a few days before the end of the registration period for the 2025 midterm polls.

"Inaasahan namin na sa dalawang linggo na nalalabi para sa registration ay mas dadami pa ang magaapply para sa voter registration at mga deactivated (We expect that within the last two weeks left for voter registration, there would be more applicants for the voter registration, as well as deactivated voters)" Comelec spokesperson John Rex Laudiangco said in a Bagong Pilipinas Ngayon public briefing.

"Otherwise, he would be unjustly enriching himself at the expense of the principal taxpayer from whom the taxes were withheld, and from whom he derives his legal right to file a claim for refund." (PNA)

Laudiangco, meanwhile, renewed his appeal for applicants not to wait until the last minute to sign up on registration sites.

"Let's not wait for the last day of the registration on Sept. 30. There would be no extension of the deadline," he added.

Laudiangco encouraged the people to download the application form, from their website: https://comelec.gov. ph/?r=VoterRegistration/ ApplicationsForms before they go to the registration centers.

The latest data from the Comelec showed that there are now 6,250,050 applications processed from Feb. 12 to Sept. 16. Of the number, a total of

1,041,179 applicants are from Calabarzon: followed by the National Capital Region with 824,239; and Central Luzon with 705,530.

Cordillera Administrative Region still has the lowest number of applicants with 88,053. (PNA)

#### Calabarzon, C. Visayas boards **OK minimum wage hike**

MANILA - The Regional Wages and Tripartite Productivity Boards (RTWPBs) of Region 4-A (Calabarzon) and Region 7 (Central Visayas) have issued wage orders granting increases in the daily minimum wage rates of workers in private establishments, directly benefiting 1.2 million minimum wage earners.

In a statement Monday, the Department of Labor and Employment (DOLE) said the daily wage adjustment Calabarzon and Central Visayas ranges from PHP21 to PHP75 and PHP33 to PHP43, respectively.

This brings the minimum wage rates in Calabarzon to PHP450 to PHP560 in the non-agriculture sector; PHP425 to PHP500 in agriculture sector; and PHP425 in retail and service establishments employing not more than 10 workers upon full implementation of all tranches.

hike The wage Calabarzon will take effect on Sept. 30 or six days from the anniversary date of the previous regional wage increase on Sept. 24 last year. It will be given in two tranches -- the first tranche on Sept. 30 and the second tranche on April 1, 2025.

Meanwhile, the wage hike in Central Visayas would take effect on Oct. 2. the day immediately following the anniversary date of the previous regional wage order on Oct. 1 last year. The region kept its areabased classifications of Classes A, B, and C, but each class now has a single wage rate for both agriculture and non-

agriculture sectors. The increase brings the minimum from PHP458 to PHP468 to PHP501 for Class A; from PHP425 to P430 to P463 for Class B; and PHP415-P420 to PHP453 for Class C.

Classified under Class A are the cities of Carcar, Cebu, Danao, Lapulapu, Mandaue, Naga, Talisay and the municipalities of Compostela, Consolacion, Cordova, Liloan, Minglanilla, San Fernando or Expanded Metro Cebu. Meanwhile, under Class B are the cities not covered under Class A -- Bais, Bayawan, Bogo, Canlaon, Dumaguete, Guihulngan, Tagbilaran City, Tanjay and Toledo while Class C include other towns not covered under Class A and

#### Japan embassy opens application for JET program teachers.

MANILA - The Japanese Embassy is now accepting applications for the highly competitive 2025 Japan Exchange and Teaching (JET) program, allows eligible Filipinos to work as assistant language teachers (ALTs) in Japan. Filipinos accepted in the program will work in public or private schools or local boards of education as assistants in classes led Japanese English

local governments across Japan and assists in the international exchange matters by translating documents; project planning designing, and implementation; oral and written communications non-Japanese residents and communities; and other related tasks.

Applicants must be Filipino citizens, possess excellent English communication physically skills. mentally fit to work abroad, and hold a Bachelor's degree or higher, or be able to obtain such qualifications bv designated arrival date.

In addition to the above, applicants for the CIR position must possess

language Japanese proficiency (JLPT N1 or its equivalent).

The application forms, and other requirements are available at the embassy website: https://www. ph.emb-japan.go.jp/itpr\_ en/00\_000193\_00001.

Submission is due on Nov. 6 for ALT applicants and on Dec. 6 for CIR applicants. The JET program was

introduced in 1987 to help deepen mutual understanding between the people of Japan and those of other countries through foreign language exchange and cultural immersion at the local level.

In 2024, more than 120 JET participants qualified from the Philippines, the largest batch in a single year, bringing the total number of participants from the Philippines to over 300. (PNA)

#### **60-Year-Old Man's Adoption** Finalized Under RA 11222

QUEZON CITY - In a unique case, the National Authority for Child Care (NACC) finalized adoption of Ranello A. Anis, a 60-year-old man, under Republic Act (RA) No. 11222, also known as the Simulated Birth Rectification Act (SIBRA). adoption order The was issued on August 13, 2024, and officially finalized on September 2024. The certificate finality was awarded by NACC Undersecretary Janella Ejercito Estrada

and Assistant Secretary Rowena M. Macalintal the Advanced during Capability Training on Adoption and Alternative Child Care, and Related Laws held on September 11 at the Sequoia Hotel. Ranello Anis had been raised by his mother, Pacita A. Anis, his entire life, but it wasn't until October 24, 2023, that they formally filed the petition to correct his birth records.

This was after a case was filed against him by a relative, and revealed that his birth certificate had been falsified or simulated. RA 11222 helps correct such cases, where birth records are tampered with to show that a child was born to parents who aren't the biological ones.

This law allows families to fix these documents, protecting the legal rights of the adoptee. "Mahalaga mapanatili maprotektahan ang legal na estado ng isang ampon. Kapag ang mga birth records ay peke, nalalagay sa panganib ang legal pagkakakilanlan at kinabukasan ng ampon.

Sa pamamagitan ng RA 11222, naitatama ang mga birth records upang mabigyan ng tamang pagkakakilanlan ang mga ampon tulad ng kaso ni Mr. Anis," said Estrada. RA 11222 also offers amnesty to adoptive parents who tampered records, giving them until 2029 to correct the documents without facing legal consequences. This allows families to secure the future of their children without fear of prosecution. "Hinihikayat namin ang mga nagpeke birth records ng kanilang mga anak na

lumantad at gamitin ang amnestiya habang ito ay available hanggang 2029. Ito ay isang pagkakataon bihirang upang maitama ang mga pagkakamali at masiguro ang kinabukasan ng inyong anak sa legal na aspeto,' Estrada added.

Parents who falsified birth records before March 2019 and have treated the child as their own for at least three years can apply for rectification. However, those who have falsified records after March 28, 2019, may face criminal charges, including imprisonment and fines.

#### **Toledo Residents Protest TVI Coal Plant Expansion**

Toledo City, Cebu -More than 70 residents in Barangays Bato, Awihao, Daanlungsodand including seniors and firsttime protesters, braved the rain and police surveillance to voice their opposition to the expansion of Aboitiz Power's subsidiary Visayas, Therma Inc. The residents submitted a petition to TVI, urging the company to comply with the law by conducting Health Impact Assessments (HIA) for the project.

Toledo City is already home to eight coal power plants. the community cannot bear another power plant without knowing the long-term impacts on our

health and environment," said Estela Patalinghug, Visayas Coordinator of the Philippine Movement for Climate Justice (PMCJ). "We demand that Aboitiz Power start putting people's health over profit," she stressed.

has not submitted the required HIA for its planned third coal power plant. The HIA is mandatory under Section 33 of Republic Act 11223 also known as the Universal Health Care Act. Under Section 33 of the Universal Health Care Act, a HIA is required for projects posing significant health risks. Joint Administrative Order (JAO) 2021-0001 by the DOH and the Department of the Interior and Local Government (DILG) further specifies that projects classified as "environmentally critical" the Environmental Management Bureau (EMB), such as coal power plants, are also considered health-sensitive" and must undergo an HIA.

However, the petition submitted to TVI was mishandled by security guards with the receiving guard merely writing "received" without the date, time, or recipient's name. No proper coordination details were provided, leaving the residents with no official channel for a response.

"This incident reflects how the power firm handles feedback from its host communities," said Estela Patalinghug, the Visayas Coordinator of PMCJ. "TVI is owned by Aboitiz Power, one of the largest power generators in the country with coal accounting for more than 68 percent of

its energy mix compared percent renewables. Patalinghug stated that while Aboitiz Power readily assures business groups their power needs, it remains silent on the communities' demands to comply with the law and conduct health impact assessments for its existing power plants and expansion project.

PMCJ's Lito Vasquez, Senior Executive Officer on Health Impacts added: "Health considerations are not part of Aboitiz's power equation. The company plans to construct a new power plant in Toledo, Cebu within the next three to four years without ensuring compliance with the HIA mandate under the law. Vasquez emphasized that health impact assessments must be conducted to evaluate the cumulative health and environmental impacts typically associated with carbon and toxic gas emissions, heavy pollutants and other water pollutants generated by coal-fired power plants." The Toledo residents are determined to continue their fight. "We won't stop until we put an end to coal, said Vasquez. "Our health and environment are at stake."

The protests will continue until TVI and Aboitiz Power comply with the law and prioritize the well-being of the community.

### PMCJ confutes Meralco PowerGen: Atimonan proposed coal project is riddled with violations

(USC) technology.

Quezon City, Philippines - The Philippine Movement for Climate Justice (PMCJ) Meralco lambasted PowerGen Corp. (MGen) for attempting to revive its controversial coal-fired power plant in Atimonan, Quezon, despite violations done during the permitting and construction process. MGen President Emmanuel Rubio recently claimed that the 1,200-megawatt (MW) Atimonan coal project was not covered by the moratorium, and has secured an environmental certificate compliance according (ECC). to reports. The Department of Energy (DOE), however, implemented a coal ban late in 2020, barring the processing of new applications for greenfield coal facilities. Atimonan One Energy (A1E) is considered a greenfield coal plant.

MGen is planning to facility, construct this through its subsidiary Atimonan One Energy Inc. (AOE), in Atimonan, Quezon in 2021. In 2023, AOE dropped the said plan and instead planned to construct a 2,400 MW combined cycle gas turbine power project and liquified natural gas (LNG) terminal with a floating storage unit for 175 billion pesos. However, the latest reports stated that MGen plans to resume its involvement in coal energy which will ultra-supercritical

Resistance Local Global Implications Climate justice groups, leaders, church and residents from Atimonan have long been battling against coal and LNG projects for years.. "We stopped their previous plan to build a coal plant [...] even the plan to build LNG. Now that the coal plant is being revived, we will not allow it because it will destroy Atimonan, our future," said Maria Opalda of Kabataan para sa Kalikasan ng Atimonan (KAPAKANAN). Negotiated Procurement -Community Participation Sangcupan, Ibrahim EPAPH regional program coordinator, described negotiated procurementparticipation community (NPCP) as a simplified and streamlined procurement method that allows government agencies to directly engage with community groups, such as local farmers and fisherfolk, for the procurement of goods and services.

Sangcupan said NPCP is in accordance with Section 11 of Republic Act 11321, or the Sagip Saka Act of 2019, which mandates national and local government agencies to "directly purchase agricultural and fishery products from accredited farmers and fisher folk cooperatives and enterprises" to promote farmer and fisher folk enterprise development.

"This is also supported by GPPB Resolution No. 18 series of 2021 that provides the guidelines for the conduct of negotiated procurement-community participation. exclusively community-based organizations," he said.

Sangcupan said, "As a form of benefit, many provided farmers are ready and direct markets for their products by supplying the needs government offices. thereby bypassing traders and middlemen who often offer disadvantageous prices."

"Since the farmers are in direct negotiation with government biddina units, they get to sell their produce at prices being offered by the government, which is much higher than when they sell to traders," he added.

Requirements

Participate in NPCP Sangcupan stated further that for a community-based organization to qualify, it must be registered with an appropriate regulatory body, such as but not limited to the Securities and Commission Exchange (SEC), the Department of Labor and Employment (DOLE), the Cooperative Development Authority (CDA), the Department of Trade and Industry (DTI), and the National Commission on Indigenous Peoples (NCIP).

"They should also be registered with the Bureau of Internal Revenue (BIR), must secure a mayor's permit, and be able to issue receipts for their business transactions," he said.

The CBOs can participate in the NPCP bidding process without registering for PhilGEPS.

"In Region 12, however, we train our CBOs on PhilGEPS to capacitate them so that when EPAHP is culminated, they are able to stand on their own and transact with government offices by other means," Sangcupan said, adding, "We also train them to negotiate as suppliers of goods for private sector entities such as malls and supermarkets."

As stated in the guidelines for conducting community participation in negotiated procurement, a communitybased organization may secure contracts the provision of goods amounting to P5 million.

However, a procuring entity may increase the amount of contract subject to the approval of the head of procuring entity (HoPE), who, in turn, should submit to GPPB a report on the amount of the approved budget contract and the reason for such.

# **SC affirms cancellation** of An Waray registration as party-list group

MANILA – Voting 14-1, the Supreme Court (SC) En Banc has affirmed rulings of the Commission on Elections (Comelec) cancelling the registration of An Waray party-list group.

An Waray was one of the 14 party-list groups proclaimed as initial winners in the 2013 elections that were guaranteed with one seat each.

In a ruling promulgated August 6, the High Court said under the Constitution and the Party-List System Act, it is the Comelec that has exclusive jurisdiction to rule on the cancellation of party-list registrations.

Following initial an Comelec ruling, the National Board of Canvassers (NBOC) had issued a resolution cancelling the registration of some party-list groups, which resulted in the adjustment of the seat allocations, so that An Waray's number increased to two.

The resolution, however, came with the caveat that the new allocation was without prejudice to the possible proclamation of other parties later.

The NBOC issued a Certificate of Proclamation to An Waray, entitling its first nominee, Neil Benedict Montejo (Montejo), to sit in the House of Representatives of the 16th Congress. Montejo took his oath of office on June 26, 2013.

Waray's second nominee, Victoria Isabel Noel (Noel), also took an oath of office on July 13, 2013, based on the tally of votes indicated in NBOC Resolution No. 0008-2013. On Aug. 20, 2014, the Comelec issued NBOC Resolution No. 13-030(PL)/0004-14 where declared the final distribution of seats for party-list groups, following the reversal by the SC of the Comelec's cancellation of the registration of Abang Lingkod party-list.

In Abang Lingkod's case, the Comelec was ordered by the Court to proclaim it as a legitimate partylist, resulting yet again in an adjustment in the allocation of seats.

In the final distribution, An Waray was declared to be entitled to only one seat. In 2019, Danilo Pornias

In 2019, Danilo Pornias and Jude Acidre filed a petition for cancellation of An Waray's registration for alleged violation of the Party-List System Act.

They claimed that Noel, with An Waray's knowledge and consent, took her oath and assumed office as second nominee of An Waray in the 16th Congress, even when An Waray was entitled to only one seat.

The Comelec's Second Division granted the petition.

This was affirmed by the Comelec En Banc, prompting the parties to bring the case to the SC claiming that it is the House of Representatives Electoral Tribunal (HRET), not the Comelec, which has jurisdiction over the petition to cancel.

"The jurisdiction of the HRET is limited only to contests relating to the election, returns, and qualifications of incumbent HOR members," the Court said.

To determine whether HRET must assume jurisdiction over a case, the Court laid down a twotiered test: first, whether the nature of the case is one of a contest relating to the election, returns and qualifications respondent; and second, whether the respondent is a "Member" of the House of Representatives.

Applying the test, the Court ruled that the nature of the petition to cancel An Waray's partylist registration is not one which falls under the cases cognizable by the HRET.

The Court also found that the Comelec did not gravely abuse its discretion when it cancelled An Waray's registration.

"The registration was cancelled based on Section 6(5) of the Party-List System Act, which states that violation of election laws, rules, or regulations is a ground for the cancellation of a party-list's registration," it said. (PNA)

ULIRCO's chairman, Wilfredo Perez, expressed his profound gratitude to DOST for their unwavering technical support. emphasized that the training was not just a refresher but a crucial step towards securing their FDA LTO, a prerequisite for market expansion.
