2 fixers nabbed in LTO Cavite

MANILA - Two fixers have been arrested in an entrapment operation at the Land Transportation Office (LTO) District Office in Dasmariñas City.

In a statement on Tuesday, LTO chief, Assistant Secretary Vigor Mendoza Il ordered the Dasmariñas office district head to explain the incident Monday.

"These people will suffer the consequences of their illegal money-making activities. We will help the police in pursuing the appropriate criminal charges against them to teach them a lesson," Mendoza said.

The two arrested were Juan Miguel Crisostomo, 21, from Imus, Cavite, and Carlito Cambronero Jr., 40, from Tagkawayan, Quezon.

Based on the report, Criminal Investigation and **Detection Group operatives** carried out an entrapment following a complaint from a 19-year-old motorist that a suspect offered PHP8,500 in exchange

for non-appearance in his application for a driver's license.

The LTO requires applicants to be personally present during their application and that offers of non-appearance will only cost them more money and possibly scammed.

RDRRMC Calabarzon warns against spread of unverified info on Taal

BATANGAS CITY (PIA) confusion among the public. The Regional Disaster Risk Local Reduction and Management Council Island Calabarzon reminds the public and media practitioners, to exercise caution when sharing information about Taal volcano's geological activity, as it can lead to panic and

government surrounding the Taal Volcano have expressed concern over fake social media posts about eruptions reportedly circulating online, which have caused unrest among the public.

Local authorities have also identified several media outlets that have begun sharing advisories warning the public about an alleged imminent eruption of the Taal volcano.

On Tuesday, October 8, the Philippine Institute of Volcanology and Seismology (PHIVOLCS) degassing activities, locally known as 'pusngat'.

Jerome de Lima of the PHIVOLCS's Taal Observatory explained that these activities are normal occurrences and are not related to any sign of eruption.

'This does not signify any eruption. These are very weak degassing from the volcano." de Lima clarified.

On Wednesday, October 9, surrounding towns reported no formation of volcanic fog in their areas.

The CALABARZON RDRRMC also highlighted the Philippine Information Agency (PIA)'s Maging Mapanuri campaign, which offers clear, accessible explanations to encourage the public to exercise caution when sharing information about the Taal volcano.

Authorities have also warned against sharing unverified information that can lead to confusion and fear among the public. (PB/PIA4 CALABARZON RDRRMC) (PB/PIA4A)

DepEd, BJMP collaborate to enhance education for PDLs

Quezon City The Department of Education (DepEd) has announced a new partnership with the Bureau of Jail Management Penology (BJMP) expand educational opportunities for persons deprived of liberty (PDLs). Every Filipino, regardless of their circumstances, deserves a chance to learn and grow." Angara further highlighted the program's impact on restoring "hope and dignity" for individuals in detention. BJMP Chief Ruel Rivera expressed gratitude for the collaboration, emphasizing its significance in promoting a fair and humane society. He stated, "This initiative showcases the joint effort of the BJMP and the Department of Education, united under a common goal to create a just and humane society through the value of education."

The "Tagapangalaga Ko, Guro Ko" program has seen significant participation, with 5,596 PDLs enrolled in elementary education, 9,286 in junior high school, and 5,983 in senior high school for the 2023-2024 school year.

Over the past three years, the DepEd has recorded average of 20,000 enrollments in ALS among PDLs, demonstrating growing commitment а their education and rehabilitation. (AVS/PIA-

Tax, customs collections up Jan-Sept 2024

MANILA - Collections of the Bureau of Internal Revenue (BIR) recorded a double-digit growth while the Bureau of Customs (BOC) posted a 4-percent rise during the first three quarters of the year.

In a Facebook post on Friday, the Department of Finance (DOF) said preliminary data from January to September 2024 showed that the BIR has already collected PHP2.08 trillion, a 12.13 percent increase from the same period last year.

BOC collection, The meanwhile, amounted to PHP690.84 billion, 4.61 percent higher than last

The DOF said Finance Secretary Ralph Recto convened the fourth BIR and BOC Command Conference on Oct. 9 to assess the agencies' collection performance and discuss plans and strategies for 2025.

BIR Commissioner Romeo Lumagui, Jr., BOC Commissioner Bienvenido Rubio and their respective senior officials attended the meeting.

The total revenue collection target for this year is PHP4.3 trillion.

Dengue cases from Jan. 1 to Oct. 4 82% higher

MANILA - Dengue cases recorded from Jan. 1 to Oct. 4 is 82 percent higher than the same period last year, the Department of Health (DOH) said Friday. 269,467 are confirmed infections as 147,678 compared to cases last year.

Among the recorded cases, only 2,856 or 1.06 percent had severe dengue, the DOH said.

"A total of 702 deaths have been reported, with a case fatality rate of 0.26 percent, lower than the CFR of 0.37 percent reported during the same period last year," it said.

A decrease in cases have been recorded in the recent four weeks in all regions except for Metro Manila. "A 20 percent drop in cases from Sept. 1 to 14, 2024, with 25,986 cases reported compared to the 32,649 reported from August 18 to 31, 2024," the DOH said. It noted that changes in figures may still occur due to late reporting from certain areas.

The public is urged to observe the 4S strategy: search and destroy mosquito breeding grounds; self-protection measures; seek early consultation when experiencing symptoms; and support fogging or spraying in local hotspot areas where dengue cases are on the rise. (PNA)

The modus is for potential investors to download a cryptocurrency app which when installed will require them to cash in their investments in digital wallets listed in the application.

In the dashboard of the apps, account holders will be able to see the amount of money they have invested and the high interest their money has earned over time.

As investors begin to see the growing interest their money has generated in a short period of time, they are enticed to invest more. When investors start to withdraw their money, the apps will not allow them to withdraw. This is when investors would realize they have been victims of a cryptocurrency investment scam. (PNA)

New law advances local defense industry

MANILA, (PIA) - President and Ferdinand R. Marcos Jr. signed Republic Act 12024, known as the Self-Reliant Defense Posture (SRDP) Revitalization Act, during a ceremony at Malacañan Palace on October 8, 2024. This new law aims to boost the country's domestic production and manufacturing of defense assets and hardware.

revitalization The the SRDP Program is designed to develop an independent and dynamic defense system that utilizes the Philippines' own capabilities and resources to meet the weapon and material requirements of the Armed Forces of the Philippines (AFP) and other law enforcement agencies. of National Secretary Defense Gilberto Teodoro Jr., along with key government officials, attended the signing of this law, which is a priority initiative of the Marcos Administration.

Program SRDP The research emphasizes

development, prioritizing innovations and technological advancements within the defense sector, including dual-use technologies.

The law aims to enhance the AFP's capabilities across both traditional and non-traditional domains, ultimately facilitating the establishment of a credible defense posture and selfreliance.

Ву fostering development of a national industry, defense the law seeks to leverage local enterprises through collaborative partnerships with Original Equipment Manufacturers (OEMs) from allied countries willing to support technology transfer.

This initiative marks significant step towards strengthening the country's defense infrastructure and ensuring that the Philippines can independently support its security needs. (JCO/PIA-NCR)

NBI IV-A tops daily clearance issuance

LIPA City, Batangas (PIA) The National Bureau Investigation Regional Office IV-A said its office holds the biggest number of NBI clearance processed nationwide.

Based on records, the NBI IV-A logged 10,000 clearances а day, biggest considered the across all NBI regional offices.

all the regions, CALABARZON has the most number of clearance centers. We have 19 clearance offices, 5 district offices and the regional office with a total of 25 clearance centers," NBI IV-A Regional Director Olivo Ramos said.

To meet high demand, the bureau expanded its satellite offices across the region, making it easier for people from far-flung areas to access clearance services. The move was well-received, particularly in areas with limited access

to government offices.

For 2024, the General Trias in Cavite Satellite office has already released 44,146 clearances, making it the highest in the region. This was followed by the NBI IV-A regional office with 35,058 clearances, and the Calamba Satellite office, which processed 34,014 clearances.

The NBI IV-A plans to increase the number of satellite offices and introduce more digital services to streamline clearance applications pursuant to the Bagong governance Pilipinas of President approach Ferdinand Marcos Jr.

The regional bureau chief said clearance processing can also be done online. "We are working to enhance clearance processing. In the future, NBI clearance renewals may no longer involve visiting the office." he said. (AM/PIA 4A)

Add'I 60K to 80K jobs in PEZA zones eyed this year

MANILA - The Philippine Economic Zone Authority (PEZA) targets to add 60,000 to 80,000 jobs this year within its ecozones across the country.

In an interview with Bagong Pilipinas Ngayon Thursday, PEZA Director General Tereso Panga said the investment promotion agency (IPA) currently has additional 35,871 jobs in ecozones nationwide from January to September this year.

Recent addition to job generation are the 4,000 fresh positions to be opened from 16 newly approved projects on Sept. 23.

"So, our ecozone development is pretty much scattered to rural areas and new growth areas although most of it is still in Calabarzon —we have 11 projects there. But we can see that we have two in Cebu, there are also in NCR (National Capital Region) and we have [in] Pampanga in Central Luzon," Panga said. Panga remains optimistic that the IPA will hit its PHP200-billion investment approvals for the full year of 2024.

As of last month, PEZA approved a total of PHP115.89 billion worth of projects.

These projects will boost Philippine exports by another USD2.51 billion.

"Towards end of the quarter, historically, we can expect a surge in investments. We're still bullish that we'll be able to achieve our PHP200-billion target for the year," Panga said. (PNA)

Comelec open to hosting election debates anew ahead of 2025 midterm polls

QUEZON CITY, (PIA) — The Commission on Elections (Comelec) has expressed willingness to hold election debates again prior to the upcoming May 2025 midterm elections.

Comelec chairperson George Erwin Garcia emphasized that these debates should be organized by media organizations, with the commission playing a supervisory role.

"In accordance with Republic Act 9006, which governs fair elections, it is essential that media entities manage these debates. Our role will be to supervise and coordinate with the candidates," Garcia said in an interview on Thursday, Oct. 10.

Garcia highlighted the importance of these debates for voters, suggesting that they

provide a crucial platform for candidates to present their platforms, discuss key issues, and share their principles with the electorate.

The decision to bring back the debates follows the commission's experience during the 2022 elections, when the last two of a planned series of five debates for presidential and vice-presidential candidates were canceled.

This cancellation was attributed to financial difficulties faced by Impact Hub Manila, the private partner responsible for organizing the events, in relation to the venue at Sofitel Philippine Plaza.

Comelec said its renewed openness to debates is aimed at fostering informed voter engagement in the lead-up to the elections. (AVS/PIA-NCR)

Child rights group backs bill seeking Vape Law amendment

MANILA – A group advocating children's rights on Thursday said it supports moves to amend Republic Act No. 11900 or the Vape Law to protect kids' health and safety. In a news release, Child Rights Network (CRN) Philippines said it welcomes the bill filed by Muntinlupa City Lone District Rep. Jimmy Fresnedi that seeks to reinstate the child protection measures removed during the passage of the law.

It noted that the bill is a development and a "good counterpart" to the amendatory bill filed by Senator Pia Cayetano in 2022.

"We are currently facing a youth 'vapedemic,' with one in seven children aged 13 to 15 already using vapes or e-cigs," the group said.

"It's only logical to return the regulation of vapes and e-cigs to the Food and Drug Administration from the Department of Trade and Industry, given the clear health risks they pose to their users, especially children."

Citing that vapes and e-cigarettes are not ordinary consumer products, the group said the DTI is not fully-equipped to oversee such products.

It also supports the ban on online marketing and distribution of vapes and the raising of the minimum access age to vapes from 18 years old to 21 years old.

"Though not addressed in this bill, we believe that the age restriction on access to all tobacco products, including traditional combustible cigarettes should also be raised to 21," it said.

The tobacco industry opposes such safeguards as their business model depends on getting young people addicted to nicotine, it added. (PNA)
