CALAMBA CITY, Laguna - The Dangerous Drugs Board (DDB) officially recognized the police provincial offices of Cavite, Laguna, Batangas, and Rizal, along with Regional Mobile Force Battalion 4A (Calabarzon), as Drug-Free Workplaces in a ceremony held on Wednesday at the Regional Police Headquarters Calamba City.

The ceremony led by DDB Undersecretary Earl Saavedra featured the ceremonial unveiling of the Drug-Free Workplace marker, highlighting the accomplishments of the provincial police offices and the battalion in promoting a drug-free environment within ranks.

PH hosts global conference on women, peace, security

QUEZON CITY (PIA) The International Conference on Women, Security and (ICWPS) opened in the Philippines on October at the Philippine International Convention Center (PICC) in Pasay City, marking 25 years since the adoption of UN Security Council Resolution 1325. The resolution calls for greater involvement of women in peace efforts and protection of their rights in conflict zones.

Under the theme Collaboration "Forging Convergence for and Women, Advancing and Security, Peace, the conference brought together governments, civil society, academia, and international organizations to advance the role of sustainable women in peace and development.

Philippines, pioneering country in Asia with a national action plan for women, peace, and security (WPS) since 2007, hosted the three-day event with over 23 side discussions on topics from interfaith peace building to women's health and security in conflict regions. Office of the Presidential Peace, Adviser on Reconciliation, and Unity (OPAPRU) Secretary Carlito Galvez Jr. highlights in his opening remarks the purpose of the gathering.

"This is the very reason why we are gathered here today — to advance equality gender and women empowerment in the areas of peace and security. These principles ae articulated in the UN Security Council Resolution 1325 that reaffirms the significant role of women in conflict prevention and resolution, peacebuilding, peacekeeping, humanitarian response, and in post-conflict rehabilitation," Sec. Moreover, Foreign Affairs Secretary Enrique A. Manalo emphasized the need for multi-stakeholder partnerships, stating the WPS agenda has evolved to meet today's emerging challenges. Key sessions include highlevel panels on women's

With participants from Southeast Asia, the Middle East, and North Africa, the conference serves as a platform to strengthen regional alliances and share best practices on WPS.

DOTr, Canada Embassy eye more flights to boost trade, tourism

MANILA – The Department of Transportation (DOTr) has begun talks with the Canadian Embassy in the Philippines to expand routes between the Philippines and Canada to boost trade, tourism and economic ties.

In a statement on Tuesday, DOTr Secretary Jaime Bautista said the country is ramping up its linkages with international destinations, discussed during a meeting with Canadian Ambassador to the Philippines David Hartman.

Bautista said the Philippines and Canada have had 75 years of "strong and friendly bilateral relations" dating back to 1949 and that more flights to and from Canada will improve the Philippines' economic resilience.

"It will contribute not only to our economic growth but also to the growth of both of our societies," he said.

Bautista added Hartman expressed optimism that the expansion of flights to and from the North American region would pan out due to increasing demand.

During the recent Aviation Summit 2024, Bautista said new routes to other countries are expected to launch as it would provide travelers with flexibility while attracting foreign tourists.

Direct flights between the Philippines and France are scheduled to begin Dec. 8 as part of the Asia-Pacific route expansion. (PNA)

PHLPost launches new postal ID, upgrades express mail service

MANILA - The Philippine
Postal Corporation
(PHLPost) on Tuesday
launched the postal ID as
functional card and the
upgraded express mail
service (EMS).
PHLPost Postmaster

General and chief executive officer Luis Carlos said the new ID provides address verification for customers. "If you notice, a lot of IDs do not confirm the address of a person. That's the first function of this ID, the KYC (Know Your Customer)," he said during a media conference at the Manila Central Post Office in Manila City.

The PHLPost has at least 150 partner merchants nationwide in the past years providing discounts

and freebies to postal ID holders, Carlos said.

The PHLPost is expecting additional merchants to partner with them, he said. "About the financial functionality, we are really looking at that one, to really to answer the Bangko Sentral's issue of the unbanked," he added.

Citing that about half of the country's population do not have bank accounts, Carlos said, they are studying how the postal ID can function as a digital bank which would be beneficial to people in farflung areas.

The functional postal ID carries the owner's name, address, birthdate and signature. It also includes the alphaneumeric zip code composed of two letters and six letters representing the owners province, municipality or city and barangay.

A quick response (QR) code is printed on the ID for the verification of its authenticity.

The PHLPost also enhanced its EMS with the next-day delivery function in Metro Manila, strengthening its competitive position in the logistics industry,

Earlier, the PHLPost said Metro Manila accounts for a substantial portion of its delivery volume.

It aims to ensure cost efficiency, reduce manual handling and provide real-time tracking, to be managed by the Quezon City Central Post Office Hub, Central Mail Exchange Center, Makati Central Post Office Hub, and Manila Central Post Office. (PNA)

PMCJ demands gov't to conduct full investigation on Masinloc coal spill, hold them accountable

Quezon City, Philippines After a barge carrying over 11,000 metric tons (MT) of coal sunk last week, releasing coal into Masinloc-Oyon protected seascape and possibly harming the marine ecosystem, the Philippine Movement for Climate Justice (PMCJ), Zambales climate justice groups who live near the protected waters of Oyon Bay, have raised alarm to the local and national government demanding accountability, investigation, immediate and prosecution. According to a Philippine

Coast Guard station head, the barge came from Semirara, Antique en route to La Union. At the height of Typhoon #KristinePH, the barge temporarily stopped at San Salvador Island. Masinloc sea patrol chairman reported that the barge bumped into coral reefs, spilling its cargo. San Salvador Island is classified as a marine sanctuary.

Last October 18, climate justice groups from Zambales, together with the PMCJ, filed a complaint at the Department of Environment and Natural Resources - Environmental Management Bureau to oppose the expansion of San Miguel Global Power (SMGP)'s Masinloc coalfired power plant. The continued presence of the coal plants will continue to

destroy marine biodiversity given that Masinloc-Oyon Bay is a protected seascape.

"The recent coal is just one of the many these violations plants in Masinloc and La Union will pose to this seascape. protected stressed Dr. Benito Molino, from Zambales Lingap Kalikasan (ZALIKA). continued operation will further endanger marine biodiversity as this has become the shipping route of coal from Semirara. Obviously, the owner of the barge, the Protected Area Management Board (PAMB), the coast guard in Semirara as well as the municipal government of Masinloc must be held to account on this tragedy," Dr. Molino continued.

Series of violations In 2017, residents near SMGP's coal-fired power plant in Limay, Bataan, complained about the ash residues as it made them ill. The coal ash spill caused skin and respiratory diseases, air

and water pollution. In 2018, there was also a coal spill in the coastal waters of La Union from the Holcim cement factory. This was also caused by a tropical depression (Henry), as it pushed the coal from Holcim's stockpile into the shoreline. "Dahil [sa coal spill], kaming mga mangingisda

We call to conduct investigation and identify the long-term effects of the incident to health, livelihood, and the environment.")

Marabe also highlighted the more than three-decade long fight of Masinloqueños and Zambaleños against the coal-fired power plant in their area. They don't deny the economical progress

these plants offer, Marabe explained, but it is definitely not worth it at the expense of the environment's wellbeing.

Fight on troubled waters

Masinloc-Oyon Bay was declared a Protected Seascape and Landscape (MOBPLS) under Republic Act No. 7586, or the National Integrated Protected Areas System Act, and became the first marine protected area in Central Luzon.

RA 7586 Section 20 (b) and (e) states: Dumping of any waste products detrimental to the protected area, or to the plants and animals or inhabitants therein; Damaging and leaving roads and trails in a damaged condition; respectively.

"Clearly, RA 7586 was

those violated and violators should be held accountable. However, there is not much news on what transpired in the investigation, who are involved and how they are being meted with penalties. There is a news blackout. We do not take this lightly as this has already become the norm. We will expose the cover-up. We urge the Department of Justice to conduct an immediate investigation to determine who is liable for this criminal act," PMCJ National Coordinator Ian Rivera said.

NIA eyes expansion of P29 rice program for vulnerable sectors in Calabarzon

PILA, Laguna (PIA) — The National Irrigation Administration (NIA) Region IV-A aims to ramp up the production and selling of P29.00 per kilo of rice under the Bagong Bayaning Magsasaka (BBM) Rice Program, with the goal of benefiting more individuals from vulnerable sectors in the region.

During the 22nd iteration of the Kapihan sa Bagong Pilipinas, NIA Region IV-A Regional Manager Roberto Dela Cruz states that NIA is actively seeking ways to boost rice production through the Contract Farming Program.

"Originally, we aim to target 40,000 hectares nationwide, some regions have large allocations while other have none. However, for Calabarzon, we did not agree to have zero allocation. We convinced our irrigators associations to start even a small pilot project so we can see the results," Dela Cruz said.

farming contract provides initiative participating farmers with P50,000 initial assistance for farming inputs, land preparation, harvesting and hauling, which includes P30.000 for seeds. fertilizers, and pesticides, along with P20,000 in cash to cover labor costs.

"The turn out of the program has been very positive, operating on a breakeven basis and implementing a program that increases the income and production of farmers is already a significant success. Farmers have realized this, and now many other members of the irrigators' association are eager to join," the regional manager shared.

Based on the agency's data, only 271 hectares in the entire region are currently part of the Contract Farming Program, which includes key areas in Nasugbu, Batangas; Maragondon, Cavite; Infanta and Sariaya, Quezon and Sta. Maria, Laguna.

Due to the positive outcome and interest from other farmers, NIA is set to cover 500 hectares of farmlands per Irrigation Management Office (IMO) in 2025 to support more farmers and provide more affordable rice for vulnerable sectors. As the program progresses, Dela Cruz believes that the support and cooperation of various government agencies, more affordable rice will be available not only to vulnerable sectors but also to the general public. PBBM wants 300 KADIWA Centers by Q2 2025

MANILA — President Ferdinand R. Marcos Jr. on Tuesday, Nov. 5, ordered the expansion of KADIWA Centers from 21 to 300 sites by the second quarter of 2025.

Kadiwa is a market linkage facilitation program intended to make agricultural products and other basic commodities accessible and affordable to vulnerable sectors such as senior citizens, solo parents, persons with disabilities (PWD), and members Pantawid of Pamilyang Pilipino Program (4Ps).

In a meeting in Malacanang, the Department of Agriculture (DA) requested the President to fund the rehabilitation and repair of warehouses for potential KADIWA center sites for an estimated 600 KADIWA Stores nationwide.

The expanded sites would be selling Rice-For-All (RFA) at P43 per kilogram or less, with selected stores to sell P29 rice depending on stock availability.

The rehabilitation is also expected to benefit an additional 2.3 million Filipinos in its initial roll.

The DA reported that 148 new sites for expansion for 2024 was approved by Agriculture Secretary Francisco Tiu Laurel. The DA is in collaboration with different government agencies and the private sector for the P29 and RFA programs.

NEDA Board OKs changes in flood control projects in Cavite, NCR

MANILA — The National Economic and Development Authority (NEDA) Board on Tuesday approved the extension of the construction period and other adjustments to the Cavite Industrial Area-Flood Risk Management Project (CIA-FRIMP) and the Pasig-Marikina River Channel Improvement Project (PMRCIP) - Phase IV.

The NEDA Board, chaired by President Ferdinand R. Marcos Jr., gave its approval during its 22nd meeting at Malacañan Palace in Manila, according to a statement from the Presidential Communications Office (PCO).

The PCO said the approved changes in the CIA-FRIMP include the increase in the total project cost to PHP22.037 billion, higher by 122.79 percent or PHP12.146 billion from PHP9.891 billion.

The NEDA Board also approved the 65-month extension of the project's implementation period starting from April 2025 until September 2029, the PCO said, adding it has been adjusted from the original October 2019 to April 2024.

The PCO said the NEDA Board also gave its nod to the change in the scope of work, particularly the widening of diversion channels and additional

The National Food Authority (NFA) also procured a large volume of palay at 6,472,299 bags for the period of January to October 2024 with a performance rate of 72.65 percent based on the 8,908,860 bags target for the said year —a first in almost a decade.

With the continuous implementation of Price Range Scheme for Palay Procurement (PRICERS) which benefits local farmers, the NFA is poised to reach the necessary amount of buffer stockpiles by the end of the year.

The project aims to mitigate flood damage in the lower reach of San Juan River Basin and its adjacent Maalimango Creek Drainage Area in Cavite province.

The NEDA Board also approved a 74.32-percent increase or PHP24.599 billion in total project cost from PHP33.097 billion to PHP57.696 billion for the PMRCIP Phase IV, the PCO said.

The PCO added there will be a 63-month extension for the implementation of the PMRCIP Phase IV from December 2025 to March 2031.

The NEDA Board also approved the changes in scope of work, such as the design of the Middle Marikina River, modifications in drainage facilities, and additional work.

A loan reallocation totaling JPY3.373 billion from consulting services (JPY1.728 billion) and contingencies (JPY1.645 billion) to the civil works component was also approved by the NEDA Board, including a supplemental loan of JPY45.759 billion.

The PMRCIP aims to

mitigate flood damage in Metro Manila caused by channel overflow of the Pasig-Marikina River.

The project is seen to benefit residents of the cities of Pasig, Marikina, and Quezon in Metro Manila and the municipalities of Taytay and Cainta in Rizal.

"Ang concern ko rin (My other concern) is the design. Does it take into account the new weather? Because ano na 'yan, danger area na 'yang Marikina talaga (The danger area is really in Marikina). The levels of water in the last two big typhoons we had, we came to within half a meter of the

limit bago mag spillover," Marcos said.

Public Works and Highways Secretary Manuel Bonoan told Marcos that the design of the project helped in stopping spillover during the recent typhoons.

"The other component that we are looking into the Pasig-Marikina River is actually the construction of the three dams in the [watershed]," Bonoan said. Apart from the changes in the two flood control projects, the NEDA Board also approved the implementation of the locally financed Philippine International Exhibition Center Project, and the acquisition of 40 units of fast patrol crafts to be funded through official development assistance (ODA). Interest in farming rising among retirees – NIA

PILA, Laguna (PIA) — The National Irrigation Administration (NIA) in Calabarzon reports that more retirees are viewing farming as a viable investment option after decades spent in their careers.

In a recent interview at the Kapihan sa Bagong Pilipinas, NIA Region 4-A Engineering and Operations Manager, Engr. Erwin Lucela stated that more retired professionals are turning to farming, highlighting the industry's viability as an investment. "It's true that a lot of people, especially retired professionals, turn to farming. This suggests that farming is a viable and respected career choice. People wouldn't invest so much in farming if they didn't see it as equally valuable as other professions,"

Citing a recent NIA survey, Lucela noted that the average age of members in Irrigators' Associations has risen, reflecting a growing interest in farming among older professionals, particularly those nearing retirement.

The irrigation agency attributes the rising number of retirees turning to farming to their desire for continued responsibilities after decades of serving others.

Lucela explained: "Even

though they are getting old, they want to have responsibilities in the association. They are the ones interested in farming." A 2023 report from the Southeast Asian Regional Center for Graduate Study and Research in Agriculture (SEARCA) states that the average age of Filipino farmers is between 55 and 59 years old.

The same report warns that this aging demographic could significantly impact farmer shortage within the next 10 to 12 years.

Despite this, NIA IV-A remains optimistic about advancements in the local agriculture industry.

"I believe this will improve considering that even in other countries, this is the age bracket of farmers. Even in other countries, there are no farmers in their 20's and 30's,"

The official added: "There are two kinds of farmers in our country: one whose family supported them to pursue other careers and one who remains a farmer because of their love for farming."

Despite the increasing age of farmers, the NIA assured that it will continue to provide its services as long as Filipinos remain interested in the profession. "We at the NIA will continue delivering our services to the Filipino farmers." (PB/PIA-4A)
