DA distributes aid to El-Niño stricken farmers in CALABARZON

CALAMBA CITY (PIA) – The Department of Agriculture (DA) in CALABARZON has tapped into the Rice Competitiveness Enhance Fund (RCEF) to provide financial aid amounting to P5,000.00 to each farmer affected by the El Niño phenomenon.

Suzette Claribelle Panopio, senior agriculturist in DA IV-A, stated that the agriculture department has also positioned P8,308,964.50 worth of farming interventions in the region under its flagship crop programs.

Under its Rice Program, the DA has readied 4,508 bags of inbred certified seeds reportedly valued at over P3.4 million.

Meanwhile, the Corn Program has allocated P2.4 million for interventions in insecticides and rodenticides, and an estimated P2.5 million worth of interventions have been prepared under the High-Value Crops Development Program.

Panopio said: "We have positioned agricultural interventions that can be distributed as soon as rainfall increases. Since there is no current rainfall, we cannot distribute the seeds yet. We are advising farmers to consider crops more suitable for the current weather conditions as an alternative

DA CALABARZON and its attached agencies, including the National Irrigation Administration, converge their efforts to train their respective Disaster Risk Reduction and Management personnel. Their goal is to develop a

system for faster assistance to local government units and introduce modern agricultural technology to farming communities.

"We are encouraging them [farmers] to adopt [modern] farming methods and technology to help them conserve water. We are also introducing rotational water distribution strategies where we need to only add fertilizers, instead of harvesting the crops," Panopio explained.

The senior agriculturist mentioned that the DA implemented a rotational water distribution strategy to ensure that farmlands receive an adequate water supply despite the extreme weather conditions.

The agriculture department has also utilized protected agriculture technologies to regulate the temperature and mitigate the impact of excessive heat in farmers' nurseries and greenhouses.

In addition to their groundwork, Panopio added that DA CALABARZON is keeping the public informed by utilizing their media platforms for an information advocacy drive on the effects of the El Niño phenomenon.

According to the department's April 25 report, El Niño has resulted in approximately Php131,997,476.54 in

DOST launches feeding program for children in Rizal town

RODRIGUEZ, Rizal – The Department of Science and Technology (DOST) 4A (Calabarzon) has gone beyond its usual mandate to promote science and technology innovations and has gotten involved in addressing this town's malnutrition problem.

Through its Provincial Science and Technology Office (PSTO) in Rizal, the agency began this week a 120-day feeding effort under its Community Empowerment through Science and Technology (CEST) program.

Rodriguez (formerly Montalban), has been designated by the government as a Geographically Isolated Disadvantaged Area (GIDA) due to the prevalence of child malnutrition within its borders, according to Rizal PSTO Director Fernando Ablaza.

In an interview on Wednesday, Ablaza said the four-month feeding program would be a collaboration between his office and the Food and Nutrition Research Institute (FNRI), another DOST-attached agency.

He explained that beneficiaries of the initiative would be fed highly nutritious food that has been scientifically formulated and fortified with supplements

to support good physical development.

"With malnutrition prevalent in Rodriguez town, we've embarked on a 120-day feeding program targeting 200 children across four barangays, aged between six months and 35 months, providing them with essential supplements. nutritional DOST's CEST program encompasses health and nutrition, aiming to elevate the quality of life for marginalized sectors through science and technology," Ablaza said.

He also said the DOST has allocated funds to supply the needs of children in four barangays, with the local government unit (LGU) of Rodriguez pledging support for expanding the initiative to encompass all barangays within the town.

Ablaza cited the pivotal role of Barangay Nutrition Scholars (BNS) in facilitating the program.

He said the BNS has been designated in each participating barangay to oversee the preparation of nutritional supplementary foods, as well as the crucial task of feeding the identified children. (PNA)

DOST'igniting' Batangueño students' interest in science, math

BATANGAS CITY - The Department of Science and Technology (DOST) has stepped up efforts to provide public and private school students in this province advanced studv resources for stimulating their interest in science, technology, engineering and mathematics (STEM). In an interview on Tuesday, John Maico Hernandez, a senior research specialist spokesperson at DOST-Batangas, said De La Salle Lipa in Batangas has become the 111th school in the region to receive the Science and Technology Academic and Research-Based Openly-Operated Kiosks (STARBOOKS) digital information source.

He said STARBOOKS was developed by the DOST Science and Technology Information Institute (DOST-STII) as a repository of thousands of digitized science and technology (S&T) resources that can supplement learning and enhance research capabilities.

The program was originally designed provide to S&T content in various formats to students and other constituents geographically-isolated and economically-challenged schools and communities throughout the country.

However, because De La Salle is not a school for those struggling financially, it provided the required computer set-up while DOST simply installed the STARBOOKS system and gave the necessary orientation to the personnel of the school.

"While DOST offered STARBOOKS for free, including the computer set-up especially to the marginalized schools, in De La Salle Lipa, we provided the STARBOOKS system into the computers they provided," he said.

For her part, De La Salle Chona Lipa librarian Chavez said "the use STARBOOKS will further enrich the learning experience of their students and promote a culture of research and innovation within the institution."

Meanwhile, Hernandez revealed that high schools in Calatagan, Lian, and Nasugbu are the first in the region to receive Versatile Instrumentation System for Science Education and Research (VISSER) kits from the DOST.

These kits are designed to ignite students' interest in inventing within various STEM fields like biology, chemistry, physics, engineering, and robotics. He said the VISSER kit is an advanced platform that encourages students to explore, experiment, and discover using interactive handheld devices equipped with sensors for data collection and analysis.

The kit allows students over 50 science experiments and operates independently, requiring only a battery or power bank for power, the DOST

DHSUD to develop townships in Clark

MANILA - The Department of Human Settlements and Urban Development (DHSUD) is eyeing to establish townships within Clark in Pampanga.

In a news release Wednesday, the DHSUD said it has discussed with Clark Development Corporation the establishment of townships within the vicinities of Clark Special Economic (CSEZ) and the Clark Freeport Zone (CFZ) under the Pambansang Pabahay Para sa Pilipino (4PH) program.

"Napakalaki po ng potential ng Clark (Clark has a huge potential) in terms of location and infrastructure. It's very ideal for our concept of township development under President Ferdinand Marcos Jr.'s flagship 4PH Program," DHSUD Secretary Jose Rizalino Acuzar said.

"By developing townships in Clark, we will be bringing in population. Mas maraming tao, mas mabilis ang asenso (With more people, development would be quicker)," he added. Acuzar said the project would provide shelters to workers and locators, thus addressing

development outside Metro Manila to resolve massive urbanization: establishment of new green and smart cities; and creating communities to trigger economic activities.

Citing the presence of an international airport, hotels, hospitals, schools and other modern infrastructures inside Clark, Acuzar said it has the "ingredients of an ideal new and modern city". However, it lacks local

Cooperate or rot in jail MANILA – The Presidential Task Force on Media Security

(PTFoMS) is urging the arrested gunman in the killing of Kidapawan City broadcaster Eduardo "Ed" Dizon to cooperate in the investigation by confessing in exchange for a potential shorter jail term or remain silent, exonerate his co-accused and rot in jail.

PTFoMS Executive Director **Undersecretary Paul Gutierrez** said authorities have new witnesses, including members of the local police, who can identify Junell Jane Andagkit Poten, aka Junell Gerozaga as the gunman who shot dead Dizon on July 10, 2019.

"If Gerozaga thinks it would be best for him to just remain silent, he is utterly mistaken, Gutierrez said, as quoted in a PTFoMS news release Wednesday.

To bolster the case further, Gutierrez said the Special Investigation Team (SIT) Dizon decided to transfer another witness to Manila under the Witness Protection Program. Gerozaga, 33, was arrested on May 2, 2024 by the combined elements of the Police Regional Office (PRO)

"We want to know where he was during the time he was wanted for the killing of Dizon,' Gutierrez said.

'We are also validating reports that Encarnacion has revived the modus of KAPPA using another name and his ongoing recruitment of members, coordinators or investors especially targeting local officials and the members of the police.

"If warranted, he may also face separate cases for them, Gutierrez said.

In Kidapawan City last May 14, Gutierrez turned over to the informant the initial reward of PHP200,000.00 put up by the local government for his critical role in Gerozaga's arrest. (PNA)

PhilHealth, PIA sign MOU on affordable healthcare awareness drive

MANILA The Philippine Health Insurance Corporation (PhilHealth) and the Information Philippine Agency (PIA) on Monday signed a memorandum of understanding (MOU) on educating Filipinos about healthcare services under the Universal Health Care (UHC) program.

The MOU builds upon a previous one signed by PhilHealth and PIA National Capital Region on Sept. 4 last year promoting the Konsultasyong Sulit at Tama (Konsulta) program in Metro Manila and surrounding areas.

"Dahil naging maganda ang epekto ng kasunduang ito, minarapat na po nating maging national and scope ng ating kasunduan at ang ating partnership para naman mas maraming tao ang matutulungan natin, at mai-inform natin, at makikinabang sa mga serbisyo ng PhilHealth (Because the MOU had a good effect, we opted to broaden it and our partnership, so we can help more people, and we inform them, and they can avail of PhilHealth services)," PIA Director-General Jose Torres Jr. said.

Through the Konsulta program, PhilHealth provides services. laboratory tests (based on doctors' prescription), and drugs and medicines (based doctors' on prescription) for all of its members.

Under the UHC, all Filipinos are immediate members of PhilHealth.

These services include CBC with platelet count, urinalysis, fecalysis. sputum microscopy, fecal occult blood, pap smear, lipid profile, fasting blood sugar, oral glucose tolerance test, ECG, chest X-ray, creatinine, and HBA1C test.

Meanwhile, the free medicines and druas include antimicrobials, fluid and electrolytes. anti-asthma, antipyretics, anti-dyslipidemia, antidiabetic, anti-hypertensive, anti-thrombotics, and

antihistamine.

As of March 31, 2024, there are 2,611 accredited Konsulta Package providers in the NCR and 372 in Rizal province.

14,947,769 There are individuals registered in the Konsulta program.

PhilHealth president and CEO Emmanuel Ledesma Jr. assured the public that the corporation has enough funds for all the health benefit packages.

"We increased 30 percent almost across the board last February 14, and then just a few weeks ago in our last Execom, we asked the group, study again, another round of 30 percent increase. We have budgeted 245 billion (pesos) for benefit payments this year," he said.

said PhilHealth is working on the expansion of free drugs and medicines from 21 to 53 for its members.

PhilHealth corporate affairs vice president Rey Baleña said the expansion is in the "pilot-testing" stage.

"Iyung 21 mag-e-expand to 53 essential drugs and medicines at kapag ito po ay fully nailunsad na po natin, na-deploy nationwide, magkakaroon po ng access dito ang mga kababayan natin (The 21 will expand to 53 essential drugs and medicines, and when we fully launch this, deployed nationwide, our fellowmen will have access to this)," he said.

New international container terminal to rise in Batangas town

BAUAN, Batangas - A is envisioned to play a role new international container facility is set to be built in this municipality and is targeted for completion by the end of 2027.

In an email on Monday, the International Container Terminal Services Inc. (ICTSI) said design and engineering studies on the new terminal are already underway with the commencement of construction scheduled in the first quarter of 2025.

new represents a significant leap forward for Southern Luzon. We are building a world-class facility that will unlock a wave of economic benefits for the region and the country. It will create new employment opportunities, improve the quality of life for our host communities... and solidify Southern Luzon's position as a key player in global trade, Christian Gonzalez, executive president, said.

The terminal, which is estimated to entail a US\$800 million investment. in providing the marine handling needs required by the country's renewable energy transition strategy for Southern Luzon.

Gonzalez said the Bauan-Pascual-Batangas-STAR tollway diversion road and other expressway projects from Cavite to Bauan have significantly enhanced the accessibility of the planned terminal.

Strategically located 120 kilometers south of Manila and nine kilometers west of Batangas City, the Bauan facility is expected to become the premier international gateway for shippers based in Calabarzon, according to ICTSI.

ICTSI is touted as the Philippines' largest multinational and transnational company, having established operations both in developed and emerging market economies in Asia Pacific, the Americas, Europe, the Middle East and Africa. (PNA)

Electronic marketplace for gov't procurement set end-July launch

MANILA – The government is set to launch by end of July an online purchasing platform to ease and digitalize the government procurement process.

Department of Budget and Management (DBM) Secretary Amenah Pangandaman said the e-Marketplace launching was approved by President Ferdinand R. Marcos Jr. during a sectoral meeting in Malacañang Tuesday.

Pangandaman said the e-Marketplace is similar to e-commerce and online shopping platforms like Amazon, Lazada, Shopee.

"We are all excited for the official launch of our e-Marketplace by end of July. As you all know, this is part of our efforts to digitalize the government's procurement system and address concerns on the procurement process which is the biggest bottleneck or hurdle in the budget utilization of our agencies," Pangandaman

said in a Palace press briefing.

She added that the platform will be piloted for government procurement of motor vehicles

DBM-Procurement Service Executive Director Dennis Santiago said the usual procurement under competitive bidding of at least 26 days to as long as 136 days will be shortened by e-Marketplace to just one day.

"Of course, delivery is another matter perhaps two or three days more but, you know, (that's way) shorter than 26 or 136 calendar days," he said.

He also said the platform will feature multilevel security systems, including mechanisms to deter hacking attempts.

Pangandaman said the President wants limitation" when it comes to openness and transparency and even recommended the addition of feedback or review mechanisms. (PNA)

Sandigan lifts travel order, returns bond of ex-lloilo town mayor

MANILA Sandiganbayan has ordered the return of the bond as well as the lifting of the travel ban on former mayor Mariano Malones of Maasin, Iloilo after the Supreme Court dismissed the graft charges against him for inordinate delay.

In its four-page resolution dated May 3, the Sandiganbayan Seventh Division explained that it received in April the entry of judgment for the Supreme Court (SC) resolution, which had declared the case against Malones closed and terminated.

The case involved alleged irregularities in purchase of a garbage compactor truck worth PHP380,000 by the local government unit without public bidding in 2001.

The Commission on Audit found that the truck came from a Japanese firm RH International Co. Ltd. but documents were falsified to make it appear that the truck was donated.

In dismissing the charges against Malones, the SC's July 20, 2022 decision noted that the case was originally filed by former local council member Winefredo Maternal on May 31, 2002, but the information was filed before the Sandiganbayan in 2014.

Malones was previously suspended for 90 days in 2016 due to the anomaly. (PNA)

Free TESDA skills assessment for SHS grads to begin next school year identify the graduating

MANILA - Senior high school (SHS) students under the Technical Vocational Livelihood (TVL) track will start receiving free assessments government certification starting in school year 2024-2025, an official of the Technical Education and Skills Development Authority (TESDA) said Monday.

During Bagong the Pilipinas Ngayon briefing, TESDA Deputy Director General Aniceto Bertiz said preparations are ongoing for the free certification program under the twin joint memorandum circulars (JMC) signed on May 10 by TESDA, Department of Education (DepEd), Department of Labor and Employment (DOLE) and Commission on Higher Education (CHED).

"We are coordinating with DepEd, DOLE and CHED para magkaroon ng dashboard at hindi mahirapan ang mga estudyante na magavail po ng (to create a dashboard that would ease the experience of our students in availing of the) mandatory certification and assessment." he said.

The dashboard would help

students who would need to be assessed while DepEd will help find which districts they are from, Bertiz said. He said an assessment center must be established, in addition to training the program's assessors.

"We have been given also a budget to add more and develop more trainers and assessors. Para po sa malaking bilang ng mga ga-graduate natin na mga senior high school as well as to cater iyong mga grumaduate po noong nakaraang taon (This is to address the large number of graduating SHS students next year as well as those who will graduate this year)," he said.

The two JMCs are in line with President Ferdinand R. Marcos Jr.'s directive to address skills mismatch employment gap among SHS graduates.

The JMCs aim to fund graduates' assessment for National Certificates I and

1st 'super health center' to open in Laguna, 12 more in pipeline

CALAMBA CITY, Laguna Lawmakers from both houses of Congress are collaborating with the Department of Health (DOH) and concerned local government units (LGUs) to build a total of 13 "super health centers" or SHCs in this province.

With the imminent opening of the first SHC in Calauan town, 12 more will be in the pipeline throughout the province, according to Senator Lawrence "Bong" Go.

took part in an inspection of the soonto-open Calauan SHC on Sunday, accompanied by local officials.

the SHC said He initiative in this province "reflects a commitment to democratizing access quality healthcare, particularly in remote areas.'

In an interview, Go said SHCs are set apart from typical community health center in the number of medical services that they offer.

He said SHCs will be equipped with X-ray and ultrasound machines for its outpatient services.

These will also have birthing rooms, surgical units and isolation areas for patients who may be confined.

SHCs will also offer specialized services such as eve. ear. nose, and throat (EENT) care, oncology treatment, physical therapy rehabilitation, and telemedicine services, having while in-house pharmacies.

Go, who is chair of the Senatecommitteeonhealth, said securing funding for the construction of SHCs in Laguna represents a concerted effort by multiple government agencies.

By bringing government healthcare closer to the people, we empower communities and promote health equity," he said.

GSIS offers emergency loan to members affected by rabies, El Niño

MANILA - Around 77,000 members and pensioners of the Government Service Insurance System (GSIS) from 13 areas in the country affected by rabies and the El Niño can now apply for emergency loans.

In a news release on Tuesday, the GSIS said a total of PHP1.7 billion was allocated for the initiative. Qualified applicants include members who are residing or working in Buenavista, Marinduque, where rising rabies cases have been reported.

Also included are members affected by El Niño in Catbalogan City in Western Samar; Cordova, Naga City, and Toledo City in Cebu; City; Buenavista Guimaras; Bayawan City and Sta. Catalina in Negros Oriental; Antique; Basilan; and Datu Piang and Sultan sa Barongis in Maguindanao Del Sur

The GSIS said members and pensioners can borrow up to PHP40,000 to clear previous loans and receive a maximum net amount of PHP20,000, while those without existing loans can apply for up to P20,000.

Qualified applicants include those residing or working in affected areas, and must meet certain eligibility criteria.

To be eligible for the emergency loan, active members must not be on unpaid leave, have no pending administrative or legal cases, and must have made at least six monthly premium payments prior to application.

'Their net take-home pay should not be less than PHP5,000 as required by the General Appropriations Act. Meanwhile, old-age and disability pensioners must have a net monthly pension that is at least 25% of their gross pension, GSIS said.

Applications may be filed through the GSIS Touch, the deadline of submission on June 7 for Luzon areas, May 31 for Visayas, and June 1 for Mindanao. (PNA)

DOJ exec: Human rights top priority in all gov't undertakings

MANILA - All moves by the Marcos administration will be undertaken "with utmost consideration for human rights," a senior Justice official said on Tuesday.

DOJ Undersecretary Raul Vasquez said this is assured by the creation of the Special Committee on Human Rights Coordination Administrative through Order No. 22 issued by President Ferdinand R. Marcos Jr. on May 8.

"The special committee is lodged under the Office of the President, and is clothed with the presidential authority to gather, require and seek the support and cooperation of all government agencies in this effort under the concept of holistic and wholegovernment approach," Vasquez said during the Bagong Pilipinas public briefing on Tuesday.

He pointed out that the special committee will have coordination functions, unlike the Commission on Human Rights (CHR)

which is an independent constitutional body.

On the other hand, he pointed out that the CHR will remain as an independent body that "overseas and monitors human right promotion and protection." (PNA)

Hontiveros scores DOE over inaction on country's power woes Risa Hontiveros to ensure adequacy of reliable, especial

MANILA - Bureau of Internal Revenue (BIR) Commissioner Romeo Lumagui Jr. said on Monday his office is heeding the call of President Ferdinand R. Marcos Jr. to continue It was followed by another its fight against illicit vape products and cigarettes.

BIR heeds PBBM's call to

combat illicit vape, cigarettes

Following the meeting of Marcos with the Private Sector Advisory Council-Agriculture Sector Group at Malacañang Palace last May 8, Lumagui said BIR officials were ordered to exert all efforts to catch illegal traders of vape and cigarettes whether they sell these products in physical stores or online.

Lumagui said the selling of illicit vape and cigarettes that evaded tax obligations is a crime.

"Since 2022, the BIR has not stopped raiding and filing cases against traders of illegal vape and cigarettes," he said in Filipino in a video message released by the BIR.

The BIR raided a vape warehouse in Manila in November 2022, wherein it won the PHP1.2-billion criminal case early this year.

In January 2023, BIR launched for the first time a nationwide raid against illicit cigarettes, and filed a PHP1.8-billion criminal case in May 2023 as a result of the campaign.

nationwide raid against illicit cigarettes in July last vear.

In November 2023, the BIR raided illicit cigarette traders and smugglers in Davao, with tax liabilities amounting to PHP252 million.

Last March, the BIR raided a vape warehouse in Manila, Laguna, and Rizal. In the same month, illicit cigarettes were found inside three large warehouses in Cavite, with total tax liabilities amounting to PHP5.4 billion.

Lumagui said those found in possession and having control over illegal vapes and cigarettes are subject to criminal and administrative charges.

"We have warned you as early as 2022. We have raided and filed criminal cases as early as 2022. Register your business and pay your taxes. You are

Senator Risa Hontiveros on Wednesday challenged the Department of Energy (DOE), the Energy Regulatory Commission, and the National Grid Corporation of the Philippines (NGCP) to demonstrate the foresight and competence needed to address the power supply shortages all over the country.

This comes as the senator expressed deep disappointment over the "continued failure' to solve the escalating energy issues, especially this summer, when their primary mandates them to ensure adequacy of supply and reliability of the system.

destroying an industry that provides millions of jobs to Filipinos," he said. (PNA)

current and future power supply while the NGCP secures the whole system from disturbances, including unplanned and forced outages. Proactive tayo dapat," Hontiveros said.

"They cannot go on giving us nothing. Kumilos naman sila," she added.

Hontiveros then strongly recommended that the DOE readopt a "proven industry-standard method" that had already been used even before the Electric Power Industry Reform Act (EPIRA) was enacted.

"Energy experts I have spoken with say that the DOE is so much better off using computations through loss of load probability (LOLP), and it is one they are already familiar with. LOLP has a distinct advantage when it comes to forecasting power supply availability. Right now, the agency is computing with a fixed 25 percentage reserve, but it hasn't been reliable, especially during this summer season. Hontiveros explained.

The LOLP is a measure of the reliability performance of the power supply system that forecasts the number of days when a brownout could occur in a year.

"Kung ginamit lang ng DOE ang LOLP, nalaman sana nito ang kinakailangang dagdag na capacity para hindi lalagpas sa isang araw kada taon may brownout imbes na halos araw-araw may yellow at red alert. DOE must reevaluate their methodology," Hontiveros said.

Hontiveros prodded the DOE to tap experts who could help it reimplement the LOLP in planning the country's power supply.

"Hindi sapat magdasal para hindi mag-shut down ang mga power plants natin, kailangang kumilos ang DOE batay sa probabilidad at pleksibilidad na maaring gawin in anticipation of a crisis situation," Hontiveros

said. "Dapat real planning for real development. Sabi nga, nasa Diyos ang awa, nasa tao ang gawa."

For NGCP, Hontiveros reiterated her call to prioritize system security rather than ensure bountiful harvest of dividends at the end of the fiscal year. The Senator cited the April data provided by TransCo showing NGCP contracting firm basis only 46% of regulating reserves, 47% for contingency reserves, and 28% dispatchable reserves
