DHSUD assures 4PH projects promote climate resiliency QUEZON CITY — The woes.

Human Department Settlements and Urban Development (DHSUD) on Monday, Jan. 27, assured all housing units under President Ferdinand Marcos Jr.'s flagship Pambansang Pabahay para sa Pilipino (4PH) Program promote climate resiliency.

This, after President Marcos Jr. called on DHSUD to explore climate-resilient housing designs to mitigate the effects of natural disasters to human settlements and ensure the safety of beneficiaries of public housing.

"Lahat po ng 4PH projects are mataas ang kalidad, dahil bukod sa compliant ang mga ito sa ating Building Code ay nakatutok ang gobyerno, kasama ang ating mga local government units, sa pagtatayo ng mga housing projects," Secretary Acuzar stressed.

"Sinisiguro din po ng DHSUD na ang ating mga 4PH projects ay wala sa mga hazardous or disaster prone areas at naka align sa mga approved Comprehensive Land Use Plans at Local Shelter Plans ng ating mga LGUs," he added.

DHSUD is also The spearheading the "Plan and Do" or the Planado aims to Program which promote climate resiliency integrating climate change considerations into urban planning processes, with a focus on developing sustainable and resilient communities through streamlined land use planning and coordination with various stakeholders, ultimately aiming to create cities that can better withstand the impacts of climate change like flooding and extreme weather events.

Currently, at least 56 projects under 4PH are in various stages of development and construction, some already have completed buildings.

Last month, the first 4PH units at the Palayan City Township Development in Nueva Ecija ceremonially turned over to overseas Filipino worker-beneficiaries by no less than the President and First Lady Liza Araneta-Marcos in Malacanang.

In Bacolod City, the LGU last week has started turning over housing units to beneficiaries the Asenso Yuhum Residences which is under the flagship 4PH.

Secretary Acuzar expressed elation that the government is now reaping the initial fruits of the flagship housing program - - two years after its formulation to finally put an end to the country's housing

ongoing turnover "These of units and simultaneous development and construction of housing projects are solid proofs of concepts that 4PH is the right track. Ito po ay patunay na kaya natin i-tap ang private funds sa public housing," Secretary Acuzar said.

PMCJ on International Day of Clean **Energy: Scrap Gas Law, Let Coal Die,** Ramp Up Our Efforts for Renewables

Quezon City, Philippines -We have just entered the new year yet the scrap of the year 2024 still lingers. Last vear was a series of climate events disastrous for the Philippines. From the impossible heat wave during the first quarter of the year, to almost concerted major typhoons in the last quarters, the vulnerable communities are always the frontlines of its fury.

On January 26, The Philippine Movement for Climate Justice (PMCJ) strengthens its resolve with the global network, for the International Day of Clean Energy, to push for a planned and managed phaseout of fossil fuels, ramp up efforts to transition to clean energy-to demand urgent action in addressing the climate crisis the world is in right now.

earth surpassed the The 1.5°C threshold in 2024 as confirmed by the Copernicus Despite Climate Change. the expected severity, the government's approach to climate policy does not stand up to what is needed to face the crisis.

Last January 8, President Ferdinand Marcos Jr. signed the gas bill into law. It is being pushed as a transition fuel but, PMCJ has long been highlighting that gas, being a fossil fuel, is always associated with risks and volatility due to political and supply chain challenges. The government must recognize the urgency to focus on the renewable energy industry, over a fake transition fuel.

With most of the governments always falling short existential addressing the threat of the planet and the people, subnational bodies organizations have stepped up in taking initiatives to assist the most vulnerable communities.

Through grassroots-based

movement and community engagement, there was a successful shift of public transition perception to into 100% RE. One of the most stimulating efforts in changing the narrative is to encourage local government units (LGU), and communitybased organizations to act on their future by transitioning to cleaner energy sources through policy initiatives and programs.

The past year, PMCJ was to encourage several provinces and municipalities to commit to transition their sources of energy; among the provinces were Albay, Misamis Oriental, and Mindoro Occidental. The most recent partnership was made last January 21, in the municipality Mindoro Sablayan in Occidental.

These milestones strengthen our efforts in promoting RE solutions and in diminishing the country's reliance on fossil fuels. These efforts are a commanding call for the national government that a just transition to renewables is attainable.

A 2020 report by the International Renewable Energy Agency highlighted the potential of RE solutions in reducing reliance on fossil fuels and how likely it is to lead a more resilient, sustainable, and climate-safe future

The government, and big fossil fuel companies, must stop offering false solutions. While we call on the government to continue to enforce the coal moratorium, now is the time to demand that it should be made permanent. At the same time, we urge for the scrapping of the law on gas and make the year 2025, the peak of the use of fossil fuels.

System Change, not Climate Change is what is needed for International Day of Clean Recto emphasized.

Meanwhile, as an attached agency of the DOF, the PMO facilitates an orderly, coordinated, and efficient program for the prompt disposition of non-performing government assets institutions, financial certain government-owned or controlled corporations (GOCCs), which been found unnecessary or inappropriate for the government sector to maintain. There are currently 28,665 non-performing assets transferred to the PMO for privatization.

If not privatized, the government will have to use much-needed funds meant to aid national development for the management, security, and maintenance of these assets.

The disposition of properties published newspapers of general circulation and posted on government websites ensure full transparency on the sale. The terms and conditions of the sale are unanimously approved by the PrC.
The DOF has been in close

coordination with the Social Security System (SSS) Security System and Government Service Insurance System (GSIS) on some assets that would serve as good long-term investments for the pension funds

The privatization of idle and underperforming government assets is a win-win solution for both the national government and investors, as compensation from the sale will support priority programs and projects that will benefit the Filipino people. (DOF)

BFAR promotes ecosystem-based approach in protecting marine resources

LOS BAÑOS, LAGUNA The Bureau of Fisheries and Aquatic Resources (BFAR) in Calabarzon has committed to employ sustainable practice ecosystem-based approach under the Philippine Fisheries and Coastal Resiliency FishCore Project.

Launched in 2023, the FishCore project is a seven-year foreign-assisted initiative funded by the World Bank.

It is being implemented in 11 provinces across the country, including the Calabarzon region, to address critical challenges in the fisheries sector and promote sustainable practices.

BFAR Calabarzon director Sammy Malvas emphasized the project's role in maintaining the resiliency of coastal communities using an ecosystem-based approach.

"One of our goals is to promote or expand ecosystem-based the approach to fisheries management. But if we talk about the preservation of the ocean, we should not only talk about the sea or river because everything that surrounds it has an effect on the quality of our lake, sea or river," the director said during an interview with the Philippine Information Agency Calabarzon.

The program emphasized the interconnectedness of marine habitats and the need for collaborative conservation efforts.

Malvas explained that the methodology involves the rehabilitation of coral reefs, mangroves, and seagrass beds that serve as critical breeding grounds for fish species.

FishCore likewise focuses on empowering coastal communities to address issues posed by overfishing through livelihood programs, capacity-building workshops, and the establishment of community-based fisheries management systems.

"Livelihood interventions (seek to) develop our beneficiaries into association, to cooperatives into enterprise... this is also one of the project's goals," Malvas explained.

The BFAR believes that the initiative is critical in equipping coastal areas with the tools and strategies to adapt to climate change impacts to ensure that their livelihoods remain sustainable while protecting ecosystems.

The bureau is in close coordination with local government units in Cavite and Batangas, where the project is primarily assigned further strengthen to the implementation of fisheries sustainable programs and ensure alignment with local development plans. (AM, CH/PIA-4A)

He explained: "We also deploy our BFAR vessels (for patrol) in the West Philippine Sea. We hope these small actions ... show that the West Philippine Sea is ours."

The BFAR previously said that they will not be deterred from patrolling all Philippine maritime zones despite the water cannon incident at Bajo de Masinloc in October 2024 involving their law enforcement personnel.

The bureau also vowed its support and assistance to Filipino fisherfolk who continue to exercise their right to livelihood in the WPS despite facing harassment from Chinese vessels.

The WPS National Task Force also continues to urge Filipinos anywhere in the world, to stand together and join the cause of advancing the country's rights over its EEZ. (CO, CH/PIA-4A)

DPWH beefs up construction, repair of flood control projects in Calabarzon

CALAMBA CITY, Laguna (PIA) – The Department of Public Works and Highways (DPWH) in Calabarzon has acknowledged the need to establish resilient flood control structures in the region due to recent destructive typhoons that hit the country.

DPWH Region IV-A director Jovel Mendoza said that the department has finished the construction and repair of 1,155 flood control projects in the region funded under the General Appropriations Act from 2023 to 2025 worth Php69.9 billion.

Mendoza said the DPWH has conducted studies to make sure that the projects can withstand the maximum effects of stronger typhoons and higher storm surges.

"We are conducting detailed estimates and designs for our damaged flood control structures especially in the past year because there have been a lot of typhoons that had devastating effects," the director said.

In a special meeting by the Calabarzon Disaster Risk Reduction and Management Council (RDRRMC) last December local governments around the Laguna de Bay said that lake waters would swamp neighboring communities due to rains being dumped by stronger typhoons, water pollution, and problems on drainage and infrastructure systems. **DPWH** The had acknowledged that floods in road networks disrupted have public transportation especially during times of disaster. DepEd to build 6k classrooms in Calabarzon under PPP

CAINTA, Rizal (PIA)
— More than 6,000
classrooms will rise in the
Calabarzon region by 2026
under the Department
of Education's (DepEd)
Public-Private Partnership
(PPP) for School
Infrastructure Program.

Eduarda Zapanta, the chief of DepEd Calabarzon's Education Support Services Division, said the new classrooms amounting to P850 million will address classroom shortage in at least 58 schools where the buildings will be constructed.

"The more congested the school is, the more qualified it is to be identified as a recipient. As we can see, this program is proportionate and justifiable because it is computed based on the number of students," she said.

Various schools in the region's five provinces been identified have where new buildings will constructed based on DepEd's five-year School Comprehensive Facilities Development Plan (CSFDP) using a regional database for constructing and repairing school facilities.

Zapanta explained that part of the plan is to construct more classrooms until 2030 to close the classroom gap estimated at 29,544 classrooms.

The CSFDP outlines the total facilities requirements for each public school in the country, organized by priority and feasibility of implementation. It details

the overall physical and financial needs for the construction, replacement, and major repairs of school buildings, as well as water and sanitation facilities, including site improvements.

The school infrastructure program, meanwhile, will prioritize construction in the most overcrowded schools to alleviate classroom congestion.

The official noted that the Education department had considered the recent typhoons that hit southern Luzon, particularly Calabarzon and Bicol regions, in its classroom allocations.

The Calabarzon region, which was ravaged by typhoon Kristine in 2024, holds the second largest budget of P850 million or 12 percent of the program's total funding.

"Region 5 (Bicol) has the highest budget allocation, followed by Calabarzon. We are taking into consideration the recent calamities [in these areas]," "Normally, the construction of school buildings can go up to a year. If we allocate a budget for the buildings like here in Calabarzon. we have 58 schools that should be constructed under the 2025 budget. And by next school year, they [the students] benefit."

The Department of Public Works and Highways (DPWH) said the classrooms will be completed by 2026. (PB/PIA4A)

Acquittal in tax case does not erase obligation to pay taxes MANILA - The Supreme

Court on Friday said taxpayers cleared of criminal tax charges are not exempt from paying their obligations.

This was stressed in a decision by the tribunal's Second Division that dismissed for lack of evidence the tax evasion cases against E & D Parts and Supply, Inc. and its treasurer.

The Office of the Solicitor General (OSG) lodged the case against E & D Parts and the official before the Court of Tax Appeals (CTA) for failure to file income tax returns and pay both income and value-added

The tax court, however, found insufficient evidence to prove that the corporate officer was responsible for the alleged violations, leading to her acquittal from criminal liabilities.

The CTA also dismissed the related civil case that aimed to determine the amount of taxes owed by the company.

The OSG argued before the SC that the company should still be required to pay taxes, regardless of the acquittal.

"A taxpayer's obligation to pay taxes arises from the law itself, and not from committing a criminal act like tax evasion. Therefore, even if a taxpayer is acquitted of a criminal charge, they remain liable for unpaid taxes," the SC said in its ruling.

However, the court noted that in this particular case, E & D Parts was not required to pay the assessed tax due to an invalid assessment. (PNA)

Plastic constitutes 91% of marinelitter in Manila Bay – group

MANILA – Hard and film plastics represent 91 percent of the collected wastes in Manila Bay, an environmental group said Wednesday.

In a press conference, the EcoWaste Coalition, together with De La Salle University - Dasmarinas, shared the findings of its 2024 Marine Litter Monitoring Survey Report, which showed a 36 percent decrease in the volume of marine litter and a 42 percent reduction in the total weight of collected wastes from 2023 to 2024 in its 10 project sites.

These include Silangan, Rosario; Timalan, Naic; Sahud Ulan, Tanza; Capipisa, Tanza; and Julugan, Tanza in Cavite. In the National Capital Region, the project sites include San Dionisio, Paranaque; and Tanza, Navotas.

Meanwhile, sites in Cabcaben, Agwawan Barangay Mariveles; Agniveles; and Bantan, Orion.

Despite the decline in marine debris, seasonal data further indicated a 16 percent increase in litter counts during the wet months compared to the dry season.

"These findings demonstrate the progress we've made, but they also highlight the urgent need for stricter waste management practices," EcoWaste Coalition's Enhancement of Marine Litter Management (EMLM) Project Officer Wes Lipana said.

"We have made significant strides in reducing litter, but the continuing dominance of plastics in our waste indicates the need for collective action — both from government bodies and the public."

The group presented key actions to address the ongoing challenge of marine litter: strict enforcement of existing environmental laws, such as Republic Act 9003 or the Ecological Solid Waste Management Act, and Republic Act 9275 or the Clean Water Act to ensure accountability at all levels; expansion of information

campaigns at the barangay level to raise awareness about waste segregation, plastic pollution, sustainable disposal practices; adoption of standardized cleanup methods, as outlined in the Manual for Beach Litter Monitoring Program, to improve data collection and cleanup efficiency; and development of comprehensive, integrated marine litter management plan for Manila Bay, incorporating both government and community efforts.

It also urged everyone to take part in carrying out the proposed solutions by adopting more sustainable waste management practices in their daily lives to protect Manila Bay and other vital coastal ecosystems nationwide.

Tourism promotions generate record-high P11.3-B in sales lead

MANILA – The country's promotions effort has generated a record-high PHP11.3 billion in tourism sales lead last year, said the Tourism Promotions Board (TPB).

TPB chief operating officer Maria Margarita Nograles said this is a 44.8 percent growth from the sales lead in 2023 and attributed it to the Marcos administration's overall push to offer tourists authentic and experiential travel in the Philippines.

"Last year, we hit our biggest sales leads ever in the agency at 11.3 billion just from our trade shows. So, this year, what we would like to do is really craft unique and world-class experiences and authentic experiences into the Philippines—that is our focus," she told reporters during the TPB Pasasalamat in Intramuros on Monday.

Nograles said the TPB, which handles promotions for the country's 13 key tourist markets, had been seeing "interest around the world to come to the

Philippines". The TPB, she said, is also gearing up to further enhance its presence in the Arabian Travel Mart as the country seeks to draw more inbound tourists from the Middle East.

"We cannot lose presence in Dubai, at the Arabian Travel Mart, we cannot. So, we have budget, we will enhance our presence there," she said.

On top of overseas trade shows, the TPB also sustains its domestic promotions, including through its community-based tourism program.

Nograles also assured that the TPB provides an equal amount of promotions to all Philippine destinations, including the already popular Boracay Island.

"We are focused and following the direction of our secretary that we are to give equal promotions to all our destinations, and let us not forget Boracay is an award-winning island, so we continue on promoting Boracay," she said.

"DOST is glad to have Thailand as one of its longstanding partners," the agency said in a news release on Thursday.

The DOST said Secretary Renato Solidum underscored the DOST's goals and undertakings anchored on human well-being promotion; wealth creation; protection; and sustainability. Solidum's counterpart, Ministry of Higher Education, Science, Research and Innovation (MHESI) Minister Supamas İsarabhakdi, discussed that their current focus is on frontier research and high-skilled manpower development on health science, artificial intelligence, electronic vehicles, semiconductors, energy, nuclear fusion, and space technology.

DOST said parties have affirmed their commitment to continuing and further expanding the science, technology, and innovation (STI) relations between the two countries.

"I am also pleased to support our research agencies in exploring additional key areas of cooperation with your agencies that benefit both our countries and regional development," Isarabhakdi was quoted as saying.

DOST Provincial Science and Technology Director Catalina De Leon-Cruz explained that Portasols are stackable aluminum trays covered with nets, designed to dry fish while shielding the contents from contaminants like dust and pests.

"The system works by allowing sunlight to directly hit the aluminum trays, which warms the air inside the dryer. The warm, dry air then flows over the food, evaporating moisture from its surface. The density differential between the warm air inside and the cooler air outside further dehydrates the food," she said. De Leon-Cruz added that the introduction of Portasols

intended to encourage fish processors to continue their work

DOST provides solar drying trays for safer fish processing in Bataan and revitalize the local fishing industry.

Captain Percival Barangay Carlos expressed his gratitude to the DOST for their continued support and pledged to help the recipients maximize the full potential of the drying trays.

"For once, the new drying trays are better than the old ones being used by our beneficiaries. The new drying trays are mostly made of aluminum and plastic, unlike the old, traditional ones, which are made of bamboo," he noted. The Bataan Provincial Science and Technology Office will oversee the implementation of the project, provide technical support, and monitor progress. The program offers a range of affordable rice, including RFA5 (5% broken grains) at ₱45 per kilogram and RFA100 ("Sulit Rice") at kilogram. Public and KADIWA ₱36 per markets centers nationwide are expanding these options to serve more Filipinos.

A beneficiary of the program, May Santos, a single mother from Quezon City, shares, "Sa ₱38 kada kilo ng bigas, mas napagkakasya ko ang budget ko para makabili ng mas maayos na pagkain para sa aking mga anak."

(With rice at ₱38 per kilo, can stretch my budget to provide better meals for my children.)
