WITH EDUCATION ON THE FRONT LINES, LASTING PEACE IS POSSIBLE

Adults' wars have irreversibly altered the lives of over 473 million children worldwide living in conflict zones where the increasing violence severely disrupted access to basic human needs, such as nutritious food and quality education.

In the Philippines, the United Nations International Children's Emergency Fund (UNICEF) reported that around 50,000 children were displaced during the 2017 Marawi siege.

The Heavenly Culture, World Peace, Restoration of Light (HWPL), a Seoul-Non-Government based Organization (NGO) affiliated with the United Department of Nations Communications Global (DGC) and the UN Económic Social Council (ECOSOC) urged the Philippines to support the Declaration of Peace and Cessation of War (DPCW), proposed roadmap towards global sustainable

To strengthen its advocacy, the NGO partnered with the Department of Education (DepEd)'s Kawit Sub-office to make education a cornerstone of peacebuilding by establishing Peace Clubs that are composed of students trained to become active peace advocates.

With DepEd's support, over 8,000 children, along with teachers, parents, and local officials, joined the HWPL Philippines's 11th anniversary of the January 24th Peace Day in Kawit, Cavite aimed at ending wars and armed conflict.

Among them was Jercelle Garcia, a student of Emiliano Tirona National Integrated Memorial High School.

"This activity is very [crucial] because it highlights the importance of communication, not only among us Filipinos, but for the whole world. Through the Peace Walk, we become united in helping efforts to promote world

peace.

Despite her age, Jercelle understood the power of social media in advocating for peace. A simple click of a button can amplify the message of Peace Walk in promoting education as a pathway towards lasting peace.

"Since we are now in the modern age, we can share these [activities] through social media. I can even share this with my classmates, my friends, and my family to help promote lasting world peace because this is what we need now."

In an interview with the Philippine Information Agency-Calabarzon, Brand Chief Manager John Rommel Gaces emphasized **HWPL** Philippines' focus education as a key step toward peacebuilding.

"One of the approaches of HWPL in peacemaking education. peace Education knows no boundaries regardless of your religion, political anď views. economic background-we all need education. Now, working with DepEd Kawit to inculcate into the hearts and minds of kids how important peace is as our future leaders.'

Gaces added, "The ones who declare war are not the youth. But the ones who go to war, and eventually die are the young people. That's why it falls to them to call for peace."

School DepEd Cavite's Operations Governance chief Diana Division Topacio, PhD, emphasized that rapid globalization collective necessitates solutions to armed conflict. "We are living in a world increasingly is interconnected, and our differences should not divide us. The challenges we face from climate change to armed conflict demand collective solutions. Peace is not a one-nation endeavor, it's a global mission," she added.

With the theme "Honoring our heritage, uniting for global peace: Empowering the youth to champion the DPCW towards a war-free world", Peace Day calls for the youth to become champions of the DPCW and its bid towards peace. (PB/PIA4A)

The Philippine Statistics Authority Regional Statistical Services Office IV-A successfully hosted an awarding ceremony for the Local Civil Registry Offices (LCRO) in CALABARZON on February 11, 2025, at Jet Hotel, Lipa City, Batangas, recognizing their vital contributions in ensuring efficient. accurate, and timely civil registration services.

The event, attended by the key officials of the PSA RSSO IV-A and invited LCROs in the region, underscores the role of the LCROs in maintaining the integrity of public records and systematically recording vital events such as births, deaths, marriages, and other life events, ensuring legal identity, access to rights and services, and reliable demographic data for governance and policy-

SKorea donates 4K MT of rice to Kristine-hit families in Laurel

LAUREL, Batangas (PIA) – At least 1,500 residents from Laurel, Batangas, who were affected by Severe Tropical Storm Kristine (Trami) in October 2024, received food aid from the Republic of Korea's Ministry of Agriculture, Food and Rural Affairs (ROK-MAFRA).

Agriculture Secretary Francisco Tiu-Laurel Jr. joined South Korean Ambassador to the Philippines Lee Sang-hwa in a turnover ceremony on Monday, Feb. 3, where 100 beneficiaries received a portion of the donated 4,000 metric tons of milled rice.

From October 25 to 26, 2024, Kristine brought significant damage to Calabarzon. The Office of Civil Defense reported that around 502 families or 1,753 individuals in Laurel were directly affected by the storm.

According to the Agriculture department, 50,000 families from Regions 1 to 5, who were affected by Storm Kristine, will receive portions of the donated rice as part of the Tier 3 program of the ASEAN Plus Three Emergency Rice Reserve (APTERR).

Aimed to ensure food security in the ASEAN+3 region, APTERR aims to strengthen food security, poverty alleviation program, and eradicate malnutrition among its members without distorting normal trade markets.

In his message, Tiu-Laurel thanked ROK-MAFRA for its assistance to the

families affected by STS Kristine, who are rebuilding their lives after the calamity. "This gift of rice from the government of Korea is certainly welcome and provides timely assistance to the Philippine government in its efforts to provide aid to calamity-affected provinces," Tiu-Laurel said.

Larry Lacson, National Food Authority (NFA) administrator, said they will work with the Department of Social Welfare and Development (DSWD) to evenly distribute the donated rice in the affected local government units.

"As approved by the NFA council, the rice will be distributed to the affected communities of severe tropical storm "Kristine" or internationally called "Trami" in regions I to V, to be led by the DSWD in coordination with the concerned local government units."

For Tiu-Laurel and Batangas Mayor Lyndon Bruce, the initiative highlights the spirit of cooperation and solidarity among ASEAN members in ensuring food security, especially during times of need.

"We extend our deepest gratitude to the Republic of Korea for this generous support, which will greatly benefit our communities. May this partnership continue to strengthen, ensuring that no Filipino goes hungry, and our nations remain resilient in times of crisis." (PB-PIA4A/DA-AFID)

Mobile app gives users glimpse of agri-tourism sites in Calabarzon

CALAMBA CITY, Laguna (PIA) – The Department of Agriculture's Agriculture Training Institute seeks to boost agritourism in Calabarzon through Agri 360, a web-based virtual map of its Learning Sites for Agriculture (LSA).

Eleazar Abestado, one of the developers of Agri 360, stated that the platform will enhance access to LSAs in the region to better promote agritourism and agricultural technologies.

"This will be a graphical representation of the LSAs in the region. It includes a list of all LSAs in each province, as well as their address and contact details so our netizens can get familiar with our sites. [More importantly] We also included the awards and recognition they received," Abestado said.

Launched on Feb. 3 during the ATI CALABARZON's 38th anniversary, Agri 360 is an extension project offering LSAs and Private Agriculture and Fisheries Extension Service Providers (PAF-ESPs) in the region.

Developed as a tool for promoting agritourism, Agri 360 serves as a technology demonstration hub. It showcases the best practices and technology adopted by LSAs, attracting visitors, raising public awareness, and boosting farm revenues through tourism and product sales.

The program also features a 360-degree view of farms, their facilities, and the technologies used. It also provides directions via private and public transportation,

improving accessibility to vital resources and support for farmers. The ATI IV-A is compiling data

on each LSA in the region, including addresses and photos for inclusion in the virtual map. However, Agri 360 will go further by offering virtual tours to showcase all the farming technologies in use.

"We are also comparing their information with what is already available online to confirm its accuracy. We conduct site visits using apps like Google Maps to verify this accuracy. Once we establish their accuracy, we use these addresses on our platform. If not, we ask the owners to update their farm's address." ATI has already incorporated at learning. Sites for

seven Learning Sites for Agriculture in the region, with more sites to be added in the coming months.

"A bulk of our development

"A bulk of our development comes with shooting photos and videos for the virtual tours of the farms. We hope that LSA owners can assist in this aspect, because it will be a big help in website development," Abestado explained.

"We need the data to be complete before we can integrate them into an app. We know that updating the platform, especially the virtual tours, needs to be quick because LSAs are adopting new technology rapidly," he added.

Abestado said an application may be developed once necessary data for the Agri 360 website is completed. (PB/PIA 4A)

Rice to cost P49 per kilo by March 1 – DA

Commercial rice prices are projected to drop to PhP49 per kilo by March 1, Agriculture Secretary Francisco Tiu Laurel announced on Monday.

New stocks of rice are expected to arrive from Myanmar, or Vietnam, Cambodia, Laurel said during a Palace press briefing. He stressed that the Department of Agriculture had discussions with rice importers, traders, and retailers, conveying its request for them to reduce rice prices to more reasonable levels.

The current Manufacturer's Suggested Retail Price (MSRP) is PhP55 per kilo, following the DA's approval to allow the disposal of old stocks.

"By February 15 ngayon, ang MSRP natin will be PhP52. By March 1, hopefully nakabili na sila ng bagong stocks mula sa Vietnam or Myanmar or Cambodia na mas mura, kaya ang MSRP natin by March 1 is PhP49," Laurel said.

"Iyong mga premium five percent broken na rice na dating PhP64, dapat iyan ay bumaba iyan ng PhP49 by March 1 as MSRP."

Laurel said the reason for the drop in prices is twofold. One factor is that traders and retailers are responding

In June of last year, President Ferdinand R. Marcos Jr. issued EO 62, which modified the nomenclature and tariff rates on various products to ensure a continuous supply of goods and to protect the purchasing power of the Filipino people.

Laurel said the government's target price for triggering an adjustment in the rice tariff would be between PhP 42 and PhP 45 per kilo.

"Puwede ng i-review at i-recommend for restoration or maybe not a full restoration, it can be from 15 to 20 or 15 to 25 or full 35 (percent). Depende na sa sitwasyon. Depende sa consultations with everybody," Laurel said.

PBBM: SUSTAIN POSITIVE IMPACT ON CONSTITUENTS EVEN BEYOND TERMS

President Ferdinand R. Marcos Jr. on Wednesday urged elected officials to maintain a positive impact on their constituents even after their terms have ended.

President Marcos made the call during the End-Term General Assembly of the League of Municipalities of the Philippines (LMP) at the Manila Hotel.

"Today we are convened here as leaders and public servants who have dedicated our years and, in many cases our lives, to civil service. For many of us, this is a calling and it is a lifelong commitment to serve our people," the President told thousands of local leaders at the meeting.

the meeting. The President acknowledged municipal mayors as essential first responders in governance, stressing their role in connecting people with the national government, especially during critical times. "Our municipal mayors, you are the frontlines of governance. You are the first to hear the concerns of our people, the first to act on their needs, and the first to bear the weight of their expectations."

the President said. He reflected on his

He reflected on his journey as a public servant, from being a local official to becoming a senator and President.

"Public service has defined much of my life. I have had the privilege of serving in various capacities—as a legislator, as a governor, and now as President," he said. "

"Throughout these years, one thing has remained constant: The challenges before us are always great, but the opportunity to create lasting change is even greater."

The President said that more local government units (LGUs) could achieve the highest standards due to initiatives introduced by municipal mayors in assessing financial sustainability under the Seal of Good Local Governance.

In 2024, the number of local government units (LGUs) increased from 493 to 714. The President called this growth "a clear sign that more local governments are enhancing fiscal discipline and transparency."

the President cited the contributions of local officials in streamlining and digitizing bureaucracy through the Electronic Business One-Stop Shop (eBOSS).

Already, 113 LGUs have complied, and 1,203 others initiated automation efforts to enhance their transactions in 2024, he said.

The government developed the eLGU as a ready-to-use eBOSS platform, which was adopted by 741 LGUs in the same year.

During the assembly, the President spoke about the Kalinga at Inisyatiba Para sa Malinis na Bayan (KALINISAN) sa Bagong Pilipinas Program, which involves over 22,000 barangays participating in regular cleaning activities.

The President expressed hopes that local public officials will continue to adopt and sustain the national government reforms even after their tenure.

He urged the municipal mayors to strengthen their partnership beyond their terms of office so that governance continues to foster prosperity and public service endures.

PBBM's foreign visits yield 200k jobs, 'more' benefits for Pinoys

The foreign visits of President Ferdinand R. Marcos Jr. generated more than 200,000 jobs for Filipinos, Department of Labor and Employment (DOLE) Secretary Bienvenido Laguesma said Monday.

Laguesma said power, renewable energy, and electronics manufacturing were the first sectors to create jobs.

He mentioned that approximately 201 investment-led projects were valued at over US\$76 billion, or PhP4 trillion, all generated from the President's trips abroad since he took office.

The Labor chief assured the government that it would take decisive action to secure more investments and create additional employment opportunities. 'Nagtutuloy-tuloy po, siguro hindi lamang masasabi natin na instant, nandidiyan na dahil nga may proseso na dinadaan. Pero given the instruction na follow-through these commitments, we will be able to know what actually would make them really put in the promised investment para makalikha ng karagdagang trabaho, Laguesma said.

Last month, DOLE held a job fair with JobStreet,

attended by approximately 18,000 job seekers, including fresh graduates and experienced professionals.

According the to National Economic and Authority Development Philippine (NEDA), the market labor concluded stable 2024 with employment rate enhanced job quality

The Philippine Statistics Authority (PSA) reported a 3.1 percent unemployment rate in December 2024, consistent with last year's figure.

On the other hand, the underemployment rate decreased to 10.9 percent from 11.9 percent in December 2023, indicating improved job quality and fewer workers seeking additional jobs.

In the same month, the labor force participation rate (LFPR) stood at 65.1 percent, a decrease from 66.6 percent in December 2023.

The youth LFPR decreased to 31.9 percent from 34.5 percent due to schooling and training. Female labor force participation also fell to 54.7 percent from 56.3 percent, as more women cite household responsibilities as a barrier to employment. | PND
