DOJ files charges vs. online child sellers in Cavite

MANILA – The Department of Justice (DOJ) on Monday said it has filed qualified trafficking and child exploitation charges against members of a criminal syndicate selling babies online.

In its five-page resolution, the DOJ Task Force on Women and Children and Against Trafficking in Persons said the charges were filed against Arjay Malabanan and Ma. Chariza Dizon before the Manila Regional Trial Court.

charges stemmed from a complaint filed by Philippine National Police-Women and Children Protection Center (PNP-WCPC) before the DOJ against Malabanan and Dizon, based on the information reported by the National Authority for Child Care regarding a "black market" in social media groups/communities where aspiring parents seek to illegally adopt children.

An entrapment operation conducted by the PNP-WCPC at the Immaculate Conception Church in Dasmariñas City, Cavite on May 15 yielded "Kuy's Jay," who later turned out to be Malabanan, offering to sell a newborn for PHP90,000 to undercover law enforcers.

Malabanan, a resident of Bacoor, Cavite, is an employeeoftheDasmariñas local government.

Dizon, a resident of Tondo, Manila, is the mother of the rescued male 8-day-old.

"Evidence adduced sufficiently established the crime of qualified trafficking; respondents facilitated the adoption of the newborn baby;

DPWH on track with key Calabarzon infra projects

CALAMBA CITY, Laguna – The Department of Public Works and Highways (DPWH) in Region 4A (Calabarzon) is on track with projects aimed at easing traffic congestion and enhancing road access to various parts of the region under the Marcos administration's Build Better More program. During the "Kapihan sa Bagong Pilipinas" media forum DPWH-4A Regional

forum, DPWH-4A Regional Director Jovel Mendoza said the rehabilitation of the portion of Maharlika Highway within their jurisdiction, which spans 231 kilometers from Calamba City to Tagkawayan in Quezon, is being diligently pursued by the incumbent administration. "Maharlika Highway is the major thoroughfare of motorists (travelling) from Calamba City to Tagkawayan, Quezon in the region... linking Bicol up to Visayas and Mindanao," he told reporters during the forum that took place at the DPWH regional office in this city.

The DPWH official did not specify the target completion date of the highway rehabilitation project but called it "a top priority."

Ferdinand R.

President Ferdinand R. Marcos Jr. last week said the reconstruction of this key highway has been ongoing for 12 years, but this is the only government that has put serious attention to its completion.

"All those rehabilitations, you know, we only really started two years ago. Because nothing was done in the previous administration, nothing was done in the administration before that," Marcos said about his administration's infrastructure initiatives.

Meanwhile. Mendoza also

underscored the significance of the South Luzon Expressway TR4, a 48-kilometer bypass road from Santo Tomas in Batangas to Lucena City, Quezon, which is envisioned to alleviate congestion in San Pablo City.

This ongoing infrastructure intended project is significantly reduce travel time in the region from four hours to one hour, making it a more convenient alternative to the congested Daang Maharlika. Barring any unforeseen delays, the road is expected to be partially passable by 2025. In Cavite, Mendoza said the 40-kilometer East Lateral Road from Aguinaldo Highway to Nasugbu, Batangas, once complete, will ease traffic in Tagaytay City, particularly on weekends when tourist traffic peaks.

Additionally, the flyover in Mendez town, Cavite, is expected to alleviate congestion at the Mendez junction leading to Nasugbu, Batangas.

Mendoza also highlighted the construction of a 1.42kilometer bridge linking Lopez in the mainland to Perez in Alabat Island, providing a faster alternative to boat or barge travel.

"This locally funded project enhances connectivity to remote areas," Mendoza said. LGU Clarin, PRRI, & DOST empowers Subanen farmers in rubber latex harvesting

The Department of Science and Technology - X (DOST - X), in collaboration with the Philippine Rubber Research Institute (PRRI), trained 25 indigenous Subanen farmers in rubber latex harvesting on April 3-4, 2024, Penacio, Clarin, Misamis Occidental. The training dubbed Skills Training in Rubber Latex Harvesting was designed to empower Subanen farmers with knowledge and skills to utilize their abundant rubber trees grown in the area.

The training is a project of DOST's Community Empowermentthrough Science and Technology (CEST) program, that aims to provide livelihood and alleviate poverty in remote communities.

The training initiative received support from LGU Clarin throughits Municipal Agriculture

Office, underscoring the importance of collaborative efforts in empowering local communities.

"Nagpasalamat mi'g dako nga na-training mi aron makatuon mi sa pagsanggot sa among rubber," said Leonard Somoson, barangay kagawad and training participant.

(We are very grateful that we were trained to learn how to tap our rubber [trees].)

The two-day training commenced with a pretest assessing the baseline knowledge of farmer participants in rubber latex harvesting.

Following this, PRRI staff
Jenepher Bade delivered
a comprehensive lecture,
providing insights into the
historical context of the rubber
industry in the Philippines,
alongside recommending
effective techniques for rubber

latex harvesting. This was complemented by a tapping demonstration conducted by Gilbert Rance of PRRI, offering participants handson experience in the proper tapping method.

On the second day, participants underwent assessments to evaluate their proficiency in rubber tapping, enabling facilitators to identify top performers within the group. Subsequently, a posttest revealed a significant enhancement in participants' understanding of rubber latex harvesting, validating the effectiveness of the training program.

To ensure that the farmers are well-equipped in their livelihood, DOST – X provided the participants with essential farming tools such as tapping knives, plastic buckets, boots,

gloves, and other materials to facilitate the harvesting process.

Mely Mintang, president of the Penacio Peglakanangan Enterprise, the farmers association conveved their gratitude for the training and affirmed their commitment to immediately commence tapping activities on their individual plantations, plans to sell the harvested latex to a consolidator in the province. The association further pledged to sustain livelihood the newfound opportunity.

DOST also recently allocated project funding to LGU Clarin for the upgrading of the Subanen farmers' abaca fiber processing, further enhancing livelihood opportunities in the area. (Ella B. Nadela, DOST Misamis Occidental)

OHSUD CITES PRIVATE SECTOR'S 'GROWING' CONFIDENCE IN HOUSING PROGRAM

MANILA – The Department of Human Settlements and Urban Development (DHSUD) has observed the private sector's "growing confidence" in the administration's flagship Pambansang Pabahay para sa Pilipino Program (4PH).

DHSUD Secretary Jose Rizalino Acuzar said the entry of Megawide Construction Corporation to the 4PH project in Imus City, Cavite is an example of such confidence in the government's housing program.

"Nakakataba ng puso ang tiwalang nakukuha ng 4PH sa ating pribadong sektor (The trust that the 4PH gets from the private sector is overwhelming). This clearly shows that we are on the right track in addressing the country's housing need," he said in a news release Thursday.

Acuzar and Megawide CEO Edgar Saavedra joined Imus City Mayor Alex Advincula at the groundbreaking ceremony of a 4PH project in Barangay Malagasang 1-G last May 28. The project is composed of midrise condominium buildings and will be developed by PH1 World Developers (PH1WD) – Megawide's real estate arm.

Afive-tower mid-rise residential community with 1,100 units is set to rise inside a 1.7-hectare property.

It will be located at the center of one of Cavite's districts, 400 meters from the New Imus City Hall.

Megawide's said Acuzar participation would "significantly contribute" to the government's objective of addressing the country's housing providina need. **Filipinos** safe. decent and affordable housing in

sustainable communities. He said cooperation between and among the DHSUD, private sector and local government units is key in resolving the backlog in housing projects.

BIR requirement to submit appointment books violation of privacy – SC

MANILA - The Supreme Court (SC) has invalidated a regulation from the Bureau of Internal Revenue (BIR) that requires self-employed professionals to submit their rates and register appointment books to monitor their tax compliance, according to a news release on Friday.

In a decision penned by Senior Associate Justice Marvic Leonen, the Supreme Court en banc declared void portions of Section 2(1) and 2(2) of BIR Revenue Regulation (RR) No. 4-2014, or the Guidelines and Policies for the Monitoring of Service Fees of Professionals, for violating the right to privacy of professionals and their clients

Issued on March 3, 2014, RR No. 4-2014 required all self-employed professionals to submit an affidavit indicating the rates, manner of billing, and the factors that they consider in determining service fees; register their books of account appointment books containing the names of their clients, and their meeting date and time: and issue a BIRregistered receipt showing the 100 percent discount for pro bono cases, in cases where no professional fees are charged by the professional and paid by the client.

On April 22, 2014, the Court issued a temporary

restraining order prohibiting the implementation of RR No. 4-2014 following several petitions filed by professional associations, who likewise prayed that the BIR regulation be struck down as unconstitutional.

In partially granting the present consolidated petitions, the SC ruled that the portions of Section 2(1) and 2(2) of RR No. 4-2014 which require professionals to submit a schedule of fees and register their appointment books were invalid

It also permanently enjoined the Department of Finance and the BIR from implementing these provisions.

On the requirement to submit a schedule of fees, the Court found this exceeded the BIR's authority for being irrelevant in its primary duty of assessment and collection of tax due.

and collection of tax due.
While the BIR may collect information, this is limited to concluded transactions, which are taxable services. The required affidavit of schedule of fees, however, is only indicative and does not bind professionals, who can ultimately charge higher or lower.

For lawyers in particular, Canon 20 of the then Code of Professional Responsibility already lists the factors in determining their professional fees. The present Code of Professional Responsibility and Accountability likewise provides the same in Canon III, Section 41.

On the requirement to register appointment books, the Court found this violated the privacy rights of professionals and their clients.

Under the constitution, the privacy of communication and correspondence is inviolable, except upon court order or as required by law for public safety and order.

The Court emphasized that

The Court emphasized that individuals have a reasonable expectation of privacy when scheduling appointments with professionals

professionals.
When considered individually, names and appointment dates may seem harmless. However, compiling all the times a person consults with a professional could reveal a pattern of behavior. This pattern could potentially disclose private information or lead to inferences that should

have remained confidential.

"It is this pattern of behavior, which can be extracted from the appointment book, that a person has a reasonable expectation of privacy over and which must be protected," stressed the Court.

Further, such a requirement violates the ethical standards of professionals bound by strict rules of confidentiality between the professional and the client.

The Court however upheld the requirement to register books of accounts for falling within the scope of the BIR's authority under the Tax Code to monitor the fees charged by professionals in assessing taxable income.

Likewise upheld was the

Likewise upheld was the requirement to issue receipts for pro bono services, which neither raises ethical concerns nor equates to regulating the practice of the legal profession, a power that belongs exclusively to the Court.

The Court held this was a valid tax measure that the BIR may employ to ascertain the correct amount of taxes payable by self-employed professionals. (PR)

DA-Calabarzon seeks media help in disseminating info on programs

LIPA CITY, Batangas – The Department of Agriculture in Calabarzon on Friday called on journalists to help in the effective information dissemination and successful implementation of the Marcos administration's livelihood programs for farmers and fisherfolk.

In a media conference, Jayvee Ergino, Regional Agriculture and Fisheries Information Section (RAFIS) officer in charge, said the press gives credibility and builds public trust in the delivery of services in the region.

"We cannot afford not having media partners because we have five provinces in the region [Cavite, Laguna, Batangas, Rizal, and Quezon]. It enables us to extend our programs and gives validation to the public as we cater to their needs," he said.

He said the influence of the media makes the delivery of their programs easier among its target beneficiaries.

Amid the era of disinformation, misinformation, and malinformation, mediapartners play an interconnected role to center on the prime issues the agriculture sector is facing, he

said.

Ergino said.

He said there has been little coverage about agriculture

statistics and the reasons behind changes in the production numbers of certain agricultural products.

Citing a report by the Philippine Statistics Authority (PSA), he noted that in 2023, there was a marked drop in the regional production of eggplant, ampalaya, string beans, chayote, black pepper, banana, calamansi, and sweet potato.

The series of storms and the EI Niño phenomenon were the primary reasons for this decrease in production, he said.

Despite performance dips, however, Ergino said the region is still the leading producer of squash in the country, 2nd in ampalaya, 3rd in eggplant, and 4th in tomato.

Among the strategies lined up this year to increase local production includes year-round year-round production of quality and safe products with identified markets, continued clustering and farm consolidation approach, modernization/digitalization, and diversification and climate resilient practices, among others.

Meanwhile, Ergino reminded the public that the DA regional office here continues to hold the Kadiwa ng Pangulo bazaar every Monday, Wednesday and Friday.

Kadiwa ng Pangulo is a DA-led marketing initiative to establish a direct farm-to-consumer food supply *chain.* (*PNA*)


