Legarda calls for Senate inquiry on reported violence against Non-Moro Indigenous Peoples (NMIPs) in BARMM

on Monday filed proposed Senate Resolution No. 1329, calling for a Senate inquiry into the situation and security of Non-Moro Indigenous Peoples (NMIPs) in the Bangsamoro Autonomous Region Muslim in (BARMM) Mindanao following reports of killings and acts of violence against these communities.

The move comes in the wake of the brutal killing Teduray-Lambangian of tribal chieftain Fernando Promboy, whose beheaded body was found near a water reservoir in Maguindanao del Sur on 19 February 2025. Promboy was a respected community leader known for his firm stance against armed encroachments on ancestral lands.

Timuay Justice and Governance (TJG) and Climate Conflict Action (CCAA) have documented at least 84 NMIP killings from 2014 to 2024, including 12 leaders. seven youth, and eight women.

Meanwhile, the Police Regional Office Bangsamoro Autonomous Region (PRO-BAR) recorded 36 NMIP killings during the same period. The Commission on Human Rights, in its 2024 Situation Report, cited 65 males, seven females. and seven youth victims between 2018 and 2024. "These significant discrepancies among the records highlight the urgent need for independent validation, comprehensive investigation, and protection reinforced measures to hold perpetrators accountable while safeguarding NMIPs from further risks, threats, endangerment, and violence," Legarda stated. The resolution directs the Senate to assess the full range of challenges faced

Senator Loren Legarda by NMIPs in BARMM, including barriers to accessing justice, the adequacy of existing protection programs, and the urgent need for strengthened legal and policy interventions that ensure the full inclusion of NMIPs in the peace and development agenda of both the Bangsamoro region and the broader national framework.

On 10 December 2024, the Bangsamoro Transition Authority (BTA) passed Bangsamoro Autonomy Act No. 64, or Bangsamoro Indigenous Peoples' Act of 2024, making it the sixth of the seven priority codes to be enacted. Legarda emphasized that the code implemented must be effectively, with clear operational mechanisms that prioritize the protection of the rights and safety of NMIPs.

"Beyond ensuring accountability for specific incidents of violence, there is a pressing need to reinforce the rule of law and establish clear, enforceable mechanisms that safeguard the rights and security of NMIPs exacerbating without or exposing tensions communities to further vulnerabilities," Legarda added.

Legarda is widely recognized as a long-time champion of indigenous peoples' rights. She authored and sponsored landmark legislation, the National including Cultural Heritage Act of 2009 (RA 10066), Cultural Mapping Law (RA 11961), National Indigenous Peoples Day (RA 10689), and the Integrated History Act of 2016 (RA 10908). Through her advocacy, she has been strongly Schools of supporting Living Traditions (SLTs), community-based centers that safeguard and transmit traditional knowledge and practices.

As former Chair of the Senate Committee on Communities. Cultural Legarda convened regional consultations and led the First National Indigenous Cultural Summit. creating vital spaces for dialogue between policymakers and Indigenous leaders. She has also brought indigenous heritage into the national and global spotlight through initiatives such as the National Arts and Crafts Fair and Hibla ng Lahing Filipino, which open opportunities for indigenous artisans to

share their work and stories with broader audiences. Her decades-long advocacy has earned her deep respect among indigenous cultural communities across the country, conferring her honorific titles such as "Bae Matumpis" or "the one who takes care" in Mindanao, "Cuyong Adlaw Dulpa-an Labaw sa Kadunggan" or "shining sun rising in power" by the Panay-Bukidnon in Visayas, and "Tukwifi" or "bright star" by the Cordillera Indigenous Elected Women Leaders' League.

DA chief inaugurates P60M Rosales Agricultural Trading Center

ROSALES. Pangasinan (March 25, 2025)—Agriculture Secretary Francisco P. Tiu Laurel Jr. on Tuesday led the inauguration of the Rosales Agricultural Trading Center, a P60-million project aimed at enhancing the profitability of farmers and agricultural cooperatives by transforming them into trade-focused. empowered individuals.

Located on an 8,000-squaremeter lot donated by Rep. Robert Raymund Estrella, the project began in November 2023, shortly after Secretary Laurel took charge of the Department of Agriculture. It was developed in cooperation with the local government unit of Rosales, led by Mayor William Cezar.

The trading center, funded through the Enhanced KADIWA Inclusive Food Supply Chain Program, will also feature a training facility designed to introduce farmers to new technologies and teach them how to become successful agricultural entrepreneurs.

"This initiative will not only boost farmers' productivity but also create new income opportunities and foster job creation throughout the supply chain in Rosales and surrounding areas," said Secretary Tiu Laurel. "Bv strengthening agricultural trade and education, this project plays a crucial role in developing a more sustainable and economically resilient farming sector, while ensuring a steady food supply for local communities."

The trading hub, Secretary Tiu Laurel said during the inauguration, will serve as a prototype for similar facilities that the Department of Agriculture plans to establish in other parts of Pangasinan,

benefiting both farmers and consumers. He also mentioned plans to build a solar-powered cold storage facility next to the Rosales trading hub, aimed at extending the shelf life of fresh produce, particularly highvalue crops.

Additionally, the DA chief revealed plans to construct a rice drying facility in Rosales, which will be situated on land donated by Mayor Cezar.

Pangasinan is one of the top 10 rice-producing provinces in the country.

Secretary Tiu Laurel further stated that a mobile soil laboratory would be deployed in July to test soil conditions across the province. This initiative aims to determine the best use of the land and identify the necessary inputs to optimize farm yields and boost farmers' incomes.

Despite the rise of commercial centers and other businesses, Rosales' economy remains primarily driven by agriculture. However, local farmers continue to face challenges, including high credit rates, expensive farm inputs, and low selling prices. In addition, unscrupulous traders exploit the lack of an efficient marketing system, inadequate infrastructure, financial limitations, and inconsistent policies.

The Rosales Agricultural Trading Center aims to these address issues by providing farmers with a direct market for their bulk produce, eliminating unnecessary and ultimately middlemen, increasing their profitability.

"We believe this trading center will serve as a catalyst to reshape the future of our farmers, empowering them to become successful agripreneurs." Secretary Tiu Laurel added

DOST pushes for expansion of scholarship programs

LOS BAÑOS, Laguna (PIA) - The Department of Science and Technology (DOST) Calabarzon in that believes the department's scholarship programs can be expanded further to provide additional services and benefits for their scholars.

DOST Quezon provincial director Maria Esperanza Jawili acknowledges the wide implementation of the program, but she believes that it can be further expanded to cater to more deserving students.

"The DOST scholarship programs are already wideranging. However, they still need to be expanded because we see that there are even greater benefits that our current and future scholars can receive through this program."

Jawili cites the positive effects of providing educational support to students who come from poor families in further developing their livelihoods. "[DOST scholarship] is a big help because it supports many children, especially those from poor families, in overcoming poverty. We believe that if at least one child in a family can graduate from college, it will already be a significant help to the family. Especially if the applicants or children are truly intelligent," the director adds.

Some students, however, still find it hard to complete their requirements on time. The science department made note of this and adjusted their processes.

"There limitations are when it comes to the documentary requirements of our students [and] those issues are gradually being addressed. Students are now allowed to take the exam even if they still lack some requirements. What the DOST-SCI and the DOST system are doing is allowing them to take the exam first, and if they passed, that's when we require them to submit the necessary documents to qualify as awardees."

Data released by DOST Calabarzon said that there are 4,071 scholars under the Republic Act No. 7687 or the Science and

Technology Scholarship Act of 1994; 2,755 scholars under the Republic Act No. 2067 or the DOST-SEI Merit Scholarship Program; and 177 scholars under the Republic Act No. 10612 or the Fast-Tracked S&T Scholarship Act of 2013.

The scholarship programs of DOST aim to encourage Filipino youths to pursue productive careers in science and technology including basic sciences, engineering, other applied sciences, and science and mathematics teaching.

After graduation, scholars are obligated to stay in the Philippines and work in science and technology sectors to ensure a steady, adequate supply of qualified S&T human resources which can steer the country towards improved competency and national progress. (CH/ PIA-Laguna)

Dr. Nancy Bantog, regional director of the DOST-CAR, said during the Kapihan sa Bagong Pilipinas forum on Tuesday that the SWEET PH project is not just ensuring a good prospect for Cordillera's cacao industry but also a market for the farmers' raw materials.

She said, "Farmers are encouraged to produce especially if they know they have a market for their products and we are happy with Dulche as a sure market who will also make our region known for its chocolates."

She said cacao is one of the collaboration products in the region with different agencies accessing their resources to help in growing the industry.

Ritchelle said that "with many people at my back ensuring the raw materials and the government for my further development, I am confident that we will make a mark in the chocolate industry produced by Igorot hands." With an increasing supply

of raw materials, Ritchelle said that aside from the international market, hotels in Baguio City are also ordering "chocobites" as an offering at their buffet tables.

"Income-wise, mas malaki kasi maraming production, maraming raw materials na naibebenta ng cacao growers at job generation na din (Better in terms of income because of the volume of production aside from income for the cacao growers and the jobs generated by the industry),' she said while refusing to give actual amount.

62 Central Luzon MSMEs receive assistance from DOST

CITY OF SAN FERNANDO, Pampanga (PIA) - A total of 62 micro, small, and medium enterprises (MSMEs) in Central Luzon received P67.8 million in assistance through the Small Enterprise Technology Upgrading Program (SETUP) of the Department of Science and Technology (DOST) in 2024. SETUP

aims to enhance productivity and the competitiveness of MSMEs, particularly in rural areas, by providing technology transfer training, consultancy, product testing, packaging support, and funding via the Innovation-Enabling Fund or iFund.

During the sixth episode of the Kapihan sa Bagong Pilipinas of the Philippine Information Agency for 2025 **DOST Regional Director Julius** Caesar Sicat highlighted that SETUP has been the agency's flagship initiative for over a decade.

"It is very critical in terms of pushing for socio-economic development in Central Luzon. As we know. Central Luzon is among the top three in terms of contribution to the gross domestic product. And our department cannot stop creating technologies. and systems, programs assistance to ensure of the continuous success of entrepreneurs in Central Luzon in terms of the manufacturing sector," he said.

Sicat clarified, however, that SETUP is a government assistance program that is not free, as beneficiaries are expected to repay what they receive within a span of three vears.

With this scheme in place, the agency has reported a repayment rate of 92 to 93 percent in the region. Our beneficiaries of the SETUP program - these are real businessmen who understand business and know their responsibility, which is why the repayment rate is very high. This is a program that DOST is very proud of because aside from providing much-needed support to our MSMEs, the funds extended by the government to them are being returned to the National Treasury," he added.

According to DOST, eligible applicants include any company or individual firm based in the Philippines and Filipino wholly owned by citizens.

The National Food Authority (NFA), a government agency under the Department of Agriculture, made significant strides in 2024, achieving its highest rice buffer stocks years, improving its in operations, and significantly reducing its deficit despite facing challenges stemming from a leadership change and an ongoing Ombudsman investigation.

In the wake of an Ombudsman probe that resulted in the suspension of 139 NFA and employees, officials the agency struggled to compete with private rice traders in purchasing palay. However, the NFA Council, led by Agriculture Secretary Francisco P. Tiu Laurel Jr., appointed Larry Lacson as the new NFA administrator and raised the procurement price for palay from a range of P16 to P23 per kilo to P17 to P30 per kilo. This decision was pivotal in attracting more rice farmers to sell their produce to NFA, setting the stage for a dramatic increase in buffer stocks

As of February 2025, NFA's total palay inventory stood at 399,701 metric tons (nearly 8 million bags), sufficient to cover eight days of supply. This marked a significant improvement from just one day of buffer stock prior to Administrator Lacson's leadership.

In addition to the buffer stock boost, NFA undertook measures to modernize its supply chain. A key component this modernization is of the Masagana Agri-Food Infrastructure Modernization (MAFIM), Program multibillion-peso nationwide initiative to build new postharvest facilities. MAFIM is expected to

NFA boosts rice buffer stocks, cuts deficit in 2024 amid challenges minimize annual wastage by approximately P10 billion, benefiting both farmers and consumers. MAFIM is part of the legacy project of President Ferdinand Marcos, Jr and

Sec. Tiu Laurel. On the financial front, NFA successfully avoided an estimated P631 million in expenses in 2024 through strategic measures, including the incorporation of the

Incentive Buffer Stock (BSI) for farmers under the PRICERS program. The agency also implemented a "less movement" policy for rice stocks, reducing logistical costs and saving an additional P172.3 million. These costcutting measures helped reduce NFA's deficit, which dropped from P6.097 billion in 2023 to P3.753 billion in 2024. The NFA also focused on strengthening its workforce, 543 personnel with appointments signed as part of an ongoing restructuring. These appointments aim to improve employee morale, and productivity, overall efficiency.

Regulatory reforms introduced by NFA further streamlined operations. A fast-lane service for small farmers selling fewer than 50 bags of palay reduced waiting times, while the agency eliminated the rebagging of 20 percent of its total palay procurement, which is expected to save around P215.4 million in operational costs in the coming year.

NFA plans to procure 90 new trucks in 2025, with an additional 150 trucks scheduled for 2026. These efforts will help address logistical challenges and ensure that farmers, including those in remote areas, have the opportunity to sell their produce to NFA.

GOV'T COUNTERING CYBERATTACKS AGAINST FINANCIAL INSTITUTIONS

The government is taking proactive measures combat the rise in to against the cyberattacks country's financial institutions Presidential Communications Undersecretary and Palace Press Officer Claire Castro said on Thursday.

Castro reassured the public that the government would raise awareness about the PhP528 billion in losses financial institutions incurred from cyberattacks in 2024, representing a 2.6-percent increase from the PhP526 billion reported in 2023.

Castro said that as cybercrime tactics evolve. the government's efforts and regulations must also be updated to counteract cyber threats effectively.

"Kasi po nag-e-evolve po talaga ang paggawa ng krimen. So, kailangan din po ang mga proyekto natin, iyong ating mga panuntunan dito ay dapat nag-a-upgrade din po,' she said.

Castro requested that banks and financial institutions revise their internal policies on online transactions and operations to protect against potential cyberattacks.

De Castro cited Social Weather Stations research indicating Filipinos manv struggle to identify legitimate news, a concern she linked directly to national security interests in disputed waters.

"There are groups using fake news to confuse the public and weaken our position." she said. "We should not simply believe everything we read or see, especially on social media.

The PIA chief highlighted recent similar forums held at other state universities across Luzon, including Cagayan State University, Tarlac State University, and recent visits to Sorsogon and Legazpi. She called for strengthening existing legislation like the Prevention Cvbercrime and implementing Act international standards for content moderation on social

corruption within the agency, instructing NFA's legal office to file administrative and criminal cases against erring officials. "We are committed to restoring public trust and transparency, he said.

However, Secretary Tiu Laurel stressed the need to restore some of NFA's powers to more effectively manage the rice market. "We simply cannot fight these battles with one hand tied behind our backs. We need to restore NFA's powers to regulate rice retail and manage stocks more effectively," he said. Despite the amendment of the Rice Tariffication Law, NFA is still from restricted importing grains to boost stocks or directly selling rice to the public.

Looking ahead, NFA plans to purchase around 880,000 metric tons of palay in 2025 to meet the higher buffer stock requirement of 555,000 metric tons, which would cover 15 days of national rice consumption in the event of emergencies.
