PAPI PRES. SANTOS: 'MALUPIT AT WALANG SENSE NA WAKAS, HINDI DESERVE NI DAYANG'

ITO ang pananaw ni Publishers Association of the Philippines Inc. (PAPI) President Nelson Santos kaugnay sa nangyaring brutal na pagpatay sa beteranong mamamahayag at former Kalibo Mayor Juan 'Johnny' Dayang. Ang 89-anyos na si Dayang ay binaril sa loob ng kanyang tahanan sa Casa Dayang sa Villa Salvacion, Kalibo, Aklan dakong alas-8:00 ng gabi nitong Abril 29. Ang malagim na pangyayari ay mariring kinondena ni Santos kaya hinihimok ng PAPI ang Presidential Task Force on Media Security (PTFOMS) at ang mga katuwang na awtoridad para agarang imbestigahan ang kaso ni Dayang upang matukoy ang mga pumatay gayundin ang utak sa likod ng pagpatay at maiharap sa hustisa. Sinabi naman ni PTFOMS Executive Director Undersecretary Jose Torres Jr. na nagsasagawa ng imbestigasyon ang Philippine National Police (PNP) at sila ay nakikapag-ugnayan sa lahat ng kinauukulang ahensya upang matiyak ang agarang paglutas ng naturang kaso. Kinondena rin ng National Press Club of the Philippines ang pagpatay kay Dayang at kaisa rin si NPC President Leonel Abasola na umapela sa PTFOMS at iba pang kinauukulang awtoridad na magsagawa ng masusing imbestigasyon sa insidente. Nabatid na bago ang krimen ay sinabi ng caretaker ni Dayang na si Marjorie Yap, na dakong alas-9:00 ng umaga nitong Abril 29 ay dalawang hindi pa nakikilalang lalaki na nakabonnet ang nakitang sakay ng motorsiklo malapit sa tirahan ni Dayang na umano'y nagmamasid sa

babay at paligid na tila pinag-iisipan o pinagpaplanuhan ang posibleng pag-atakeng gagawin.

Batay sa ulat, noong gabi ng naturang petsa ay kasalukuyang nanood ng telebisyon si Dayang nang isagawa ang tatlong sunod na pamamaril sa kanya ng mga salarin mula sa labas ng bahay.

Nagtamo si Dayang ng malafang sugat sa leeg at dalawang tama ng bala sa likod na naisugod naman sa Dr. Rafael S. Tumbocon Memorial Hospital subalit idineklarang dead on arrival dakong alas-8:33 ng gabi.

Si Dayang na chairman emeritus ng PAPI ay respetadong pigura sa industriya ng media. Naglingkod s Dayang bilang pangulo ng PAPI sa loob ng mahigit 20 taon na nag-iwan ng hindi maalis na marka sa organisasyon at sa tanawin ng paglalathala ng Pilipinas. Siya ay pangulo rin ng Manila Overseas Press Club, dating director ng National Press Club, at founding president ng Federation of Provincial Press Clubs of the Philippines at secretary ng Catholic Mass Media Awards.

Ang pagkamatay ni Dayang ay malaking kawalan sa Philippine media at political landscape habang ang kanyang pamana ng pamumuno, dedikasyon sa pamamahayag, at serbisyo publiko ay maaalala sa mga susunod na henerasyon. 'Nakikiisa kami sa buong komunidad ng media sa paghini ng hustisa para sa ating Chairman Emeritus at sa kanyang pamilya. Ipinaabot din namin ang aming pinakamalalim na pakikiray sa kanyang pamilya at mga mahal sa buhay,' bahagi pa ng payag ni Santos. **RS**

Sa press conference sa Kamuning Restaurant Cafe, binigyang-diin na ang LGBTQ+ Agenda ay nabuo mula sa kasalukuyang sitwasyon ng mga komunidad ng LGBTQ+ sa iba't ibang larangan.

Sinabi ni Reyna Valmores Salinas, Chairperson ng Bahaghari, "Sa kauna-unahan ng pagkakataon sa kasaysayan ng Pilipinas, ang mga LGBTQ+ na Pilipino sa buong bansa at internasyonal ay lumikha ng isang pinag-isang LGBTQ+ Agenda isang komprehensibong listahan ng mga kahilingan ng patakaran ng mga LGBTQ+ na Pilipino sa larangan ng mga karapatang sibil at demokratiko, ekonomiya, edukasyon, kalusugan, politika at soberanya."

"Itong nagsisilbing kahinginan ng komunidad bago, habang at kahit na tapos na and eleksyon 2025," dagdag ni Salinas.

Inilista ni Salinas ang sumusunod na pitong-puntong 2025 LGBTQ+ Agenda:

Imus Clan Keeps 19th-Century Lenten Tradition Alive for Future Generations

Imus City, Cavite — While Cavite is rightfully known as the birthplace of Philippine independence, it is also a stronghold of religious and cultural traditions that have stood the test of time such as "Pabasa ng Pasyon" (Reading of the Passion, a province-wide observance), "Penitensya" (Penance, in Ligton of Rosario town) and "Santo Entierro" (Holy Burial, also province-wide). One family that has kept these sacred traditions alive is the Montoya-Sayoc-Dominguez clan of Imus City. As modernity continues to reshape Filipino culture, this family offers a powerful reminder: that "some legacies are worth carrying, not just in memory, but in faithful action," says Architect

Romy Sayoc Cord Cruz - a sixth-generation descendant. "In today's fast-changing world, traditions like these remind us of our roots," says Coord Cruz. "It's not only about maintaining a tradition—it's about passing down a part of who we are to the generations after us." The family gathers every Palm Sunday to venerate a wooden image of the dead Christ, believed to be from the 19th century. Its origins is anchored in documents dated 1878 which "were written by my great-great-grandfather Emeterio Dominguez, listing the materials and expenses related to the Santo Entierro," said Coord Cruz. He adds that the image is owned by Nicolasa Sosa Dominguez Sayoc, and its care has been

a family responsibility ever since.

Like last year, the Mater Dolorosa (the image of a sorrowful mother, the Virgin Mary grieving over her dead son, Jesus Christ) is placed beside the Santo Entierro (Holy Burial), serving as a perfect backdrop to the annual 'pabasa' (chanting/singing in public of the 16th to 17th century epic poem narrating the life of Jesus Christ from birth to resurrection) hosts are Greg and Analynn Padua De Perio, Rolly and Lolit (+) Dominguez Pascua and Mario D. Padua who are all based in California, USA.

The tradition of Santo Entierro is not unique to Cavite alone. Across the country, particularly in deeply Catholic provinces such as Pampanga, Bulacan, and Quezon, similar processions take place on Good Friday.

Owned by Eric Michael Nolasco, the 3 1/3 feet antique statue of Mater Dolorosa used to be the Holy Week image of the Our Lady of the Pillar Parish in Imus (City) and was a regular in Holy Week processions until the 1960s," he said.

The Montoya-Sayoc-Dominguez family intends to not just keep this Lenten practice alive but to carry it on to the family's next generations as it not only tightens the family's bond, but

An independent street survey ("kalye survey") conducted by PAPI from April 1 to 20, 2025, gauged early preferences for the upcoming Senate race, tapping the sentiments of motor riders, jeepney and bus commuters, and public market patrons.

Gathering responses from 1,100 participants nationwide, the survey results reveal strong support for familiar names in politics and media, indicating public leanings ahead of the official campaign period.

According to the survey,

Christopher Lawrence "Bong" Go emerged as the top choice, closely followed by Rodante D. Marcoleta and Erwin Tulfo. Other notable candidates who secured significant support include Ronald "Bato" Dela Rosa, Vicente "Tito" Sotto III, and Pilar Juliana "Pia" Cayetano.

The survey highlights the continued dominance of political veterans and media personalities, with familiarity and public visibility playing key roles in voter preference.

PAPI clarified that while the survey offers a snapshot of current sentiment, the

figures could still shift significantly as official campaigns and debates unfold.

The survey method involved random street interviews at transport hubs and public markets to capture the pulse of ordinary commuters and

small vendors, groups often underrepresented in traditional polling.

As the Senate race heats up, analysts expect the numbers to fluctuate, especially with political endorsements, issues, and media appearances influencing the electorate.
