PAGTIBAYIN PA ANG 'K TO 12' PANAWAGAN NG 'PBED' MAY PAG-ASA PARA SA EDUKASYON PHIL 2025

Naninindigan ang Philippine Business for Education (PBE) para sa pagpapatibay ng K to 12 habang inihayag nito ang 2025 State of Philippine Education na may temang: "Pagtatamo ng Bagong Landas: Mga Reporma at Muling Pag-asa sa Edukasyong Pilipino." Sa isang press conference sa Milagritos, Tryp Hotel, na binanggit na "Ang edukasyon ay negosyo ng lahat", sinabi ni PBE President Dr. Chito Salazar na ang PBE ay ginagawa ito mula pa noong nakaraang 10 taon at tuwing sa pagbubukas ng paaralan. "Kami ay kasama pa rin ang EdCom, TESDA, at ChEd at kami ay naniniwala na may pag-asa pa para sa edukasyon ng bansa," sabi ni Dr. Salazar. Gayunpaman, sinabi niya, "Kailangan talaga nating magtuon sa mga problema. Ito ang tamang panahon para sa tamang pamumuno." "Malalaki at napakalaki ng mga problema sa edukasyon at patuloy itong nararanasan," dagdag niya. "Hindi po tama na 20% ng ating mga bata sa paaralan ay may stunting," sabi ni Dr. Salazar. Naniniwala siya na bago ang anumang proyekto sa imprastruktura sa bansa, ang pinakamahalagang bagay ay edukasyon. Binanggit ni Dr. Salazar na hindi dapat sisihin ang K to 12 dahil kailangan pa nito ng mas maraming oras para mapangalagaan. "Huwag nating sisihin ang mga guro dahil sila rin ay bahagi ng sistema," aniya. Idinagdag niya na ang mga guro ay may maraming problema at kailangan nila ng pag-unlad sa karera at hindi dapat manatili bilang Guro hanggang sa kanilang pagreretiro. "Ang pagtanggap sa K to 12 ay mas lalo pang laban sa mga mahihirap dahil sila ang talo kung hindi sila mabibigyan ng pagkakataong mag-aral ng 12 taon," sabi ni Dr. Salazar. "Hindi kahit na perpekto ang tripocalization," idinagdag niya. Binanggit ni Dr. Salazar na hindi kinakailangan na ipatigil ang K to 12, kundi dapat itong ayusin upang ang isang Grade 4 na hindi marunong bumasa ay maaari pa ring makatugon sa loob ng 2 taon." Ang PBE ay nananawagan para sa desentralisasyon

sa paraang nakatuon sa pagpapalakas ng mga kasanayan sa kurso, kakayahang makapagtrabaho at sila ay handang magtrabaho at hayaang magpasya at magtrabaho para sa kanilang sarili. Ang AI (Artipisyal na Katalinuhan) ay maaaring makatulong sa mga mag-aaral at makahabol sa kanila. Ang AI ay hindi isang banta," sabi ni Dr. Salazar. Itinatag ang PBE noong 2006-2007 at kabilang sila sa mga unang nagwagi para sa pagpapatupad ng K to 12. Ang Batas sa Inang Wika, na ilang buwan na lamang bago ang K to 12, kung saan ang mga estudyante ay dapat mag-aral sa wikang kanilang alam at nauunawaan. Sa utos ng DepEd tungkol sa Batas sa Inang Wika, sinabi ni Dr. Salazar na "Sa tingin ko, dapat bigyan ng oportunidad ang lokalidad na magdesisyon." Sinabi ng Executive Director ng PBE na si Hanibal Camua na "Ang ating mga mag-aaral ay nangangailangan ng oras. Kailangan nating bigyang-pansin ang edukasyon." Ang Batas sa Inang Wika ay ilang buwan na lamang bago ang K to 12. Nagsisimula ang problema mula 0 hanggang 5 taong gulang o Kindergarten o Baitang 1 hanggang 4. Binanggit niya ang EdCom 1 noong 1990, ang pagpasa ng K to 12 noong 2013 at ang ikalawang Kongres na Komisyon sa Edukasyon. Sa nakaraang mga dekada at patuloy ang sama-samang pagsisikap. Gayunpaman, ang pagganap ng ating mga mag-aaral ay patuloy na bumababa. "Ang aming mga guro ay hindi sanay. Ang aming mga nagtapos ay hindi makahanap ng trabaho, habang ang mga industriya ay hindi makahanap ng tamang talento," sabi ni Camua. "Nakasalalay ang hinaharap ng ating bansa sa kung paano natin ihahanda ang ating edukasyon," dagdag niya. "Higit pa sa badyet para sa edukasyon, mas mabuting malaman kung saan ito inilaan," sabi ni Camua. Ang karaniwang layunin ng pagpasok sa paaralan ay magkaroon ng maliwanag na

kinabukasan o magandang trabaho at kinakailangan ng isang sama-samang pagtugon ng lipunan kung saan ang pribado at publikong sektor ay maaaring tugunan ang kakulangan ng mga silid-aralan. Idinagdag ni Camua na ang mga mag-aaral ay dapat turuan sa tamang paggamit ng mga plataporma ng social media. Ang pag-alis ng congestion sa mga senior high school ay isinagawa sa higit 800 paaralan ng DeEd kung saan mayroong 600 na oras ng immersion na pinangangasiwaan ng mga lider sa industriya. Kailangang palakasin ang pagbabasa, pag-unawa, at matematika. Sinabi ni Samantha Uichico, Senior Program Manager ng PBE, na kailangan ng bansa ng 47,000 na tagasuri upang matugunan ang 'backlog'. "Ang krisis sa edukasyon ay bunga ng aming dekadang pagwawalang-bahala," sabi ni Gomez. 9 sa 10 mag-aaral ay hindi nakakaunawa ng simpleng teksto. 62% ng mga guro ay nagtuturo sa labas ng kanilang espesyalisasyon. Si Clarisse Gomez, Senior Program Manager ng PBE, ay binanggit ang mga kaso nina Myra Dagdagen, isang Grade 11 STEM, Justine Agustin, isang punong guro ng senior high school, at Winniefreta Domenez. Gayundin, si Jonald Macrohon mula sa Lungsod ng Zamboanga. "Mabilis at puno ng pressure ang paglipat mula mataas na paaralan patungo sa kolehiyo," sabi ni Gomez. "Dahil malapit na matapos ang EdCom 2, maaaring mawala ang ating momentum," sabi ni Camua, na nagdagdag na "dapat itakda ng pambansang polisiya ang direksyon." Kailangan nating mamuhunan sa edukasyon. Malapit nang matapos ang EdCom 2.

Ang SONA ay nagsisilbing pag-uulat sa bayan ng ating pangulo sa lahat ng kanyang achievement o magaganda at makabuluhang naisakatuparan sa loob ng isang taon. Lagpas tatlong taon na o nasa ka-

Ang NAST PHL ay isang ahensyang nakatalaga sa Kagawaran ng Agham at Teknolohiya (DOST) na may mandato na kilalanin ang mga natatanging nagawa sa pananaliksik at kaunlaran sa agham, magbigay ng payo sa Pangulo at sa Gabinete sa mga usaping kaugnay ng Agham at Teknolohiya, at makilahok sa mga proyekto at programa na nagtataguyod ng produktibidad sa agham.

Sa ginanap na forum, ipinakilala ang mga bagong nahalal na Miyembro ng NAST PHL, ang 2025 Outstanding Young Scientists (OYS), at ang mga nagwagi ng 2025 NAST Talent Search for Young Scientists (NTSYS). Sa naging pambungad na pahayag, sinabi ni Academician Jaime C. Montoya, Pangulo ng NAST PHL, "Dapat itong maging masayang akasyon."

Dahil lubos na ikinagalak ni Montoya ang mga kalahok sa ikapitong episode ng Kapehan bilang isang lugar upang ipakilala ang mga pinarangalan sa napapanahong kaunlaran sa siyensya at teknolohiya. Sinabi niya, "Ang akasyong ito ay upang makakuha ng kaalaman tungkol sa 2025 NAST Awardees."

Binati din ni Montoya ang tatlong bagong halal na Akademiko na sina Dr. Leocadio S. Sebastian (Pagpili ng Halaman), Dr. Wilfredo Roehl V. Licuanan (Ekolohiya ng Dagat), at Dr. Charles V. Yu (Sakit sa Baga/ Nakakahawang Sakit). Ipinabatid nito ang katiyakan sa mga tumanggap ng gantimpala na maaari silang makakuha ng pinansyal na suporta mula sa NAST PHL para sa kani-kanilang pag-aaral. Sa panahon ng bukas na forum, sinabi ni Dr. Sebastian na sinimulan niya ang kanyang Plant Science sa Mataas na Paaralan sa Ilocos Sur.

Idinagdag niya na siya ay nakilahok din sa "Science Cup" sa lalawigan at sa rehiyon. Si Dr. Sebastian ay naging OYS din. Binanggit niya ang kahalagahan ng scholarship para sa mga estudyante.

Tinukoy nito na sa kasalukuyan ay maraming estudyante sa Philippine Science High School. Naalala ni Dr. Sebastian na sina Budget Secretary Emilia Boncodin at Civil Service Commission (CSC) Chairperson Patricia Sto. Tomas ay parehong tagapayo ng DAR (Department of Agrarian Reform). "Ang pag-angkop sa pagbabago ng klima ay hindi kasingdali ng paggawa ng isang eksperimento."

Sa pagbabago ng klima, may mga nananalala at may mga talunan. Hindi tayo makakapagpangkalahatan. Kailangan nating tukuyin ang mga lugar. sabi ni Dr. Sebastian. Binanggit niya na ang Baguio City ay may malamig na panahon at ang mga mababang lugar ay may mainit na panahon. Habang tinalakay naman ni Dr. Licuanan, 61, "Ang ating baybayin ay mahigit tatlong beses kumpara sa US (Estados Unidos)." Maraming siyensya ang kinakailangan upang makapunta sa isang antas kung saan alam mo kung ano ang gagawin at makagawa ng rekomendasyon na maaaring magkaroon ng epekto," dagdag pa nito.

Ayon pa sa kanya maraming siyensya ang kinakailangan upang makagawa ng makabuluhang resulta para mabago ang lipunan. Si Dr. Licuanan ay isang biologist. Nagtuturo siya sa mga mag-aaral sa mataas na paaralan tungkol sa mga coral reefs.

Paliwanag pa nito na isa siya sa iilang siyentipiko na nais na iwasang magkomento sa sinasabing "pagsira sa mga coral reefs" sa Kanlurang Dagat ng Pilipinas (WPS) bago dumating ang mga dayuhan. "Wala tayong mapa ng mga coral reefs sa Pilipinas. Wala tayong sistemang nakaka-coordinate para sa pagmamanman," sabi ni Dr. Licuanan.

Iginiiit pa nito na "Wala tayong kontribusyon o sistema ng pagmamanman para sa mga coral reefs. Wala tayong matibay na datos na maipapakita sa korte. Wala tayong mapa. Wala tayong sistema ng pagmamanman kaya't dito na lang tayo titigil. Wala tayong matibay na datos na maipapakita sa korte," dagdag pa niya.

Ayon naman kay Dr. Yu, "Kailangan nating lumabas sa mga tao upang masolusyunan ang mga problema." Siya ay nagtatrabaho bilang isang espesyalista sa tuberculosis sa buong buhay niya. "Nasa No. 4 tayo sa Tuberculosis sa mundo," sabi niya.

Paliwanag nito "Kailangan nating gawing kaakit-akit ang siyensya at teknolohiya. Ito ang hamon sa komunidad. dagdag ni Dr. Yu. Sinabi ni Dr. Montoya na siya ay masaya na kahit papaano ay mayroong isang tagaganap sa grupo ng mga pinarangalan.

lahati na ng termino ang panunungkulan ni PBBM sa ating bansa. Mahalaga sa taumbayan ang kada taong pag-uulat ng nakaupong presidente dahil ito ang panahon o pagkakataon sa pagsusuri sa kredibilidad ng tumatayong lider ng bayan. Sinabi ni Dr. Cadag na pagkatapos ng pananaliksik, makipag-ugnayan sa komunidad tungkol sa pagbawas ng panganib sa sakuna. Sinabi niya na sa isang sukat, binibigyan niya ang kanyang sarili ng grado na "10" habang nagtatrabaho siya kasama ang komunidad.

Ang nangyungunang 2 nagwagi ng NTSYS ay sina Dr. Isaiiah Paolo A. Lee (Molecular and Evolutionary Systems Biology) – 1st na gantimpala, at Dr. Victor Manuel R. Aricheta (Mathematics) – 2nd na gantimpala. Nakibahagi rin ang Executive Director ng NAST PHL na si Luningning E. Samarita-Domingo sa programa.

Ang #PilipiNAST Kapehan ay isang serye ng mga talakayan na nagtataguyod ng mga siyentipiko ng NAST PHL at mga mamamahayag, midya, at tagapagbalita ng siyensya.

Hindi matatawaran ang linamnam o sarap ng mga nasabing isda kaya iwaksi ang pangamba.

Sa kabila ng pagtutuwid sa impormayon sa naturang ulat ay nasa inyo pa rin naman ang pagpapasya kung hihinto muna pansamantala o sige lamang sa pagkain ng mga isdang ito.

Wala namang epekto sa mga mangingisda ng tawilis ang isyu dahil ang kanilang bultong nahuhuli ay nabibili at nauubos naman.

Para sa kaalaman, ang tawilis ay isang endemic species ng isda na matatagpuan lamang sa Taal Lake.

Kada taon, mula Pebrero hanggang Abril ay mahigpit na ipinagbabawal ang pangingisda ng tawilis sa Taal Lake upang bigyang-daan ang mga species na magparami.

Dengue Cases Rise

From January to February 21, 2025, dengue cases in Isabela rose to 659—up from 434 during the same period last year. To address the surge, the Cauayan City Local Government—one of the Philippine cities named among the top 50 finalists in the 2025 Bloomberg Global Mayors Challenge—has proposed Project C-DEWS (Community Dengue Early Warning System). The proposal aims to strengthen public health through an early warning system that raises awareness, alerts households, and encourages active community participation in dengue prevention. Project C-DEWS is an online platform that uses an IoT-based OL trap to predict household mosquito infestation levels. It provides early warnings and recommends sanitation practices to help prevent the spread of dengue. This project is a collaboration between the Cauayan LGU, Isabela State University (ISU), and the Department of Science and Technology (DOST) under the Smarter City Project. Liveable Cities Philippines, a proud local partner of Bloomberg Philanthropies Bloomberg Mayors Challenge, will continue working with Cauayan City throughout the challenge.

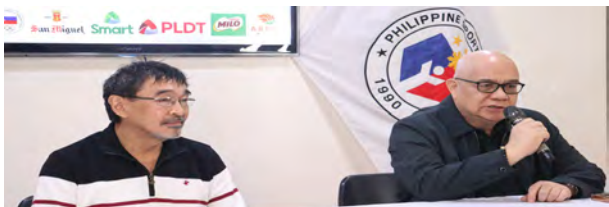
Legarda pushes landmark bill to give monthly allowance for every Filipino student

Four-term Senator Loren Legarda today filed the National Student Allowance Program (NSAP) Act, a bill that seeks to provide a monthly allowance of ₱1,000 to every Filipino student from kindergarten to college. The Senate bill complements the bill filed in the House by her son, Congressman Leandro Legarda Leviste, reinforcing their shared commitment to accessible and inclusive education for all Filipino students. The proposed national student allowance will be granted to all enrolled Filipino students who meet minimum attendance requirements, to help cover essential educational expenses such as food, transportation, and school supplies. Disbursement will be done through student cards or digital vouchers, which may be used at accredited vendors such as school canteens, transport providers, and school supply retailers. These mechanisms help ensure that the allowance will be used for the student's education and help encourage school attendance and improve academic performance. “This is not ayuda or short-term relief. This program is grounded in the belief that investing in every Filipino student is investing in the nation's present and future,” Legarda said. “This will be structured as an allowance that can only be used for school-related expenses, like food, transportation, and school supplies. Student cards or digital vouchers also help eliminate corruption and ensure this assistance can equitably reach every student in the country,” Legarda added. The bill also promotes digital financial inclusion by allowing the student card to serve not only as an access point for the allowance but also as a basic savings or e-wallet account, enabling students to develop responsible budgeting habits and engage in secure financial transactions. The Bangko Sentral ng Pilipinas (BSP) and partner institutions are mandated to ensure these systems are accessible, especially in geographically isolated and disadvantaged areas (GIDAs). To safeguard the program's long-term viability, the bill directs the Department of Finance (DOF) to lead the formulation of a Sustainability Framework and conduct an actuarial analysis every five years to assess cost trends and demographic shifts. The proposed NSAP is expected to assist more than 30 million students nationwide and strengthen the government's constitutional duty to make quality education truly accessible and sustainable for all Filipinos.

Ang Tagapangulo ng Philippine Sports Commission na si Pato Gregorio ay nagbigay ng isang revitalization roadmap at ang estratehikong direksyon ng kanyang administrasyon, na nagtipon ng mga stakeholder kasama na ang mga atleta, coaches, at mga opisyal ng National Sports Associations at ng Philippine Olympic Committee, Commission on Audit, at mga mambabatas sa isang Pangkalahatang Asembleya na ginanap sa Ninoy Aquino Stadium. Binigyang-diin ni Gregorio ang mga pangunahing prayoridad na tututukan ng PSC sa kanyang termino: pagpapabuti ng kapakanan ng mga pambansang atleta, pagpapa-professionalize ng pamamahala sa sports at pasilidad, at pagpapalakas ng sports tourism sa pakikipagtulungan sa Kagawaran ng Turismo.

Samantala, ang mga atleta sa Training Pool B ay makatatanggap ng pinakamababang halaga na P10,200 batay sa scheme. "Karamihan sa mga atleta ay tumatanggap pa rin ng humigit-kumulang P10,000 kada buwan." Mas mababa po 'yun sa minimum wage," sabi ni Gregorio. Nangako rin si Gregorio napaikliin at i-digitize ang proseso ng pagbibigay ng stipend upang mabawasan ang oras ng pagproseso sa limang (5) araw mula sa dati nang ilang linggo, nakadepende sa tamang pagkakatapos ng mga kinakailangang dokumento. Ipinagdiwang din niya ang makabuluhang hakbang patungo sa pagpapalawak ng akses sa mga pasilidad sa sports sa pamamagitan ng pag-apruba ng PSC board sa mga alituntunin at regulasyon (IRR) ng Philippine Sports Training Center sa ilalim ng Republic Act 11214.
