Promoting Local Livelihoods in Sagay, Camiguin through PORTASOL

The Department of Science and Technology (DOST) Camiguin, led by Provincial Science and Technology Director Joanne Katherine R. Banaag, conducted a monitoring activity on July 4, 2025, to assess the performance and impact of the Portable Solar Speed Drying Trays (PORTASOL) deployed in Sagay, Camiguin. This initiative aims to empower local micro-entrepreneurs by enhancing productivity through sustainable technology.

PORTASOL units were provided to three local enterprises:

- The Holy Trinity Fisherfolks Association in Manuyog, engaged in dried squid production

• Mr. Ricky Obsid

of Poblacion, known for his traditional kiping delicacies

• Mr. Roland Zaballero of Cuña, who processes cacao into tablea

All three beneficiaries have reported notable improvements in their production processes. The use of PORTASOL significantly reduced drying time, enabling them to scale up operations, meet growing demand, and increase income.

The Department of Science and Technology

- CALABARZON (DOST CALABARZON)

thru DOST Cavite, facilitated the installation of an ethanol distiller machine for the funded and partnership research project with Cavite State University and Philippine Coconut Research and Development Foundation Inc. (PCRDF): "Technology Commercialization of Makapuno Galactomannan and Powder as Intermediate Raw Materials" last July

21, 2025.

The equipment is one of the provided equipment for the project for ethanol distillation used for extracting galactomannan from makapuno liquid endosperm. Galactomannan is used for variety of cosmetic products including lotion, soap, and other pharmaceutical purposes which is now adopted by a private company. Thru this project, the sourcing out of galactomannan and cost of raw material can be more accessible for mass production of makapuno galactomannan-based cosmetic products. (*DOST CAVITE*)

Flood control projects for a safer Bagong Pilipinas

Department of Public Works and Highways Secretary Manuel Bonoan reported the completion of 9,856 flood control projects nationwide, providing immediate relief to low-lying communities.

Following President Ferdinand Marcos Jr.'s directive, the DPWH continues to prioritize

Agarang nakalayo ang Tropang 5G sa unang quarter pa lamang ng tagisan kung saan lamang ng diwa ng personal na tagumpay ay magkakaroon ng pambihirang pagkakataon na gawin ito sa oras na ilunsad ang ASICS Meta: Time Trials sa Pilipinas sa Oktubre 19, 2025, sa Vermosa Sports Complex sa Imus, Cavite.

Nilaloyan na hikayatin ang mga runner sa lahat ng antas na itulak ang mga hangganan at habulin ang mga personal na rekord, ang 10km road race ay higit pa sa isang kompetisyon ito ay isang pandaigdigang pagdiriwang ng personal na pag-unlad.

Unang inilunsad sa Malaga, Espanya noong 2022, ang Meta: Time Trials ay binuo para sa mga mabilis na kurso, nakatuon sa atleta na diskarte, at nakabukas sa kapaligiran na nakatuon sa pagganap. Matapos ang matagumpay na mga edisyon sa Thailand at Malaysia, ang kaganapan ay nasa Pilipinas na ngayon, kung saan ang mga isport sa pagtitig tulad ng IRONMAN series ay patuloy na umuunlad at nagbibigay inspirasyon.

"Ngayon na nandito na ito sa Pilipinas, ang tagumpay nito ay nagpapakita ng potensyal ng kaganapan sa ating lokal na talento sa pagtakbo at nasasabil kaming makakita ng higit pang mga personal na record na naitatag dito mismo sa ating sariwang lupa," sabi ni Diego De Dios, Executive ng Komunikasyon ng Brand ng SONAK sa Philippine Sportswriters Association Forum sa conference hall ng Rizal Memorial Sports Complex.

Inorganisa ng Sunrise Events, Inc., ang bahagi ng Pilipinas ay nangangako na magbigay ng isang karasanan sa karera na klase sa mundo na nagtatampok ng pagtitigay, personal na tagumpay at ang walang kapantay na pagsusumikap para sa kahusayan.

Sa suporta ng Sonak Trading, ang opisyal na tagapamahagi ng ASICS sa Pilipinas, umaasa ang mga tagapag-ayos ng isang mahusay na bilang ng 3,500 kalahok, mula sa mga elite na atleta at batikang mananakbo hanggang sa mga masigasig na baguhan at umuusbong na talento.

Ang pahayag ni Calinisan ay sumasang-ayon sa kamakailang pagpasa sa Kongreso ng panukalang batas na nagaamyenda sa Republic Act 10591 (An Act Providing For A Comprehensive Law of Firearms and Ammunition and Providing Penalties for Violation Thereof).

Sa ilalim ng binagong panukalang batas na ipinadala na sa Senado, mula sa dating limitasyon sa pagbili ng bala na 50 rounds lamang, ang mga non-sports shooters ay maaari na ngayong mag-enjoy ng 500 rounds habang ang mga miyembro ng Philippine Shooting Team (rifle, pistols, shotgun, at practical shooting) ay nire-reload na ngayon ng hanggang 5,000 rounds para magamit sa intensive training at competitions.

Ngayon, ang mga legal na

nakarehistro ng tao ay maaaring makatanggap ng Permits to Carry (PTC), na naggapahintulot sa mga sports shooter ng hanggang tatlong baril at bawat isa. Maaari na ngayong i-fast-track ng gobyerno ang pagpoproseso ng permit at lisensiya, pagpapalawig ng validity ng PTC mula 5 hanggang 10 taon at mga lisensiya sa negosyo ng baril mula 5 hanggang 10 taon, alinsunod sa Ease of Doing Business Act (RA 11032).

Pinaikli din ng binagong panukalang batas ang gun ban mula 6 na buwan hanggang 45 araw lamang bago at 5 araw pagkatapos ng araw na halalan.

"Kami ay lubos na nagpapasalamat sa lahat ng mga mambabatas para sa suporta.

Ito ay isang malaking tulong sa industriya at isang malaking tulong

sa mga miyembro ng Philippine team na umaasang mapanatili ang momentum ng kanilang kamakailang mga nagawa sa world shooting sa Czech Republic," sabi ni AFAD president Edwin Lim, na nagsisibol rin bilang pinuno ng Philippine Practical Shooting Championships.

Sa kanyang bahagi, inimbitan ng Topacio ang lahat ng mga mahilig sa pagbaril at mga atleta na bisitahan ang limang araw na kaganapan, na tutagal ng hanggang Hulyo 27, na nag-aalok ng world-

PSC Chairman Pato ipagkakaloob na 5,000 dagdag buwanang allowance sa mga atleta at coaches ngayong buwan ng Agosto

Tulad ng ipinangako ni Philippine Sports Commission chairman Patrick "Pato" Gregorio, lahat ng pambansang atleta at coach ay magsisimulang makatanggap ng P5,000 na dagdag sa kanilang buwanang suweldong simula sa susunod na buwan.

Inaprubahan ng PSC board ang pagtaas ng sahod ng mga atleta at coach, na humigpit-kumulang P10 milyon buwan-buwan, tulad ng inannunso ni Gregorio noong Hulyo 8.

Si Gregorio, na itinatalaga ni Pangulong Marcos bilang ika-13 na chairman ng PSC, ay gumawa ng anunso ang kanyang pagupo nang makilala niya ang mga atleta, coach, at mga kinatawan ng iba't ibang NSAs (pambansang samahan ng palakasan) sa Ninoy Aquino Stadium.

Sinabi ni Gregorio na panahon na upang makakuha ng dagdag na allowance ang mga atleta at coach.

"Bakit? Kasi napagtanto namin na napakaraming atleta ang kumikita pa rin ng P10,000 bawat buwan," sabi ni Gregorio. "Mas mababa pa 'yun sa minimum wage."

Samantala, naggadalang PSC

ngaya sa mga atleta at coach na nakabase sa Rizal Memorial Sports Complex sa pamamagitan ng pamamahagi ng mga nakapack na pagkain sa gitna ng masungit na panahon.

"Namigay kami ng pagkain para sa mga atleta na hindi makalabas ng kumpleks dahil sa pagbaha," ayon kay Gregorio.

Nakipagsama si Gregorio kay PSC

Commissioner Edward Hayco sa

pagsusuri sa mga atleta, tinitiyak na sila ay ligtas at ang kanilang mga pangangailangan ay sapat.

Kabilang sa mga atleta na

kanilang binisita ay ang mga mula sa baseball, softball, wushu, wrestling, at hockey.

Sa panahon ng pagbisita,

nakanahap ng oras ang mga

pagunahing opisyal ng PSC

upang makining sa "kwentong buhay"

ng mga atleta at sa

kanilang mga pangarap na

magpatuloy sa mas mataas na

edukasyon.

Ang hakbang na ito ay dapat
