Cayetano sa Ombudsman: Magsagawa ng lifestyle check sa mga opisyal ng gobyerno

Hinimok ni Senador Alan Peter Cayetano ang Office of the Ombudsman na magsagawa ng maagap na lifestyle checks sa mga opisyal ng gobyerno bilang panangga laban sa korapsyon.

Iminungkahi ito ni Cayetano sa kanyang pagtatanong sa mga kandidato na nagnanais maging susunod na Ombudsman, na isinagawa ng Judicial and Bar Council (JBC) mula August 28 hanggang September 2, 2025.

Si Cayetano ang Senate representative sa JBC sa kanyang kapasidad bilang Chair ng Senate Committee on Justice and Human Rights.

"I'd really like for you to consider lifestyle checks. Kasi kung wala, there's no deterrent," sabi ni Cayetano sa isang kandidato para sa pagkakakaroon ng GSIS o SSS coverage, hazard pay, at representasyon sa Solid Waste Management Board ang mga waste worker.

Ipinaliwanag ng senador ang kahalagan ng lifestyle checks sa pagkumpirma kung naaayon ba ang pamumuhay ng isang opisyal ng gobyerno kumpara sa idineklarang kayamanan base sa kanyang opisyal na Statement of Assets, Liabilities, and Net Worth (SALN).

"Ngayon sa social media, kapag nakita sa SALN mo na meron kang P5 million, but because all of that were acquired in the 1970s to 80s, and you have a car or watch, they automatically think you're corrupt.

On the other hand, if you say no to lifestyle checks, many will be flaunting their wealth,"

Binigyang diin rin ni Cayetano ang kahalagan ng mamuhay ng payak at umiwas sa marangyang buhay ang mga opisyal ng gobyerno. Sinabi niya ito sa gitna ng mga maiinit na alegasyon ngayon ng korapsyon sa flood control at ghost projects.

Iginiit rin niya na dapat mapili ang isang matuwid at proactive na Ombudsman sa gitna ng mga pagsisikap ng pamahalaan na tugunan ang katiwalian.

"Napakahalaga na tama ang mapili nating Ombudsman. Given yung nangyayari ngayon sa Department of Public Works and Highways (DPWH), given yung perennial na nangyayari sa iba't ibang departamento, having a very proactive but balanced Ombudsman will really change so much," aniya.

Dagdag pa niya, malaking bagay ang pagpili sa susunod na Ombudsman dahil magiging kritikal ito sa pagbabalik ng tiwala ng publiko sa gobyerno.

"I think who the next Ombudsman is will determine whether people will totally lose confidence in any government official," wika ng senador.

Legarda, isinusulong ang Magna Carta of Waste Workers

Muling inihain ni Senadora Loren Legarda ang isang panukalang batas na naglalayong ayusin ang kondisyon ng pagtatrabaho ng mga waste worker dahil sa kanilang mahalagang papel sa kalusugan ng taumbayan.

"Humaharap sa panganib ang ating mga waste worker sa kanilang araw-araw na trabahong pangongolekta ng ating mga basura," wika ni Legarda.

"Marami rin sa kanila ang mababa ang suweldo, hindi tiyak ang kaligtasan, at nadi-discriminate dahil sa kanilang trabaho," aniya.

Tatawaging pormal ang mga nagtatrabaho para sa pamahalaan, pribadong kumpanya, o kooperativa; at impormal ang mga mangangalakal.

Magkakaroon ng GSIS o SSS coverage, hazard pay, at representasyon sa Solid Waste Management Board ang mga waste worker.

Sila rin ay bibigyan ng pagkakataong sumailalim sa libreng taunang medical exam, pati na ang pagbibigay sa kanila ng personal protective equipment, at mga bakuna. Higit pa rito ay pa-ospital at regular check-up hatid ng health maintenance organization o HMO.

Kasama rin ang physical, dental, mental health, at psychosocial examinations upang matutukan ang pisikal at mental na kalusugan ng waste workers.

Hindi dapat humigpit sa walang oras ang kanilang trabaho, at ang sosobra rito ay babayaran ng overtime o ng holiday pay.

Aatasan ang Department of Labor and Employment (DOLE) na tiyaking maayos ang kondisyon ng mga waste worker, kabilang ang pagpapatupad ng security of tenure.

Ang Department of Social Welfare and Development (DSWD) ang magbibigay ng social protection, samantala ang Department of Environment and Natural Resources (DENR) naman ang magsisiguro ng tamang implementasyon ng Solid Waste Management Act. Pag-aaccredit naman ang magiging tungkulin ng Technical Education and Skills Development Authority (TESDA).

"Hindi masyadong napapansin ng waste management industry, ngunit mahalaga ito sa ating pang-araw-araw na buhay. Ang ating mga waste worker ay nagtatrabaho araw-araw upang di kumalat ang sakit," giit ni Legarda.

"Ang pagpasa ng panukalang ito ay isang pasasalamat sa mga nagtatrabaho ng ganito na marangal."

May punto ang SINAG

EPEKTIBO nitong Setyembre 1 ang Executive Order Number 93 ni Pangulong Ferdinand 'Bongbong' Marcos Jr. Ito ay ang suspensiyon sa pag-aangkat ng regular at well-milled rice sa loob ng 60 araw. Ang paliwanag ng Samahang Industriya ng Agrikultura (SINAG) na hindi maaaring maging dahilan ang importation ban para sa pagtas sa

presyo ng mga inangkat na bigas. Katwiran ng naturang samahan na nakuha pa sa mababang presyo ang mga inangkat na bigas ng mga importer bago pa man naging epektibo ang importation ban. May punto ang SINAG kaya naman kinakailangan ang mahigpit na pagbabantay laban sa mga mapagsamantala. Ang presyo ng special rice mula sa Thailand batay sa monitoring ng nasabing samahan ay sinasabing bumaba pa. Dagdag pa na sa nakalipas na buwan ay nagsimula na ang anihan ng palay kaya talagang wala dapat asa-

Legarda nanawagan sa mga Pilipino na gawing kilos pang-komunidad ang mga batas pangkalikasan

Nanawagan si Senadora Loren Legarda sa publiko na isalin ang mga patakaran ng pangkalikasan sa konkretong kilos pang-komunidad habang ipinagdiriwang ng bansa ang National Clean-up Month ngayong Setyembre sa bisa ng Proklamasyon Blg. 244 s. 1993, na sinahaman ng Proklamasyon Blg. 470 s. 2003 na itinalaga ang bawat ikatlong Sabadong Setyembre bilang International Coastal Clean-Up (ICC) Day sa Pilipinas.

"Bilang principal author at principal sponsor ng Climate Change Act of 2009 (RA 9729), at bilang may-akda at pangunahing tagapagtugon ng Ecological Solid Waste Management Act of 2000 (RA 9003), nakita ko na nagbubunga lamang ng tunay na pagbabago ang mga batas kapag tinanggap at isinabuhay ito ng mamamayan," ani Legarda.

"Tumindig tayo sa hamon ngayong Setyembre. Ang pangangalaga sa ating kalikasan ay higit pa sa pag-sunod; nangangailangan ito ng pagkakaisa, agarang pagkilos, at araw-araw na dedikasyon. Gawing simula ang sandaling ito para sa isang mas malinis at matatag na Pilipinas," dagdag pa niya. Binigyang-diin ni Legarda ang datos mula sa Department of Environment and Natural Resources (DENR), na nagpapakita na ang Pilipinas ay nakakapagdulot ng humigit-kumulang 61,000 metrikong tonelada ng solid waste araw-araw, kung saan 12 hanggang 24 porsyento nito ay plastik. Sa karaniwan, bawat Pilipino ay kumokonsumo ng 20 kilo ng plastik kada taon, at 15.4 kilo dito ang nagiging basura. Dahil dito, nangunguna ang bansa sa mundo sa kontribusyon sa plastik sa karagatan, na umaabot sa halos 36 na porsyento ng pandaigdigang marine waste.

Itinampok din niya na noong nakaraang taon, nakapaglinis ang ICC ng 352,479 kilo ng basura mula sa 250 lugar sa buong bansa sa loob lamang ng isang araw.

"Ito'y malinaw na bakas ng sugat," babala ni Legarda. "Ang pagbaha at sapilitang paglikas ay hindi na isolated na pangayari; sintomas ito ng baradong dulayun ng tubig, nasadsad na kagubatan, at mahabang taon ng maling pamamahala ng basura. Ang epektu ng polusyon at pagbabago ng klima ay hindi malayong bantang panghinaharap; nangyayari na ito ngayon at kumitil na ng buhay ng mga Pilipino."

Upang tugunan ang mga hamon ito, muling inilahad ni Legarda ang panawagan para sa mas mahigpit na pagpapatupad ng batas pangkalikasan at malikhain ng pagpapalo. Sa ika-20 Kongreso, naghain ang four-term senator ng Senate Bill No. 1250 para sa pagtatatag ng Environmental Protection and Enforcement Bureau (EPEB) sa ilalim ng DENR upang mapabuti ang kakayahan ng pamahalaan sa pagsubaybay sa paglabag ng mga batas, lalo na sa mga mapanganib na basura ng ospital at polusyon pang-industriya.

Naghain din siya ng SBN 1251, o ang Philippine Environmental Assessment System Act, na naglalayong i-modernisa ang pamamahala ng kalikasan sa bansa. Pinakikilala ng panukala ang tatlong mekanismo: Strategic Environmental Assessment para sa mga polisia at programa, Environmental Impact Assessment para sa mga proyekto, at Health Impact Assessment na nakaayon sa Universal Health Care Act. Sama-samang naglalayong magkaroon ng mas maagap, siyensiado, at pangkalusugang pananaw sa paggawa ng desisyon Ayon kay Congresswoman

pangkalikasan ang mga repermang ito.

"Hindi sapat ang batas upang lutasin ang ating mga hamon sa kalikasan," diin ni Legarda.

"Kailangan natin ng partisipasyon ng publiko, lokal na inobasyon, at tuloy-tuloy na pagkilos ng komunidad. Sa paggunita natin ng National Clean-up Month, ICC Day, o anumang inisyatibo para sa kamalayan sa kalikasan, hinihikayat ko ang aking mga kababayan na huwag ituring itong isang beses lamang na aktibidad kundi bilang mitsa

para sa pangmatagalang pagbabago."

"Ang mga batas pangkalikasan ay hindi lamang salita sa papel; ito'y kasangkapan para sa pagbabago. Palalimin natin ang ating paninindigan upang iugnay ang patakaran at gawain, hindi lamang ngayong Setyembre kundi araw-araw. Nagsisimula ang tunay na pagbabago kapag tinanggap natin bilang sarili ang mga batas na nilikha para sa ating proteksyon," pagtatapos ni Legarda.

Panukalang Financial Literacy ni Cong. Lani Revilla, Lusot na sa Komite—Isasalang na sa Plenary

Isang makabuluhang hakbang patungo sa mas matatag na kinabukanan ang naabot ng panukalang batas ni Congresswoman Lani M. Revilla na naglalayong isama ang personal financial literacy sa curriculum ng mga technical-vocational institutions at TESDA training centers. Matapos ang masusing deliberasyon, inaprubahan ito ng Committee on Higher and Technical Education at nakatakdang isalang sa ikalawang pagbasa sa plenary ng Kongreso.

Sa pagdinig ng komite, napagkasunduan pang palawakin ang saklaw ng panukala. Bukod sa mga training centers ng TESDA, isasama na rin ang kurso sa lahat ng tertiary education institutions sa bansa. Layunin nitong bigyan ang mga estudyante ng kaalaman sa tamang paghawak ng pera, pag-impok, pamumuhunan, at pagpaplano para sa kanilang kinabukanan—mga kasanayang kritikal sa pangaraw-araw na buhay ngunit madalas na hindi bahagi ng tradisyunal na edukasyon. Ang panukalang ito ay bahagi ng mas malawak na abokasiyang #AlagangAteLani, na patuloy na nagsusulong ng edukasyon may malasakit, praktikal na pakinabang, at pangmatagalang epektu sa buhay ng bawat SPilipino.



TAGAYTAY CITY

In a decisive push for public safety and preparedness, the Tagaytay Component City Police Station (CCPS) conducted a full-scale Simulation Exercise on September 2, 2025, simulating an active shooting and robbery-in-progress scenario at Fora Mall. The drill, which began at 6:00 AM, mobilized police personnel, Field Training Program (FTP) trainees, mall employees, and security staff in a coordinated effort to test emergency protocols and rapid response strategies. Led by PLTCOL Jefferson P. Ison, Acting Chief of Police, the exercise opened with a comprehensive briefing and orientation, emphasizing the importance of situational awareness, inter-agency coordination, and swift tactical execution during high-risk incidents. The simulation was designed not only to assess operational readiness but

aimed at cutting carbon emissions and supporting sustainable urban growth. These presentations were followed by an engaging open forum where participants exchanged ideas on blending science, culture, and technology for sustainable progress.

R&D Summit 2 centered on community-focused research tackling social welfare, disaster preparedness, and agriculture:

Dr. Noel S. Gunay of Mindanao State University-General Santos introduced “ItWatcher,” an AI-powered 24/7 traffic monitoring system designed to enhance road safety and traffic flow in General Santos City.

Dr. Mary Jane K. Balawag of Notre Dame University presented her study on the psychosocial impact of maternal incarceration on children, highlighting the need for stronger social support systems.

Engr. Christopher A. Benito of the University of Southern Mindanao presented the “USM Center for Flood/Landslide Preparedness and Mitigation,” a project aimed

also to foster a culture of vigilance among private sector partners and frontline responders.

The initiative was made possible through the leadership of Hon. Aizack Brent D. Tolentino, City Mayor of Tagaytay, whose commitment to proactive safety measures has resulted in a series of drills across key business establishments in the city. His support underscores the local government's dedication to building resilient communities through strategic preparedness.

Regional and provincial police leadership also played a pivotal role in the success of the exercise. PBGen Paul Kenneth T. Lucas, Regional Director of PRO 4A CALABARZON, and PCOL Ariel R. Red, Provincial Director of Cavite PPO, provided guidance and institutional backing, reinforcing the importance of continuous training and scenario-based learning in law enforcement operations.

Mall employees and security personnel actively participated in the drill, simulating real-time responses and evacuation procedures. Their involvement highlighted the critical role of private sector stakeholders in ensuring public safety, especially in high-footfall commercial areas vulnerable to security threats.

This simulation marks

at strengthening community resilience through disaster risk reduction and early warning systems.

local innovations, and community-driven solutions can address pressing challenges and drive regional progress. Participants are expected to engage in forums, explore interactive exhibits, and experience technology demonstrations from DOST and its partners. A major highlight of the week is the 2025 STI Awards, which recognized outstanding beneficiaries of DOST programs such as the Small Enterprise Technology Upgrading Program (SETUP), Community Empowerment thru Science and Technology (CEST), and Grants-in-Aid (GIA). From entrepreneurs developing unique products to farmer groups adopting modern technologies, this year’s awardees exemplify how science and innovation directly uplift lives and strengthen local industries. As Secretary Solidum noted, the honorees prove that science is not confined to textbooks or laboratories—it is about lives improved, livelihoods uplifted, and futures secured.

Another key feature was the signing of a partnership among the DOST-Philippine Textile Research Institute (PTRI), DOST Region VIII, and the Local Government Unit of Bobon, Northern Samar. The collaboration seeks to enhance fiber extraction technologies from abaca and pineapple, transforming agricultural by-products into sustainable raw materials for the textile sector while creating new livelihood opportunities in local communities.

Running until September 5, the 2025 RSTW in Eastern Visayas stands as a regional showcase of innovation and collaboration—affirming that science and technology are vital in building resilient, future-ready, and inclusive communities. **(Nelson Santos)**

DOST-Pangasinan opens opportunities for PDLs in Dagupan City Jail, provides training on Calamansi Juice Processing

In its continuing effort to bring science, technology, and innovation closer to all, the Department of Science and Technology - Pangasinan (DOST-Pangasinan) conducted a Technology Training on Calamansi Juice Processing for 30 Persons Deprived of Liberty (PDL) on August 20, 2025, at the Dagupan City Jail - Male Dormitory (DCJ-MD).

The partnership between DOST-Pangasinan and DCJ-MD forms part of its Skills and Enhancement Training Program for both PDLs and jail officers. The training opens opportunities for microenterprise development inside and outside the facility, giving PDLs a better chance at opening opportunities that support rehabilitation and successful reintegration into their communities.

One of the participants, identified as “Mario” (not his real name), shared, “Ang training na ito ay nagbigay sa amin ng pagasa na makapagsimula ng kabuhayan kapag nakabalik na kami sa aming mga tahanan. Taos-puso kaming nagpapasalamat sa kaalaman at sa pagkakataong matuto habang ginugugol ang aming panahon dito” (This training has given us hope to start a livelihood once we return to our homes. We are sincerely grateful for the knowledge and for the opportunity to learn while spending our time here). Mr. Alvin S. Aguilan, Instructor I from Pangasinan State University - Bayambang Campus, and Ms. Monica May B. Varilla, a Professional Food Technologist from the DOST Region 1 – PSU Food Innovation Center served as the resource persons of the training. The activity featured Calamansi Juice Processing as one of the technology offerings of the PSU-DOST Region 1 FIC under its extension and skills training program, which aims to promote food innovation and enterprise development. The participants also learned about current Good Manufacturing Practices (GMP) and Basic Food Safety, essential foundations for producing safe and market-ready food products.

Statement of the Dayang Family Four Months After Journalist Johnny Dayang's Assassination

On this day, August 29, the Church commemorates the Martyrdom of St. John the Baptist, who was executed for

speaking truth to power and refusing to remain silent in the face of wrongdoing.

Exactly four months ago, on April 29, our father, veteran journalist Johnny Dayang, met a similar fate. He was assassinated for being a fearless voice of conscience, a man who dedicated his life to truth, and someone who never compromised in his duty to inform the public. Like John the Baptist, he unsettled those who thrived in silence and falsehood. And like St. John, he was silenced by violence. As his family, we affirm that while his life was cut short, his voice endures. His writings, his example, and his memory remain alive. His legacy as a journalist and as a truth-teller cannot be erased.

Violence may end a life, but it can never extinguish the truth for which that life was lived.

We continue to seek justice for his assassination, holding on to the hope that those responsible will be held accountable.
