FORUM TUNĞKOL SĂ PAG-IWAS SA PAGHAHANDA PARA SA TERORISMO NA GINAWA

Tinalakay sa forum ang lumalalang banta ng paghubog sa terorismo, ang epekto nito sa mga mahihina na sektor lalo na sa kabataan at ang kahalagahan ng mga batas na pang-iiwas upang maprotektahan ang mga komunidad mula sa radicalization.

Ang BKFI, NTF-ELCAC, lumahok ang mga stakeholder mula sa pamahalaan. lipunang sibil, sektor ng seguridad, grupo akademya, mga kabataan, at mga kasamahang pangkomunidad sa forum upang palakasin ang kamalayan at suporta para sa Batas sa Pag-iwas sa Teroristang Pagpapalago at itampok ang papel nito sa pagtanggol sa mga bulnerableng grupo.

Ang mga nawawalang bata ay nakilalang sina Queenly Gromeo, na nag-aral sa PUP. Siya ay na-recruit ng Anakbayan sa edad na 16. Huling nakita siya noong Setyembre 2016.

Kumpirmadong miyembro NPA mula sa liham ipinadala niya Siya kanyang pamilya. rin ay positibong nakilala ng kanyang ina sa isang narekober na video. Nagaral si Frances Ern Meriveles sa PUP. Siya ay nakuha ng Anakbayan at League of Filipino Students. Kilala na siya ngayon bilang "Ka Nico" sa NPA.

Ipinakita ni Direktor Joel Sy Egco, isang konsultant ng NTF-ELCAC, ang pananaw ng akademiko at rekomendasyon sa patakaran tungkol sa panluluto ng terorista.

Sinabi ni Dr. Egco na dati siyang miyembro ng Makabayan. Siya mismo ay naging miyembro ng NPA sa edad na 18. Ang kanyang kumander ay isang Aeta at sila ay gumagala sa lalawigan ng Zambales.

Binanggit ni Dr. Egco ang pagtugon sa marahas na ekstremismo/pang-akit terorismo (VE-Grooming), na hindi imbento ng isang Pilipino. Sinabi niya na ito ay tinutukoy bilang isang na banavad proseso. madalas na hindi nakikita, na yugto bago ang pagrerekrut na kailangang tugunan sa pamamagitan ng maagang pagtuklas at mga estratehiya laban sa pag-akit.

"Walang ipinanganak na marahas. Ito ay nahuhubog at pinapalakas," sabi ni Dr. Egco.

Ipinunto niya na ipinakita ng AVP ang apat na magkakaibang indibidwal ngunit may parehong mga pattern o katangian.

Binigyang-diin ni Dr. Egco na ang grooming ay isang paglabag sa karapatang pantao dahil binabago nito ang pagkatao at ugali ng isang tao.

"Maniwala kayo sa akin, hinarap ko ang aking ama sa isang barilan dahil hindi ko siya nakumbinsing sumali sa NPA," sabi ni Dr. Egco.

Sinabi niya na ayon sa RAN (Radicalization Awareness Network), ang mga naggugroom ay parang mga Neo-fascist at mga Utopia, na mga normal na indibidwal ngunit idealistiko batay sa prinsipyong Utopian.

"Marami na sa mga NPA ang sumuko. Kaya mali ang ideya (doktrinang) iyon," sabi ni Dr. Egco. Dagdag pa niya, ang doktrina ay nasa lipunang walang uri ay hindi matatalo.

Sinabi niya na si Joma Sison ang gumawa ng Sisonism," "chopsuey nangopya kina Mao Tse Tung at Nikolai Lenin. Si Dr. Egco, noong siya ay isang NPA, ay may limang magkakaibang pangalan sa limang magkakaibang lugar. Puna niya na maraming dating cadre tulad niya ang naging tagapagsanay din. Sa kanyang sariling pagaaral, ipinaliwanag ni Dr. Egco ang mga yugto ng grooming tulad ng pagpili ng biktima, pagtatayo ng tiwala, pagpapakilala ng ideolohiya, emosyonal na pag-iisa, pagpapakita ng commitment, at sa huli, ang pagkilos.

Ang mga pamamaraan ng grooming ay love-bombing, pagpapalaganap ng impormasyon, sosyal na izolasyon, deindibidualisasyon kung saan ang isang indibidwal ay hindi na inaalagaan ang kanyang sariling kapakanan at kagalingan, at grooming sa social media.

"Ang pinakamahusay na katatagan ayon sa mga pandaigdigang katawan ay ang malaman na ikaw ay tinuturuan," sabi ni Dr. Egco. Idinagdag niya ang kahalagahan ng Forum on Terror Grooming Prevention Bill kung saan hinihikayat ang lahat na makibahagi rin.

that endure heat, pressure, and time, yet remain full of potential to grow tall and strong, Chella Baraquel, a corn vendor from San Vicente North, Calapan City, Oriental Mindoro, embodies survival and resilience in both life and business. From a simple kariton they built themselves to a permanent stall in the market, Chella and her family turned their humble beginnings into a lasting space to sell corn.

At an early age, Chella learned the values of perseverance and selfreliance. She had to leave school early due to family circumstances, having only reached the third year of high school, which prompted her to start working and support herself. She left home at the age of 16 and worked various jobs: a household helper in Manila, contractual factory worker in Laguna, and then a cashier and waitress in Batangas. Each role refined her work ethic and determination to persevere. When she returned to Oriental Mindoro in 2007, fate introduced her to Jeffrey Casalla, the man who later became her partner. Together, they faced the daily challenges of making ends meet. With little to no capital, they started selling root crops and fruits, such as singkamas and rambutan, using a kariton they had built themselves.

By 2009, they turned to selling corn, which soon became their steady source of income. Without a fixed supplier, they learned to adapt, constantly

But in 2014, everything changed. A series of financial challenges struck their family, draining their business capital and even their daily funds for food and expenses. With no resources left to sustain the business, Chella made the painful decision to seek work abroad in Egypt as a domestic helper. Unfortunately, even there faced hardships. she Chella experienced maltreatment and abuse by her employers and was forced to return home after several months.

That same year, her partner, Jeffrey, became a client of CARD Bank, a microfinance-oriented rural bank, and applied for a PHP 5,000 loan to revive their corn business while Chella was abroad. In 2015, when Chella decided to stay home for good, she also became a member of CARD Bank and applied for another PHP 5,000 loan to help expand their small enterprise. Together, they

slowly rebuilt what they had lost.

By 2016, their perseverance paid off. They were able to rent a stall in the Calapan City Public Market while continuing to sell at the night market. Their stall became a familiar sight, offering a variety of corn cobs. They also continued selling from their kariton, but this time, they improved it into a more durable food cart. They nurtured a simple yet thriving business that continues to sustain their family.

Their business helped them send their children to school. Their eldest is now a college nursing student, and the younger two are in senior and junior high school.

Then came the COVID-19 pandemic in 2020, their most formidable challenge yet. Lockdowns halted their selling, their savings were depleted, and they were forced to sell their tricycle just to survive. Before this happened, they had taken out a loan of almost PHP 80,000 from CARD Bank to expand their business further. That very loan became their lifeline, helping them keep their business afloat by selling within neighborhoods nearby

and covering their daily expenses. After the pandemic, they gradually repaid the loan little by little while rebuilding their business.

With only limited resources left, they began again with just two sacks of corn as their supply, steadily earning and saving until their livelihood regained its strength. They expanded their product offerings to include peanuts, boiled corn, and buttered corn. They were even able to purchase a new tricycle, gradually recovering what they had lost during the pandemic.

Chella believes that true capital in life and business is not just money, but also patience, hard work, and perseverance. Like a kernel of corn that grows into a strong, sustainable livelihood, her story reflects steady effort overcoming challenges.

In the future, she and her partner, Jeffrey, hope to have their own non-rented stall and expand into fruits and condiment retail, a dream they will once again pursue step by step, believing that setbacks are never final for those who keep moving forward. (Jireh Pearl Casionan, Junior Writer)

Legarda suportado ang desisyon ng Korte Suprema sa pagbabalik ng pondo ng PhilHealth; iginiit ang Transparency, matatag na pagpopondo para sa kalusugan

Suportado ni Senadora Legarda Loren ang naging desisyon Korte Suprema na nagaatas sa pamahalaan na ibalik ang ₱60 bilyon na naunang nailipat mula Health sa Philippine Corporation Insurance (PhilHealth) pabalik sa ahensya sa pamamagitan 2026 General Appropriations Act (GAA). Kasabay nito, ipinagbawal ng Korte Suprema ang karagdagang paglilipat ng natitirang ₱29.9 bilyon, na agad na ipinatutupad.

"Tama ang desisyong ito at kaayon ng matagal na nating ipinaglabanang pondo ng PhilHealth dapat manatili sa ay Ang PhilHealth. mga subsidyo umiiral ay upang protektahan ang Pilipino, sambayanang hindi upang ilihis sa ibang pahayag layunin," Legarda.

Orihinal na inatasan ang PhilHealth na mag-remit ng kabuuang ₱89.9 bilyon sa National Treasury. Sa halagang ito, ₱60 bilyon ang nailipat noong nakaraang taon bago maglabas ng temporary restraining order (TRO) ang Korte Suprema na pumigil sa paglilipat ng natitirang ₱29.9 bilyon. Mula noon, parehong Kamara at Senado ang nagsama ng probisyon para sa pagbabalik ng ₱60 bilyon sa 2026 General Appropriations Bill (GAB) na tinatalakay sa Senado. Ito ang binigyang-diin ni Legarda sa sesyon ng Senado noong Disyembre 4, 2025.

Sa parehong sesyon, muling iginiit ni Legarda na tungkulin ng Kongreso na tiyakin ang sapat na suporta sa PhilHealth maihatid ang upang pangunahing serbisyong pangkalusugan. Binanggit niva na nananatiling kulang ang alokasyon sa ilalim ng 2026 National Expenditure Program (NEP) at hindi ito tumatalima sa itinatadhana ng batas sa sin tax.

"Kongreso ang may pananagutan sa taumbayan na tiyakin ang maayos na pondo ng PhilHealth," diin ni "Sa Legarda. aking

interpelasyon sa General Principles ng 2026 budget, binigyang-pansin ko ang kakulangan sa pondo ng PhilHealth para sa 2024, 2025, at 2026. Kailangang itanong kung saan inilagay ang mga pondo, bakit ito inalis, at paano natin ito ganap na maibabalik." Binigyang-diin din

Legarda ang pangangailangan transparency accountability sa paggamit ng mga subsidyo ng PhilHealth. Pormal niyang hiniling sa PhilHealth at Department of Health (DOH) na magsumite ng detalyadong liquidation reports upang matiyak na ang ibinalik na pondo ay magagamit nang mahusay at naaayon sa mandato ng ahensya. "Habang ibinabalik natin ang mga halagang ito, dapat din nating hingin ang ganap na transparency," ani Legarda. "Hiniling ko sa PhilHealth at DOH na ipaliwanag ang paggamit ng mga pondong ito upang matiyak na tunay na makikinabang ang ating mga kababayan.

Dagdag pa rito, iginiit ni Legarda na ang accountability ay dapat sabayan ng sapat at maaasahang pondo. siya Nanawagan sa ganap na pagbabalik ng lahat ng kakulangan sa pondo mula sa iba't ibang pinagkukunan, kabilang ang earmarked revenues mula sa sin taxes, PAGCOR, at PCSO na naipon sa mga nakaraang taon.

Bilang matagal nang tagapagtaguyod ng abot-kaya at dekalidad serbisyong pangkalusugan, muling pinagtibay ni Legarda ang kanyang paninindigan protektahan na ang katatagan ng pananalapi ng PhilHealth at tiyakin na ang mga yaman nito ay direktang nakikinabang sa mga pamilyang Pilipino, lalo na ang mga pinakanangangailangan.

"Ang kalusugan av hindi pribilehiyo; ito karapatan. Bawat ay pisong nakalaan para sa kalusugan ng taumbayan ay dapat pangalagaan," pagtatapos ni Legarda.

Weavers Manifesto cries for respect, support

for Philippine weaves, denounces machine replicas, printed substitutes

popularity The growing traditional of handloomwoven textiles has placed Filipino weavers at a critical crossroads. Their designs, and livelihoods heritage, are increasingly threatened only by printed and machine-made replicas but also by unfair market access, lack of intellectual property protection, and limited recognition of their rights as artists, cultural bearers, and workers. While counterfeit fabrics dilute authenticity deceive consumers, deeper challenges persist. Weavers struggle to reach inclusive markets, secure fair compensation, and pass down their craft to future generations. These shared concerns have prompted weaving communities across the country to unite and assert rights to livelihood, cultural identity, and a rightful place in the nation's textile value chain.

In response to this growing concern, the Department of Science and Technology, Philippine Textile Research

Institute consolidated the insights and thoughts through Weavers Manifesto during the 1st Philippine Handloom Weaving Festival held at Robinsons Ilocos in Ilocos Norte on 22 November 2025 as part of the National Science, Technology Innovation Week. The signing was led by Dr. Julius Leaño Jr., Director of DOST PTRI, and the delegation of more than 120 weavers from over 40 weaving communities across the country. It was witnessed DOST llocos Region Director, Dr. Tereista Tabaog Assistant Secretary and Anna Carmela V. Remigio, Presidential Assistant Northern Luzon.

The DOST-PTRI and the weavers initially conducted a focused group discussion (FGD) that raised the concerns and needs of weaving communities across the country. The resulting Weavers' Manifesto captured the 8 main and critical issues raised during the FGD. The signatories call for the following:

• Opposition to the widespread use of counterfeit handwoven textiles and machine-made woven replicas as substitutes for the authentic handwoven fabrics of the Philippines. (Pagtutol sa malawakang paggamit ng

mga pekeng hinabing tela at mga hinabing replika na gawa ng mga makina bilang panghalip sa mga tunay na habing-kamay ng Pilipinas.)

• Use of handwoven textiles for the uniforms and attire of government employees and students. (Paggamit sa mga hinabing tela para sa uniporme at kasuotan ng mga kawani ng pamahalaan at mga magaral.)

• Strong opposition to the use of woven textile designs in sublimation printing and in printed fabrics being sold as if they were handloom woven. (Mariing pagtutol sa paggamit ng mga disenyo ng hinabing tela bilang disenyo sa sublimation printing at sa mga printed na tela binebenta bilang hinahabing tela.)

• Expanded access for weavers to cotton and natural textile fiber-based yarns. (Mas pinalawak na akses ng mga manghahabi sa cotton at natural textile fiber-based yarns.)

Broader access training programs to prepare the next generations of weavers and to promote knowledge about the art and science of weaving. especially among the youth. (Pinalawak na akses sa mga programa sa pagsasanay upang maihanda ang mga sumusunod na henerasyon ng mga manghahabi at pagpapalaganap ng kaalaman ukol sa sining at agham ng paghahabi lalo na sa mga kabataan.)

• Unification of all weavers across the Philippines into an organized group. (Pagbubuklod ng lahat ng mga manghahabi sa buong pilipinas bilang isang organisadong grupo.)

Strengthening policies for the development of the weaving sector and for the protection of intellectual property and the creations of weavers and their respective communities. (Pagpapaigting ng mga polisiya para sa pagpapaunlad ng larangan at pagprotekta sa yamang-isip at mga likha ng manghahabi at ng kanilang grupong kinabibilangan.)

• Respect for the rights and recognition of weavers, especially women whose livelihoods depend on this craft. (Paggalang sa mga karapatan at pagpapahalaga sa mga manghahabi lalo na ang mga kababaihang nakabatay ang kabuhayan sa larangang ito.)

As the Weavers' Manifesto underlines the importance of keeping weaving traditions

alive for cultural and economic advancement of weavers, a testimony came from Marlyn Muyana of the Baraclayan Weavers Association lloilo who shared how their community's weaving center contributes to their community advancement. "Before the weaving center was established, our barangay was considered one of the poorest in the municipality. Many families struggled to meet daily needs, and sending children to school felt like an impossible dream. But through hard work. unity, and commitment, the weaving center became our turning point. Today, we are proud to say that we have no out-of-school youth in our community. Almost all our students now have the chance to pursue higher education in colleges and universities." The said Manifesto is also in

line with the advocacy raised

by Dr. Leaño, Jr., during the opening ceremony of the festival, when for the first time he publicly called on the public and said, "Sana 'wag na kayong bumili po ng fake handloom woven fabrics...because you are not just depriving them of their livelihood. You are depriving them of their culture. You are depriving them of their identity. And most importantly, you are depriving them of their future. Philippine Handloom The Weaving Festival generated over ₱2 million in gross sales of handloom woven products from over 120 participating weavers from more than 40 weaving communities representing various regions across the country. A total of 600 kilograms of cotton yarns was also distributed to the weavers as part of CottonPH Weaving the Movement, a program that aims to boost local handloom weaving, reduce dependency on imported yarns, and promote sustainability by providing weavers with locally spun quality yarns. This is the first massive distribution of yarns that awaits feedback on the weavibility and the overall transitioning journey that the weavers will undergo in weaving Philippine cotton varns. Ilocos Norte will also be able to spin and produce cotton varns for Northern Luzon after the inauguration of the facility last 20 November in Vintar, Ilocos Norte, during the duration of the Festival.

The 1st Philippine Handloom Weaving Festival is a collaboration of the Provincial Government of Ilocos Norte, Ilocos Norte Tourism, Cebu Pacific Air, Robinsons Ilocos, and the Local Government of Taguig City, which is the host city of the Philippine Handloom Weaving Center
