**O R D E R**

Before this Court is a Petition for Judicial Settlement of the Intestate Estate of Presumptively Deceased Sebastian R. Riocasa, Jr. filed by petitioners Joriz Sebastien and Jesse Sebastian both surname Riocasa through counsel.

The petition alleged that Sebastian R. Riocasa, Jr., has been missing for more than (11) years already, and at the time of his disappearance, he was seafarer on board GDF Suez Ghent, and a resident of Dasmariñas City, Cavite. He allegedly left behind parcels of land covered by and embraced in Transfer Certificate of Title No. T-118850 of the Registry of Deeds for the Province of Albay, registered in the name of Sebastian Riocasa, Jr., and Transfer Certificate of Title No. 057-2013027598 of the Registry of Deeds in the Province of Cavite, registered in the name of Sebastian Riocasa, Jr. married to Teresita Riocasa. The petition prays that the aforesaid properties be distributed among the heirs of Sebastian R. Riocasa, Jr., as listed in the petition, on the ground that Sebastain R. Riocasa, Jr. is allegedly "presumed dead".

Finding the petition to be sufficient in form and substance, **NOTICE IS HEREBY GIVEN** that said petition has been set for hearing on **August 4, 2026 at 1:30 in the afternoon**, in this Court, on which date and place all persons named in the petition and/or any person interested is cited to appear and show cause why the same should not be granted.

Let this NOTICE be published once a week for three (3) consecutive weeks in a newspaper of general circulation in the Cities and Province of Cavite, at the expense of the petitioners.

Let copy of this Order be furnished the Office of the Clerk of Court, Regional Trial Court, Dasmariñas City, for the inclusion of this order in the raffle of notices.

Likewise, furnished copy of this Order together with the petition and its attachments, the persons name in the petition as the surviving compulsory heirs.
